Arsenault received report from victim (who resides in [REDACTED]) on 12/26/02. Contacted Chief Brown-Littleton PD, and advised that Lamontagne would be calling his Dept. to report this sexual abuse. Chief Brown indicated that Off. Keeney would be waiting for the call. Called Lamontagne back, and referred him to Off. Keeney-LPD. Atty. Lamontagne stated he was making the call to LPD himself. Atty. Lamontagne stated that FR. LOWER is an active priest in New London, NH and would be removed from ministry immediately and the parishioners of his church would be notified of the removal. Chief Brown stated they would document the report from the Diocese. Fr. Lower committed suicide (overdose) on 12/29/02-Enfield PD. See reports in Diocese file-AG. Reports on Lower's suicide in audit file.

Joe Naff has tried unsuccessfully to speak to victim again to get details of the abuse and who the accused person is.

Victim did not disclose this information when he called. Naff reported to Dover PD-Chief Fenniman. Lamontagne stated he would get back to me with all the information once they have reached the victim and have spoken to him. *Called Ovide Lamontagne on 1/6/03 for more info and identity of priest. He did not have further information, but would call me when and if that was developed. *1/9/03-Spoke to Lamontagne and they still have not been able to contact victim. The accused priest is still not identified.

Summary: In the summer of 1982 or 1983, victim reported to Diocese she was 12-13 yrs. old and living in Gilford, NH with her parents. There was a priest (Sullivan) visiting from another (unidentified) Diocese from Arizona serving at St. Joe's in Laconia, NH. Victim's parents are [REDACTED] and the sexual abuse took place at this address. Fr. Sullivan visited their home, and came by one day and fondled the victim sexually. Unknown if penetration occurred. Victim told her parents at the time, who then told the parish priest Fr. Michael Griffin. It appears Fr. Griffin did not do too much with the report. Her parents then reported this to the Diocese during the time of the abuse to Fr. Christian. The accused priest Fr. Sullivan then left the State and went back to Arizona. The diocese cannot find any record of this report. This case may be prosecutable if the accused priest left NH and did not return. Lamontagne to contact Gilford PD-Det. Christian Kelly for report. I called Gilford PD and explained they would be getting a call from Attny. Lamontagne. Victim resides at [REDACTED] * 1/16/03-Spoke to Cty. Attny. Lauren Noether about this report. Faxed her the information we had received above. They will investigate to see if a prosecutable case. *1/17/03-E-mail report in audit file. Notified Lauren Noether that Sullivan may be deceased and his full name. Will verify if Sullivan is deceased or not.

Lirette in Manchester, NH. 12/16 spoke with [REDACTED] of Washington, DC and he was going to get the information. 12/30 called [REDACTED] in that he had not responded. Summary: [REDACTED] reported to the Diocese on 3/21/02 the abuse by Fr. Osgood. He did not want to involve law enforcement. [REDACTED] advised in 1960 to 1962 when he was between 15 and 17 years of age he was an alter boy and Osgood was groping him at the Cathedral. Joe Naff sent follow-up letters to [REDACTED] on 5/7/02 and 9/16/02 to encourage [REDACTED] to report to County Atty. Or AG. Evidently [REDACTED] mother

recently passed away and he received a letter to attend a retreat on 1/17/04. This has brought back the memories of the abuse. Diocese supposedly told [REDACTED] that they did not know the location of Osgood. Ovide Lamontagne confirmed that Donald Osgood is at [REDACTED] Atty. [REDACTED] who represented a number of victims advised that Osgood is dying of cancer. The NH Diocese also recently sent a letter to GA Diocese advising them that Osgood was in their Diocese.
12/30/03 Atty. Lamontagne advised Osgood left NH in 1968. Called [REDACTED] and advised statute of limitation expired. He would need private counsel for anything further. Emails in file.

Neighbor laid on top of [REDACTED] while in bed while dressed only in underwear. There was no penetration or touching of genitals.

Summary: 1/16/04 [REDACTED] reported to Atty. MacDonald. [REDACTED] reported abuse of kissing, hugging, fondling, sexual intercourse took

place in Plaistow, NH between 1942 and 1944 when she was 15 to 17 years old by a Rev. John T. Sullivan (deceased). These acts took place in an automobile, the parish rectory and the church.

ACCUSED: FR. JOHN T. SULLIVAN (DECEASED)

Summary: 1/16/04 [REDACTED] reported to Atty. MacDonald. [REDACTED] DOB ? 1948 reported abuse of fondling, oral sex, digital penetration, and partial vaginal penetration took place in Plaistow, NH between 1953 and 1957. The abuse took place by a Rev. John T. Sullivan (deceased). The acts took place in the victim's home, parish rectory, automobile and lake.

Summary: ██████ had previously reported an incident on 1/23/03 (See #8 above) involving a Fr. Rocco Memmolo. 2/17/04 ██████ wrote a letter to Joe Naff about a Fr. Shields and a teacher at St. Thomas Aquinas school who left in the 1970s. Naff attempted to obtain more information but a Counselor advised that ██████ suffers from multiple personality disorder and it is unlikely further statements will be available. Fr. SHIEDS is 93 yoa and in FL. He is to take up residence at Bishop Peterson residence.

Summary: ██████ had contacted the Holy Cross Order. Fr. Colgan of CSC notified NH Diocese. 4/14/04 Fr. Arsnauld completes the report that ██████ advised in the late 1970s Fr. ██████ brought him to a home in ██████ 4/26/04 I spoke with ██████ reported leaving home Nov 1978 and living with Fr. ██████ in MA. Late 1970s they came to a home in ██████ where ██████ massaged him and attempted anal penetration. ██████ has lived in NH for past 10 years. Statute of limitations has expired and ██████ advised to work with CSC for further counseling.

Summary: The Diocese received an anonymous report that ██████ had been victimized 30 years prior at St. Anthony's Parish. I spoke with ██████ on 5/6/04. She reported 1975 – 1976 at the age of 14 or 15 she feels there was inappropriate kissing and hugging by Deacon and then became Fr. Patrick Dubreuil while at St. Anthony's and St. Jean's parishes. Her younger sister also reported kissing by Dubreuil. Dubreuil has left the priesthood, is now married and has children of his own. He is also associated with the ██████ School District and a prior report was filed and a letter sent to the district.

arrested for molesting two girls that he was babysitting that are age 4 and 6 yoa.
[REDACTED] was an altar server and trainer at St. Johns.

[REDACTED] was born in 1950 he believes he was 13 or 14 at the time. Diocese believes this report was part of the March 3, 2003 review by OAG.
