

Recently I was present in a home of two parishioners and their neighbors who stated(when the conversation of sex abuse in the church arose) that they knew of the sexual antics of Father Joyal who had sex with young boys in the parish and they named one boy in particular who they new personally. They no longer go to St.Pius for services for this reason, although they still live in the parish.

You may wish to survey present/former St.Pius parishioners to see who may come forward with first hand information on Father Joyal. I asked these folks why didn't they come forward and they said they are too old to get involved and their health is not good.

I wonder where Father Joyal is now, and whether his alleged behavior continues today.

I cannot tell you their names but both families live between in Manchester.
