A few weeks ago, Diane Quinlan met a priest from the Archdiocese of Boston, Father O'Leary, at a conference who told her that a report had been filed with the Mass AG and the NH AG (or Hillsborough County Attorney) in 2002 (and to local law enforcement earlier in the 1990's) regarding alleged abuse by a Father Robert Gale at his camp in NH involving a Robert Apparently was a youth volunteer at Camp Fatima's "Exceptional Citizens Week" program and was allegedly abused at Fr Gale's private home.

After learning about this information, Diane reviewed Diocesan records and determined that the Diocese has no file on this matter and she assumes the Diocese was not previously informed about this matter. Fr Gale is not permitted to minister in New Hampshire.

Please find attached a report about this matter with contact information for Fr O'Leary. Please let me know if I can provide you additional information. We do not know in which New Hampshire community the abuse allegedly took place or any details for that matter. I would suggest your calling Father O'Leary, if you would like to obtain specific information about the alleged abuse.
