In 1990, the complainant's mother reported the matter to her son's pediatrician, who reported the matter to the Massachusetts state authorities. The complainant's parents spoke with Martha Coakley, Massachusetts Assistant District Attorney, but decided not to pursue the matter criminally. The pastor became aware of the allegation through the parent of an altar server and immediately informed Mr. [REDACTED] that he no longer is eligible to serve as a volunteer in the parish.

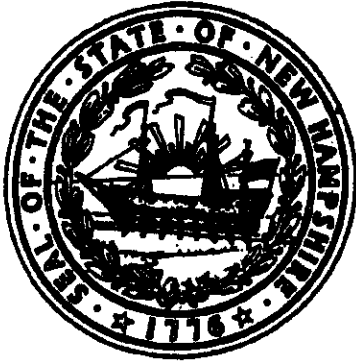
