Update on last two. Victims accused accused (usher) Portsmouth PD contacted family and mother became very defensive and would not allow children to be spoken with. Diocese Inv. Lunt also attempted to speak with family. Mother again very defensive and indicated only reason they were following up was because the Pope was in US. Suffers from dementia and has been allowed to return to church by his family at a mass that is very well attended and is not allowed contact with children. Victim accused Paul Groleau - I had asked if Diocese was paying for seminary. Brian advised prior issues as priest. Also was a Boy Scout councilor and that is where he met accused at old index and found and found 4 prior entries. Groleau was liaised back in the 80s.
