PERSONAL AND CONFIDENTIAL

Dear Father MacCormack,

This is a difficult letter for me to write. I sense your anger and hurt around what has happened and that they have deeply affected your recent decisions. In all honesty, they have hurt me as well. I continue to pray that both of us as men of faith will be able to reach a reasonable and just conclusion about the circumstances of your life and ministry as priest.

I am aware that your attorney has been in contact with the diocesan attorney, Mr. Brad Cook, over the last several days regarding your current situation and your desire to begin shaping a new future for yourself. As Mr. Cook communicated to Mr. McDaniel, communication through an attorney is highly unusual and contrary to the bond that exists between a priest and his bishop. While it may be difficult for you to speak or meet with me at this time, I respectfully ask that communications about your support and status as a priest of the diocese be between you and me. At this time, it seems best to be in writing. I do encourage you to consult with someone you think can be helpful and supportive to you in the decisions you make.

There are three concerns I would like to address with you in an effort to make clear my desire to be helpful and supportive of you. They are, (1) your current status as a priest of the Diocesc of Manchester; (2) your evident intention to leave priestly ministry; and (3) the situation of St. Patrick Parish in Jaffrey. I have provided my own thoughts about each of these issues in an enclosure to this letter and would like you to respond to them.

I can only imagine how difficult this experience is for you. I have personally anguished over my seeming inability to assist you thus far and your seeming disregard for the Church in the decisions that you have made recently. Any suggestions that there are ulterior motives on the part of the diocese for what has transpired these last few months are false, and if you follow through on what you have threatened to do, I can only see more pain for you and everyone affected.

I firmly believe that you are in need of significant pastoral care and counseling. I remain willing to assist you in obtaining whatever medical or psychological care you need, but I also must bear in mind my responsibility to care for others in the Church. You have drawn many people into a difficult situation that I believe we could have resolved confidentially. Your decisions have forced me to focus my attention not only on you, but also on the well being of the Church and your brother priests.

I ask that you review this letter and the enclosure with whomever you rely on for assistance and advice. After some reflection. I ask that you respond to my request and inquiries either by mail or by fax to my office. In the meantime, please know you are remembered in my prayer often.

Status as a Priest

I acknowledged your written request to leave active ministry for a period of one year by accepting your resignation as pastor of St. Patrick Parish in Jaffrey and assigned you to reside at St. Joseph Cathedral while at the same time granting you permission to take an extended three-month vacation prior to resuming a dialogue with me about your priestly life and ministry. I also postponed my original request that you make a retreat under the direction of Abbot Matthew Leavy, OSB, which I offered as a means to assess God's will and plan for you in terms of your life and ministry. You were informed that during this time of vacation you would receive a monthly stipend and the associated benefits equal to that of a priest and pastor ordained in 1997.

As of today, you have not reported to your assignment. You have chosen to remain living in Jaffrey in violation of my request that you not do so. My request that you relocate is based solely on what I believe is best for you, the people of St. Patrick Parish and their new pastor.

Today I repeat to you my request that you report to your assigned residence. I have offered you a great deal of latitude while in residence, giving you a lengthy vacation in an effort to allow you to step aside from the evident pressures of this situation. If you do not accept this assignment, I will have no other choice than to respond to your lack of cooperation according to the provisions of Canon Law.

Leaving Priestly Ministry

In your letter to me dated May 3, 2002, you requested a one year leave of absence. I did not grant your request for a formal leave of absence at the time and asked that you make a private retreat under the direction of Abbot Matthew Leavy, OSB, to clarify and discern with and before God your reasons for this request. Notwithstanding what I noted above, your recent decisions to use the media and to retain a civil attorney and to represent through him that you have been demoralized, demoted and manipulated is very disturbing to me. You continue to reorganize facts and, through what I can best characterize as reconstructed recollection, reshape everything that has happened to you in order to serve a purpose that I struggle to comprehend.

If you intend to permanently leave priestly ministry, I ask that you express this to me clearly in writing. The traditions of the Church and Canon Law have specific provisions in place to respond to such a request by a priest. If your intent is to step aside from active ministry and to examine your priestly life and ministry, I ask that you express this to me clearly in writing. Together we can revisit these matters and work out a plan that best suits your need to do so. Regardless of which you choose, I will do all I can to support you through the provision of pastoral support, spiritual and psychological counseling and sustenance in conformity with our diocesan policies and the law of the Church.

St. Patrick Parish, Jaffrey

As you know, I have assigned Fr. Roland Cote as pastor of St. Patrick Parish in Jaffrey. I remain concerned about the well being of the people of the parish, and I urge you to respect them and allow them to begin to heal from the experience that they have had these last few months. I reiterate again my request that you relocate your residence to a location away from Jaffrey immediately so that the people of the parish can move on with their life as a community of the Lord.

Dear Friends,

I am mindful that Fr. MacCormack's request to leave active ministry and my acceptance of his resignation as pastor have been the source of upset and concern for many of you. I must say from the onset that I am uncomfortable writing about the personal decision of a priest to request a leave from active ministry and the discussions he and I had on this matter. However, because of the unrest that this has occasioned in your parish, I feel it necessary to attempt to clarify the situation to better help you understand the situation and, also, to enable you to welcome and support your new pastor.

After receiving several letters and calls of concern regarding pastoral matters and communications that Fr. MacCormack had with some parishioners, I asked a member of my staff to meet with him. In doing so, it was my objective to provide Fr. MacCormack an opportunity to respond to the concerns that were raised and to learn what effect these were having on him personally. In that meeting, Fr. MacCormack himself suggested that a medical evaluation would be helpful to him and to me, in order to assure us both that we address his health in an informed manner.

Fr. MacCormack and I met on two other occasions and spoke on the telephone about the options he had, based on his request for a leave. My ultimate decision was that he take residence at a rectory in Manchester plus an extended vacation during the summer and that we meet again in September to discuss his future plans.

There is nothing more difficult for me as bishop than to see a priest in need of support and care and to find that I am not able to help him as much as I would like. I am deeply sorry that part of his understanding about these matters, matters that are normally handled in a personal and confidential manner, were made public and, as a result, have been upsetting and confusing to many of you

I ask that you join me in praying for Fr. MacCormack. God has given him many fine gifts that have served you well. As a result of his resignation as your pastor, I have begun the process of assigning a new pastor for St. Patrick Parish. Until then, I have asked Fr. Thomas Coover to provide pastoral and sacramental ministry for you.

Please be assured that I pray for you, for Fr. MacCormack and for the bond we share as members of the Church. There is no question that all of us have been affected and disturbed by these recent events. It is my prayer that God's peace and presence abide in your minds and hearts.

Dear Father MacCormack,

After a great deal of consideration of the matters, which you presented to me in your letter of May 3, 2002, I accept your resignation as pastor of Saint Patrick Parish in Jaffrey, NH, effective May 24, 2002. It is clear to me that the issues which you raise support your sense that they are serious and it is necessary for you to remove yourself from active ministry.

It is my hope that you and I can work on the future of your life as a priest together in dialogue. My request is that you make arrangements for a retreat with Abbot Matthew Leavy, OSB as soon as possible. I am sure that you will find it helpful in discerning the issues that concern you. I am mindful too that you feel alone and hurt by the process in which the issues raised by some of your parishioners have been addressed. Hopefully the retreat will be helpful in these matters too.

After your retreat, I am willing to reconsider your taking a leave of absence. As I understand the issues, that you face as a priest, they are best addressed in an environment where you can count on the active presence and support of other priests. If the plan for you to address your personal issues allows for it, I am willing to assign you to some pastoral work, as long as it does not interfere with your personal efforts.

This weekend, I want you to speak to the people of your parish about this matter and to share with them that this will be your last weekend serving them. I ask that you explain to them that there has been a misunderstanding between you and me and that you have miscommunicated the substance and spirit of our conversations. I also ask that you inform the people that you are sorry for this miscommunication, for any upset that this has caused them and that you are resolved to clarify these issues with me so that what is hurt can be healed. Finally, please inform the people of the parish that it was you who requested to leave active ministry as their pastor and that I accepted your resignation as pastor. Please reassure the people of Saint Patrick Parish that I will do all that I can to achieve what is best for you and for them as a parish.

Seamus, I am aware that you are hurt by all of this, but I am also very concerned that an entire parish community is now in pain. Although we both know that some people have been


hurt by some of your choices and actions, many parishioners have expressed to me their deep gratitude for your devoted ministry during these past years. I am grateful too.

St. Patrick's Parish
Pastoral Council Meeting
Discussion Topics
October 7, 1993

The primary purpose of this part of tonight's meeting will be to discuss the overall status of St. Patrick's Parish, the role and effectivity of the Pastor, the role and effectivity of the Pastoral Council, and the role and general acceptability of the laity in the life of this parish.

We have the potential for a very active and faith motivated Parish community but many of us see it developing a very serious malaise. We have had several previously very active families leave this Parish recently, several others have expressed their thoughts about doing the same but have not as yet done so, and numerous others have stated that they do not feel "nourished" or motivated by this Parish. Several people have confided that they are seriously considering returning to their prior Protestant denomination to meet their needs, or they are considering quitting "Church" participation altogether.

These are very difficult situations for the individuals, and of course frustrating, and frightening, from the Parish standpoint as well. These people present a very real message that this body had better pay attention to and get about the real purpose of helping to build a Parish that lives up to our vision statement, and meets peoples needs.

If we, as Parish leadership, can get serious about these issues, and the perceptions listed below, and begin to implement the remedial programs that we have discussed "ad nauseam" in previous meetings, then this will be a Council that is exciting and worth being a part of, and worthy of our investments of time, talent, and spirit. If, however, we can not achieve a mandate, and support, to develop positive programs that, with the peoples help can be designed to make people feel welcome and spiritually and emotionally fulfilled then we should all stop wasting our time and abandon the concept of a Pastoral Council.

What we truly need has to come from you Father Kelley. You have to break out of your restrictive, secretive, and protective mold and empower lay people to help this Parish. This Council, and those we bring in to assist with specific programs can make your life much easier if you just allow it, and also, I believe make this Parish better as a result. Being a single Priest in a Parish is a very tough job, no one can expect you to do it all alone. That is why the Church has developed the idea of lay involvement. We need to have it happen here.

Attached is a brief list of concerns that have been expressed by various members of the Parish community relative to their deep concerns about where St. Patrick's is heading.

On behalf of the Council, and the Parish,

People are leaving the Parish, as evidenced by the results of some of the census replies, (up to one-third of the respondents in several groups have left the Parish or the Catholic Church altogether).

People are calling expressing their concerns about;

- uninspiring liturgies
- demeaning and/or boring sermons
- lack of a welcoming spirit ("a dead Parish")

"The Pastor is gone too often, he's never here..."

"Month's mind mass canceled without notice...."

"I have worked in Religious Ed for x years and Fr. Kelley doesn't even know my name."

"The Parish is without direction, or purpose..."

"Father Kelley asks us to come to him with our problems or concerns, but if you are a woman you might as well forget about it, he may give you lip service but he will ignore you, or your concern..."

"We spend a lot of time in the school but about the only time we see Fr. Kelley is at lunch, or at programs, he's hardly ever there for teaching."

"I feel down after mass at St. Patrick's, the lack of spirit, the lack of welcoming, the demoralizing sermons,...."

"We moved here recently, from a very active Parish, and my husband absolutely refuses to attend Mass at St. Patrick's, as a matter of fact he dislikes it so much that he often times misses Mass altogether..."

"We never know what is going on with Parish finances, we have reduced our contributions greatly..."

"We have been in the parish for a number of years now and I can't remember the last time Father used the word "sin" in an instructional manner."

"If you're not one of Fr.'s favorites, forget about being selected for any ministry"

There are other quotes that could be listed but the purpose is to present to you Father, a sampling of the concerns that are running through the minds of many Parishioners, and in fact through the minds of many of the Pastoral Council members as well. The purpose of presenting these concerns is to shock you into the reality that this Parish needs significant rebuilding, and that many people are deeply concerned about whether or not it can, or will ever happen. The Parish is comprised of so many wonderful people who deserve more than they are getting, but ho are also very willing to help to make it right. However they see your attitude and your suarded nature as standing in the way. You have to change, and you have to empower the people to help. They want to help, they need to help, and they are willing, those who are left.

Seamus: Meeting Notes 5/3/02 w/Bishop Machmach

11:00 a.m. Meeting with Bishop MacCormack and Father Seamus MacCormack

Questions and concerns that Father Seamus has about the situation he is in

What was the complaint in full?

What was said and who made complaints?

Need to see all the paperwork

Many questions unanswered

Why was the Dean not informed of allegations and a simple process followed?

Is my understanding that the Dean would be informed by the Bishop and/or Chancellor of said reports and then Dean would meet with said Priest. After interviewing the Priest the Dean would report back to Bishop and/or Chancellor with results.

Father Seamus met with Chancellor by passing the Dean and it was determined at that time that Father Seamus should seek full psychological evaluation.

Father Seamus suggested his innocence and volunteered to be tested and it was said that this would look good for Father Seamus. My impressions after my meeting with Father Arsenault that the psychological testing was already put in place prior to my meeting.

From the time of the allegation to post psychological evaluation why was their no Pastoral care for Father Seamus.

Why was their no phone call if these allegations were serious at anytime offering support? No visitation from the Diocese to Father Seamus, no assistance for possibly taken a weekend off.

Pastoral Care:

More attention was placed on individuals who made the allegations

I felt as though I was already judged guilty and had to strive to prove my innocence.

I have informed the Pastoral Council as of all allegations.

I never went beyond the Pastoral Council.

I have never starting a writing campaign nor have said anything from the pulpit

Pastoral Council was promised a visitation and discussion with the Chancellor Father Arsenault after Father Seamus's evaluation. Father Arsenault cancelled any visitations with the Pastoral Council.

If there was a problem why did not the Finance/Pastoral Council see a problem with me earlier on?

The Pastoral Council suggested to me upon arriving on June of 00 to be aware of the Bishop's cousin running the Parish and the secretary doing whatever she wanted.

Does anyone have a clue that these people ran the church prior to the Parish? It is obvious that there is a power struggle, clear and simple. The Pastor came in to gain control of Parish operations and liturgical ministries. My being the Pastor I hold people accountable as well as I am held accountable for my actions.

My Thoughts:

This situation is very upsetting to me.

This has been causing stress, physical and spiritual stress.

I feel let down and disappointed on the accusations of a few people that have caused such great attention from the Diocese.

I feel as though my ministry is less effective now as a result of this situation.

I feel humiliated and marked as a troublemaker.

The serious lack of Pastoral care causing me great concern.

Dear Brad:

To confirm our discussion of Tuesday, our client does not wish to speak with Bishop McCormack. In addition, he requests that Bishop McCormack not disturb his parents.

Let me describe this case for you one last time.

Seamus MacCormack was systematically persecuted and punished by the Diocese because he was a potential whistle-blower. He was not in the inner sex circle which was known and sanctioned by high-ranking Diocese officials. He was not a participant, but he knew too much as a result of having been directed to a dead priest's rectory apartment, where he witnessed a systematic clean-up, the purpose of which was to remove evidence of a deviant sexual lifestyle. The contents of the residence were so extensive that they could have filled a pornography shop: an array of leather garments in various sizes, sadomasochistic sexual devices, (including the kind found by the coroner on the dead priest) a number of wigs and disguises, pornographic magazines, videotapes both commercial and homemade, sex enhancing drugs, and items of child pornography. The assemblage was shockingly extensive and obviously not solely for personal use.

Deeply troubled by this lurid scene, Seamus had to sit down and gasp for breath. He took little comfort from the comment of a senior Diocese official who, while busily packing up the materials, assured him "We've done this lots of times."

According to the witnesses and certain documents, the entire collection was taken to a church-controlled site in Concord and destroyed. Everything, that is, except the computer.

These events led directly to the destruction of Seamus' career at the hands of the Diocese.

As a parish priest, as your records will show, Seamus devoted himself to the task of renovating the parish and inspiring his parishioners. A self-described workaholic, he created an unprecedented enthusiasm among those who had been spiritually starved for years. Immensely popular in the community, Seamus worked tirelessly to unite, to lead, and to breathe new life into a disenfranchised constituency. All seemed well until the nightmare began.

An ineffective secretary, recommended for replacement by the parish counsel, sought support from a few malcontents. Under Bishop McCormack's orchestration, what should have been a minor personnel issue inflated into the full-scale agenda to discredit Seamus, or, if necessary, to destroy his career. Ludicrous complaints were brought to the Bishop, who used them to justify, of all things, a psychological evaluation. Seamus went along with it, hoping his cooperation would stop the proliferation of absurdities, including the Diocese' heads-up to the evaluator that Seamus had become paranoid and did not have "any prudent sense of with whom to share confidences." Neither of these concerns was borne out in Seamus' evaluation.

Then, in a newspaper interview, Seamus made the observation that the church was spending more effort protecting pedophile priests than helping good ones. The Bishop responded immediately.

Ignoring the pleas of dozens of parishioners, the Bishop determined to demote and transfer Seamus. In writing, he ordered my client to tell his parish that he had lied to them, and to apologize for lying to them. Most humiliatingly, Bishop McCormack directed Seamus to tell the parish that he had requested to leave the parish and that McCormack had accepted a "resignation." To follow the Bishop's directive would be Seamus' ultimate degradation, inferring that his entire priesthood had been a sham. Seamus was acutely concerned that, given the current church crisis, parishioners might leap to their own conclusions. The Bishop attempted to extort from Seamus a public confession that he was a liar, a man not worthy of belief. The purpose of this tactic was lost on Seamus at the time. It is not lost him now.

My client's calling and his profession have been destroyed in what I can only describe as a cover-up of a cover-up.

It is the responsibility of the Diocese to repair the damage which it has inflicted upon this man whom Bishop McCormack himself describes as gifted.

We are making the following proposal in full settlement of all claims:

- 1. The Diocese provides the sum of \$30,000 for Seamus' re-education in a field he has selected.
- 2. His remuneration of \$1,000 per month, and benefits, continue for two years from July 1, 2002.
- 3. His car lease payment contribution and allowances continue for the same period.
- 4. He receive rental and relocation allowance of \$1,000 per month for one year.
- 5. His seminary student loans are forgiven in full, approximately \$56,000.
- 6. He is compensated for his loss of profession and calling, for the infliction of emotional distress and for his defamation and humiliation in the amount of \$200,000.

The total cost of this settlement is \$327,000.

We are not interested in Bishop McCormick's maneuverings, his attempts to influence this matter, or his efforts to color the testimony of potential witnesses – all of which I have confirmed.

Moreover, we can dispense with pious discussions about "healing". The audacious use of terms such as "shakedown" and "blackmail" tells me that church officials are conscious of their culpability, and, that where Seamus MacCormack is concerned, healing is the last thing on their minds.

Our offer expires at close of business Monday.

Having heard nothing from you since our discussion early last week I presume the diocese is just buying time. I hope that is not the case because there isn't any time.

Following the catastophe which the diocese inflicted upon his life, Seamus now must rebuild again from the beginning. Each day puts him further behind in this process. Each day costs him opportunities which he could capture, but which the diocese's unwillingness to step up and accept responsibility prevents.

"Honest self-revelation, which can be painful to do, is required not only of individuals but the church as well. At times, certain events compel the church to face evil within itself." John B. McCormack, February 1, 2002.

I do not ask that Bishop McCormack follow his own wisdom in this case. I don't care whether he faces the evil in the church or not. I simply demand that he and others involved in the systematic destruction of Seamus MacCormack's life, profession and calling repair the damage which they intentionally inflicted upon him. Seamus did not ask to be pulled into the darkest side of the church. He did not ask to witness an expertly executed, routine, sanctioned cover-up, and he did not deserve to be the victim of organized retaliation orchestrated at the highest levels of the diocese.

I read that the conference of U.S. bishops takes place in Dallas later this week. We must have this matter satisfactorily concluded before Bishop McCormick departs for Dallas.



This letter is being written in response to some of the allegations being made against Father Seamus MacCormack at St. Patrick Parish in Jaffrey.

I am not a parishioner of Saint Patrick's parish, however, I have had the pleasure of working with Father Seamus for the past 13 months, as the bookkeeper/accountant. Consequently, I feel that I am in a unique position to speak, and hopefully bring clarity to the situation at St. Patrick's.

First, I want to state that Father Seamus did not ask me to write to you, and since I will no longer be employed by the Parish after the month of April, I have nothing to gain by writing this letter. I do so simply because it is the right thing to do. Second, I would like to state that although I am aware that members of the Parish have tried to organize a rally behind Father, I have not been a part of it. The reason for this is that as an employee of the Parish and Diocese I felt it would be inappropriate due to confidentiality issues.

In my opinion, Father Seamus has done his very best for Saint Patrick Parish. He deserves the support of his parish, and the support of the Diocese.

I believe that in this time of scandal in the Church, where all priests are suspect simply because of the collar they wear, it is imperative that people speak up for all the good and kind priests who serve us all. Father Seamus MacCormack is one of those priests and I have been honored to work with him.





Dear Bishop MacCormack:

I am writing to express my enormous disappointment in your decision to remove Pastor Seamus MacCormack from St. Patrick's Parish in Jaffrey. I have been a parishioner of St. Patrick's since I was a baby and, despite my recent move to Peterborough, continue to attend St. Patrick's Church. I, like the majority of the Parish, am devastated by the news that Father Seamus will be removed from our Parish. At no time did you or anyone from the Diocese consult the people of St. Patrick's Parish to find out what we want. If you had, you would have found that St. Patrick's Parish loves, trusts and respects Father Seamus. has brought more to our Parish in his short time here than other priests and pastors have contributed in ach longer stays. Statistically, attendance at the Masses has soared since Father Seamus arrived at St. Patrick's Church and the monies contributed to the Parish have increased dramatically as well. But more importantly, Father Seamus has been responsible for bringing many people back to the Church, especially younger people, like myself, who have had our share of disillusionments with our religion and the Catholic Church. I wrote to you in February regarding our Pastor, Father Seamus MacCormack at St. Patrick's Church in Jaffrey, N.H. I explained to you how he helped my family when my brother Jack Dupre was killed. We didn't know who to turn to, but, because of our faith in the Catholic religion and Fr. Seamus MacCormack's unrelenting support we overcame obstacles that no one should have to endure.

Jack's death was caused by the hands of 5 young men from this town and 4 of whom were parshoners of St. Patrick's Church. Fr. Seamus also helped their families go through the difficult times as 3 of their sons went off to prison.

I can honestly tell you that our family would not have survived this crisis without Fr. Seamus's help. I know there is no one that could fill his shoes. I also know no one in the diocese helped him, help us.



Most Rev. McCormack,

My husband has been a lifelong resident of Jaffrey, and I came to town almost 40 years ago when we were married. I have seen many changes in St. Patrick's parish; such as when the entire community saved the school when it was near closing it doors, to the fund raising campaign to renovate the church, all of which we proudly participated. But the biggest impact I have seen in our parish was the arrival of Father Seamus MacCormack. Our parish seemed dormant for many years and Father Seamus' presence has revitalized not only the parish but also the entire community.

My husband is an usher, and on Saturday evenings we always arrive early and sit in the same pew. When my daughters and their families would attend the Saturday service they usually were guaranteed a seat in the same pew in which I was sitting. Since Father Seamus has come to our parish, the masses have grown such in attendance that my daughters have learned that if they want to sit with me they need to arrive early. There is no such thing anymore as choice seating. And this is a good thing. Our packed church now has an atmosphere of warmth, love and spirit, which was long overdue. Not only is it amazing to see the increased attendance of youth at masses but I cannot believe the amount of elderly people in attendance, most of whom I did not realize belonged to our parish.

When my mother in law, Germain Blair, became afflicted with alsymers, we were no longer able to care for her and applied to Good Shepherd Nursing Home. We were confident she would be admitted, as she was a lifelong member of the Parish and Town. All the feedback was positive until they came to interview her in her home. She was denied admission, and we were devastated and didn't know where to turn. We turned to Father Seamus and it took several months, but she was finally admitted and last May, she died with dignity.

It has been brought to our attention that some negative feedback has come to your office regarding Father Seamus and I feel the need to voice my opinion. For too long, a handful of parishioners have been so called "running the parish". We had no real direction. When Father Seamus came, it was like a breath of fresh air to have someone who was willing to take command, give directives, and enforce some guidelines. As these changes came about, we witnessed so many people coming forth with the desire to serve on committees or just plain help out with projects. Our church is alive again and we need to keep it that way. The respect he has earned from non-Catholics in the community was reflected at the Ecumenical service he held for the 9-11 victims. There was standing room only – every church and civic organization in the community was represented.

We get a warm feeling about our parish when we drive by and see lights on in the rectory and know that someone is there, or when we drive by and see our pastor in jeans with a shovel in his hands. The Lord knew what he was doing when he placed Father Seamus in St Patrick's parish in Jaffrey. He is certainly an answer to our prayers.

I hope my petition for Father Seamus has shed a small ray of light on the self-sacrificing and dedicated work he is doing at St. Patrick's. Thank you for allowing me to express my concerns.




