Dear Msgr. Tom,

Your letter of March 29th. came as a welcomed and pleasant piece of good news; it is encouraging to know that in the wake of personal destruction there are still fragments of good to be gathered upon which one can rebuild.

Aside from my personal opinion, I can confidently say that the owner of the Village Inn Pancake House, Mr. Ben Bronstein, has placed complete trust in my integrity and confidence in my ability to manage his operation satisfactorily. He has made it known to me that in the event I did not return to the priesthood, I could continue my position on his executive staff with the possibility of having my own restaurant in the future. I have managed my staff, which includes about six cooks, between ten and fifteen waitresses and hostesses plus a dozen or more bus boys, with due caution and have always kept in mind and practiced the relationship necessary for proper management. Dr. Brown has been very helpful in assisting me in the management of my personal problem in relation to life in general.

During the last two years I have developed a new skill and technique in the managerial and administrative world. I believe that Dr. Brown referred to this in his letter to His Excellency and suggested that this newly acquired ability could be put to work for the good of the Church in some area.

With Dr. Browns full knowledge and collaboration, in a couple instances, I have worked with the State Probation Office and several prominent attorneys for the betterment of three young delinquents. I have also been active in such civic groups as the Albuquerque West Side Association and the Southwest Optimist Club by representing the restaurant. Which all adds up to the fact that I have put forth a good public image and carried civic responsibilities.

So where do we go from here? First of all, I feel deeply obligated to Mr. Bronstein to work out the summer as we are now starting the tourist season and a new man is not equipped to handle this but must be trained over a period of time. Secondly, I would like to finish the year that I have started with Dr. Brown as I have implicit confidence in his ability. Thirdly, I have started a program of dental work with Dr. Garber and it won't be completed til July sometime. and lastly, I am taking a therapy course to strengthen the muscles in my back to give me more support around the area of the fusion I underwent.

If possible, however, I would like to know if I could have the privilege of saying Mass "intra muros" during the summer at some convent or monastery. In this way I could be preparing for an active ministry and giving myself the spiritual good of the Mass. Dr. Brown concurs with this request and considers it of value in the re-establishment of the priestly image within myself and recommends it 100%. I realize that this request for continuance of work throughout the summer and the privilege of the Mass is subject to the decision of His Excellency and therefore present this to you as a possibility, keeping in mind that the Bishop has the final word. If such should be the pleasure of the Bishop, I would appreciate it if you would make the Archbishop of Santa Fe aware of it.

As for the place, I would like to know exactly how far from New Hampshire I would have to be stationed. My folks are along in years now and we would both like to see each other more often than onace a year, if possible. Once again I realize that this is a decision for the Bishop to make and I will gratefully acquiesce to whatever he deems prudent and necessary.

Outside of this, Tom, I guess that I have not much else to say at this time except once more express my deep gratitude for all that you and the Bishop have done for me. Regards to all there at the Chancery and any others who might venture to ask for or about me.

Dear Msgr. Tom:

I don't know where the time has gone since I received your letter last July but I sure have been remiss for not answering sooner. My plans at present are to come to New Hampshire for a couple weeks the end of this month. On the way I intend to make a contact or two to see just what the climate is with other Bishops. Your letter seems to indicate that it would be difficult to place me - that most Bishops wouldn't want to take on an added burden or risk, or whatever they might call it. This is understandable in the light of my past performance in the priesthood, but I do think that the past three years do have something to say on the matter.

Dr. Brown and I have discussed the crossroads of the oresent situation - a subject matter I would like to talk over with you and the Bishoo when in New Hampshire. Being an employer with the responsibilities of a business I know what it means to hire people who either bring their problems to work with them or become a problem themselves. I can now see that it was this very thing that I did to the Bishops of Manchester. I sincerely want to do what is best for the Church and for myself and believe me the decision is not as simple and easy as one might imagine. The problem at hand is not so Imuch my past deviations as the bankrupted position that I must hold in the mind of the Church. I have been successful the past three years through my own initiative and hard work and I don't want to close a door on this if there is no longer any door open to an opportunity in the Church. I am sure that you can appreciate my dilemma.

At present he is working as a layman (with the Bishop's approval) in Albuquerque, New Mexico. He is anxious to get started with whomever we suggest, so we write to ask whether you know a competent man in that area who might be able to help him.

I might say that at one time while at Via Coeli, Jemez Springs, N. M. Father Osgood was seen weekly by Doctor Thomas S. Evilsizer, Jr., M. D. who was apparently the staff psychiatrist at that institution. His address is 2000 Gold Ave., S. E., Albuquerque, N. H. I shall enclose a copy of the only letter we ever received from Doctor Evilsizer. I feel from this report that the doctor was not aware of the problem or that he was very much deceived by Father Osgood in his talks with him. In later correspondence, Father Osgood indicated that he was not satisfied with the doctor. I mention this just in case you may have Doctor Evilsizer in mind as a possible contact.

The Bishop is presently in Rome but he directed me to write to you during his absence so that there would be no unreasonable delay in this project. I am sorry to say that I am behind schedule in contacting you because of a flood of other problems.



Since receipt of your last letter, we have been trying to work out an arrangement for you in keeping with the changes which you and Doctor Gibson have been able to accomplish. Due to many factors, there has been a long delay in writing to you for which I apologize.

Bishop Primeau has been in touch with the Psychiatrist in Chief of the Institute for Living (rather, The Institute of Living) in Hartford and he has made the following proposal:

- 1) The Institute would be pleased to receive you for a month for evaluation. This would be quite expensive.
- 2) The alternate would be to have you live at a rectory in Hartford and visit the Clinic as a regular private out-patient.

The Bishop is quite willing to do either of these things but he and I feel that you would probably prefer the second arrangement. Will you please let us know whether you are interested and, if you are, which set-up you would prefer? We shall take care of the details.

We realize that you cannot pull up stakes immediately because of your job but I am sure you would like to take care of things as soon as possible. We shall be interested in hearing from you soon.

As I understand the above proposal, you would be expected to take some psychological tests and a clinical evaluation upon which a confidential report would be given to the Bishop. From this report, he would be able to judge the effectiveness of Doctor Gibson's treatments and your ability to go back to work.


