- 1 professional counselor, psychologists psychiatrists were
- 2 capable of helping these people.
- 3 Q. In Dr. Morris' report he refers to something about
- 4 having Father O'Grady getting involved in some kind of
- 5 tasks?
- 6 A. Yes.
- 7 O. Was that independent of working in parish?
- 8 A. It was -- what he refers to is that I urge that you
- 9 assign him to the task in a diocese by which he can develop
- 10 a more healthy relationship with authority.
- 11 So actually that was something according to his
- evaluation he felt that Father O'Grady did not relate well
- to authority from his childhood days. And whatever that
- was, whatever he was recommending, to find some way to help
- him relate more honestly and honestly with people of
- 16 authority.
- 17 Q. But he was -- and Dr. Morris realized that when he
- suggested he be assigned a task, that he would also be with
- 19 a parish?
- 20 A. Oh, yes. He made no suggestion he be removed from the
- 21 parish to do something else, no.
- Q. Was -- during a period of time you were the bishop of
- 23 Stockton, were there any other priests that were involved in
- 24 any kind of sexual misconduct with children?
- MR. DRIVON: Your Honor, that calls for
- 26 speculation.
- THE COURT: If the witness has personal
- 28 knowledge, he can answer.

- 21 A. Well, I was installed as the archbishop of Los Angeles
- 22 September 5th, 1985, where I've served ever since and became
- a member of the College of Cardinals in June 1991.
- 24 O. How many Cardinals are there in the United States?
- 25 A. Presently there are eight active Cardinals.
- Q. After Father O'Grady was transferred to Saint Andrew's,
- 27 did you keep in contact with him?
- 28 A. No. Other than that correspondence, one letter in
