




Dear Mr. Anderson:

Last week we provided to you (through Jessica Arbour) a complete set of the produced documents related to Rev. Daniel J. McCormack, comprising about 2,000 pages. The produced documents did not include McCormack's "seminary" files; as you know, we have routinely withheld seminary files with respect to all priests on the basis that they are educational records protected by statute. The seminary files for any priest may include materials from St. Mary of the Lake Seminary ("CB2"-labeled documents), Niles College/St. Joseph Seminary (CB8) and Quigley Preparatory Seminary (CB10).

In reviewing the McCormack files, we realized that we have "declassified" some documents in the McCormack CB8 file relating to McCormack's employment as an adult at St. Joseph seminary, since these are not educational records. These documents are enclosed with this letter; they comprise about 80 pages. They should be considered to be produced, as a supplement to the previous McCormack production, pursuant to the terms of the Mediation Agreement.

We apologize for this late notice. If you need any further explanation of the documents or our standards for production, please do not hesitate to call me.

Over the past months we have begun production of documents pursuant to the Mediation Agreement dated September 29, 2006, relating to certain priests of the Archdiocese of Chicago. Those priests with respect to whom at least some files have been produced are listed on the attached table, along with data explained below.


As discussed in earlier correspondence and with your representatives at the times of production, priest-related documents originate at several distinct locations within the Archdiocese, including Archdiocesan archives for priests who are long deceased or departed; In general, the source location of each document is shown in the document identification code assigned to each document. We have received the files from those locations over a necessarily extended period of time. Additional materials have (in the ordinary course of business) been added to those files over time.

In the interest of full disclosure at this point in time, we wish to make available to you additional documents that have accrued in the files that we have produced, since our initial receipt of those files from the Archdiocese. The sources of these documents are indicated on the attached table; as you can see, they aggregate about 200 pages.
