I am writing because I was sexually molested by Father Todd Brown when I was twelve years old in 1965. This took place on at least one occasion at the church during catechism. I have been in psychological counseling for several years related to childhood sexual abuse issues and have only recently come to the realization that the abuse perpetrated on me by Father Brown was not a fantasy, but a detailed memory.

For most of my life I have been vehemently opposed to any sort of organized Christian religion and I have only recently realized why I despised the church so strongly. I believe I have a casual relationship with God, but still have no place in my heart for the church.

I request that you investigate the possibility that Father Brown is still perpetrating himself on children under the guise of trust as a priest. If he has not already been stopped, please do so now so that innocent children will be spared the adverse affects on their character, the loss of their self-esteem, and the loss of their faith in God.

Your cooperation and prompt attention to this matter is genuinely appreciated.

Dear Mr. Hicks:

I am writing in response to your letter dated July 3, 1997, which I received when I came to my office on July 9th.

The Diocese has a policy regarding the receiving of an allegation of sexual abuse, of initiating immediately an investigation into the allegation to determine how to proceed. The first step of such an investigation is to interview the person making the allegation in order to determine the exact nature of the allegation.

The most qualified person to interview you is a trained person in these issues. I have asked Dr. Kevin McCready, a psychologist located in Clovis to do this on my behalf. I would ask you to please call him to set an appointment as early as possible, so that this matter may be addressed promptly. His office and phone number are: 3114 Willow Avenue, Clovis, 292-7572.

In response to your concern expressed at the end of your letter, I would mention that the priest in question has been ordained 34 years, has led an exemplary life, and has never had any such allegation against him in all those years.
