**CREDIBLE ACCUSATION OF ABUSE:** The Diocese of Duluth announces that a retired diocesan priest, Father Cornelius Kelleher, has recently been credibly accused in the sexual abuse of a minor female during his time as pastor of St. Joseph's Church in Chisholm from 1975 to 1986. When the accusation was made, Father Kelleher was immediately removed from any public ministry and is no longer able to function as a priest in his retirement. He retired July 11, 2012. - 1) Contact civil authorities
- 2) Contact the Diocese
- 3) Contact a Diocesan Assistance Coordinator

#### We are open to and respect your complaint.

While diocesan representatives are open to receiving your complaint, you may feel more comfortable contacting civil authorities first. Both justice and compassion, however, call us as diocesan officials to respond to the harm you or someone you know has experienced from a person in a position of trust. We sincerely want to listen and address the hurt that may have occurred because of the improper exercise of pastoral care.

Please know your complaint will be heard in confidence and only those who have a right to know will be informed. Even if civil authorities are involved, your complaint may go before the Diocesan Review Board in accord with our Sexual Misconduct Policy and Code of Pastoral Conduct.

#### Clergy with credible claims against them concerning sexual abuse of a young person

As part of the Diocese of Duluth's ongoing efforts to foster safe environments for children and young people, Bishop Paul D. Sirba released on December 31, 2013 information about clergy members who have been credibly accused of sexual abuse of young persons while serving or residing in the Duluth Diocese. Included in the release are clergy members who served as diocesan priests as well as clergy from other dioceses or religious orders who at one time worked or resided in the Duluth Diocese.

Despite our best efforts to make sure our information is accurate and complete, we know that it may include errors or be incomplete. We ask that anyone who believes they have information about any instance of child sexual abuse involving any member of the clergy to contact their local law enforcement and the diocese or a diocesan assistance coordinator. Contact information for the diocese and its coordinators is listed in the diocesan newspaper and on the diocesan website.

The list below includes those clergy members whose names were provided to the John Jay Study conducted in 2004, one diocesan priest against whom credible claims have been made subsequent to the compilation of the John Jay list and four non-diocesan clergy who worked or resided in the diocese and who are the subject of allegations made against other institutions. The names included in the John Jay Study have had credible accusations made against them which, for purposes of the study, was a standard defined to be "not implausible." An allegation was considered "implausible" only if it could not possibly have happened under the given circumstances.

#### 18. UN-NAMED ACCUSED PERSON NO LONGER IN MINISTRY

The name of a former priest was included in the list provided to the John Jay Study solely on the basis of a single vague and ambiguous allegation that did not identify the priest by name. A subsequent investigation did not produce any further information or corroboration. This individual voluntarily left the priesthood prior to and not related to the allegation. As a result, the diocese is re-investigating this matter but is not releasing the former priest's name at this time.

"As part of our ongoing efforts to address issues related to clergy sexual misconduct and to make our parishes, schools, religious education and youth programs the safest possible places for the children of our community, we are releasing information today related to priests who have been credibly accused of sexual abuse of minors in the diocese from 1950 to 2013.

"Much of this information is drawn from the John Jay Study, which was commissioned by the U.S. Conference of Catholic Bishops in 2004 to study the causes and context of clergy sexual abuse. It also includes information regarding five additional clergy members.

"The release of this information underscores a sad truth that must be acknowledged: Over the last 65 years, a number of clergy members in the Diocese of Duluth have violated the sacred trust placed in them by children, youth and their families. These clergy have caused terrible harm to victims, to the victims' families, to our community, to the Church and to the many, many good priests who faithfully carry out their duties to God's people with love and generosity. Again, I offer my apology on behalf of the Church to all those who have been affected by clergy sexual abuse. I pledge once more that this Church stands with all those who seek to know the truth and to see justice done in these matters.

"The names released today will be published on our diocesan website and in our diocesan newspaper, the *Northern Cross*, which goes to every Catholic household in the Diocese. Our hope in releasing the names is to bring hope and healing to victims of clergy sexual abuse. Jesus, Our Savior, brings hope where there is hurt.

"Since 1992, the Diocese of Duluth has had in place a sexual misconduct policy that has been conscientiously enforced. The United States bishops issued their Charter for the Protection of

Children and Young People in June 2002. The Diocese of Duluth is committed to upholding these principles, to assisting in the healing of any victim of sexual misconduct by a member of the clergy and to preventing this terrible crime from happening in the future.

"If anyone hearing my words today have suffered such abuse, I ask you to report it to your civil authorities and to the diocese. We are located at 2830 E. 4<sup>th</sup> Street, our phone number is (218) 724-9111. You can also contact one of our diocesan Assistance Coordinators whose contact information is available in The *Northern Cross*, and on the diocesan website, www.dioceseduluth.org.

## **Q&A** on the disclosure of names

- O. Will the names be posted online? If so, where?
- A. Yes. Information about clergy members who have credible claims of sexual abuse of a minor that have been substantiated will be posted on our website at www.dioceseduluth.org.
- Q. The diocese was reluctant to release this list. Why are you choosing to disclose the names of offending priests now?
- A. Appropriate disclosure is important if we are to do all that we can to keep children safe, help victims of abuse heal and maintain the trust and confidence of our communities. Most importantly, we believe these actions will further serve our primary goal of protecting minors. As the diocese reported a few weeks ago, the list many have sought was provided by the diocese to the John Jay Study in 2004 and used, for research purposes, to compile a nationwide summary of credible claims of clergy abuse of minors covering the time period of 1950 to 2002. It was not meant to be a definitive list and is an imperfect means for identifying those credibly accused. We have worked to try to name those credibly accused without harming those who may have been wrongly accused. In one case, the name of a former priest was included in the list provided to the John Jay Study solely on the basis of a single vague and ambiguous allegation that did not identify the priest by name. A subsequent investigation did not produce any further information or corroboration. This individual voluntarily left the priesthood prior to and not related to the allegation. As a result, the diocese is re-investigating this matter but is not releasing the former priest's name at this time.
- Q. Media reporting has suggested there were 17 names on the list, and the diocese has released 17 names but said one is not included. Where did the extra name come from?
- A. For reasons that are not entirely clear, the figure of 17 names on the list came into widespread use, but it was not correct. The list provided to the John Jay Commission had 18 priests.
- Q. Is this the extent of the disclosure of names? Is it possible more names could be added?
- A. The list is complete to the best of our knowledge, but we will amend and update it as necessary.
- Q. Are these priests being supported financially or in other ways by the diocese?
- A. All priests are legally entitled to receive pension benefits that have been accrued. Financial support varies depending on the individual circumstance. The diocese has an obligation in church law to ensure that no priest is left destitute. All of the living priests who have not been laicized are receiving their pension and retirement healthcare.
- Q. Have any of these men been permanently removed from the priesthood (laicized)?
- A. None of these men is in active ministry. Most of them are dead, and some have been laicized.
- Q. What is the threshold for removing a priest from active ministry?
- A. If the diocese receives a credible claim of sexual abuse of a minor, a priest is removed from active ministry. These restrictions stay in place until an investigation determines whether or not the claim is substantiated. If a claim is determined to be substantiated, he will remain restricted until any criminal or canonical proceedings are concluded.

- Q. What should a person do if he or she recognizes a name on the list and has concerns about further risks the man may pose?
- A. Any concerns or information should be directed to the proper civil authorities, such as the local police. In addition, we encourage anyone with such information to notify the diocese at (218) 724-9111 or to contact one of the assistance coordinators listed in the diocesan newspaper or on the diocesan website.
- Q. How much has the diocese paid to victims to settle civil claims related to clergy sexual abuse of minors? How have those settlements been funded?
- A. Relating to the allegations covered by the John Jay Study, the diocese has paid out approximately \$780,000 to victims, about \$738,000 in settlements and about \$42,000 in counseling. A significant amount of that was covered by our insurance carriers.
- Q. How many individuals have civil suits pending against the diocese regarding sexual abuse of a minor?
- A. Currently, there are two lawsuits involving two people alleging that they were sexually abused as a minor by a member of the clergy who, at one time, had an assignment within our diocese.

## What is the 'Charter for the Protection of Children and Young People'?

- Q. What is the "Charter for the Protection of Children and Young People"?
- A. The Charter is a comprehensive set of procedures established by the U.S. Conference of Catholic Bishops in June 2002 for addressing allegations of sexual abuse of minors by Catholic clergy. The Charter includes guidelines for reconciliation, healing, accountability and prevention of further acts of abuse. It directs action in all the following matters:
- \* Creating a safe environment for children and young people;
- \* Healing and reconciliation of victims and survivors;
- \* Making prompt and effective responses to allegations;
- \* Cooperating with civil authorities;
- \* Disciplining offenders; and
- \* Providing for means of accountability for the future to ensure the problem continues to be effectively dealt with through the Secretariat of Child and Youth Protection and the National Review Board.
- Q. Where can I read it?
- A. The Charter is available for download from the USCCB Secretariat of Child and Youth Protection website.
- Q. How does the Charter define a "minor"?
- A. In both civil and canon law, a minor is anyone under the age of 18. Until 1994, under canon law, a minor was considered any person under the age of 16. In 1994, canon law was changed for dioceses of the USCCB so that anyone under the age of 18 was considered to be a minor. In 2001, it changed for the universal Church. Also covered under the Charter is anyone over the age of 18 who habitually lacks the use of reason and therefore is considered equivalent to a minor.
- Q. What if the abuse occurred prior to the enactment of the Charter?
- A. Any act of sexual abuse of a minor which occurred prior to the Charter being implemented but is brought forward now will be considered relevant and subject to the Charter. The Charter pertains to acts of abuse in the past, present and future.
- Q. How is compliance with the Charter monitored?
- A. In June 2003, the Office (now Secretariat) of Child and Youth Protection began an audit process of all dioceses throughout the United States. The audit is used to determine if the diocese is implementing the practices required by the Charter. An "Annual Report on the Implementation of the Charter" is prepared by the Secretariat of Child and Youth Protection.

#### GLOSSARY OF TERMS

used in the John Jay Study

**Allegation:** Any credible accusation that is not *implausible* (see definition below). This should include allegations that did not result in a criminal, civil or diocesan investigation and allegations that are unsubstantiated

Clergy or Cleric: Any current or former, living or deceased, diocesan, clergy, religious Cardinal, Arch/Bishop/Eparch, Priest, Deacon or Seminarian. Religious orders include societies, congregations and male, clerical communities. This does not include lay people, brothers or nuns within the Church.

**Diocese:** For purposes of clarity and flow, when the term diocese is used in a question, it will be understood to refer to diocesan, eparchial and religious orders, societies and communities.

**False allegation:** an allegation that was proven to be untruthful and fabricated.

**Implausible:** Any allegation that could not possibly have happened under the given circumstances (e.g., an accusation is made against a priest who was deceased at the time of the alleged offense). Erroneous information does not necessarily make the allegation implausible (e.g., a priest arrived at the diocese a year after the alleged abuse, but all other facts of the case are credible and the alleged victim might have mistaken the date).

**Sexual abuse:** As per the Charter, sexual abuse includes contacts or interactions between a child and an adult when the child is being used as an object of sexual gratification for the adult. A child is abused whether or not this activity involves explicit force, whether or not it involves genital or physical contact, whether or not it is initiated by the child, and whether or not there is discernible harmful outcome
