3. This statement is based on my own personal knowledge.

4. I am the father of M-015 , Jr. and M-014

5. I am Catholic and was a parishioner at St. John Nepomucene.

6. I know the Rev. Raymond Pcolka who was a Catholic priest and was in charge of my sons as altar boys at St. John's.

7. During approx. 1979 -- 1982 I was told by my sons that they were sexually abused by Father Pcolka which abuse started when M-014 was fondled by Father Pcolka as he was being robed as an altar boy.

8. At the time my sons revealed this to me Father Pcolka as assigned to Holy Name Parish in Stratford. I told the pastor whom I believe was Father Patoniak and gave him my name so that he would know it was not an anonymous call.

I said, "You better watch out for Father Pcolka, this is what he did to my children. He abused them." I told him that I was going to go to the police about this. Father Patoniak said, "Do you know what you are saying, it's your children's word against an outstanding priest in

this parish," and he kept in effect threatening me that the story wasn't so. I then started to tell him over the phone the graphic details that M-014 had said to me and, at this point, he hung up. I called back immediately and the housekeeper answered and said if I called again F would be turned over to the police."

Q For the record, and again, I know, Mr. M-016 , this is difficult, but could you just, so we will have a complete record of this, would you be good enough to tell us what you recall you said to Father Petoniak in this particular telephone conversation and what Father Petoniak said to you?

10 Α After I started to tell him -- after I said 11 that the priest had molested the children, he said it was 12 outrageous and didn't want to hear anything more about it. And I said, well, listen, you are going to have to hear 13 more about it because this is what has happened, and I 14 15 intended to go further. He said, well, where the hell do 16 you think you are going to go with this? Do you think the 17 cops are going to believe you or the Catholic church? And at that point there he hung up on me. So I called back and 18 I got the housekeeper again. The housekeeper says if I 19 20 call there again they are going to have me arrested, and 21 she hung up on me.

At that point, is when I went to my father, as a matter of fact. I spoke to my father after I did that because that's when I got -- I thought my father being a trustee, I felt as though he might have some pull.

1. I am over the age of 18 years.

2. I believe in the obligations of an oath.

3. This affidavit is made on my own personal knowledge.

4. In approximately 1971 - 1973, I was a parishioner and altar boy at the St. John Nepomucene Church in Bridgeport, CT. At that time, Father Raymond Pcolka was stationed at that church and was in charge of the altar boys.

5. During that period of time, I was repeatedly sexually abused by Father Pcolka.

6. Subsequent to that period of abuse, sometime in the early 1980's, I wrote letters to the following places in order to report the fact that I was sexually abused by Father Raymond Pcolka when I was a child:

a) Bridgeport Catholic Diocese on Jewett Street in Bridgeport, addressed to either Bishop Curtis or Monsignor Cusack;

b) Greater Archbishop Counsel in Washington, D.C.

c) Father Tomasko at St. John Nepomucene Church.

7. I never received a response to any of my letters.

8. Sometime in 1986, I also wrote to the Pope in Vatican City, Italy regarding the fact that I was sexually abused by a Bridgeport Roman Catholic priest. I did not receive any response to this letter.
