After extensive prayer, sharing I have made three most serious decisions regarding my relationship to the church.

I believe that it is in the best interest of the church at large, and the Diocese of Suffalo specifically, as well as the best interests of Jim Spielman, that these three decisions be made. Therefore:

- As of this date, June 6, 1989, I, James A. Spielman, resign as Pastor of SS. Peter & Paul Church in Jamestown, New York.
- As of this date, June 6, 1989, I, James A. Spielman, surrender my priestly faculties in the Diocese of Buffalo or any other diocese.
- I respectfully request an indefinite leave of absence during which time I might reconsider my call to priesthood of the past 20 years.

I believe that it is important for me to express to you the depth of anger and betrayal I feel toward you personally. Never once did I minimize the seriousness of the issue, yet over and over again you lectured me about its seriousness. Your approach was cold, calculated and business-oriented a tremendous disappointment for me coming from a church I had given my life to since the age of 14. You were successful in demoralizing me and making me feel worthless, the example of the "tooth decay" and "getting it all" was particularly offensive and repulsive.

I was particularly leveled by your lack of hope or encouragement with no promise or safeguard of future assignment, there simply was no ability or willingness to trust.

As of today I am requesting that any and all communication that may be necessary between the diocese and myself be made through Bishop Trautman. I pray you honor this request,

In recent days you have no doubt received many letters and messages of support and affirmation. I hope you will read this letter in the same way namely, one of support and affirmation. I do write with the input and advice of Bishop Trautman. In accord with your wishes, Bishop Trautman will be my liaison to you.

With reference to your letter to me, may I say that I accept your resignation as Pastor of SS. Peter & Paul Parish, Jamestown, effective June 6, 1989. I know full well all you have done to build up this faith community. The results of your recent fund raising efforts to meet the crisis of the church repair is just one indication of the cooperation of your people in their esteem for you.

It is with sadness that I accept your surrendering of your priestly faculties. You have served God's people for nineteen years with dedication, enthusiasm and effectiveness. In accord with your request, I grant you a leave of absence from the active ministry. I ask that you work closely with Bishop Trautman in discovering-your future.

Your letter speaks candidly of the upsetment which my meeting with you caused. I never intended such distress for you. I apologize for any poor choices of words. I believe there was a misconception of my remarks to you. Nevertheless, your perception is what counts at this point and I simply want to reiterate that I welcome a meeting with you and Bishop Trautman to effect a healing. We will be happy to go and see you if you prefer not to come here.

I have confidence in you. You have humbly admitted that personal behavioral mistakes have been made.

St. Paul addresses these words to the Philippians: "I am confident that he who has begun the good work in you will bring it to fulfillment". With confidence in you and with support and affirmation for you, I address these words to you.

Twenty years ago this month I was ordained a deacon. In the years that followed I served the priesthood of Jesus with joy, enthusiasm and dedication on a road that led me through a number of parishes and a six year teaching career and ultimately brought me here to SS. Peter & Paul. WOW! I get tired just thinking about the years - and that's the problem.

I am totally and completely "burned out". I have given everything I had to give and my "well has gone dry".

I have therefore requested and received an indefinite leave of absence from all ministry. This was the hardest decision of my life but it was right - I feel so much better having made it.

My intention is to live at the farm in Scio and after a few months of rest to seek gainful employment in the area.

I know this news is difficult enough without getting it in a letter but emotionally I just couldn't do it any other way. I am eternally grateful to all of you for your tremendous support and encouragement which enabled us to do so much. The church building will stand as an ever-present reminder of the success of our cooperative efforts. Please help my successor by faithfully working down the debt and freeing the parish of this burden.

I realize I have robbed you of the chance to express your gratitude to me by sending this letter. Believe me, I know how grateful you are - my emotions would not have been able to handle this any other way.

Please know my prayers and hopes for each of you and please pray for me during this difficult transition.

Dear Family and Frienc ,

I have over the past 19 years communicated with you at this time of year via a Christmas card or letter. Lately it has been via a card, but the circumstances of this past year demand that I use the letter form once again Since there are so many of you, it must be a copied form - please excuse the impersonal nature and know that it is intended to be as personal as possible

It was a difficult year for me. It began as I completed the 1.4 million dollar renovation of SS. Peter & Paul Church in Jamestown. It is a beautiful building which clearly reflects the commitment and faith of the people of the parish. They really did an outstanding job.

However the building project, as well as 19 years of ministry, had left me drained. As spring approached these pressures, as well as some personal issues, weighed heavily upon me. I decided to take a leave of absence from ministry to get some professional direction and put my own house in order. So Badger and I moved to the farm in Scio at the beginning of June. The first two months was a "settling down" time. Even Badger - my trusted companion these last 11 years - needed time "away". Needless to say the hills of Allegany County are capable of great healing. In August I was offered a temporary job in the Mental Health Unit of Steuben County. I decided to take it since it was working with the elderly and I always find them rewarding. I worked at the job until early December and enjoyed it very much.

As the days of fall revealed the magnificent beauty of the leaves, I began to progress enough that my doctor and I agreed that it was time to look ahead. In spite of my frailties and failings I knew that I was still pries It was time to start thinking about returning to ministry. In subsequent meetings with Bishop Head, Bishop Trautman and my doctor it was agreed that I would go on a sabbatical experience this winter and return to ministry in the spring. I expect to be reassigned by Bishop Head in May.

This was a very difficult process but necessary that I might go on as priest in the service of t e Lord. Throughout these months I have been very grateful for all of you, my family and friends. Your support, expressed through Masses, prayers, novenas, notes, cards and phone calls, was very much appreciated. My faith is strong, my energy returning and my anticipation heightening as we celebrate Christmas - the birth of hope and love - and move into a new year and a new decade in the grace of God.

I will be celebrating Christmas Eve Mass at St. Joseph's in Scio, where I celebrated my first Christmas Mass 19 years ago. Know that I will remember all of your intentions in my Christmas Nass. Please keep me in your Masses and prayers these next few months.

Dear John & Members:

I am now beginning my 6th year of service to the people of Portageville and Canaseraga. These years are a combination of two separate terms of ministry. In between, I served a three year term at SS Peter & Paul in Jamestown.

In all my years as a pastor (8+) I have excelled in my responsibilities and have successfully strengthened the sense of community within the parish unit, resolved serious financial difficulties, strengthened education, religious and adult, and in the case of Jamestown, made great strides in the parochial school. In addition, major maintenance needs were met in all three parishes.

As our clergy shortage grows ever more serious, I have dedicated my efforts to empower the people to gradually but definitely assume responsibility for their parish and its well being. I have enjoyed and met the challenge both in Jamestown and the Portageville/Canaseraga assignments.

As you are well aware, in 1989 I resigned the Pastorate of SS Peter & Paul in Jamestown to deal with some personal issues that simply could not wait. After extensive work with a local psychologist and experiencing the Southdown wholistic program, I returned to ministry in 1990 and assumed the pastorate I currently hold at Portageville/Canaseraga. Over the last year, with the encouragement of the Ordinary, Bishop Head, 1 have applied for several assignments that would offer me dis appropriate challenge.

At this time I find myself confronting the profile of the very parish I left behind in 1989. My leaving Jamestown was for personal reasons that are now resolved, and was in no way connected to the parish. When I left I had a wonderful relationship with the people, which had resulted in greatly increased Mass attendance, a 1.8 million dollar drive to rebuild the church, a 30% increase in the enrollment of the parochial school and an extensive program of home visitation to the abnormally high number of confined senior citizens. 
