8 Q. Tell me about the first time you were abused
9 by Soens. Please describe what happened.
10 A. Well, what happened the first time was very
11 similar to what happened the second, third, and fourth,
12 and so on, times. But he would call me into his office.
13 And usually it had to do with some -- something to do
14 with either my family or -- because I had several
15 brothers at school, or some disciplinary situation, some
16 excuse to get me in his office.
17 And then he would sit me down and he would
18 sit down in a chair right adjacent to me, and just start
19 talking about the issues. And he would move slowly
20 towards me as he is talking. And he would position
21 himself, by the time he was done moving towards me,
22 where his leg was right in between my two legs, his knee
23 close to my genitals. And as he would talk, he would
24 move his hand down his leg to his knee, and then he
25 would grab on to my genitals.

1 And what he did with most of that was to grab
2 ahold of my penis and squeeze the end of it while he is
3 talking to me, look me right in the eye and be talking
4 to me, and he was squeezing my penis. And this is what
5 he did the whole time he was talking.
6 Q. Did every event of abuse with you take place
7 in his office at Regina High School?
8 A. Yeah, except for the squeezing of the
9 nipples, the pinching there, which was very painful. He
10 would do that anyplace. Hallways, bathrooms.

9 Q. Now, as far as the purpling, the squeezing of
10 the nipples, do you claim that that in any way was
11 sexual in nature?

12 A. What I connected to -- looking back on it, I
13 connect that to the holding of the genitals. I do
14 believe that Father Soens was getting a sexual
15 gratification out of doing that, or excitement.

16 Q. What do you base that on?

17 A. Because of the fact that he liked to induce
18 pain on other people.
