Tribunal: Ghost Writer for Fr. Chuck Taylor, 1st & 2nd Instance

Jefferson County Board of Health, Member of the Advisory Committee, Methadone Treatment Program, 2 year term. The Advisory Board consists of professionals from law enforcement, the medical profession, therapists, and correctional personnel in the city and county.

Alternate for Region VI to the Priest Council

Park Wood Medical Center: This is a large nursing home on Eastern Parkway. I am on-call for Sacrament of Sick and Liturgies. I am assisting Fr. Anthony Olges in whatever way I can there.

Marion Home: Assist Fr. Joe Merkt with liturgies and Sacramental needs for the infirmary. Also special services at the retirement home for the sisters throughout Lent.

Sisters of Charity of Nazareth, liturgies and coverage when needed.

Sponsees: I currently sponsor 19 recovering addicts, eleven of which are revisiting their Catholic faith. I am working with three priests who are in other diocese. I meet with these people on a bi-weekly basis and make myself available to them in a crisis situations any time. I also make quite a few hospital/treatment center visitations.

Ministry to AIDS/HIV patients: I currently have four people I give pastoral care to.

I assist the Passionists here at the Monastery with maintenance and other things as time allows. It keeps my

plumbing and electrical skills in tact.

12 Step Recovery Programs: I have started three recovery groups in the Louisville area. I also meet with newcomers before they go to their first meeting in order to answer questions and give pastoral care. These people who are working through denial are quite frightened. I usually average eight per month.

Consultant for therapists in the Region for addictions and referral person for 12 step groups. Work close with Dr. John Maloney, Certified Psychologist.

Co-presenter of Days of Recollection with Fr. Jim DeManuele, CP, for the 12 step recovering communities at the Monastery. It's our hope that the Monastery will become a spiritual resource for people in recovery.

Greater Louisville Council On Sexual Health & Addiction (GLCOSHA), Secretary for six years, Member of Board of Directors, Chairperson of Finance Committee, Consultant to Judith Matheny, LCSW of the Family Care Center and GLCOSHA Chairperson. I also write articles for therapists and health care professionals in the Council's newsletter, "Currents." Currently I am working with Council members on a program for middle high and high school students called "Boundaries, Guardians of Life." The program hopes to address the issue of spousal and relationship abuse in public and private schools and youth organizations. Although I will not be a participant in giving the talks, I have been doing the behind-the-scenes work in writing for grants, organizing speakers, and participating in Board discussions.

Clinical Associate - Del Amos Hospital in California. Assist patients who have undergone treatment at the hospital in finding 12 step programs in our area and therapists. Del Amos Hospital is Dr. Pat Carnes' treatment center which specializes in sexual addiction and training counselors and therapists.

REACT - Radio Emergency Action Communication Team, Treasurer, 2-year term, organization provides emergency radio communication via amateur radio voice and RTTY computerized packet, GMSR radio, and Citizen Band.

DES - Louisville/Jefferson County, Disaster and Emergency Services, operate a radio emergency relay station and operator.

RACES - (Radio Amateur Communications Emergency Service),

volunteer radio operator with technician license in amateur
radio and emergency operation.
