My dad wanted me to go camping

- Camping trip to Mammoth with Fr. P.
 - w/ [REDACTED] wife [REDACTED]
 - w/ Fr. P.
 - fishing, camping, tubing
 - fun time -
- 14 years old - Fr. P. gave some coolers to drink
 - Fr. P. let me drive up to the mountains (long stretch)
(what's with
manipulating
me?)
- 1st or 2nd night [REDACTED] asked me if I wanted to sleep in the campers -
 - Made one sleeping bag of 2 ...
 - Refer to text for what took place - These things happened over the 3 nights - not all @ once - but grew in intensity as the nights went on.
 - I wanted to tell his family - I felt detached.
 - Skin to skin contact (hard to refuse both ways)
 - Kissed my chest and back.
 - Drive home was hardest part - he held my hand the whole way

and during the drive he talked about my parents divorce

- I felt "debailed" "sad" when I got home - I woke up crying - I was angry, "rage", etc
- Didn't want to talk w/ him for a long time after that - he would call periodically - didn't see/talk for awhile
- I wanted to talk about it - but didn't. Felt there

I felt:
detached
out of it
just living

(He was
a friend)

(my fault)
1-1½ yr later I made a shallow attempt & success
(but wasn't slightly)
(he didn't want to
talk further about
this)

— Further incidents?

- ① - One time we went skiing - @ (?)
I don't remember any skiing.
- ② - Once @ St Julian's @ rectory . . .
I don't remember details of the situation - why I was there -
I opened up my feelings about my parents divorce and I felt good about expressing my feelings.
I was 15 - spent the night @ the rectory - both in bed - he was rude - asked me to take off mine (underwear); patting; rubbing;
no further contact - activity

At his cabin & helped him build
a wall & his driveway - he cooked -
brought out wine (I was 17 or 18);
I got really drunk (I think) -
went to other bedroom - he kept
asking me to come to his bedroom -
I said No; then he came in. -
laid down; rubbed me - my
body, my penis (over my shorts) -
I had an erection; & became
angry - "is this what you want?" -
& left the room @ this point.

This was the last incident.

- I saw Dr. F. once again when he
came to the house - I didn't
talk w/ him.
- When he moved to Santa Margarita,
he wanted me to come down -
help him move, etc. - helped him
set up things, etc.
- He's right next to a high school -
where kids are the age I was -
and I helped him move there!

- I really havent seen him much -
maybe only a couple times (once
for sure for Mass).

- (What caused you to write now?)

- all family home in New Jersey
for reunion - I felt a
peace I hadn't experienced
before.
- stayed up all night and then
wrote this all out.
- one month later I wrote the Pushys

- I have talked w/ my Dad a little
bit. He had asked me "had
F P ever messed w/ you"? I
said yes -

The reason my dad asked
was that my older brother
Tim had mentioned something
that F P had made him
feel uneasy. No allegations -
just a feeling.

- I want for P confronted w/ this -
- I want for P to understand the impact this had on me
- My wishes are as stated in my letters -
I feel there was more planning involved in P's actions w/ me than "spur of the moment".

He is concerned

- I don't want for P to contact me.
- I'd call [REDACTED] in first week of August. - we discussed the schedule upcoming (me away 7/3-7/4, & P gone a good part of July)
- I will meet w/ for P in first of August
- I will meet w/ committee then, too.
- [REDACTED] is moving to N.Y. @ end of August.

He appeared sincere; open; appropriate in demeanor/affect; made certain not to "overstate" nor "understate". Was a little emotional; very polite. Seemed appreciative of the "process" - had some trouble recalling times, places, etc - kept using the word "detached".
