I wanted to get back to you in order to finalize our conversation of mid-March regarding the whereabouts of (Reverend) Sig Widera. This is, of course, in reference to your concerns regarding the allegations of molestation which you told me happened to your [REDACTED] by (Rev.) Widera many years ago.

I have no way of knowing his whereabouts at this time; I do know that he is not listed in any Diocese of the United States as being active in the priesthood. He is listed on page 2030 of the 1999 Official Kenedy Directory as "Inactive Leave" from the Diocese of Orange. This has been his status since September 24, 1985.

I did check a few years ago with the Diocese of Phoenix and the Diocese of Tucson; neither diocese had ever heard of him.

As I mentioned to you on the phone a number of times, I would be pleased to speak with your son Christopher at any time. Please continue to communicate that to him for me.
