HISTORY OF DEATH: Reportedly the subject was found dead in his bed. Reportedly he has hypertension.

EXTERNAL EXAMINATION: The 68 in (measured) about 175 lb embalmed, completely nude and washed body is of an elderly appearing white male with:

- a moderately thick basally encircling fringe of dark brown-black hair and "blue eyes."
- slightly poor tissue turgor.
- an 8 in old fine left flank apparent surgical scar.
- a 2.5 cm basal diameter soft protrusion at the umbilicus.

INTERNAL EXAMINATION:

The lumens of the major coronary arteries and their branches of this about 475 g heart are concentrically and eccentrically narrowed up to 65% in a few places by lightly calcified atherosclerotic material.

The right coronary artery, beginning about 0.7 cm from its origin and extending over a 0.3 cm distance, is completely occluded by a recent antemortem blood clot.

The maximum thickness of the wall of the left ventricle is 2.5 cm and all the cardiac chambers are moderately dilated.

A 1 cm greatest diameter old scar is in the superior and medial aspect of the posterior wall of the left ventricle.

A small wad of greater omentum fills the umbilical hernia.

The left kidney is absent.

The capsule of the about 300 g right kidney strips with moderate difficulty leaving a coarsely granular cortical surface.

The thoracic and abdominal segments of the aorta are moderately to markedly brittle and the greatest change is in the abdominal segment.

The stomach is distended by particulate food material and there must be at least 300 ml.

## SIGNIFICANT NEGATIVE FINDINGS:

1. There is no jaundice, edema or significant mark of recent violence.
2. There is no myocardial evidence of an acute infarct, valvular lesion or intracardiac thrombus.
3. There is no significant lesion of the liver, spleen or right adrenal.
4. There is no gastrointestinal hemorrhage, peptic ulcer, dissecting aortic aneurysm or pancreatitis.
5. There is no foreign body obstruction of the tracheobronchial tree, pulmonary embolus, significant atelectasis or emphysema, pneumonitis, neoplasm, cavity or fractured rib.

## COMMENTS:

The autopsy and historical findings are interpreted as a death resulting from a coronary artery occlusion, due to hypertensive arteriosclerotic heart disease.

Reportedly the left kidney was removed for a cancer. There is no evidence of metastatic carcinoma in the lungs, liver, surgical bed or associated lymph nodes.

Microscopic studies either clarify and/or confirm and/or establish the appropriate diagnosis.

This is to inform you that Rev. Msgr. Joseph V. Clarkin died in Brawley this morning. Msgr. Clarkin was born in County Cavin, Ireland, on June 1, 1901 and attended elementary and secondary schools there. He studied at St. Kieran's College, Kilkenny, and was ordained to the priesthood on May 30, 1926 for the Diocese of Los Angeles and San Diego.

His first assignment was Associate Pastor at St. Anthony Church, Long Beach. In 1935 he was appointed Pastor of Sacred Heart, Brawley, and in 1938 he was named Dean of Imperial County. He became Pastor of Mary Star of Sea Church, La Jolla, May 1, 1939, where he served until his retirement on May 1, 1969. He was named a domestic prelate in May 1951.

The Rosary will be recited at Mary Star of Sea Church, 7727 Girard Avenue, La Jolla, at 7:30 on Sunday, February 11, 1979. The Mass of Christian Burial will be celebrated in the same church on Monday morning, February 12, at 10:00 o'clock. Interment will be in Holy Cross Cemetery, San Diego.

If you plan to attend and concelebrate, please provide your own alb and white stole. Msgr. Gilfillan has graciously extended an invitation for luncheon to all the priests who attend.

In your charity please offer three Masses for our deceased brother priest.

Dear Msgr Egan:

Enclosed please find check for my Personal Dues (insurance) for the next year. I received your follow up letter and have noted the changes.

No doubt you heard that last Jan. 12 & 13th- I had two major operations-in Scripps Hospital--something new in my long healthy life ! D.G.

I havent sent any bills on this Insurance Policy -as yet... but there were many and heavy ones...Twenty days in a private room-@ \$109:00 per day--!two Doctors for the operations-plus all the other multitude of items...all expensive. However Medicare has already paid most of these bills...or 80% of them. Doctors indicated that only what Medicare would pay-would be all they would require ! Medicare is slow in paying--also I was busy on the Golden Jubilee-preparations--and after the celebration I went abroad for a few weeks...so I got an behind in the bills. I have paid myself some of the smaller items--as I was so thankful that the cause of the second serious operation-was discovered IN TIME-and removed before real damage was done. It was a malignant tumor-in one kidney-which was detected on the film taken of the prostate! It was still in a state of incapsulation-hadnt broken thru--so hadnt rays left its presence or bleeding. With the removal of the kidney-no trace of the "bug" was left--as seeing in the pathology....

I estimate that the total bill for between 10 and 15,000 through all bills...! Thank God for Medicare--and that I was the "Right" one !

If there are any further expenses to be paid I will be in contact with you....

I will see you some time -with excellent health-and am so grateful to you....

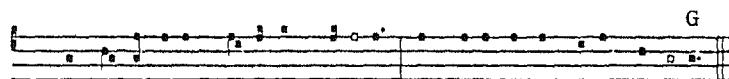

## LITURGY OF THE WORD

A reading from the Acts of the Apostles.

Acts 1/15-17, 20-26 (61)

In those days Peter stood up in the center of the brothers; there must have been a hundred and twenty gathered together. To state that I was amazed by the contents of your letter of Dec. 28.  
to express my feelings mildly. It is true that I did sing a High Mass in

English I chose (in the best of good faith) to sing a High Mass in Latin  
ause it was more familiar to me and besides I was experiencing considerable  
fficulty with my throat. To provide for the people's need of participation  
had a half hour of singing Christmas Carols, the Epistle and Gospel were in  
GLISH, there was a very eloquent sermon preached by a professor from St. Edward  
inary, Seattle, and the entire Communion Service was in English. There was an  
erflowing and very attentive congregation with nearly one hundred per cent  
ipients of Holy Communion. There were, also, six Masses in English on  
istmas Day.

Our parish Library is stocked with the "Sixteen Documents of Vatican II."  
made the "Sixteen Documents of Vatican II" available, by public display, for  
ominal sum, for three weeks in November. I am doing my best to have all the  
ms. of Vatican II implemented here - even to the extent of having discussions  
the Documents at our parents and teachers meetings. The most outstanding

ee weeks ago, on "The Decree on the Apostolate of the Laity". I think this

Just a few lines with my Christmas good wishes to you, to let you know that all is well with me. I am anticipating the joy of my first Christmas in Ireland as a priest and I am sure it will be memorable.

I have been able to keep in touch with activities in America, both religious and secular, thru the daily press, T.V. and Time magazine. Time gave a very fine detailed report on the elections and I was very much interested in California results. I was not surprised that Gov. Brown lost so badly, after I saw that he opposed the Proposition on Pornography. Time also kept me informed on the fortunes of Notre Dame—I was very proud of the results of their final contest—U.S.C. had robbed them twice—before my eyes on two previous occasions.

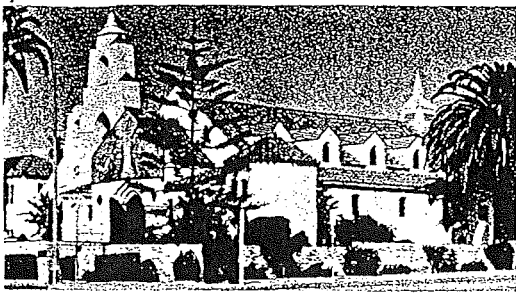

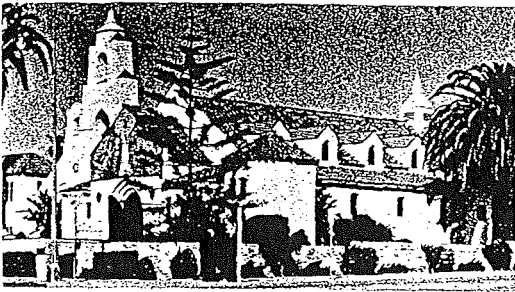

Further to my talk with you in your office last June about a leave of absence I wish to add now, that with your kind permission, I plan to leave here the 7th of Sept. the day after the re-opening of school. I wish to renew my request to Your Excellency that Fr J. Vincent Sullivan be appointed by you to administer this parish in my absence. On two previous occasions—twenty years ago, in 1946 and again two years ago he took charge for a shorter period. Between these times he supplied here on Sundays for extended periods. I have always found him most dependable and competent. As soon as I hear from you that he will be appointed I plan to contact him at Our Lady of the Lake, Arrowhead where he has been taking charge of that parish since the end of June.

There is another important matter in conjunction with my absence that I wish to bring to your attention at this time. A priest from the La Jolla Deanery will need to be appointed to the office of Dean to arrange for the monthly days of Recollection for the priests, and to assist the ladies of the Deanery with their meetings and activities. You may wish to appoint a priest either pro-tem or permanently. I have held the position for the past ten years.

My last request is that as soon as it is possible that you would appoint a second full-time Assistant to this parish. There is a real need for him.

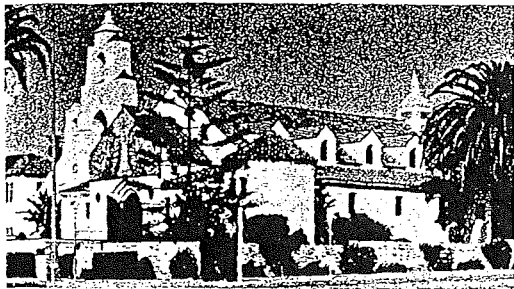



In response to your letter of June 8, 1958 please be advised as follows: The Bishop does not grant permission for priests to participate in the Vesper services of non Catholic Churches, in fact, if this is a service at which a Public High School Choir participates, the Catholic students of that group are not allowed to go, no matter what threats their public high schools teachers may use. And if the so called Baccalaureate is conducted in a non Catholic Church and is in effect a religious ceremony, the Catholic students are forbidden to attend. This is considered as direct participatio in divinis. This latter is an abuse that has been creeping in during the last few years and is dangerous in developing religious indifference.

As to Catholic students attending the religious-denomination schools in your area, you would not be advised to write a letter of recommendation for your Stella Maris graduates to attend these schools unless they have direct permission from the Bishop's office, which incidentally, the Bishop has not been inclined to give in the last several years since our own wider development of a complete educational program.

As to the problem of Catholic girls acting as brides maids in Protestant Church weddings, it's the general policy to not permit this participation, however, there are circumstances in which said permission can and is give (there are moralists who state that even when this permission is given it is not a participatio in divinis since the State only requires one witness for validity and basically the ceremony could go on without their presence) but, permission is not given except when the Pastor knows and agrees that this will not cause scandal in his particular parish. An example of when a permission might be granted would be if a non-catholic girl had attended the San Diego College for women and knew no non-catholic girls and ask for one of her fellow students to be in the bridal party, then, scandal not being present, permission might be granted.

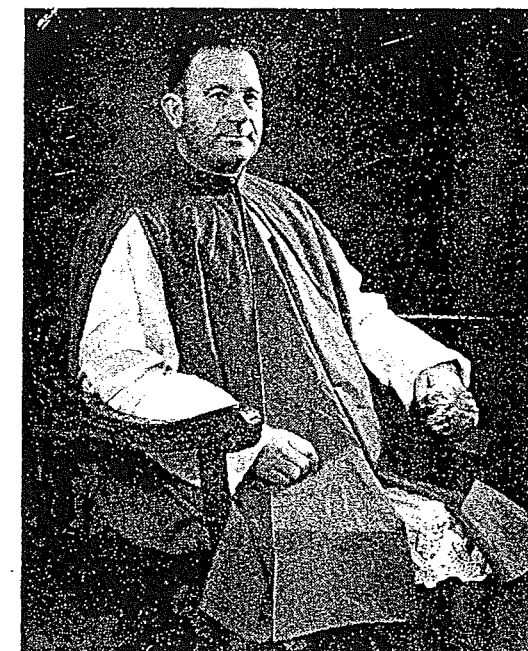

On last Friday the Diocesan Consultors met in San Diego and the facts of the case, to most of them never known before, were accurately submitted with the request that they give me in writing (copy of form inclosed) the benefit of their counsel with regard to future action.

You know, of course, that it is the mind of the Church that the Bishop seek advice from his Counsellors.

In the questions proposed much is at stake, including justice and truth, the dignity of the Church, and the establishing of a precedent in this Diocese. The other Consultors who were not present have been sent copy of this letter together with the form to be filled out. You will be interested to know that with a view to precluding a long drawn-out court case the Consultors voted unanimously that a committee of five judges be appointed to study the case and render a final decision. Monsignor Hegarty asked for one week to consider this proposal. In the event that he does not accept it, a majority of the Consultors voted that suit be brought against him in the Ecclesiastical Court. Please answer the questions frankly and return the same marked "confidential" to me.

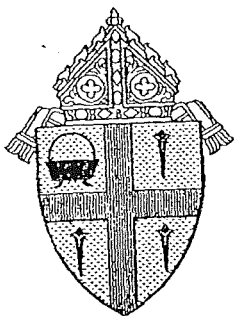

Dear Father Clarkin:

Let me acknowledge with sincere appreciation your prompt response together with your check for \$200. It was a surprise to learn about the defect in the floor and before paying the architect in full we have written asking that the defect be corrected. He will probably get in touch with the contractor. You will find, herewith, copy of the letter sent to Mr. Winslow and our plan is to hold up the payment until some adjustment is made. We have also noted the balance of \$225 due the contractor. It is our earnest hope that some benefactor may be disposed to clear this amount.

In reviewing your ledger page in the Chancery account, I note that the July 1 interest due, \$166.07, was paid but that the principal of \$593.10 is not paid but that you indicated your intention to take care of it within a month. This is a very serious matter and should be taken care of within the next month without fail because to let that pile up to the next quarter would be getting in the frozen asset class. As clearly explained at the Retreat, the Chancery account is the only preferred creditor. If, then, it should be necessary to defer other items, even the salary of pastor and assistant, it would be far better than letting the account overlap to the point where it could not be handled at all. You know the majority of our priests do not receive anything like the appointed salary.

My thought is that you can adjust the matter and perhaps a bazaar or special collection in the fall will bring you out of the difficulty.

This letter will I hope cover at least three matters of business. First regarding our previous communications regarding the coming visit of His Excellency to the Valley for Confirmations, Blessings, and Dedications, I regret that I have been unable until now to get a satisfactory program worked out with ~~xxx~~ my suffragans down here- "Tot homines quot sententias". Here now is the proposed schedule, which meets with the approval of the Fathers. His Excellency to come to Brawley (the corner stone) (which was rejected by the builders) on Thursday afternoon, with dinner at 6 PM and Confirmation at 7:30 PM (Sacred Heart Church). Friday afternoon Confirmation at Calipatria at 3 PM. Dinner at Brawley 6 PM, followed by Blessing of new Rectory and Confirmation at St Margaret Mary's Church, Brawley, 7:30 PM. Saturday Blessing of the new Rectory and Confirmation at Holtville, at an hour to be determined by the Pastor and which he will communicate to you later. Sunday Dedication of new Church and Confirmation at Calexico-details to be arranged later by the Pastor and which will be communicated to you by him in due season. If we can hold the Holy Name Rally at Calexico in the afternoon prior to the other services we will do so-but we have not got down to business on it yet-that is the only time and place I can see open for it. Other arrangements regarding Mass & accommodations will be worked out and wont be necessary to forward to you. I think the Bishop will have a little more time-in between-on this tour of the Imperial Deanery than on former occasions.

Second matter is your puzzle of yesterday-find the Mexicans! All the information so far is negative-they dont give a dollar a Sunday at any of the Imperial Valley Churches-Finding the "needle in a bundle of straw" would be easier than finding "the Jesus Gonzalez"-in Imperial Valley-however should any of the priests locate them you will get the information right away.

The most crying need now in the Valley is the erection of a hall to accommodate the Catechists and the 900 children in St. Margaret Mary's Parish. In view of the needs throughout the Diocese of churches or halls where people may meet for worship, it could easily cause scandal to neglect the more important things for the erection of even a suitable home. With these thoughts in mind, let me beg of you to postpone the matter for the present.

Dear Fr. Forristal:

Enclosed is the latest and best estimate submitted on the new house to be built here. Mr Lodge was here yesterday and I had him meet this contractor, and discuss all details. Mr Lodge is satisfied that this contractor, Mr Dahm, will do satisfactory work. He is a Catholic of this parish, though not very practical; he has other relatives in the parish however who are. He built the St Margaret Mary Church here in Brawley, and over a period of years has done many jobs in this parish on the church, school and parish house. He has many other buildings to his credit in this city.

You will notice that his total estimate for the complete job, including rockwool insulation, is \$8715, and that the credit for omitting the three rooms and bath room upstairs is only \$679, which is so little that in my opinion it would be as well complete the building. I suggest that for details on this that you call Mr Lodge.

The new estimate for the air-conditioning of the first floor, which includes a heating unit, is \$1200, making a total for the house \$9915. The type of cooling and heating is known as Yorkair, and is considered the best.

The estimate submitted by the contractor on the basis of cost + 7% was away high.

"I . . . . firmly hold and accept each and every definition of the unerring teaching of the Church, with all she has maintained and declared, but especially those points of doctrine which expressly combat the errors of our time. In the first place I profess my belief that God, the beginning and end of all, can be certainly known and therefore proved to exist by the natural light of reason from the things that are made, that is, from the visible works of the creation as a cause from its effects. Next I recognize and acknowledge the external arguments of revelation, that is, divine facts, especially miracles and prophecies, as most certain signs of the divine origin of the Christian religion, and I hold that these are altogether suited to the understanding of every age and of all men, also of our times. Thirdly, I likewise hold with firm faith that the Church, the guardian and exponent of the revealed Word, was proximately and directly founded by the true and historic Christ Himself, while He dwelt amongst us, and that she was also built upon Peter, the Prince of the Apostolic Hierarchy, and upon his successors to the end of time. Fourthly, I sincerely accept the teaching of faith as transmitted down to us from the Apostles through the orthodox Fathers in the same sense and even in the same wording; and, therefore, I wholly reject the heretical notions of the evolution of dogmas, which pass from one sense to another alien to that which the Church held from the start; and I likewise condemn every error whereby is substituted for the divine deposit, entrusted by Christ to His Spouse and by Her to be faithfully guarded, a philosophic system or the creation of a human consciousness, gradually refined by the striving of men and finally to be perfected hereafter by indefinite progress. Fifthly, I hold for certain and sincerely profess that Faith is not a blind religious sense making its way out of the hidden regions of the sub-liminal consciousness, morally tinged by the influence of heart and will, but is a true assent of the intellect to truth received from without by hearing, an assent whereby we believe to be true, because of the authority of the all-true God, whatever by the personal God, our Creator and Lord, has been spoken, testified and revealed.

"I further, with all due reverence, submit and with my whole mind adhere to all the condemnations, declarations, and ordinances contained in the Encyclical letter *Pascendi* and in the Decree *Lamentabili*, particularly regarding what is called the history of Dogma.

"I also reject the error of those who aver that the Faith proposed by the Church may be in conflict with history, and that Catholic dogmas in the sense in which they are now understood cannot be harmonized with the more truthful "origins" of Christianity. Moreover, I condemn and reject the opinion which declares that a Christian man of better culture can assume a dual personality, one as a believer and another as an historian, as if it were permissible for the historian to hold fast what his faith as a believer contradicts, or to lay down premises from which there follows the falsity or the uncertainty of dogmas, provided only that these are not directly denied. Likewise I reject that method of estimating and interpreting Holy Writ, which, setting aside the Church's tradition and the analogy of Faith and the rules of the Apostolic See, adopts the rationalists' principles and with equal arbitrariness and rashness considers criticism of the text the one only supreme rule. Furthermore, I reject the opinion of those who hold that a teacher of the science of Historical Theology or the writer on the subject must first put aside the notions previously conceived about the supernatural origin of Catholic tradition or about the divine aid promised for the perpetual preservation of each revealed truth; then, that the writings of individual Fathers must be interpreted solely by the data of science, without any reference to sacred authority, and with that freedom of judgment wherever every profane record is usually examined.

"Finally and in general, I declare myself to be far removed from the error of the modernists who hold that in sacred tradition there is nothing inherently divine; or who—far worse still—admit it in a pantheistic sense; so that thus there would remain only a bare simple fact equal to the ordinary facts of history, viz., that the school started by Christ and His Apostles finds, in the ages that follow, men to carry it on by their energy, their skill, and their genius. Wherefore most firmly do I retain and to my last breath will I retain the Faith of the Fathers of the Church concerning the sure endowment of truth, which

is, has been, and ever will be in the succession of the Episcopate from the Apostles; not in such a way that what seems best and most fitting according to the refinement of each age may be held, but that the absolute and unchangeable truth preached from the beginning by the Apostles may never in any different wise be believed, never in any different wise be understood.

All this I promise that I will faithfully, entirely and sincerely keep and inviolably guard, and from this never in teaching or howsoever by word or writing in the least depart. So I promise, so I swear, so help me God and these His holy gospels.

#### REMARKS

1. The Profession of Faith is made and the Oath taken before the *Ordinary* of the place or his *Delegate* by:
  - a) the Vicar General,
  - b) the Diocesan Consultors,
  - c) the Censor of books,
  - d) Pastors,
  - e) Confessors and Preachers before they receive the faculty to exercise their functions,
  - f) Clerics called to Subdeaconship,
  - g) Superiors and Professors in the Grand Seminary.(Cf. C. 1406 et Motu Prop. Pii PP. X., Sept. 1. 1910.)
2. When several take the Oath at the same time, one may read the formula aloud; at the end each one, placing his hand on the gospels reads the words "Haec omnia spondeo," etc., and signs his name. (S. C. Consist. Oct. 25, 1910.)
3. The document is to be kept in the safe of the diocesan curia.
