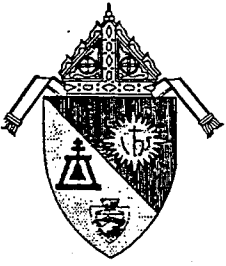



Thank you for your time and cooperation in this matter. It has been a long search for someone to assist us in Pastoral Care, especially with the sacramental needs of the patients.

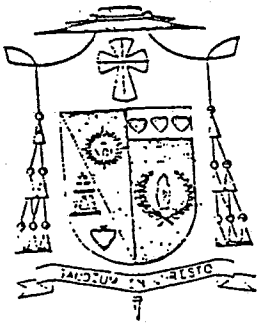

Would you please assist in expediting the necessary documentation so that both of these men may begin to receive their retirement benefits on July 1, 1987?

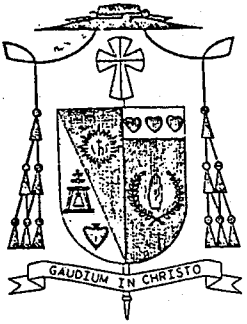

Re: Building Project

Dear Bishop Straling:

This letter is a follow-up of my letter to you of Jan. 6, 1987 in which I suggested a new approach to our building project here.

I suggest:

1. Build on the new land a new church, first of all, to seat 1200 persons. (Not a multi-purpose building. We can use our present downtown facilities for parish functions, CCD classrooms, etc.)
2. Do not sell the downtown land at this time. Rather, borrow whatever monies are needed to build the church. (We have \$350,000 available in savings at the present time. Our gross income this year, including building fund monies, will be close to \$200,000—ample to pay the interest on a loan of \$1,000,000 dollars).
3. Start a fund-raising drive here to raise at least \$500,000 over a period of the next three years.
4. Don't sell the downtown land until the new church is built and it becomes financially feasible to build a large hall on the new land.

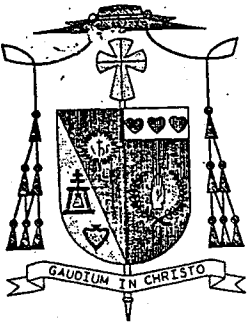
Notes:

1. Our area is already growing fast. When I came here, the road sign said 3,000 population. It now says 15,000—and that is an understatement. The population of Rancho California alone is expected to be 85,000 within 15 years.
2. The Parish Financial Report of '80-'81, Grand Total (B+C+D): \$50,146.78.
" " " " " '85-'86, " " " \$176,068.07.
----More than tripled in 5 years, and just starting to grow.
3. Since 1981, the following expenses were paid off: \$35,000 parish debt; \$40,000 addition to church bldg; \$160,000 for new land.
4. New pastor: If he lives a simple life, keeping expenses to a minimum, he should be able easily to pay the expenses on a new church and hall.
5. You probably will be receiving letters also from the Parish Council, the Parish Financial Committee, and the Building Committee.

I pray that this will be a very blessed and fruitful time for you in your priesthood. As I have mentioned to others who have retired, this is a time to set aside




After much thought and careful consideration I have decided to ask for retirement.

Dear Bishop Straling:

We are interested in selling our land here in Temecula, in order to get enough money to build a new church building in our new location.

One of the prospective buyers of this land is the Diocese of San Bernardino. You could buy the land from us at this time, hold the land until you get a good offer for it, and make a profit in so doing.


We have not listed the land for sale with any broker. Nor have we had the land appraised. Perhaps Mr. Tom Fry, the Diocesan appraiser mentioned in your letter of Oct. 28, 1985, can make an appraisal for you that would be satisfying to you.

Some real estate brokers have told us that our land is valuable and that it would not be asking an unusual amount to ask for \$750,000 for the land.

The land immediately adjacent to us (between us and the Post Office) just recently sold for \$650,000, which figures out approximately \$10.75 per square foot. We pay taxes on 1.41 acres of land.

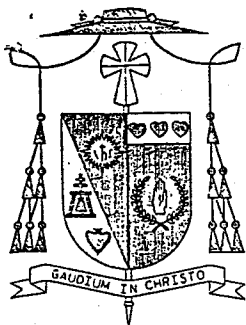
We would appreciate knowing what your thoughts are about the purchase of this land by the Diocese.

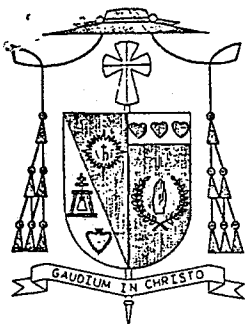

This is to acknowledge your letter of August 12, 1985 concerning the request that the Sam Hicks Monument Park Foundation be allowed to use the old Catholic Chapel in Temecula as a temporary museum until a permanent site is established.

As the administration of church properties in Temecula is under the care of the pastor, Father James Ganahl, and the Catholic Community of St. Catherine's, I would need to receive the recommendation of Father Ganahl and his Parish Council regarding your proposal. As they are planning to re-locate the parish, any permission to use the old Catholic Chapel as a museum would have to fit into their future plans.

I would also need assurance that there is no conflict on the tax exemption for the property, even though another non-profit group is making use of the facility. Finally, any activity that would take place in the old Catholic Chapel should be of a nature that, at all times, would show respect.

I ask that you meet with Father Ganahl and the Parish Council, in order to receive their recommendation on your proposal.

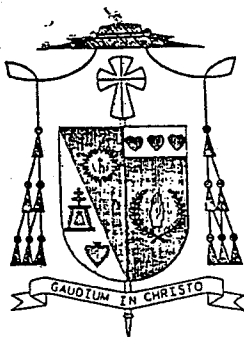

In any case, I think we need to do some serious thinking before we approve a church with seating capacity for 1500.

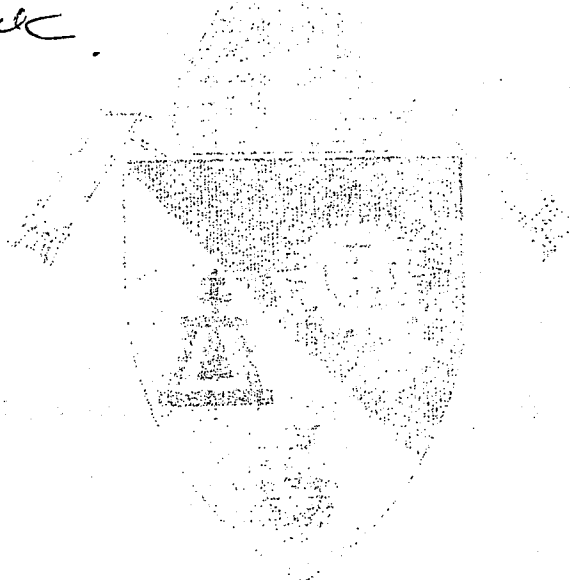

To date the following has been accomplished:

1. 8+ acres of land have been purchased from Kaiser Development Co.
2. A Site Plan of future buildings was submitted to the Diocese indicating the location of future buildings. (John Reinhart of this parish prepared the Site Plan).
3. Our Parish Council and our Finance Council have approved the hiring of Joseph Dameron as architect for future buildings.
4. Joseph Dameron has submitted an AGREEMENT FOR ARCHITECTURAL SERVICES at my request to cover the cost of plans, etc., for the first phase of our future building.

Our plan for future is:

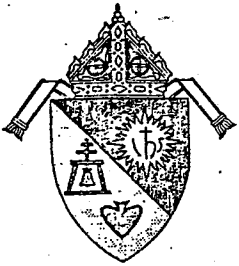
1. Do whatever grading, roadwork, parking space, underground services, etc., are necessary for now and the future. Move our present multi-purpose building from our present location to the new location, where this bldg. will be used temporarily as a church (seats 300 persons).
2. After the move to the new land has been made and we are reasonably settled there, then sell our present land. With the monies from the sale of this land, together with monies that we can gather by way of donations, plus what we can borrow from the Diocese, we will be able to build a large, new church, seating in the neighborhood of 1500 persons.
3. When the new church is occupied, the multi-purpose bldg. will be used for classrooms and hall.
4. When funds are available, we will build a large hall, and also a rectory.
5. In the distant future, when funds are available, we will build a grammar school.

Exclusive of the school, the overall project should cost in the neighborhood of \$2½ million to \$3 million dollars. At present we have about \$50,000.00 in funds available. The site preparation and moving of our Present bldg. should cost less than \$200,000. We have plenty of money to pay Mr. Dameron for his proposed work, of course.

85,000 persons are projected to be living in this area within 15 years. We have between 800 and 900 persons attending Masses on week-ends right now. Our present land is worth probably between 500,000 and \$600,000. The new church should cost about 1½ million dollars.

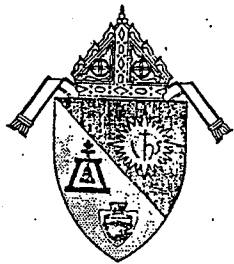

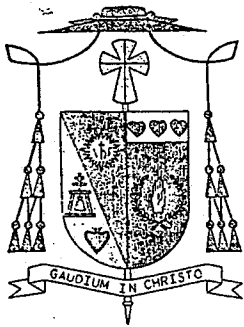

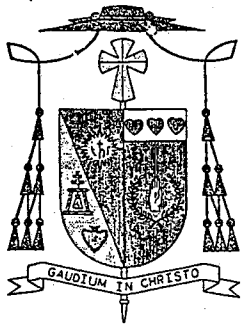

DEAR BISHOP STRALING:

IN LATE MARCH OF 1983, MR. RICHARD KURTZ OF RANCHO CALIFORNIA MADE AN OFFER TO US TO BUY APPROXIMATELY 10 ACRES OF LAND FOR OUR NEW CHURCH. WE ACCEPTED THE OFFER TENTATIVE, OF COURSE, UPON FINALIZING THE DETAILS.

IN EARLY JANUARY OF THIS YEAR WE WERE GIVEN A COPY OF THE PARCEL MAP WHICH HAS BEEN FILED WITH THE COUNTY OF RIVERSIDE--PARCEL NUMBER 19534. THE PROPOSED PARCEL IS APPROXIMATELY 8.4 ACRES.

OUR PARISH CCUNCIL VOTED UNANIMOUSLY TO PURCHASE THE PROPERTY AS SOON AS POSSIBLE.

AT PRESENT, WE HAVE AN ENGINEER WORKING ON THE POSSIBILITY OF MAXIMUM USE FOR THE LAND AND THE POSITIONING OF FUTURE BUILDINGS. RANCHO CALIFORNIA IS ALSO WORKING ON A SET OF CONDITIONS, COVENANTS, AND RESTRICTIONS WHICH THEY WILL PRESENT TO US WHEN THEY HAVE COMPLETED THAT WORK. AS SOON AS WE CAN, WE WILL GET ALL THE INFORMATION TO YOU AND THE BUILDING COMMISSION.

WE HAVE BEEN IN CONTACT WITH YOU DURING THESE PROCEEDINGS, OF COURSE, AND ALSO WITH THE BUILDING COMMITTEE, AND WITH BLANCHE STEWART. SHE CAME DOWN ONE DAY AND LOOKED OVER THE LAND AND WAS EXTREMELY PLEASED WITH IT, AS WE ARE.

MY MAIN REASON FOR WRITING THIS LETTER IS TO KEEP YOU IN TOUCH WITH OUR PLANS AND ALSO WITH FINANCIAL NEEDS IN THE FUTURE. WE HAVE \$125,000 ON DEPOSIT WITH THE DIOCESE




Dear Father Ganahl:

It has been some time since we last met with you to discuss the Catholic Church site in the Rancho Highlands area near Santiago Road and in front of the Temecula Cemetery. We have now effectively identified a 10 acre site for the church as indicated on the enclosed map which we offer for consideration of purchase by the church for \$20,000.00 per acre. We would be willing to enter into a Sales Contract with the Catholic Church on this basis. The terms are: 3% earnest money deposit; 25% of the purchase price payable at the close of escrow; the balance will be covered by a First Deed of Trust and a Note amortized over 20 years with a 10 year due date at 12% interest and with quarterly payments of the principal and interest. Escrow will be for 60 days.

For budgeting purposes and based on a total purchase price of \$200,000.00, with \$50,000.00 paid at the close of escrow, the quarterly principal and interest payments would amount to \$4,966.76 and the 10 year balloon payment would total \$119,772.86.

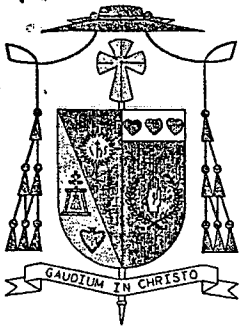

Some days ago when we were at the Priests' Ongoing Education Program, you mentioned to me that people in Temecula were accusing the diocese of taking money that belonged to the parish. As a result, the Parish Council is reluctant to place money that is presently being raised for the purchase of land and the building of a new church on deposit with the diocese.

I want to put a stop to any rumors since I insist that the diocese account for all parish money that comes to the diocese for deposit. I asked for a thorough investigation of all money that had been received from the Temecula Parish and forward on to you a summary of the results.

You will note from an enclosure from the Mission San Antonio de Pala that the total amount of money received from them at the time of the split of the diocese amounted to \$35,000.00. Of this money, \$25,000.00 was deposited to the account of St. Catherine's, Temecula and \$10,000.00 to Sacred Heart Chapel in Anza.

As you will note from the balance sheet dated 3-31-79 for St. Catherine's Church, Temecula, a deposit of \$25,000.00 as of 7-10-79 was recorded. A check posted for 12-31-79 in the amount of \$10,000.00 was withdrawn and paid to St. Catherine's Church for updating of CCD Building. There was a dispute as to the amount of monies due to the Anza Mission and a check posted 3-31-80 was transferred to Sacred Heart, Anza in the amount of \$5,000.00.

On 8-25-80 a loan in the amount of \$35,000.00 was paid for the mobile home purchased for St. Catherine's Church, Temecula. \$851.61 was transferred from funds on deposit against this parish debt 10-1-80.


This is a complete and accurate account of all monies handled by the diocese belonging to St. Catherine's Church in Temecula and Sacred Heart Mission in Anza. If further documentation or other records are needed, they can be obtained at the Diocesan Financial Department.

As we discussed, I hope all parish funds, as well as future funds which are in excess of the ordinary operating expenses, be on deposit with the diocese. This is essential so that the diocese can in turn loan out money to various parishes for their building projects. St. Catherine's, itself, will be looking forward to such a loan in the near future.

I have also received the report concerning the clearance of the property on which the church is now located. Please note the report enclosed.

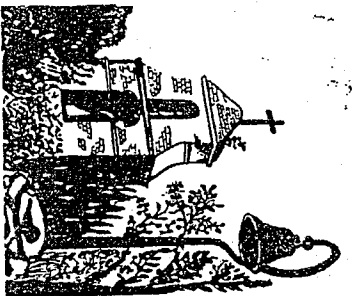

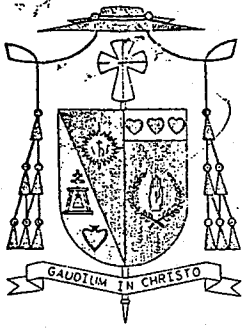

Dear Father Ganahl:

I wish to thank you for the hospitality and warm welcome you afforded me on my recent Parish Visitation to St. Catherine's Parish.

The following are some of the items that we discussed, as well as some of the issues the lay leaders of your parish brought to my attention. This will hopefully help us to look at the overall plan and growth of the parish.

You are to be commended on the fine pastoral ministry you are doing at St. Catherine's. When you arrived to take over the pastorate, it was a community that was deeply divided and needed direction. There is now satisfaction among the people regarding the direction that your pastoral guidance has taken. This was indeed a joy for me to see, after the many divisions and problems that we had in the past.

One of the great needs of St. Catherine's is its relocation and the development of adequate facilities for the growing community. It is my understanding that we are presently investigating various proposals concerning property commitments. As I mentioned to the people during our open meeting, upon finalization of this investigation, I will ask for a master plan for a long range development of the property. Some of the present church facilities could be relocated on the new site. The major portion of the money to build the new church or multi-purpose hall, could be obtained from the sale of the present property. I am in the process of having a title search of the property conducted and will send it to you as soon as possible. Hopefully, the title search will show no encumbrances on the selling of the present property.

As parishes continue to grow and needs and services multiply, there is the need for continuing the training of our laity. If finances

permit, the hiring of full time sisters or lay people to assist us in our parish ministry, will be necessary. During our general meeting, two areas surfaced that need attention and that is someone who might help as a Director of Religious Education and the other for someone in Youth Ministry.

We discussed the possibility of inter-cooperation between parishes for full time personnel that might be hired. I commend you and your parish for your efforts in training lay people to assist you in your pastoral ministry.


I was also pleased that the issue of a parochial school or Catholic High School was discussed, so that people will not be living under any false expectations. I am not fully aware of just how things were formulated some time ago, but they are unrealistic at this place and time. I can not see building a Catholic School that will cater to a few upper income people.

I appreciated the frank and open discussion that we had concerning Father Ed Ball's article on "Resurrection." I am sorry, but until a short time ago, I was unaware of your grave concern about this matter. Be assured that I am concerned about the content of the doctrine that is being taught by our Catechetical Office. I have had the article evaluated by several theologians and it is presently being reviewed by the Diocesan Theological Commission. It has been discussed with Father Ball, as to the prudence of putting such a speculative article in one of our publications. Father Ball is taking steps to avoid such things happening in the future or in any way possible misleading our people in regard to the basic teachings of the church.

In the future, if there is some issue or problem that disturbs you, please feel free to personally talk to me about it. It helps me if it can be put in writing, so I can know exactly what is being said and can pass it on to those who could assist me in evaluating any problems.

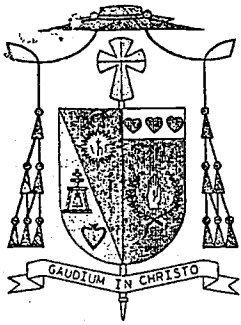

After mature deliberation on my part, I have decided not to subsidize the Idyllwild parish.



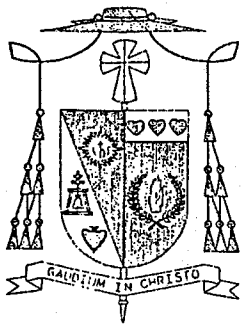

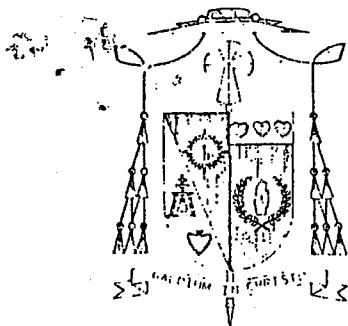

The Superintendent of Catholic Schools has asked me to get a clarification of the status of St. Mary's School in Apple Valley.

It is my understanding that, up to the present time, all three parishes, St. Joan of Arc, St. David's School and Holy Family were contributing to the support of the school. It is also my understanding, that as of this year, this agreement has been completed. It has also been brought to my attention, that Father Harmon believes that the school should be attached to St. David's Church. In any case, he has been more or less responsible for overseeing the operations of the school and feels it is his responsibility, now that the original agreement has been completed.

To clarify any misunderstandings about past agreements and the present situation, would you please contact Father Harmon regarding this matter? It is my feeling that you, Father Ganahl, Father Harmon, the principal of St. Mary's School and Sister Charlotte Ell, the Superintendent of Catholic Schools, should get together at a meeting in your area to discuss this matter. Some of the questions that I would like answered are:

Is the original agreement made between the parishes now completed? What about financial responsibility of the various parishes to St. Mary's School in the future? Is it the wish of the pastors and the principal that the school be attached to St. David's Parish as a parochial school of that parish? These are only a few of the questions that I can think of, but perhaps you and the others might have questions that need to be answered.



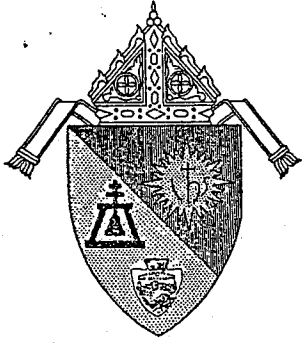

You will be receiving a request from Father John Harmon in the near future. You will recall, I discussed the issue of "parish school" versus "area school" at our meeting in October.

Father Harmon was evidently dissatisfied with our consensus decision that settlement of the existing dilemma should be handled at the local level. He will be asking you/me to decide the issue so that he "knows where he stands."

My response to him on November 14th was that since the school serves several parishes, it is really just that and not a parish school. The pastors who are on the School Board could/should rotate responsibilities.

Since he claims the other pastors won't take that on, perhaps we need to explore another "title" for the pastor of St. David's in regard to the school, or for that matter, for anyone who accepts that responsibility. Precedents are hard to get rid of! I would prefer that the Board have a policy which indicates rotating school responsibilities.

These are just thoughts for you to mull on - especially since you have little else to think about!

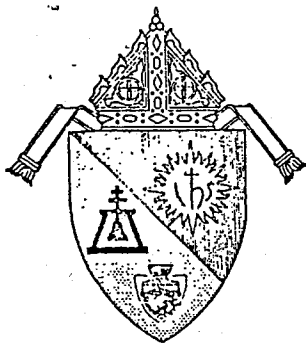

In response to your request that unanswered questions at St. Mary's School and St. David's parish in Apple Valley be addressed, Father O'Day, Pastor of Holy Family parish, Father Ganahl, Pastor of St. Joan of Arc parish, Father Harmon, Pastor of St. David's parish, Sister Virlee Egler, Principal at St. Mary's School, and Sister Charlotte Ann Ell, Superintendent of Elementary Schools met at Apple Valley on the afternoon of January 28, 1980.

Questions that you posed in your communication to Father O'Day of December 4, 1979 were discussed:

1. Is the original agreement made between the parishes now completed?

Answer: The original agreement is fulfilled.

2. What about the financial responsibility of the various parishes to St. Mary's in the future?

Answer: Father Ganahl proposed, and both Father O'Day and Father Harmon agreed, that the parishes would share the school deficit in proportion to the number of students attending St. Mary's from St. Joan of Arc, Holy Family and St. David's.

3. Is it the wish of the Pastors and the Principal that the school be attached to St. David's parish as a parochial school of that parish?

Answer: Father O'Day of Holy Family parish and Father Ganahl of St. Joan of Arc parish wish to go on record that St. Mary's School be attached to St. David's parish as a parochial school. Father Harmon and Sister Virlee expressed no preference, but Sister Virlee voiced the opinion that St. Mary's should be attached to some parish. As Father Ganahl pointed out, the school is within the territorial limits of St. David's parish. Therefore, the school should be attached to St. David's parish. All agreed.

The group was in agreement also that the pastor of St. David's should be the Pastoral Administrator of St. Mary's School.

4. If St. Mary's becomes a school attached to St. David's, what help might be expected from the other two parishes?

Answer: Pastors from St. Joan of Arc and Holy Family will participate in the Sacramental programs of St. Mary's; be available for celebration of the Liturgy; visit students and teachers periodically and make social visits.

The financial agreement was answered in number 2.

The above decisions will be incorporated into the new Constitution of the Board of Education for St. Mary's parish.

Because parental concern had surfaced about future enrollment policies, the group was in agreement that for the present, parents of children already enrolled in the school will be assured stability.

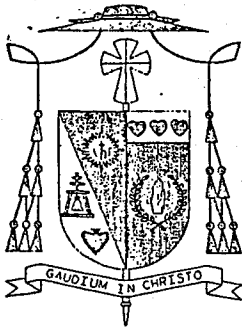
