

#### Dear Bishop

I am writing this letter to you to express my long standing outrage at the Churches lack of action where Dennis Jost's behavior is concerned. It has been tolerated, and in essence, condoned for more than ten years, to my personal knowledge.

My husband and I brought the matter of Dennis' behavior, in our particular case, to the attantion of the priests at St. Thomas Church when it became known to us, begining in 1980. And on many occasions, I might add.

DITFIDENTIAL

It was very difficult for me to sit through masses he piously participated in expounding Christian virtues, and on may occasions, on the problems of victimization of our youth through the use of drugs.

He was the adult we entrusted our children to in teaching Catholic moral ethics, and in reality, he was the adult who introduced my son to drugs in the 8th grade where he was a student at St. Thomas School.

As a result of his influence and actions, our family, and in particular, my son, has spent the last ten years trying to pick up the pieces, rebuild the damage to his spiritual being and his personal self esteem, which will be forever affected.

I took my son out of public school in his early elementary education because the confusion of living with a standard of ethics at home and a virtual "free for all frenzy" of no discipline or direction in the public school system. We enrolled him in Catholic School to learn the Christian standards we were trying to ingrain in him at home, and under tremendous financial sacrifice.

I guess what I am saying is that I am angry that Dennis was quietly allowed to "phase out" of the Church, and over such a longperiod of time. I shutter to think how many other children in our diocese may be quietly carrying a secret of shame this man perpetrated under the the trust of the Church. It must be very anguishing for them. I will pray for them to find the courage to speak out in light of this arrest, and find Peace somewhere. In my professional life, I am exposed daily to the horrendous injustices imposed upon people in the secular realm. Fortunately, some of those find relief through divine spiritual guidance. Unfortunately, some find themselves at the mercy of people such as Dennis Jost.

I hope you will hold this latter in confidentiality. It is between you and I and Christ. No other member of my family knows that I have contacted you.

# Charge alleges man took boy, planned sex

A Riverside man was arrested yesterday on a federal indiciment charging him with taking a minor across state lines with the intent of engaging in sexual activity, authorities reported.

Federal court Judge Charles F. Elck ordered a \$50,000 bail for the release of Dennis Raymond Jost, F 50. He also ordered Jost to wear and electronic monitor, not to associate with minors and to undergo psychiatric counseling, according to Assistant U.S. Attorney Jean E. Gilliland, who is prosecuting the case.

The May 7 indictment alleges, that between July 14, 1990, and Aug. 5, 1990, Jost transported a male minor from Riverside County, to Tucson, Ariz., and Albuquerque, N.M., with the intent that the minor engage in sexual activity in violetion of the laws of both states, Gillfland said.

Jost was unavailable for com-

The case was investigated by the. FBI and the Riverside Police Department. according to FBI Spokesman Ron Heller.

If Jost is found guilty, he could, be sentenced to a maximum of 10 years in federal prison and fined \$250,000, according to the FBI. Gilliland said Jost is sentential

### SERMON on the MOUNT

Sermon on the Mount

Matthew takes the words of Jesus from his wources, Mark, Luke and Quellen, but recasts them in time and situation. This recasting does create a whole new context and emphasis for the words of Jesus. Matthew, himself probably aconverted pharisee, is attempting a catechesis, an in depth study of the words and deeds of the Master for Jewish Christians. His Gospel presupposes that his audience is already familiar with Mark and are lookin for more instruction and a deeper understanding of Jesus' teaching.

Mathew's Gospel written in Greek around 85 A.D. was very polemical. Because the Jewish Christian community was under pressure from the larger Jewish community, Matthew designed his sermon to illustrate Jesus' authority over Moses' (without putting Moses down), the superiority of the new law over the old, and the nature of true worship and discipleship over false piety and words without deeds. Matthew is ambiguous intentionally about the audience at the Mount because he wants to include a condemnation of the old Isreal of the pharisees in favor of the New and Real Jerusalem. And so he curses those who heard His words and saw His works but who refused to believe.

We know that Matthew constructed the present format of the sermon as we have it, because when we compare it to Luke's we see that he has twice the amount of material. Matthew took a lot of material that Luke situated elsewhere and tied it into the sermon because then he coul present a more complete teaching on any given subject. For example, after previding the desciples with the proper motives and attitudes of proayer Matthew has the Lord instructing them on the how to proy. He gives us the Our Father: Luke does not record that until near the end of Jesus' ministry. Matthew also tips us off about his redactive activity when he begins and ends his sermon with the stereotypic formulas that earmark his other four descourses. Ane then he includes remarks about all of his major concerns: Jesus' authority; the endtime; the missioning of the Apostles; the conunuity of the old and new law; and discipleship.

The sermon is related to the whole of Matthews Gospel in that it expresses all that Jesus came to say; It is the "quintessence" of the Gospel. The sermon on the mount really is a PEAK experience for Matthew. Recalling Moses on Mount Sinai, Matthew sets Jesus on another high and holy place, The other peak experiences recorded later echoe this theme again and again. Peter is christened the "Rock". Jesus relationship to the Father is revealed while on a mountain and then the references made to a mountain in Galilee. All of these events presume that the reader is knowledgable of the content and parallel made at the sermon on the mount.

Christian discipleship for Matthew is participation or membership in the Kindom of Heaven which begins with Jesus. Christianity is presented as a new Way of living, a new Torah, a fuller happier life. This new way involves faith atitudes and deep trust in Jesus. And although many radical challenges are made to previous values, Christian living is also practical in that it places and orders our priorities by putting everything in its proper perspective. Christian living then will bring us real deep, true and lasting joy. However, discipleship does exact a price - real deep and painful suffering for the sake of others. The perfection or completness and wholeness that we are called to be in Christ makes us conessuers of the contingencies of human existence. Love of one's enemies is perhaps the tastiest morsel in this love feast. Christianity is for Matthew, the assembly of the people of God.

There are three basic types of interpretations given to the sermon on the Mount reviewed by J. Jeremias. The first that he cited was called the perfectionist ethic. Those who interpret the sermon in this way would have us believe that Jesus really gave us just another legalism, another lego-centric moralty. We can easily see that this interpretation is really quite contrary to the spirit of the One who said that man was made not for the Sabbath. And, if Jesus meant to merely give us a new legislation then He failed to cover a good many moral issues in His sermon. Jesus is the fullfillment of the law.

The second major trend, a real trip for Protestants, is called the impossible idea theory. Here we are given to believe that Jesus would challenge us way beyond our human capabilities inorder to embarass us into a spirit of humility. To me it is unlikely that if Jesus wanted this effect that within the same breath He would call us the Light of the world and the salt of the earth. Nor is it in Christ' spirit to put people down who are trying or willing to try no matter how many times we might fail. He seems to loose patience with those who made no effort at all.

A third interpretation is that of the interim-ethic. Jesus believed as his followers did that the end time was upon them and that in this era of emergency people could behaverin an extraordinary manner. Heroic sacrafice could be expected if the world was going to end any minute. Well, we already know that Matthew wrote about fifty years after Jesus' departure and that He had not returned as soon as expected. Matthew was writing for a church that had gotten down to the nitty gritty of daily Christian life.

J. Jeremias offers us another possible interpretation that Ellis builds on. Those who heard and those who would read the Sermon on the Mount are expected and can live according to the Way. Remember that we are a people transformed by a new knowledge, a divine revelation, by grace, by the compassionate love of the person of Jesus. If we but trust in Him than we can do all that he did and more! The beatitudes are not a new set of regulations but "sysmptons" of a new holiness.

When we compare the beatitudes as written in Matthew's Gospel to those recorded by Luke we notice tremendous differences. Matthew presents us with eight or nine while Luke offers us four beatitudes and then a additional four woes that Matthew renders in the latter part of his Gospel Then Matthew adds phrases that seem to shift the meaning of the words. He spiritualizes the saying of Jesus while Luke is for more liteal and socially concerned. By eliminating those protions of the beatitudes that are not common to both versions, (that are obviously Matthean or Lucan in orgin), we can surmise what Jesus did say in his famous discourse.

Because Matthew was writing to Jewish Christians who were already familar with the concept of the blessedness of belonging and depending on God alone, he took liberties with his source material for the sake of further instructions in the moral and spiritual life. Luk's Greek audience had no such background and had entirely different needs to which Luke would respond. Matthew added phrases like "in spirit" and for "justice", "the merciful", "the pure of heart" and "the peacemakers" inorder to explicate what he felt Jesus meant when He originally spoke those words. Luke's audience must have been living in the most primitive conditions when he addressed them with the most primitive meanings possible for the words of Jesus. In fact by adding the word now to his beatitudes and woes he becomes more literal and more immediate than Jesus meant to be when He spoke them! And it is likely that Luke changed the indirect address commonly used in all scriptures for beatitudes to direct address inorder again to edify his suffering have-not community. In several other places in his Gospel Luke appears to opt for the second person. Luke's design and purpose here is quite deliberate and obvious. He, with his blesseds and woes, has constructed a series of antithesis meant to console people who were really poor. Mathew''s poor in spirit were neither necessarly poor or rich, but simply Christians in need of moral and spiritual direction.

It is my bias that Matthew's version is more meaningful and closer to the meaning of Jesus' words. Luke, however, because of his reluctance to add to his source material, more closely approximates what Jesus actually said. Both, of course, were spoken under the inspiration of the Holy Spirit to the felt needs of their communities and I am "blessed" to hear these words take on new life for me.

My primary sources for this paper are: Ellis' <u>Matthew</u>, Jeremias' <u>The Sermon</u> on the Mount, Senior's <u>Matthew: a Gospel for the Church</u>, notes from this class, and of course Matthews Gospel and appropriate parallels in Luke's Gospel.





### FIRST SUNDAY OF LENT

### Theme: New Beginnings

Spring is the new beginning of the earth. New Signs of life show that winter is past. Nature begins again a new awakening, a new color, a new life. Along with the beginnings of new life comes also the violence that accompaniew re-birth: the floods, the storms, the tornadoes. The human experience of beginnings carries with it some of the gentleness and some of the turmoil of spring. But both are necessary to produce new life, new growth. Lent is the church's springtime. It is the time for each Christian and the Christian community to be reborn in gentleness and in violence to new life in Christ.

#### <u>Symbol: Water</u>

Water is at the center of our lives. We are born out of it. We aresustained by it. We drink it. We swim in it. We wash in it. Sometimes the power of water is mighty, cometimes gentle; but it is always mysterious. As a mighty force, it extinguishes fire and generates electricity. In its gentle flow, it cleanses and heals. The church has always used the tangible to speak about the great mysteries of faith. The church uses water as a sign of death-resurrection, a sign of new beginnings. Plunged into water at Baptism, the Christian emerges to new life and new beginnings. Through water and the Spirit, this new person is received into and welcomed by the Christian community. Water is the symbol of this new life.

#### Sunday Celebration Suggestions

Rite of Sprinkling with Water. Bless and sprinkle the assembly with water. Rite to take place at the symbol place. Be generous so that the people fell the water.

SECOND SUNDAY OF LENT

#### Theme: Wholeness

If you have ever tried to put a jigsaw puzzle together, you know that it is easier to do if you have a vision of the completed whole. Without such a vision, putting the pieces together becomes frustrating and often impossible.

Achieving wholeness of life may be compared to putting the pieces of the puzzle together. Having a vision of the meaning of life enables us to become whole, or holy.

Where do we find this meaning? How do we achieve a vision that will sustain us through the difficult choices and tests of life? Such a vision comes to the Christian community through the life-death-resurrection of Jesus. Jesus brought Good News that lends unity, peace, and direction to life. Listening to and accepting this Good News enables us to bring the pices of life together and achieve wholeness within ourselves.

#### Symbol: Salt

Salt is not eaten by itself. It is sprinkled on other foods in order to bring out the fullness of their flavor. Salt gives wholeness. It has its own taste, yet it loses itself in transforming the food that seasons. It becomes one with that with which it is united, and both the salt and the food are transformed.

In biblical tradition, salt was a sign of covenant. The covenant partners became one through the sharing of salt. Wholeness in relationship was signified. In the catechumenate, candidates for membership in the church are given salt as a sign of incorporation into the community. They become one with the community, yet they do not lose their own identity. Both church and catechumens are transformed as they become one.

#### Sunday Celebration Suggestions

Display a salt block at the symbol place. Loose salt could be poured over and around the salt block.

Achieving wholeness is part of the journey of Christian life.

Faith calls us to wholeness.

Discipleship is apattern of wholeness, or holiness in life.

Accepting discipleship is an invitation to transformation.

#### THIRD SUNDAY OF LENT

#### Theme: Changing

Habits are not easy to change. Yet the events of life are constantly calling on us to change our ways. A new job or the loss of an old one, financial crises, sichness, the growing independence of our children the beginning of a new love relationship, all call on us to change in some way. There is a natural human inclination to resist change. We are comfortable in our self-designed ruts. Change in our way of life is costly.

The Gospel is always calling on us to change and row. Jesus preached a message of conversion. Turn away from evil. Turn toward God. Conversion is the everday experience of choosing or refusing to grow. Lent is the time when the church stops and reflects on what changes the Gospel demands of us.

#### Synbol: Fire

Fire gives light. It gives heat and warmth. Fire consumes and transforms, destroys and creates. Fire purifies and refines. Fire describes anger and revenge as well as love and devotion.

The mystery of fire brought the Hebrews to associate God's presence with fire. Moses describes his first call from God in terms of a flaming bush that did not consume itself. The Israelites were led through the desert  $\pm$ by a "pillar of fire." As Moses and the Israelites camped at the foot of the mountain, "Mount Sinai was all wrapped in smoke, for the Lord came down upon it in fire" (Ex 20:18). God's presence among the people was likened to a consuming fire that gathered all into itself, uniting while purifying.

Fire symbolizes for Christians the Spirit of God among us. The Spirit descended as tongues of fire on the assembly at Pentecost. The Spirit is a fire that purifies, creates, refines, destroys, and transforms - if we let the Spirit do so.

#### Sunday Celebration suggestions

Put water in a clear goass bowl, about two-thirds full. Add enough cooking oil to bring the liquid level near the top of the bowl. Place floating wicks on the oil. At the beginning of Mass, light the wicks. This produces a firelight effect, especially if other lights are dimmed.

#### Reflections for homilist

We have all kinds of habits.

The Christian way of life is a moral way of life.

Sin and guilt need to be coped with.

#### FOURTH SUNDAY OF LENT

# Theme: Being Loved

Being loved is always a surprise. The love of another thrills and excites us. It supports us in all that we do. It enables us to value ourselves; and even when we recongnize our own self-worth, being loved is still a Startling experience. Are we worth of this devotion? We wonder, even as we are continually re-created by the experience.

The realization that we are really loved by God is difficult to grasp. Yet the signs of God's love are all around us. The incarnation, the becoming human of the Son, is the Father's fullest sign of his love for us. It is a startling sign. If we believe it, this sign should support, thrill, excite, and re-create us.

#### Symbol: The Cross

In ancient times the cross was an instrument of execution. It was used to punish slaves and non-Romans who had committed heinous crimes, such as murder or rebellion. The cross was a sign of infamy and treason.

With Jesus' death on the cross, it has become a sign of contradiction. For Christians it is no longer a sign of infamy, but a sign of the vulnerabelity of love. Loving and accepting love require a death to self. But death is not the end. Jesus' death was followed by his resurrection. The cross as death symbol is also a resurrection symbol. It is a symbol of love.

#### Sunday Celebration suggestions

Highlight the church building's central inside cross or crucifix. This can be done by spotlighting the cross and dimming other lighting.

Prepare the congregation in advance for making the sign of the cross slowly and in silence this week.

Reflections for homilist

Love stories are always popular.

Loving and being loved are transformative.

The Christian life is a way of love.

God's love offers us salvation.

Lent is a time for reflecting on God's love for us.

#### FIFTH SUNDAY OF LENT

#### Theme: Community

Every one of us needs other people to support us in our daily lives. We need community. Community is not the same as a association of people who happen to meet occasionally for a particular purpose. Community is formed as people share experiences, ideals, and vlaues. Support, service, encouragement, and sharing of life are mutually given and accepted in community.

The dhurch is meant to be such a community; not just the universal church, but the local church. The church is a community of people who are joined together by a common faith in Jesus as Lord. This faith compels them to proclaim God's word, to live in unity, supporting, serving and sharing life together, and to celebrate their life as church in the eucharist.

#### Symbol: Wheat Bread

Breadmakin is a process in which each element dies so that a new creation can come into being. The seed dies in the ground so that the wheat may live. The wheat is crushed to produce grain that can be converted into flour. The flour is mixed with other ingredients and finally baked so that the bread may be broulght forth.

At each stage of the bread-making, human energy is expended. Many people join together to produce the loaf. The farmer toils as he or she plants the seed and garvests the wheat. Millers grind the wheat into grain, and truckers carry it to the graneries. Bakeers mix the flour and yeast and carefull tend to the baking. Human life is given every step along the way as the seed becomes the loaf. Bread symbolizes the life of the many who work together to produce that which feeds and gives life to all.

The human community is sustained by bread in its many forms. The Christian assembly gathers to eat that bread which symbolizes our life, Christ's Body. We are all fed by the same holy bread. We all become that which we eat, the Body of Christ.

#### Sunday Celebration Suggestions

Display an arrangement of a loaf or loaves of wheat bread and wheat sheaves in the symbol place.

The breaking of the bread is a significant ritual action, not just a functional prepartion for communion. Emphasize the breaking of bread this week.

#### Reflections for homilist

Alienation is a mark of our times.

Christians also experience the need for support in community.

Growing is a community process.

The community of faith must be like Jesus

#### HOLY WEEK

CONTRACT STATES

There is only one week of the year we call "Holy." The week is so named because it calls us to holiness and it commemorates the last holy days of the Lord Jesus. In this week we remember our Christian roots and look forward to our reunion in resurrection in the fullness of God's reign.

"Holy Week" calls us to holiness. It calls us to the cross. It calls us to enter into the great mystery of the Lord Jesus' deathresurrection. Sunday, the beginning of Holy Week is the time when we gather together to proclaim the Lord's Passion, a passion we all share as we move from the sufferings of one day to the next. Holy Week begins with the proclaming of the Passion and culminates with the Alleluia proclamation of Easter.

But Holy Week does not exist in a vacuum. Everything that we have done during the weeks of Lent builds us to this week. We are preparing to enter into the fullness of the mystery of the suffering, death, and resurrection of the Lord Jesus. The shared prayer, shared faith, shared living out of Lent in our daily lives all lead us to the week in which the church remembers all that God has done through Jesus for us.



# Molestation of Children in the Family

#### BY ABIGAIL VAN BUREN.

DEAR ABBY: This concerns the letter from the woman who wrote to say that her brother might be , sexually molesting his stepdaughter. As district attorney, in the past seven years I have personally interviewed 140 men who have sexually molested children in their family. While long-term intensive therapy may be successful in treating some offenders, voluntary or self-referrals are almost never successful. If the offender had the self-control and initiative to stay ; involved in long-term treatment necessary for rehabilitation, he would most likely not have molested the child in the first place.

I would urge you to tell your readers who suspect that a child is being molested to immediately contact their local child protective unit or the police department.

Some jurisdictions have programs that provide treatment without incarceration for incest offenders and their families where evaluation indicates that treatment will be successful. Specifically excluded from these programs, however, are pedophiles-individuals with a specific sexual preference. for children. Most experts agree that there is no known successful treatment for these individuals, and they should be incarcerated. DENNIS W. MOORE, DISTRICT ATTORNEY, JOHNSON COUNTY COURTHOUSE, Olathe, Kan.

## Dennis Jost was accepted into the Deacon Formation Program in June of 1983. At that time some signs of a lack of maturity showed in psychological testing and his pastor expressed concern in this area. Some of that was laid to the fact that he had never been matried. It was also noted that Dennis' primary ministry involvement had been liturgical but the committee felt the program could have impact in helping Dennis to grow and mature and broaden his ministry focus.

In October, 1984, Fr. **Constants** spoke to **Constants** of his deep concern over an incident involving Dennis while he was in St. Peter & St. Paul parish during Fr. **Constant**'s pastorate. He asked if Dennis had informed **Constant** of the facts before he entered the Diaconate Program as he felt they should be considered carefully before deciding for ordination as they had ramifications for a public minister in the Church. **Constant** had not been informed.

had a conference with Dennis during which he stated he had been advised by a "spiritual director" to "forget and move on" and so he hadn't thought it necessary. At that meeting explained clearly that ordination is given for the good of the People of God and therefore the people, as well as the Bishop and Official Church, must be protected from scandal wherever possible. She gave clear indication of her hesitancy to continue Dennis' candidacy. He seemed devastated. She insisted that certain steps be taken, i.e., that he seek an evaluation from the courselor whom he had worked with at the time of the incident, and that he confer with Fr. Exercise. He was told at that time that his continuation in the program was probationary, depending upon the outcome of consultations with the psychologist and Fr.

Months passed and Dennis had to be reminded several times to locate and consult with the psychologist. There was evidence of lack of maturity on Dennis' part during this time. He seemed to take the child-like attitude that if he just did nothing it would all go away.

In time had another conference with Dennis, where she insisted he confer with Fr. (1997), and Deacon (1997) and the psychologist. Thus began a frustrating saga of Dennis' inability to hear and interpret what all parties were saying.

On February 25, 1985, Dennis met with Deacon **(Dennis)**, Fr. **(Decent)** and At that time it was made very clear to Dennis (or so we thought) that he would not be ordained until he got further counseling. He was given the option to remain in training if he told his classmates he was not intending to be ordained. Dennis' immaturity had become increasingly evident as the months went on. Also apparent was his single-minded focus on liturgical ministry, the training of altar boys, etc. His unhealthy <u>need</u> for Diaconate became very apparent to all of the staff of the program.

It became the consensus of those persons involved as staff and consultors that Dennis was not ready at this time to go FORWARD FOR CANDIDACY or ORDINA-TION.

Dennis was told this and expressed shock. He claimed he had no idea that this was to be the decision. REVIEWED WITH HIM the process they had been through since 1984. Again, the sign of immaturity-he apparently had not "heard" what everyone involved had been saying. (Or was not able to accept it.)

In the past few months Dennis has been to several priests and deacons-Fr. Deacon Deacon He has expressed to Deacon his anger and his inability to "get over it." He has pleaded with Deacon to take up his "cause."

Dennis' behavior indicates a disturbing lack of maturity for a man in his forties. His "need" for Diaconate borders on obsession. I met with Dennis Jost this morning, gave him the attached report signed by the committee, and at that point told him he was no. longer considered a candidate for the Permanent Diaconate.

It is the considered opinion of the committee, Fr. **Sectors**, Deacon **Sectors**, and myself, in consultation with several others that Dennis is not suited for ordained ministry in the Church, and that the people of God of the Diocese of San Bernardino will not be well served by his ordination.

Dennis Jost was accepted into the Deacon Formation Program in June of 1983. At that time some signs of a lack of maturity showed in psychological testing and his pastor expressed concern in this area. Some of that was laid to the fact that he had never been married. It was also noted that Dennis' primary ministry involvement had been liturgical but the committee felt the program could have impact in helping Dennis to grow and mature and broaden his ministry focus.

In October, 1984, Fr. **Considered** spoke to **Considered** of his deep concern over an incident involving Dennis while he was in St. Peter & St. Paul parish during Fr. **Considered**'s pastorate. He asked if Dennis had informed **Considered** of the facts before he entered the Diaconate Program as he felt they should be considered carefully before deciding for ordination as they had ramifications for a public minister in the Church. **Constant** had not been informed.

had a conference with Dennis during which he stated he had been advised by a "spiritual director" to "forget and move on" and so he hadn't thought it necessary. At that meeting **see and therefore** the people, as well as the Bishop and Official Church, must be protected from scandal wherever possible. She gave clear indication of her hesitancy to continue Dennis' candidacy. He seemed devastated. She insisted that certain steps be taken, i.e., that he seek an evaluation from the counselor whom he had worked with at the time of the incident, and that he confer with Fr. **Second**. He was told at that time that his continuation in the program was probationary, depending upon the outcome of consultations with the psychologist and Fr.

Months passed and Dennis had to be reminded several times to locate and consult with the psychologist. There was evidence of lack of maturity on Dennis' part during this time. He seemed to take the child-like attitude that if he just did nothing it would all go away.

In time had another conference with Dennis, where she insisted he confer with Fr. (1997), and Deacon (1997) and the psychologist. Thus began a frustrating saga of Dennis' inability to hear and interpret what all parties were saying.

thought) that he would not be ordained until he got further counseling. He was given the option to remain in training if he told his classmates he was not intending to be ordained. Dennis' immaturity had become increasingly evident as the months went on. Also apparent was his single-minded focus on liturgical ministry, the training of altar boys, etc. His unhealthy <u>need</u> for Diaconate became very apparent to all of the staff of the program.

It became the consensus of those persons involved as staff and consultors that Dennis was not ready at this time to go forward for candidacy or ordination.

Dennis was told this and expressed shock. He claimed he had no idea that this was to be the decision. The reviewed with him the process they had been through since 1984. Again, the sign of immaturity—he apparently had not "heard" what everyone involved had been saying. (Or was not able to accept it.) In the past few months Dennis has been to several priests and deacons—Fr. Deacon Deacon and Deacon and Deacon among them. He has expressed to Deacon to take up his "cause."

Dennis' behavior indicates a disturbing lack of maturity for a man in his forties. His "need" for Diaconate borders on obsession. For those reasons, as well as his other problems, it is the discernment of this committee that Dennis does not have a call to the Diaconate of the Diocese of San Bernardino.





## Ex-worker with altar boys gets 6 months in prison

#### The Press-Enterprise

We are proceeding with the counseling for our alter servers A.S.A.

A Riverside man who worked with altar boys at two Riverside churches was sentenced Tuesday to six months in federal prison for transporting a young boy across state lines for sexual purposes, officials reported.

Dennis Raymond Jost, 50, pleaded.guilty to the single charge and was sentenced by U.S. District Court Judge Robert M. Takasugi in Los Angeles.


The judge also sentenced Jost to three years of probation and required that he not associate with anyone under the age of 21 during that time, said Special Agent Karen Gardner of the FBI office in Los Angeles.

Jost faced a maximum sentence of 10 years in prison. He was arrested May-14 on a federal indictment that alleges he took a Riverside boy to Tucson, Ariz., and Albuquerque., N.M., between July 14, 1990, and Aug. 5 1990, with the intent that the minor engage, in sexual activity. Such activity violates laws of both states.

Dennis Raymond Jost, 50, pleaded guilty to the single charge and was sentenced by U.S. District Court Judge Robert M. Takasugi in Los Angeles.

The judge also sentenced Jost to three years of probation and required that he not associate with anyone under the age of 21 during that time, said Special Agent Karen Gardner of the FBI office in Los Angeles.

He was arrested May 14 on a federal indiciment that alleges he took a Riverside boy fo Tucson, Ariz, and Albuquerque, N.M., between July 14, 1990; and Aug. 5 1990, with the intent that the minor engage in sexual activity. # Suit alleges sexual battery by ex-altar boy coordinator

RIVERSIDE A former coordinator of altar boy services at two Riverside churches has been sued by a boy he allegedly conspired to have sex with.

In the suit, which comes four weeks after Dennis Raymond Jost was ordered to stand trial in federal court, the youth alleges Jost did more than conspire to have sex with him.

Jost, 50, of Riverside, "did commit on at least four occasions physical and sexual batteries upon" him between April and August of 1990, according to the suit. Further, the suit alleges Jost threatened to kill the boy if he told anyone about the "physical and sexual batteries," and that he put an unspecified "dangerous drug" in the boy's "food or drink."

The suit also alleges false imprisonment, claiming Jost forced the boy "to stay, or go somewhere, against his will."

The suit does not say whether the Riverside County youth was an altar boy, but one of the incidents allegedly took place at Queen of Angels Catholic Church in Riverside.

Also named in the suit are the Catholic Church's Diocese of San Bernardino, Queen of Angels church and Bernard Waltos, former pastor of the church. The other Riverside church where Jost worked as a volunteer, St. Thomas, was not named in the suit,

According to the suit, those named "had actual or constructive knowledge" of Jost's "criminal record involving sexual assaults against minor boys."

The Rev. Ron Rocky, pastor of Queen of Angels, said he did not know about the lawsuit. He said Waltos, his predecessor, has been transferred out of Southern California.

Diocese officials could not be reached for comment yesterday. But in May, Rev. Donald Webber, moderator of the curlae for the diocese in San Bernardino, said of the criminal case. The Bishop has written a letter that he asked be read at all Masses at Queen of Angels.







Dear Brothers and Sisters in Christ:

The people of God are not immune from difficult and troubling times. The past few weeks have been such times for our Diocese.

During this period, the people of the Riverside area have been subjected to a barrage of press coverage concerning sexual abuse by priests and a lay volunteer. Recent reports have centered around separate and distinct allegations of sexual misconduct towards minors. Two of these allegations pertain to conduct which purportedly transpired six and twenty-two years ago, respectively. We are currently addressing these allegations in a context of clear and forthright actions, coupled with candor towards our parishioners and sensitivity to those directly involved. Our actions have included reaching out to the purported victims and their families.

The extensive coverage by the Riverside <u>Press Enterprise</u> over the past two weeks could be misinterpreted as indicating that this matter is uniquely a Catholic issue, or that child abuse among clergy is in disproportion to other sectors of our society. Such, is not the case at all. However, even one allegation is one too many. Even one case of proven child abuse is wholly unacceptable. That such allegations may involve a member of the clergy, regardless of denomination, must be condemned.

During the past several years, the Diocese of San Bernardino, together with the rest of society, has increased its awareness of the tragic effects of child abuse in its many forms. Most abuse of children takes place in the home; some studies suggest that sixty percent of child abuse occurs in this environment. Providers of child services account for about twenty percent. If the Riverside <u>Press Enterprise</u> would give as much coverage to the overall problem of child abuse as it does to alleged clerical offenders, child abuse as a societal problem would be better served. However, perhaps the disproportioned attention Catholic clergy abuse cases have received in the United States has rendered a service to our Church. We are now far more aware of the problem and far more active in prevention, not only among Church clergy, but within the context of our entire society.

The Church in San Bernardino and Riverside counties has taken steps to address the problem of child abuse, both to clergy, religious and lay leaders, and to society as a whole, as this problem impacts our entire social fabric. The Diocese has held classes and workshops to help recognition of abuse, and what to do when the signs of abuse become apparent. Guidelines have been developed and distributed to church personnel. Brothers and Sisters in Christ. May 7, 1993

Action has been outlined concerning proper handling of the offender, and the necessary steps for outreach and sensitive assistance to the victim.

It is anguishing that any priest is the subject of allegations. Assistance is being given to these priests. However, all priest of our diocese are affected by such charges. They sense that aspersion is cast over all them. Some feel abandoned, even betrayed, especially by the extensive press coverage. They do not abuse children; on the contrary, they actively assist in helping to prevent child abuse in their parishes, and counsel and assist victims. I can confirm the dedication and hard work of the priests of our Diocese. They are extremely dedicated and are carrying a heavy load due to the rapid increase of population in our two counties. I ask for respect and support for our priests.


As Christians engaged in Christ's work, we need to reach out to victims and assist them in getting the help that is available. Your local parish knows how to put you in contact with qualified professionals. Become aware of the signs of possible abuse in any form, and take the necessary steps to report and stop it. Cases which go unreported only compound the evil.

Use the resources of the Diocese such as workshops, speakers, and materials on child abuse and reporting. For further reference, the diocesan policy handbook is made available to all school personnel and those involved in our parish work. Catholic Charities can also provide highly professional counseling in this area.

Finally, I ask for your prayers. We must ask for the power and grace of God to confront this demon in our Church and community. In the end, God's almighty power and love will triumph. Nearly two thousand years ago, God's miraculous power transformed the tragic event of Good Friday into an Easter Sunday. Pray that Christ through his Church may help us today pass from our present Good Friday to an Easter Sunday of love and peace, in Christ, and with one another.





We wish to advise you that once allegations were made known with regard to Mr. Jost, he was immediately suspended from any voluntary duties which he may have had at the parish.

We remain concerned about the privacy of all parties involved, and, as such, we believe it is not appropriate to provide further details of the report. We have kept in touch with diocesan officials in order to complete all technical procedures and have given the fullest cooperation to the confidential investigation.

We wish to underscore that any person, especially minors and their families, who has been emotionally distressed or in any other way effected by the circumstances surrounding what has occurred should be aware that we stand ready to provide the benefit of counseling without the need for families to incur personal costs.

If you would like further information regarding what is available and how we wish to be of assistance, we would appreciate hearing from you. Be assured that all technical and legal steps which are being taken will be followed to a resolution as quickly and as justly as possible.

[At this point the pastor may like to write a spiritual message consistent with the faith showing our responsibilities as Christian disciples. Perhaps it would be appropriate to insert a prayer to Our Lady Queen of Angels asking that she radiate some light and rays of hope into this dark period of the parish.]

We will continue to make a pastoral response to a very sad situation without in any way condoning or ratifying the conduct of any person.

The church continues to express great concern and prayers for those effected by this tragic situation and will continue to offer its counseling services to our parish.

#### STATEMENT ON BEHALF OF BISHOP

Bishop **Construction** this week reported that the Diocese supports a full and complete investigation of allegations-made against the voluntary Director of Altar Servers at Queen of Angels Parish in Riverside, Dennis Jost. He has asked that provisions be made with respect to the rights of all persons so that the same may be protected.

The Bishop has written a letter that he asked be read at all Masses at Queen of Angels.

The Bishop has extended his concern and sympathy to all effected persons, most particularly, the families involved. The Diocese of San Bernardino will, as always, be available to help the families in their time of need. All resources of the Diocese have been committed toward that end.

Police in the City of Riverside have been investigating allegations and improprieties regarding Dennis Jost. The Bishop has further stated that it would be inappropriate to comment on the allegations against the accused while the matter is in the court system. The Diocese has and will continue to cooperate with all authorities in the investigation.

Bishop bishop is extremely saddened by the allegations and his immediate and primary concern is and will remain reaching out toward the young people who may have been effected in any way as well as their families and friends. A personal letter has been sent by Bishop bishop to the people involved. In the letter, he offers confidential special counseling services to the families at no expense to them.

The Diocese and the Bishop will continue in every way to cooperate with authorities and do whatever is necessary and possible to assure that there is complete justice.
