Dear Karl and Sofie,

I wish to extend my condolences and prayers to you on the death of your brother Father Franz. His funeral services was celebrated at Our Lady of the Rosary Cathedral on Wednesday April 27th which turned out to be a beautiful day, after some early rain. I was very pleased that I was able to celebrate the Funeral Mass for your brother and give the homily. I am sorry you were unable to attend the services honoring your brother, but understand that the long distance made it impossible.

The funeral was attended by a number of the priests and also some of Father Franz's old friends from his previous parish in Trona and Ridgecrest. I am enclosing a copy of the note we sent to all the parishes, throughout the diocese, as well as to the Diocese of San Diego, announcing the services for Father Franz.

Your brother was a very fine priest and it was a pleasure to have him as part of the Diocese of San Bernardino. He, of course, started when this area belong to the Diocese of San Diego and since he was serving in Trona when we became a diocese in 1978, he had the privilege of being a part of the new Diocese of San Bernardino. He then retired in 1982.

I am sorry that the stroke so disabled him during his retirement years, but it was a miracle, taking into consideration the seriousness of the stroke, that he was again able to walk and have the ability to speak, although somewhat limited. The Sisters of Nazareth in San Diego, which is a special home for priests, took very good care of him in his latter years. I

was glad that he was able to be in their loving care. I saw Father Franz about two weeks before he died and spent some time praying with him. He was very alert, but it was impossible for him to speak other than a few words of German.

Father Franz is now with the Lord and I will continue to keep him in my prayers and Masses. I will also remember both of you and ask Almighty God to console you and strengthen your faith as your brother enters into eternal life.

Regarding his personal belongings, such as pictures etc., they have been given to his friends in Ridgecrest, who have been in contact with you. They said they would forward to you the items which you desire.

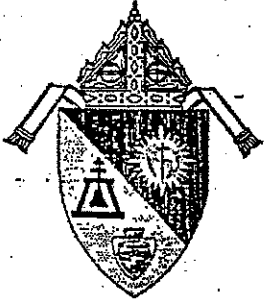

Dear Brothers and Sisters in Christ,

It saddens me to inform you that Reverend Franz Robier was called to his eternal rest, over the weekend, at Nazareth House in San Diego. Father Robier retired from the active priesthood in 1982. He suffered a stroke approximately 5 years ago and has been in residence at Nazareth House since that time. We pray that he may enter now the joy of the Most High, whom he trusted, loved and faithfully served.

Father Robier was born to Franz Robier and Maria Moser on March 2, 1912 in Kaindorf bei Leibnitz, Austria. He attended elementary school in Leibnitz, Austria, high school in Linz, Austria and the seminary in Salzburg. He was ordained to the priesthood on May 24, 1936 in Salzburg for the Diocese of Espirito Santo, Brazil. Father Franz was a man of many talents and spoke German, Portuguese, as well as English.

He served for eighteen years as a missionary priest in Brazil for the Diocese of Espirito Santo. In May, 1955, he wrote to Bishop Charles F. Buddy, requesting permission to serve in the Diocese of San Diego. His first assignment was Holy Spirit Parish in San Diego. He also served at St. Joan of Arc in Victorville and his final assignment before he retired was at St. Madeleine Sophie Barat in Trona where he served for 7 years.

On May 24, 1976, Father Robier celebrated his 40th Anniversary of ordination to the priesthood. Bishop Leo T. Maher granted him permission to return to his native Austria and celebrate this special occasion with relatives.

The Vigil Service will be celebrated on Tuesday, April 26, 1994 at 7:30 p.m., at Our Lady of the Rosary Cathedral, San Bernardino. Father Mel Collier from Saint Michael Parish in San Diego will preside. On Wednesday, April 27, 1994 at 11:00 a.m., Bishop Phillip F. Straling will celebrate a Funeral Mass for Father Franz at Our Lady of the Rosary Cathedral, San



Dear Reverend Collier:

This is to confirm our telephone conversation of June 7, 1991 wherein I advised you that I would be assisting Margaret Grams and Joe Sonia in the termination of Father Robier's interest in Homewood Canyon property. Since Father Robier no longer resides in his trailer, Father Robier's interest in the Homewood Canyon property owned by Margaret Grams and Joe Sonia is terminated. In order to preserve clear title in the property, I request that a Quitclaim Deed be signed by Father Robier's personal representative quitclaiming all interest in the property to Margaret Grams and Joe Sonia.

You advised me that Father Robier's personal property was being sold. Access to all personal property is through the real property owned by Margaret Grams and Joe Sonia. Therefore, please contact Margaret Grams or Joe Sonia for permission to enter the property before any person does in fact enter the property to remove the personal properties. When the personal property is removed, please ascertain that the premises is left in a clean condition and that all improvements constructed upon the land by Father Robier are removed. It is further requested that the neighboring lands of BLM are likewise left in a clean and clear manner so as to insulate Grams and Sonia from any claim of BLM that, as the adjacent neighbor, they may have caused clutter or encroachment upon their lands.

Please have your attorney contact me at his earliest convenience so that we may coordinate this termination and removal.

Trona has paid yearly 590 dollars to the Catholic Mutual Relief Society of America for more than 25 years and never had any claim made for repairing or damaging the church structure.

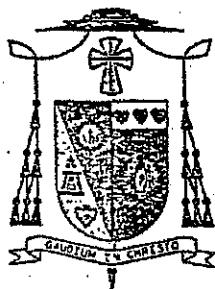

We have been advised by the adjuster that the engineer has completed inspection of the parish premises.

They have provided us with a detailed report indicating the walls have a consistent cracking pattern adjacent to many of the pilasters vertically. They say the cracks are apparently due to thermal stresses and are located along grouted and ungrouted cells of the panels. They indicate there is no detrimental structural cracking and that the terrazzo flooring had only minor cracking and no apparent foundation failures. They conclude their report indicating it is their opinion that the exterior walls have cracked primarily from stresses due to the type of construction. They say some of the cracks could have been caused by or widened by earthquake forces.

In reviewing the coverage available, Father, we must apply the mandatory deductible on a per occurrence basis. This deductible is \$12,550 and with their total recommended cost of repair of \$25,576.80 we can be of no assistance.

This conclusion was reached after we determined there have been a minimum of six earthquakes occurring since your arrival on the premises and it would have to be assumed all of the damage is not the result of earthquakes.



This letter is to report the findings on a field inspection of St. Madeline's Sofia Catholic Church located at 83395 Trona Road in Trona, California. The inspection was made on August 4, 1981 accompanied by yourself and Mr. Pimke of your firm.

Partial plans were available at the site to review. According to the Pastor the church was constructed in 1957. It is constructed with concrete precast Switzer panels with poured in place concrete pilasters for the walls. The roof is wood framed arched glu-laminated beams with a glu-laminated compression ring. The interior partitions are wood framed gypsum board. The floor is cast in place terrazzo. The ceiling is accoustical tile on concealed metal splines.

The walls have a consistant cracking pattern adjacent to many of the pilasters vertically. The cracks are apparently due to thermal stresses and are located along grouted and ungrouted cells of the panels. Bond beams are located at 9 feet on center at the panel ends and the vertiwal cracks follow the bond beam to the weak panel joints. No detrimental structural cracking was noted. The terrazzo flooring had only some minor cracking and no apparent foundation failures were noted.

There was numerous wall and ceiling staining due to roof leaking. Some attempts have been made to repair roof leaks. If the roof is still leaking it should be repaired and the exterior walls water proofed.



The ceiling tiles have been forced out of alignment in a symmetrical pattern around the compression ring area. Also one of the interior partitions has a separation from the exterior concrete wall near the top. These conditions could very well be due to earthquake forces. It is my opinion that the exterior walls are cracked primarily from stresses due to the type of construction. Some of these cracks could have been caused by or widened by earthquake forces.

I feel that I must write and see what can be done to help my daughter, [REDACTED] retain her faith in the Catholic Church.

I have Raised all of my children as Catholics. My husband and I were both married in the Saint Madelines Catholic church in Trona. Each of our children have received the holy sacrament of baptisa, First Holy Communion, and Confirmation. Our youngest daughter has seen her older sisters receive the Holy Sacrament of Matrimony In their home parish.

[REDACTED] has now decided to be married and would like to receive the Holy Sacrament of Marriage in the same parish.

The problem is that her fiancee [REDACTED], also a catholic, was married at the age of 16years to a girl of 15 years of age. they were married by a justice of the peace.

After being together for many years the two came to the realization that the marriage was a bad decision made by two youngsters that weren't mature enough to make a marriage work. The two agreed to obtain a legal divorce. Which they did.

Now the same young man is 31 years of age and is mature. He is ready to take on the responsibility of being a husband. He would also like to stand before Our Father in Heaven and ask his blessing.

██████████ have been attending mass together. Last Sunday after mass they went to Father Robier to seek counseling. When they told Father Robier of the previous marriage, he went into a rage and said he didn't even want to see them until ██████████ brought his divorce papers. The two were a bit shocked by his attitude and hurt by the way he spoke to them. ██████████ went to Father Robier because he needed to talk to someone who could tell them what to do. Instead they saw someone who made them feel that they were bad people and that he had no time for them.

Several days later ██████████ was able to get his divorce papers for Father Robier. They went back to see the father and were told to just cancel their plans, because he wasn't about to get himself into any trouble. And that he would have to go to bishop with this matter.

The Father was very rude to them and would not even talk to them or counsel them. They just wanted gods blessing and to be married as Catholics. So that when they had children they could become good Catholics too.

Now they are considering going to the Cumberland Presbyterian Church in Trona. They want to be married where they will be welcome.

Their faith in god is strong but their faith in the Catholic Church is being weakened by a Catholic priest.

I have listened to many sermons about how the young people are turning away from their Catholic faith. I have to wonder how many of these young people feel that they are being chased away.

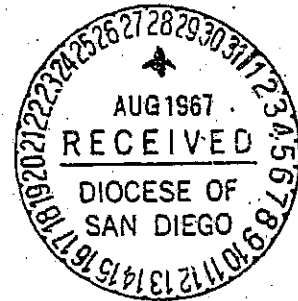

Your Excellency.

It is now almost three months that I have been removed from St. Anthony's parish, Riverside. Allow me to express my feelings of the situation I am in as chaplain for the Carmelite nuns. I hope Your Excellency will have an understanding and I hope also that I can speak to You as a son to his father with confidence. I'm like a handicapped priest, deprived of my priestly work and therefore I am not happy and satisfied with this present job. Concerning my removal from St. Anthony's parish I didn't get any chance to defend myself against the complaints made by a group who called themselves the closest ones to the church. On that day I received the word of my removal I told one of the parishioners what is going on and I didn't ask anyone to do anything in my favor. Then a group of the parishioners, without my knowledge started to act. They went first to Msgr. Lynch for help and advice; and he said to them he didn't know anything what was going on at St. Anthony's. Then they went to San Jacinto to talk to Your Excellency and You said to them that it had been an investigation under the direction of Msgr. Lynch. If there was an investigation, why didn't Msgr. Lynch come to me or call me to talk over the situation in order to clear up some misunderstandings? I think he hasn't act correctly toward his brother priest. What I lament profoundly is the lack of charity among the priests.

I have myself conformed to Your decision, but as I told You I am not happy. At St. Anthony's I tried to do my best; I have not neglect my duties to my parish. The parish was not going down, the contrary the reception of Holy Communion was increasing and also the Sunday Masses have been more attended. I founded also the O Y O four the young people. Some parishioners who stood away from the Sacraments came back. And financially the parish was prospering. I remodeled the rectory and furnished it; I did not squander the parish money and have made economies; and I have worked toward the Building Fund, then I was anxious to build a new church as Your Excellency told the people of St. Anthony's. I hope this letter will not upset my Superior; my intention was to bring my feelings to Your Excellency and You can be sure of my sincere cooperation in the service of God.

Welcome to Valley Convalescent Hospital. It is our wish to offer the best possible care and we know this is what you want for your special patient.

Our staff is trained to care for the chronically ill and the elderly as well as those convalescing. There may be questions which may arise which we hope you will feel free to ask.

Below is some information which may be helpful to you in working with us to provide the best care for your loved one.

Doctor:

Medications, treatments, diet are based on the orders of the patient's doctor. Since the patient is not considered acutely ill when they are in this facility, the doctor is only required to visit patients once a month. However, he is kept aware of any problems or changes in the medical situation by the nurses and will visit more frequently if his condition warrants it.

Visiting Hours:

Relatives and friends are encouraged to visit frequently. Visiting hours are from 8 am to 8 pm daily. If you cannot visit frequently and you know others are in the same position, it would be best to plan the visits so that they are spread out rather than, no visitors for a long time. There is no age limit for visitors; children of any age may visit.

Food:

Meals are served at 7 am, 12 pm, and 5 pm. Nourishments are offered every evening. Mid-meal nourishments are provided if ordered by the physician. Special therapeutic diets are provided on the basis of doctor's orders. We request that no food or beverage be given without checking with the licensed nurses.

Safety:

Because patient's safety is of utmost concern, the following rules must be observed:

- No medications may be brought to patients
- No cigarettes may be smoked except in marked smoking areas
- Patients may not keep any matches or cigarettes with them
- Patients needing assistance in moving in/out of beds or chairs should be assisted by our trained staff

Clothing, Laundry and Personal Items:

Patients will need nightgowns, pajamas, robe, slippers, and several changes of comfortable, washable daytime clothing. We do not assume responsibility for loss of personal property. (Please leave all valuables at home) All clothing items must be marked with a special pen for easy identification. Personal items are available at the families request for a fee or to be provided by the families. Personal laundry can be done at the facility for a fee. Arrangements for this should be made upon admission and if any changes are needed, with the business office.

Social Services:

The facility social service designee is available Monday through Friday 8 am to 4:30 pm to help you with any questions or problems you may have related to the patient's adjustment, behavior, needs, etc. as well as to help you with any problems you may have as a result of the placement and/or the condition of the patient.

Activities:

Familiarize yourself with the many activities planned for the patients by our Activity Department. Information about the programs can be found on the calendars located across from room #3 and next to the activity directors office. You are welcome to participate with your patient.

Telephones and Televisions:
