It was reported that Bill Young wants to go into Success Motivation Institute more full time. He does not see himself working in a parish. He would like to work in some institution so that he has the opportunity to work with SMI.

Jeff Sarkies feels he should not stay at Kennedy with a new principal there. He would like to take a sabbatical year of study or work in the Office of Religious Education. The Board recommended that Sarkies stay at Kennedy. It will clarify with the Archbishop the possibility of Sarkies in the Office of Religious Education.
