Your Excellency,

The Congregation for the Doctrine of the Faith received, on 14 November 2006, your correspondence in the case regarding the alleged sexual abuse of minors by Reverend Francis G. DELUCA, a priest of your diocese. In your votum which accompanied the case you request an ex officio dismissal from the clerical state.

THE STATE OF THE SECOND ST STATE MAJES After a careful examination of the case the Congregation is inclined to agree with your request. It was noted, however, that there is no reference to a response from Reverend DeLuca concerning your decision. Before a request for dismissal from the clerical state is presented to the Holy Father, it has been the practice of the Congregation for the Doctrine of the Faith to allow the cleric himself to ask for a dispensation from the obligations of priesthood, including celibacy. I would ask you to arrange a meeting with Reverend DeLuca allowing him to know the seriousness of the penalty you are requesting. Knowing the difficulty he has experienced living the obligations of priesthood Reverend DeLuca may choose to request a dispensation from them himself. A request for such a dispensation should denote that the cleric recognizes it as a grace granted to him. His letter to the Holy Father should indicate he understands the seriousness of the matter and is penitent for his actions.

Before proceeding further with this case we will await the results of your consultation with Reverend DeLuca. Once you have had the opportunity to arrange a meeting with him please notify this Dicastery.

#### Your Eminence:

I write you with an urgent request for the removal from the clerical state and dispensation from the obligation of celibacy for Fr. Francis G. DeLuca [original Prot. N. 460/2003-20154], a 77 year old prayer and penance priest [Essential Norms 8b], who was just arrested on October 20, 2006 for recent sexual abuse involving a minor [touch, fondling, masturbation, alcohol, pornography] in Syracuse NY [where he retired after being removed from active ministry by then Bishop Robert E. Mulvee in 1993].

I ask that Fr. DeLuca, because of the serial nature of his abuse [all involving his admission] with the most recent abuse occurring repeatedly from 2001 to 2006 be removed from the clerical state and given a dispensation from celibacy immediately and as soon as possible to prevent further scandal [the media coverage in both Wilmington and Syracuse has been intense], and to emphasize categorically to Fr. DeLuca that the abusive behavior will not be tolerated.

I had hoped that Fr. DeLuca could live the life of prayer and penance prescribed by section 8B of the *Essential Norms*. It is clear that that is not possible. Now 77 years old, he will likely live his remaining years of life either in jail or in house confinement.

You will find this votum amply supported by the enclosed summary [according to the directives of the CDF] and relevant appendices. Msgr. John Barres, our Chancellor, alerted Augustine DiNoia, OP, of the CDF by email on Friday, October 14, 2006 that this case would be sent to the Congregation. I'm grateful to you and the Congregation for your assistance.

Current Status: Fr. DeLuca lives in Syracuse, NY in retirement in his own residence. The Bishop of the Diocese of Syracuse, NY had been notified. Fr. DeLuca was arrested on Thursday, October 19, 2006 by the Syracuse police.

#### ACCUSATIONS AGAINST FR. DELUCA

Year: Began circa 2001, repeated approximately monthly and continued until May or June 2006.

Victim: Michael Dingle [Fr. DeLuca's grand nephew] and apparently witnessed some of the abuse.

Imputable Acts: Fr. DeLuca admitted the abuse, claiming it was limited to touch, fondling and masturbation. But also admitted use of pornography when the boy reached 16. [See Appendix 1 and 1a — especially highlighted News Journal of October 26, 2006] DeLuca gave the boy alcohol to drink, bought him jewelry, games and clothes and deposited about \$9000 in a bank account in the youth's name. [Appendix 1a, October 29, 2006 Syracuse Paper]

Denunciation: October 2006

Year: 1958-1960

Victim: Michael Ward and approximately five other unnamed boys Fr. DeLuca was involved with.

Age: Not exactly clear in documentation but they were altar boys so most likely between 10 and 13 years old.

Imputable Acts: Psychological report [see Appendix 2] says that

Fr. DeLuca "unlawfully fondled, molested, touched, abused, sexually assaulted and/or battered..." 12-5-93 Notes of Vicar for Clergy Msgr. Lemon [Appendix 4] confirm the physical description in the legal complaint].

Age: 12 or 13

Imputable Acts: Sexual abuse occurred 5 or 6 times though the documentation does not detail the nature of the abuse. [see Appendix 5, documentation of Vicar General Msgr. J. Thomas Cini]

DeLuca, because of the serial nature of his abuse [all involving his admission] with the most recent abuse occurring repeatedly from 2001 to 2006 be removed from the clerical state and given a dispensation from celibacy immediately and as soon as possible given the intense media coverage of his case. I had hoped that Fr. DeLuca could live the life of prayer and penance prescribed by section 8B of the *Essential Norms*. It is clear that that is not possible. Now 77 years old, he will likely live his remaining years of life either in jail or in house confinement.



Redacted (Liverpool) reported a concern re child sex abuse to Msgr. C. Lemon of Wilmington. The alleged victim is Michael Dingle (turned 18 on 9/21/06); the accused is Francis DeLuca (100 Pastime Dr., Syracuse 13208; phone , Msgr. Lemon informed me of the accusation.

F. DeLuca has been in Syracuse for c. 13 years; returning here from Wilmington, pursuant to charges of inappropriate behavior. He attends daily Mass frequently at the Dominican Monastery and on weekends in various north-side parishes. I think he does not celebrate privately, but of this I am not certain.

The alleged abuse with Michael (who is a blood relative of DeLuca) began c. 5 years ago and was repeated approximately "monthly". The place was DeLuca's residence.

Redacted is aware of the inappropriate behavior, witnessed some of it, but apparently is not himself a victim. The abuse of Michael came to light in the late Spring of 2006; the last instance was in May or June, and since July there has been no contact between DeLuca and Michael, who had been the favorite (grand) nephew.

I met on 9/29 with Redacted, advising her that she might wish to report the allegations to law enforcement officials, and notifying her that we would report the accusation to the D.A. since the alleged crime was current. She subsequently did notify the Syracuse Police Department which after investigation arrested DeLuca on 10/19 charged him with criminal sexual abuse of a child and subsequently released him with a court appearance (arraignment) scheduled for 10/24 when D.A. will bring charges.

On 10/4 I met with F. DeLuca who admitted the abuse, claiming it was limited to touch and masturbation (whether mutual not indicated).

Our victim assistance coordinator (Teresa Secreti) has met with Redacted Michael Dingle. Michael did have some (perhaps four) sessions with a counselor selected by his family. F. DeLuca was billed and paid for this assistance. The experience was not helpful; Michael was found to be universally angry. Michael did not do well with this counselor; currently he is resisting further psychological assistance, but T. Secreti continues to meet with him and is somewhat hopeful that he may eventually agree to some therapeutic intervention.

I have shared our information first with C. Lemon, more recently with T. Flynn (302-571-6675).

### Retired priest accused of abuse

Syracuse police say crime took place over several years with underage boy.

A retired Catholic priest unaffiliated with the Syracuse dio-, cese has been accused of having repeated sexual contact with an underage boy over the course of several years, Syracuse police said Friday.

Francis G. Deluca, 77, of 100 Pastime Drive, Syracuse, was arrested Thursday and charged with one count of second-degree sexual abuse, two counts of third-degree sexual abuse and two counts of endangering the welfare of a child; all misdemeanors, according to an arrest report. He was issued an appearance ticket and released.

The alleged abuse began when the boy was 12 or 13 and continued for several years, said Lt. ## Former Del. priest accused of sex abuse arrested in New York

A former Diocese of Wilmington priest, allowed to retire in 1993 after allegations of child sexual abuse surfaced, was arrested last week in Syracuse, N.Y., on the same charges.

Francis G. DeLuca, 77, a priest in Wilmington for 35 years, left in 1993 when former Bishop Robert E. Mulvee removed him from the ministry and allowed him to retire early.

DeLuca then moved to Syracuse, his hometown.

DeLuca now is charged with sexually abusing a Syracuse boy for several years, from the time the boy was 12 or 13 until the boy told his mother when he was 17, according to published reports. He is now 18.

DeLuca did not return messages left at his home.

"It breaks my heart to learn that someone in Syracuse may have been victimized by a removed priest of our diocese," Diocese of Wilmington Bishop Michael A. Saltarelli said in a statement released Saturday. "My sincere apology and pledge of continued prayers go out to this young man and to all victims and their families."

The sexual abuse allegations against DeLuca were not reported to the Delaware attorney general until 2002, after the national scandal of child sexual abuse by priests emerged in the media.

Diocese officials said they heard from other victims of DeLuca after the reports.

Later that year, the U.S. Conference of Catholic Bishops adopted new policies on how dioceses should respond to and report assaults and how they should prevent them.

Since then, officials have acknowledged that more than 60 people were victimized by priests in the Diocese of Wilmington, which includes more than 220,000 Catholics in Delaware and the nine counties of Maryland's Eastern Shore. They have acknowledged credible allegations against 30 priests, some dating back more than 50 years, but have refused to release all the names of the

Many have died. Some have retired in the area. The where-

abouts of others are unknown by church officials.

None remains in ministry in the diocese, Krebs said Saturday A 2006 audit showed the Diocese of Wilmington was in full compliance with the 2002 policies adopted by the nation's bishops, he said.

DeLuca never faced prosecu-. tion for previous alleged assaults, in large part because the statute of limitations has expired in Delaware.

State Rep. Greg Lavelle, R-Sharpley, and state Sen. Karen Peterson, D-Stanton, sponsored legislation last spring to change the statute of limitations, but time ran out before a bill was passed.

That effort will continue in the next legislative session, said a spokesman for Voice of the Faithful, a lay Catholic group that serves as an advocate for victims. Delaware has two chapters of the group.

Bill Pare, spokesman for the northern chapter, said Mulvee was right to take action in 1993. Mulvee, who went on to serve as bishop of Providence, R.I., retired in 2005.

"At least he took him out of the ministry," Pare said.

Diocese officials urge anyone victimized by a priest, deacon or layperson to report the abuse to the state attorney general or the appropriate Maryland State's Attorney. Instructions and information about counseling services are available at the diocese Web site: www.cdow.org.



#### Accused ex-priest had been barred

Delaware diocese defrocked Francis G. DeLuca after abuse-of-minors report.

A retired Catholic priest charged by Syracuse police with sexually abusing a minor was permanently barred from the ministry in 1993 after his former diocese found he had abused minors there, a representative of that diocese said Saturday.

"It breaks my heart to learn that someone in Syracuse may have been victimized by a removed priest of our diocese," said the Most Rev. Michael Saltarelli, bishop of the Diocese of Wilmington, Del., said in a statement after learning of Francis G. DeLuca's arrest.

DeLuca, 77, of 100 Pastime Drive, Syracuse, could not be reached for comment Friday or Saturday.

Wilmington diocesan officials received a report in 1993 that DeLuca sexually abused a minor in Wilmington in the 1960s. Diocesan officials contacted the victim and confirmed that he had been molested by DeLuca, according to a diocesan statement. The diocese con-

firmed that "about three or four" individuals had been molested by DeLuca in the 1960s, said Bob Krebs, a spokesman for the Wilmington diocese.

DeLuca was immediately and permanently removed from ministry, barred from functioning publicly as a priest and sent for psychological evaluation, according to the statement. DeLuca then was allowed to retire and chose to move to his hometown, Syracuse.

Syracuse police charged DeLuca on Thursday with one count of second-degree sexual abuse, two counts of third-degree sexual abuse and two counts of endangering the welfare of a child, all misdemeanors. The alleged abuse began when the boy, now 18, was 12 or 13 years old and involved hand-to-genital contact, said Lt. Joseph Cecile, speaking for police.

The police investigation began after the boy told his mother about the alleged abuse, and she reported it to police, Cecile said. The Post-Standard does not identify alleged victims of sex-related crimes.

DeLuca is not a priest in the Syracuse diocese, said Danielle Cummings, assistant chancellor and diocese spokeswoman.

The Wilmington diocese shared information about the 1993 allegation with the Delaware Attorney General's Office in 2002. Krebs said DeLuca was not charged with a crime in Delaware, and that's why he isn't listed in Delaware or New York sex offender registries.

Barbara Blaine, president of the national group SNAP, The Survivors Network of those Abused by Priests, said she's heard many stories of priests who have abused minors in one town and then move and do it again elsewhere. She said she believes church leaders are protecting those priests.

"What's so damaging about that is, unfortunately, the excuses keep leaving more children at risk," Blaine said.

#### Former Del. priest arrested in New York

Man was accused here of 1960s sex abuse

A former Diocese of Wilmington priest, allowed to retire in 1993 after allegations of child sexual abuse surfaced, was arrested last week in Syracuse, N.Y., on the same charges.

Francis G. DeLuca, 77, a priest in Wilmington for 35 years, left in 1993 when former Bishop Robert E. Mulvee removed him from the ministry and allowed him to retire

DeLuca then moved to Syracuse, his hometown.

DeLuca now is charged with sexually abusing a Syracuse boy for several years, from the time the boy was 12 or 13 until the boy told his mother when he was 17, according to published reports. He is now 18.

DeLuca was arrested Thursday and charged with one count of second-degree sexual abuse, two counts of third-degree sexual abuse and two counts of endangering the welfare of a child. Syracuse police Lt. Joseph Ceclle said. DeLuca was given an appearance ticket and released, Cecile said.

All are misdemeanors, and each count is punishable by up to one year in prison, Cecile said.

"Even the victim doesn't know how many times" he was fondled, Cecile sald. "But he stayed over there guite often and whenever he did stay over there it usually happened. It's been continuing, but he finally told his parents after the last incident."

DeLuca did not return messages left at his home.

"It breaks my heart to learn that someone in Syracuse may have been victimized by a removed priest of our diocese," Diocese of Wilmington Bishop Michael A. #### Accused briest not in N.Y. ministry

Syracuse diocese: DeLuca not working for church when alleged abuse occurred By BETH MILLER, The News Journal Posted Tuesday, October 24, 2006

Syracuse officials say the former Diocese of Wilmington priest arrested on child sexualabuse charges last week was not serving in a New York church when the incidents allegedly occurred.

Danielle Cummings, a spokeswoman for the Diocese of Syracuse, said Francis G. DeLuca has not served in any capacity in the diocese, where he has lived since he was removed from ministry in Wilmington after similar allegations arose against him in 1993.

Cummings said Wilmington church officials notified Syracuse officials in 2002 that DeLuca was living in their area and should not serve in any priestly capacity. That notice was given to comply with a 2002 charter adopted by the U.S. Conference of Catholic Bishops requiring dioceses to report abuse allegations to civil authorities and to notify other dioceses when priests with credible allegations moved into their area.

Syracuse police spokesman Lt. Joseph Cecile said he could not say how DeLuca, 77, came into contact with the alleged Syracuse victim, now 18 years old, because it could reveal the boy's identity. The alleged abuse did not occur in a ministry context, Cecile said. The charges against DeLuca were made after the boy told his mother that DeLuca had abused him from the time he was 12 or 13 until he was 17 years old.


No other victims have come forward to New York police since DeLuca was arrested Thursday, Cecile said, and DeLuca has been cooperative. Police do not believe he poses a risk to anyone else in the community.

DeLuca was removed from ministry in Delaware in 1993, after 35 years of service, when allegations surfaced of sexual abuse from the 1960s. Former Bishop Robert Mulvee allowed DeLuca to retire and return to his native Syracuse.

The priest never faced prosecution in Delaware, but he soon will appear in court in Syracuse to hear the charges against him: two counts of third-degree sexual abuse, two counts of second-degree sexual abuse and one count of endangering the welfare of a child. Cecile said the offenses were described as hand-to-genital contact.

A former altar boy said he was stunned by the news and doesn't believe any of the allegations. Vincent Testa served as an altar boy for several years during the time DeLuca was pastor of St. Matthew's Church in Christiana Hundred, from 1976-82.

"I was flabbergasted," said Testa, who works for New Castle County. "He was a good mentor to everybody in the school. He taught us the right way to be. He helped us

along if we had problems. I do not believe any of it."

## Lastest priest scandal again raises questions about Church's silence

There is something deeply unsettling about the latest tale of priestly abuse that made headlines over the weekend.

A former Wilmington priest has been arrested in Syracuse, N.Y., and charged with molesting a 12-year-old boy. This news is bad enough. But it gets worse.

Apparently, in 1993, Wilmington Catholic Diocese officials had received similar complaints about the priest when he was stationed here. The then-Bishop Robert E. Mulvee removed him from the ministry and sent him packing ... to do what? Prey on other 12-year-old boys?

The argument can be made that the original Delaware incident happened in the 1960s but came to light 30 years later, long after the statute of limitations ran out. The diocese could rightly say that no criminal charges could be brought against the priest and therefore kept quiet about the matter.

But that wall of silence crumbled in the past few years and the Wilmington Diocese had ample opportunity to make public the complaints against this particular priest. But it declined to do so.

Is it possible that the latest victim could have been spared if the diocese had gone public?


Over the years, much of the hierarchy's response has been disingenuous. In 1985, the bishops were given a report about the problem with a relative handful of priests. But the bishops did nothing. In the early 1990s, scandals popped up all over the country. The scandals exploded in 2002 when the Boston Globe published a damning series of abuse and coverups in the that city's diocese. It led to stories, suits and outrage across the nation. The bishops met in Rome, then in Dallas. They formulated a tough policy and acknowledged the names of many abusers.

According to the Wilmington Diocese, it stripped the priest in question of his priestly duties and allowed him to retire. Certainly that is an improvement over the earlier practice of transferring culprits from parish to parish.

In wake of scandal, letter sent in 2003

The arrest of a former Delaware priest on child sexual abuse charges in New York last week removed the hope some church officials held that such abusive behavior was a thing of the distant past.

Francis G. DeLuca, 77, was charged with repeated sexual abuse of a Syracuse boy. The abuse, prosecutors say, occurred after the scandal of child sexual abuse by priests emerged nationally in 2002, after the U.S. Conference of Catholic Bishops adopted stronger policies to protect children and improve resolutions.

A December 1993 letter from former Bishop Robert E. Mulvee notes the bishop accepted De-Luca's retirement from active public ministry as a priest for "reasons of health:" Later in the letter, Mulvee said he remembered DeLuca's "years of faithful service" and that only De-Luca could agonize more than Mulvee "over the tragedy that your actions of so many years ago has caused you and the Church.

But it was another 10 years before the Wilmington diocese told Syracuse church officials about his past. Bishop Michael A. Saltarelli notified Syracuse officials in an October 2003 letter that DeLuca had been removed from active ministry because of "credible allegations of the sexual abuse of minors." The letter was sent in compliance with reporting requirements adopted in 2002. Those requirements, adopted by the bishops conference, were intended to end the practice of moving predatory priests from one parish or diocese to another.

Saltarelli sent DeLuca a letter in September 2003, putting in writing the diocese's "understanding" with the priest that he would not celebrate Mass publicly or administer the sacraments, that he would not wear clerical garb or present himself publicly as a priest.

DeLuca was not serving as a priest during the period of the most recent allegations, Wilmington and Syracuse church officials say.

He was not charged in previous alleged cases, so authorities did not monitor his behavior and contact with children.

The Syracuse accuser, now 18, told his mother he was molested by DeLuca from the time he was 12 or 13 until he was 17.

Chief Deputy Michael Kerwin, of the Syracuse police department, said it bothers him that sexual predators may be living in his jurisdiction without his knowledge. "We are always concerned - whether it's a paroled bank robber or a paroled rapist or a paroled child molesPreying on innocent boys'

At least four people have made allegations about DeLuca to the Wilmington diocese, Flynn said Tuesday. The wife of one alleged victim made an anonymous report, Flynn said, and it was unclear whether that man was among the four who came forward.

One Delaware man, who said he was a victim and asked that his name not be published, said he fears there are many more.

'I think a pattern was developed back in the '60s by this man, by preying on innocent boys in the 11 to 14 age range and every few years preying on someone new," said the man, who said he was victimized about 40 years ago. "If true, there must be a great deal of men who are suffering alone with what was perpetrated on them by Francis DeLuca. They most likely will never come forward because of embarrassment and fear of being found out by their friends and family

"I know because that is the way I feel and why I will not divulge my name. I have been in and out of counseling for 20some years, and talking with

professionals has helped me deal with the pain of my adolescence."

A lawsuit filed a few years ago in Indiana dates one alleged victim's abuse to 1958-60. The suit was dropped, as was an attempt to prosecute DeLuca in Maryland, where he was accused of abusing in the 1960s a different boy on a trip there.

Maryland has no statute of limitations for felonies such aschild sex abuse, said Elizabeth: Ireland, assistant state's attorney in Wicomico County, where DeLuca once served at a parish in Salisbury. But the acts De-Luca was accused of were not

considered felonies then.

"It would be a felony now," Ireland said, "but back in 1962 and 1963, the law in Maryland didn't make the nature of the abuse he engaged in criminal. That's how unenlightened we were.

Ireland said that victim still suffers - and she wishes she could do more for him. "I hate it that there's no redress for this man," she said, "My victim is in his late 50s and is daily impacted by this breach of trust. There's nothing I can do about it, and it's very frustrating."







Warning of suspected priest pedophile may have come too late 10/25/2006, 7:09 p.m. ET

WILMINGTON, Del. (AP) — Catholic Church officials in New York were warned several years ago that a former Delaware priest arrested on child sexual abuse charges last week was a suspected pedophile, but only after the man allegedly began molesting a New York boy.

Francis G. DeLuca, 77, was arrested Oct. 19 and charged with repeated sexual abuse of a Syracuse, N.Y. boy.

DeLuca was removed from the ministry in Delaware in 1993 after officials with the Catholic Diocese of Wilmington learned of credible sexual abuse allegations against him dating to the 1960s.

A former Wilmington bishop accepted DeLuca's early retirement in December 2003 "for reasons of health" and forbade him from engaging in active public ministry without permission, according to documents obtained by The (Wilmington) News Journal.

"Only you can agonize more than I over the tragedy that your actions of so many years ago has (sic) caused you and the Church," Bishop Robert Mulvee wrote in a 1993 letter to DeLuca. "... Frank, you will always have a special place in my prayers and Masses."

DeLuca moved back to his hometown of Syracuse, but the Wilmington diocese did not inform Syracuse church officials about his past until 10 years later.

Bishop Michael A. Saltarelli of Wilmington notified Syracuse officials in an October 2003 letter that DeLuca had been removed from active ministry because of "credible allegations of the sexual abuse of minors."

The Syracuse accuser, now 18, told his mother he was molested by DeLuca from the time he was 12 or 13 until he was 17.

DeLuca was not serving as a priest during the period of the most recent allegations, according to Wilmington and Syracuse church officials. He was never charged or convicted in connection with the previous allegations, so authorities did not monitor his behavior or contact with children.

Tony Flynn, an attorney for the Wilmington diocese, said there was no procedure or policy in place in the 1990s requiring church officials to alert their counterparts elsewhere of credible abuse allegations against a cleric.

The U.S. Conference of Catholic Bishops adopted stronger policies to protect children and improve reporting practices following a nationwide church sex abuse scandal surfaced in 2002.

Flynn, who said at least four people have made allegations about DeLuca to the Wilmington

diocese, said diocesan officials in Wilmington may have corresponded with church officials in Syracuse regarding DeLuca prior to 2003.

Danielle Cummings, a spokeswoman for the Syracuse diocese, said she was unaware of any prior correspondence.

Paul Hanrahan, an attorney representing the Syracuse diocese, did not immediately return a telephone call from The Associated Press on Wednesday.

Former Delaware priest Francis G. DeLuca has confessed to molesting a boy during a five-year period, accordboy during a live-year period, according to a report released by Syracuse, N.Y., police.

17, DeLuca said he added pornographic movies to the meetings, police said. The meetings continued until earlier this year, he told police. DeLuca also provided a three-page affidavit, which was not released, police said.

Wilmington diocese officials have said at least four people here have made similar complaints against DeLuca, all dating to the 1960s.

DeLuca was ordained in 1958, serving first at St. Francis de Sales in Salisbury, Md. ## Defrocking of priest requested

Diocese seeks Vatican action following sexual abuse charges

Officials of the Catholic Diocese of Wilmington confirmed Thursday that they have asked the Vatican to remove from the priesthood the former Delaware priest arrested last week on charges of sexually abusing a Syracuse, N.Y., boy

Diocese spokesman Robert G. Krebs said the diocese made the request to the Congregation for the Doctrine of the Faith last Friday, the day after the Rev. Francis G.

# Church defends policy on priest

Victims' advocates: Disclose the charges. Dioceses: We followed our protocols.

The bishops of the Syracuse and Wilmington, Del., dioceses should have warned the community that a retired Roman Catholic priest accused of sexually abusing minors was living upsupervised in Syracuse, victims' advocates say.

"The fact is they had a dangerous predator, and they didn't disclose that," said David Clohessy, executive director of the national organization Survivors Network of those Abused by Priests.

The case of the Rev. Francis G. DeLuca — charged Oct. 19 with five misdemeanors accusing him of repeated sexual contact with an underage boy — reveals flaws in the church's response to the clergy sexual-abuse scandal, Clohessy said.

They should have used every neans possible to warn Catholics about him," he said. "Viriully no diocese does that. We beeve it's the bare minimum proach. It's the moral apoach."

- 10. FRANCIS DELUCA's sexual abuse of the Plaintiff, as described more particularly in paragraph 9, continued until 1960.
- 11. FRANCIS DELUCA fraudulently concealed the abuse from the Plaintiff, JOHN DOE, and from JOHN DOE's parents, preventing them from learning of the abuse.
- 12. FRANCIS DELUCA violated a fiduciary duty to JOHN DOE to report the abuse to authorities.

#### COUNTI

# NEGLIGENCE AGAINST ST. JOHN THE BELOVED CATHOLIC CHURCH AND THE CATHOLIC DIOCESE OF WILMINGTON

- 13. The Plaintiff, JOHN DOE, reavers and realleges paragraphs 1 through 12 of the Complaint as if the same were fully set out herein.
- 14. At all times material hereto, the Plaintiff, JOHN DOE, was a parishioner at ST. JOHN THE BELOVED CATHOLIC CHURCH and was involved in many activities at said church.

- 15. At all times material hereto, the Defendant, FRANCIS DELUCA, was acting in the course and scope of his employment with the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH and the Defendant, CATHOLIC DIOCESE OF WILMINGTON.
- 16. On numerous occasions during the time that the Plaintiff, JOHN DOE, was participating in activities at or sponsored by the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and a parishioner at the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, the Defendant, FRANCIS DELUCA, unlawfully fondled, molested, touched, abused, sexually assaulted and/or battered the Plaintiff, JOHN DOE, while an Associate Pastor at the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and both on the premises of the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH and elsewhere.
- 17. At all times material hereto, the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH and/or the Defendant, CATHOLIC DIOCESE OF WILMINGTON, owed to its employees and parishioners, especially those of tender years such as the Plaintiff, JOHN DOE, the duty of hiring persons reasonably suited for teaching, counseling, spiritually guiding, supervising and leading employees and parishioners of the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH.
- 18. The Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH and/or the Defendant, CATHOLIC DIOCESE OF WILMINGTON, their agents, servants, and/or employees, breached their duty to the Plaintiff, JOHN DOE, in one or more of the following ways:
  - A. Negligently hiring the Defendant, FRANCIS DELUCA, who the said Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH and/or the Defendant, CATHOLIC DIOCESE OF WILMINGTON, knew or in the exercise of reasonable care,

should have known, was unsuited for teaching, counseling, spiritually guiding, supervising and leading employees and parishioners of then tender years such as the Plaintiff, JOHN DOE.

- B. Negligently failing to make inquiries into the Defendant, FRANCIS DELUCA's background, qualifications, reputation, work history, and/or criminal history prior to employing him in the capacity of Associate Pastor; or in the alternative,
  - i. The Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and/or the Defendant, CATHOLIC DIOCESE OF WILMINGTON, did make such inquiries, but did so in an unreasonable, negligent and/or incomplete manner; or in the alternative,
  - ii. The Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and/or the Defendant, CATHOLIC DIOCESE OF WILMINGTON, did make reasonably inquiries, but failed to act on such information in a reasonably prudent manner for the protection and safety of the employees and parishioners of the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and/or the Defendant, CATHOLIC DIOCESE OF WILMINGTON, and the Plaintiff, JOHN DOE, in particular.
- C. Negligently failing to have any procedures for conducting background checks prior to hiring its associate pastors/priests or other persons responsible for the supervision of its employees or parishioners; or in the alternative;
  - i. Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and/or the Defendant, CATHOLIC DIOCESE OF WILMINGTON, did have

procedures for conducting background checks as described above, but failed to implement said procedures; or in the alternative,

- ii. Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and/or the Defendant, CATHOLIC DIOCESE OF WILMINGTON, did have procedures for conducting background checks as described above, but implemented said procedures in a careless or negligent manner.
- D. Negligently placing the Plaintiff, JOHN DOE, under the supervision of the Defendant, FRANCIS DELUCA, when the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and the Defendant, CATHOLIC DIOCESE OF WILMINGTON, knew, or in the exercise of reasonable care should have known, that the Defendant, FRANCIS DELUCA, had propensities to commit acts of sexual assault, and/or molestation, and/or indecent conduct upon other persons, and especially young children such as the Plaintiff, JOHN DOE.
- E. Negligently retaining the Defendant, FRANCIS DELUCA, as a priest employed by the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and/or the Defendant, CATHOLIC DIOCESE OF WILMINGTON, notwithstanding the fact that said defendant knew or should have known that FRANCIS DELUCA had committed several sexual assaults and/or batteries.
- F. Negligently placing the Plaintiff, JOHN DOE, under the supervision of the Defendant, FRANCIS DELUCA, when the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH and/or the Defendant, CATHOLIC DIOCESE OF WILMINGTON, knew or in the exercise of reasonable care, should have known, that the Defendant, FRANCIS DELUCA, had propensities to commit acts of sexual assault,

molestation, abuse, and/or indecent sexual conduct upon young children such as the Plaintiff, JOHN DOE.

- G. Negligently failing to report immediately one or more prior incidents of suspected child abuse and/or assault to civil authorities.
- H. Instead of reporting the prior incident(s) to the civil authorities, the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and the Defendant, CATHOLIC DIOCESE OF WILMINGTON, allowed the Defendant, FRANCIS DELUCA, to continue to teach, counsel, spiritually guide, supervise and lead its employees and parishioners at ST. JOHN THE BELOVED CATHOLIC CHURCH.
- I. Negligently failing to follow its own procedures, rules and regulations dealing with reprimands and/or sexual misconduct by priests, termination notices, reports of firings of priests, obtaining a recommendation from previous and/or the most recent employer, record keeping, performance of priest evaluations and treatment, and the reporting of child abuse and/or suspected child abuse.
- J. Negligently failing to use reasonable care in reviewing the work record of the Defendant, FRANCIS DELUCA, and/or failing to use reasonable care in reprimanding and/or failing to suspend the Defendant, FRANCIS DELUCA, when circumstances dictated that the Defendant, FRANCIS DELUCA, should have been reprimanded and/or suspended.
- K. Negligently failing to use reasonable care in determining, subsequent to hire, whether the Defendant, FRANCIS DELUCA, was qualified and/or mentally fit to teach, counsel, spiritually guide, supervise and lead employees and parishioners of the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and of the Defendant,

CATHOLIC DIOCESE OF WILMINGTON, including children of tender years such as the Plaintiff, JOHN DOE.

- 19. As a direct and proximate result of the negligence of the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and the Defendant, CATHOLIC DIOCESE OF WILMINGTON, the Plaintiff, JOHN DOE, was unlawfully fondled, molested, touched, abused, sexually assaulted and/or battered. The Plaintiff, JOHN DOE, has suffered grievous mental pain, anguish, and suffering, as well as deep psychological fear; his mental, psychological, religious, and social development has been permanently marred; his ability to lead and enjoy a normal life has and will continue to be impaired, his ability to engage in close, personal relationships has and will continue to be impaired; all of the said injuries are permanent and continuing in nature, and the Plaintiff, JOHN DOE, will suffer such losses and impairments in the future.
- 20. As a direct and proximate result of the negligence of the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and the Defendant, CATHOLIC DIOCESE OF WILMINGTON, the Plaintiff, JOHN DOE, has in the past and will in the future be caused to pay sums of money for the psychological treatment and other expenses related to the injuries sustained by him.

WHEREFORE, the Plaintiff, JOHN DOE, demands judgment against the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, and each of them for compensatory damages and for such other and further relief as the court deems just and proper.

#### COUNT II

#### RESPONDEAT SUPERIOR

- 21. The Plaintiff, JOHN DOE, reavers and realleges paragraphs 1 through 20 of the Complaint as if the same were fully set out herein.
- 22. On numerous occasions, the Defendant, FRANCIS DELUCA, an employee in the course and scope of his employment with the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, unlawfully, violently, maliciously and in a grossly negligent manner, and without justification therefore, sexually assaulted, molested, fondled, abused and batteredthe then minor Plaintiff, JOHN DOE.
- 23. The said molestations and other acts occurred while the employee was performing his duties as a priest and while he was supervising other employees/parishioners of the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and Defendant, CATHOLIC DIOCESE OF WILMINGTON, who were entrusted to his care and control, and were done and performed in furtherance and during the course of the daily operation of the church itself.
- 24. At the time of the above-described molestations and other acts, the Plaintiff, JOHN DOE, was in the care, control, and custody of the Defendants, FRANCIS DELUCA, ST. JOHN THE BELOVED CATHOLIC CHURCH, and the CATHOLIC DIOCESE OF WILMINGTON.
- 25. At the time of the above-described molestations and other acts, the Defendants, FRANCIS DELUCA, ST. JOHN THE BELOVED CATHOLIC CHURCH, and the CATHOLIC DIOCESE OF WILMINGTON, had undertaken to spiritually guide, counsel, instruct, supervise and safeguard the then minor Plaintiff, JOHN DOE.

- 26. The conduct of the Defendant, FRANCIS DELUCA, as described hereinabove, was, at least in part, perpetrated under the guise of better serving the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON.
- 27. At the time of the above-described molestations and other acts, the Plaintiff, JOHN DOE, entrusted his bodily safety to the care and control of the Defendant ST. JOHN THE BELOVED CATHOLIC CHURCH, and the CATHOLIC DIOCESE OF WILMINGTON's employee's, including the Defendant, FRANCIS DELUCA.
- 28. At the time of the above-described molestations and other acts, the Plaintiff, JOHN DOE, could not freely or independently walk away from the control of the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON's employees, including the Defendant, FRANCIS DELUCA.
- 29. By virtue of all of the foregoing and the unique relationship hereinbefore described, the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, and their employees were under a special duty to protect the then minor Plaintiff, JOHN DOE, while said Plaintiff was in the Defendants' custody, care, and/or control.
- 30. At the time of the above-described molestations and other acts, the Defendant, FRANCIS DELUCA, purported to act and/or speak on behalf of his principals, the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON.
- 31. Further, the Plaintiff, JOHN DOE, relied on the Defendant, FRANCIS DELUCA's, apparent authority while the Defendant, FRANCIS DELUCA, was accomplishing said torts and engaging in the subject tortious conduct.

- 32. Further, The Defendant, FRANCIS DELUCA, was aided in the commission of his tortious conduct by the existence of his agency relationship with the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON.
- 33. The Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, knew or should have known that said employee was a threat to others including, but not limited to, the then minor Plaintiff, JOHN DOE.
- 34. The subject tortious conduct was committed by the Defendant, FRANCIS DELUCA, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, during the course of his employment. That is, the tortious conduct was committed in the apparent furtherance of a purpose or interest of the employer, the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON.
- 35. The Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, were responsible for bringing the Defendant, FRANCIS DELUCA, into contact with the Plaintiff, JOHN DOE.
- 36. The tortious conduct occurred within the time and space limits of the Defendant, FRANCIS DELUCA's, employment and was engaged in, at least in part, by the Defendant, FRANCIS DELUCA's perceived desire to better serve his employers, the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON.
- 37. Between 1958 and 1960, the Defendant, FRANCIS DELUCA, sexually assaulted, molested and fondled the then minor Plaintiff, JOHN DOE, while said Plaintiff was under the

care, custody, and control of the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON.

- 38. As a direct result of the foregoing, the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, are vicariously liable for said torts committed by their employee, the Defendant, FRANCIS DELUCA.
- 39. Between 1958 and 1960, the Defendant, FRANCIS DELUCA, an employee in the course and scope of his employment with the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, unlawfully, violently, maliciously in a grossly negligent manner, and without justification therefore, sexually assaulted and battered the Plaintiff, JOHN DOE.
- 40. Said assaults occurred while the employee was performing his duties of supervising employees and counseling parishioners in his care, including the Plaintiff, JOHN DOE. Under the doctrine of *Respondeat superior*, the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, are responsible for the loss, injury, and damage sustained by the Plaintiff, JOHN DOE.
- 41. The Plaintiff, JOHN DOE, suffered grievous pain, anguish, and suffering, as well as deep psychological fear; his mental, psychological and social development has been permanently marred; his ability to lead and enjoy a normal life has and will continue to be impaired; his ability to engage in close, personal relationships has and will continue to be impaired; all of the said injuries are permanent and continuing in nature, and the Plaintiff, JOHN DOE, will suffer such losses and impairments in the future.

42. The Plaintiff, JOHN DOE, has in the past and will in the future be caused to pay sums of money for the psychological treatment and other expenses related to the injuries sustained by him.

WHEREFORE, the Plaintiff, JOHN DOE, demands judgment against the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, and each of them for compensatory damages and for such other and further relief as the court deems just and proper.

#### COUNT III

# IMPLIED CONTRACT AGAINST ST. JOHN THE BELOVED CATHOLIC CHURCH AND THE CATHOLIC DIOCESE OF WILMINGTON

- 43. The Plaintiff, JOHN DOE, reavers and realleges paragraphs 1 through 42 of the Complaint as if the same were fully set out herein.
- 44. At all times material hereto, the Plaintiff, JOHN DOE, was a parishioner of ST. JOHN THE BELOVED CATHOLIC CHURCH, which was being supervised and controlled by the Defendant, CATHOLIC DIOCESE OF WILMINGTON.
- 45. At all times material hereto, the Defendant, FRANCIS DELUCA, was employed by the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH, and/or the Defendant, CATHOLIC DIOCESE OF WILMINGTON.
- 46. At all times material hereto, the Defendant, FRANCIS DELUCA, was acting in the course and scope of his employment with the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and/or the CATHOLIC DIOCESE OF WILMINGTON.

- 47. On numerous occasions between 1958 and 1960, the Defendant, FRANCIS DELUCA, unlawfully fondled, molested, touched, abused, sexually assaulted and/or battered the then minor Plaintiff, JOHN DOE, while he was employed by the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and/or the CATHOLIC DIOCESE OF WILMINGTON.
- 48. At all times material hereto, the Plaintiff, JOHN DOE, was a parishioner of ST. JOHN THE BELOVED CATHOLIC CHURCH and an active participant in church-sponsored and supervised programs.
- 49. By virtue of said church-sponsorship and supervision of programs, the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, were contractually obligated and responsible for the Plaintiff's safety, health, and well-being while the Plaintiff participated in church-sponsored and supervised programs.
- 50. The Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, breached the above-described implied contract as a result of their employee's sexual assault, molestation, battery, fondling and/or indecent conduct perpetrated upon the then minor Plaintiff, JOHN DOE.
- 51. Further, the above-described implied contract was breached by the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, when they hired and subsequently retained the Defendant, FRANCIS DELUCA, despite the fact that his prior employment record indicated that his character, demeanor, background and temperament would be and were detrimental to the health, safety and welfare of the employees and parishioners of the Defendant, ST. JOHN THE BELOVED CATHOLIC CHURCH.

- 52. Further, the above-described implied contract was breached by the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, when they failed to properly monitor, supervise and/or evaluate the Defendant, FRANCIS DELUCA's activities prior to the perpetration of the subject molestations.
- 53. Further, the above-described implied contract was breached by the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, when they failed to terminate the employment of the Defendant, FRANCIS DELUCA, thereby submitting those with whom he came into contact, including the then minor Plaintiff, JOHN DOE, to a risk of bodily harm.
- 54. The Plaintiff, JOHN DOE, suffered grievous pain, anguish, and suffering, as well as deep psychological fear; his mental, psychological and social development has been permanently marred; his ability to lead and enjoy a normal life has and will continue to be impaired; his ability to engage in close, personal relationships has and will continue to be impaired; all of the said injuries are permanent and continuing in nature, and the Plaintiff, JOHN DOE, will suffer such losses and impairments in the future.
- 55. The Plaintiff, JOHN DOE, has in the past and will in the future be caused to pay sums of money for the psychological treatment and other expenses related to the injuries sustained by him.

WHEREFORE, the Plaintiff, JOHN DOE, demands judgment against the Defendants, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, and each of them for compensatory damages and for such other and further relief as the court deems just and proper.

#### **COUNT IV**

#### ASSAULT AND BATTERY AGAINST FRANCIS DELUCA

- 56. The Plaintiff incorporates by reference paragraphs 1 through 55 of the Complaint as if the same were fully set out herein.
- 57. The Defendant, FRANCIS DELUCA, did commit and perpetrate an indecent sexual assault and battery upon the Plaintiff, JOHN DOE, as hereinbefore more particularly in paragraph 9.
- 58. As a direct and proximate result of the indecent, sexual assault and battery perpetrated by the Defendant, FRANCIS DELUCA, the then minor Plaintiff, JOHN DOE, was unlawfully fondled, touched, abused, sexually assaulted and/or molested.
- 59. The Plaintiff, JOHN DOE, suffered grievous pain, anguish, and suffering, as well as deep psychological fear; his mental, psychological and social development has been permanently marred; his ability to lead and enjoy a normal life has and will continue to be impaired; his ability to engage in close, personal relationships has and will continue to be impaired; all of the said injuries are permanent and continuing in nature, and the Plaintiff, JOHN DOE, will suffer such losses and impairments in the future.
- 60. The Plaintiff, JOHN DOE, has in the past and will continue in the future, been caused to pay sums of money for the psychological treatment and other expenses related to the injuries sustained by him.

WHEREFORE, the Plaintiff, JOHN DOE, demands judgment against the Defendant, FRANCIS DELUCA, for compensatory damages and for such other and further relief as this court deems just and proper.

#### COUNT V

#### FRAUDULENT CONCEALMENT

- 61. The Plaintiff incorporates by reference paragraphs 1 through 60 of the Complaint as if the same were fully set out herein.
- 62. The Defendant, FRANCIS DELUCA, concealed the fact of the abuse from the Plaintiff, JOHN DOE, and from the plaintiff's parents, who would have been able to bring an action within the period of limitation after discovery of the cause of action.
- 63. The Defendant, FRANCIS DELUCA, had a fiduciary duty to the Plaintiff, JOHN DOE, and violated that fiduciary duty by failing to disclose the abuse of the Plaintiff, JOHN DOE.
- 64. The Plaintiff, JOHN DOE, suffered grievous pain, anguish, and suffering, as well as deep psychological fear; his mental, psychological and social development has been permanently married; his ability to lead and enjoy a normal life has and will continue to be impaired; his ability to engage in close, personal relationships has and will continue to be impaired; all of the said injuries are permanent and continuing in nature, and the Plaintiff, JOHN DOE, will suffer such losses and impairments in the future.
- 65. As a result of the fraudulent concealment by the Defendant, FRANCIS DELUCA, the Plaintiff, JOHN DOE, was unable to discern the source of the suffering described in paragraph 64 for over 40 years, and therefore was unable until recently to seek redress for the harm inflicted by the Defendant, FRANCIS DELUCA.
- 66. The Plaintiff, JOHN DOE, has in the past and will continue in the future, been caused to pay sums of money for the psychological treatment and other expenses related to the injuries sustained by him.

#### **PUNITIVE DAMAGES**

67. Pursuant to Delaware law, the Plaintiff, JOHN DOE, reserves the right to amend this Complaint for the purpose of asserting claims for punitive damages against each of the three Defendants, FRANCIS DELUCA, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, on each count, after a reasonable showing by evidence in the record or proffered by the Plaintiff that would provide a reasonable basis for recovery of such damages including, but not limited to, a showing that the conduct on the part of the Defendants, FRANCIS DELUCA, ST. JOHN THE BELOVED CATHOLIC CHURCH and the CATHOLIC DIOCESE OF WILMINGTON, was willful, wanton, malicious, and in reckless disregard of the rights of the Plaintiff.

#### DEMAND FOR JURY TRIAL ON ALL COUNTS

68. The Plaintiff demands a trial by jury on all counts of all issues so triable.

"In a telephone conversation with Frank on September 17, 2002, I told him of the allegation made by Michael Ward and Ward's retention of counsel. In that conversation I stated we were a little confused since was abused by another priest. Did M. Ward mistakenly identify Fr. DeLucar I said, "Would I be correct in concluding Mike Ward was probably mistaken in accusing you (Frank)?" Fr. DeLuca responded, "I (you) would not be correct" in that conclusion. Fr. DeLuca went on to describe the incident: "There was one time on a trip ..."

In march of 1993, while investigating and allegation of clergy abuse involving another priest, (who happened to be stationed with the ble Ruca) I was told about the Da Luca's abusive involvement with mike Schulte. Dince the matter was related to me on a third party basis, I encouraged the presson to have the family contact me directly. No contact was forthcoming at that time.

Ichnete for a second time, reviewed his story and tried to elicit more information. He held to his original testimony and restated that

In november 29, 1993 I confronted Fe. DeLuce pt the rectory with the testimony from mike and his parents. Memo to File W-007

Mr. W-007 contacted this office in late August 2004 after a friend of his strongly urged him to report to the Catholic diocese the abuse he suffered back in the 1960's. I met with Mr. W-007 on September 13, 2004 at St. Ann's Parish at 10:00 in the morning. Our discussion lasted about 1 hour and 40 minutes. The discussion was pleasant. Mr. W-007 was respectful, mature, and unemotional in his relaying his account of the abuse and his problems, at least in part caused by the abuse. The communication between us was excellent.

In addition to hearing what Mr. W-007 had to say, I tried to apologize on behalf of the church, acknowledging the fact that we had mismanaged the abuse issue in the past, particularly in regard to the priest he had spoken of. I encouraged him to call me at any time should he have any need for further discussion, spiritual direction, or advice he thought I could give him. In addition to offering an apology, I also advised him of the policy of the Diocese, to provide assistance for on-going counsel, therapy, and spiritual guidance; our willingness to pay out of pocket costs for any professional services he would require; and our willingness to pay for out of pocket costs he had to absorb up to this time related to therapy, counseling, or testing related to the abuse.

He reported that the abuser is Fr. Frank DeLuca. Mr. W-007 stated that he was 12 or 13 when the abuse occurred. He described how Father paid particular attention to him in little ways, expressing thanks for the boy's faithfulness of serving Mass, asking him to help do errands around the rectory or for him. At one point he was invited to help count the collection. One day Father said they needed to do some things at the rectory that involved several hours so he should ask his parents if he could stay overnight. Permission was given. That night the first abuse was committed. He made reference to vet another abusive incident on a trip to Salisbury. Fr. DeLuca asked Mr. W-007 parents if he could ride down to Salisbury with the priest. It would be an overnight. He also made mention of Father allowing him to drive his brand new 1962 black, red interior, Chevrolet. All in all, although he did not go into any detail, in answer to my guestion, Mr. W-007 said that the abuse occurred five or six times. He described himself as having been ashamed. He tried to avoid Father whenever possible. He went on to Salesianum. I asked him if he suffered any kind of cruelty or abuse by priests at Salesianum. No abuse. One priest did hit him with a trigonometry book. He reacted and pushed the priest. I think he also hit the priest, for which he had been suspended.

He never told his parents of the abuse because he thought (a) they would not believe him; (b) because of the high regard they had for priests. He had an uncle who was a priest and an aunt who is a religious nun. It was also during a time when you just did not say anything about such things. He is aware of at least one more victim whom he named to me (who has yet to come forward). He did warn his brother to stay away from Fr. DeLuca, but did not indicate why. In later years, raising his own boys, he forbad them to serve Mass as a protective step.

He knew the name of the Bishop who administered the Diocese at the time of the abuse. And he also knew that Fr. DeLuca obviously was transferred. I stated that Fr.

DeLuca was transferred, that diocesan officials at that time probably were aware of the abuse, but that is the way it was handled. I apologized for the cover up and for the church's inability to cope appropriately with the situation. He expressed thanks for my candor. I also shared with him the fact that another case involving Fr. DeLuca had come to light in the late 1980's or early 1990's (need to check the files) and at that time, the then Bishop, removed Fr. DeLuca from ministry permanently. Fr. DeLuca has not able to function publicly as a priest since then. In view of the Charter, the present Bishop also restricted Father even further, forbidding him from representing himself as a priest, wearing the collar, etc.

Mr. W-007 is 55 vears of age. He is married with two sons, I believe he said they were ages and both are students at the University of Delaware. He is a member of St. John the Beloved Parish in Wilmington, DE (it appears he is a lifelong member ... he grew up there and there is where the abuse began). He is a salesman for He makes a good appearance. His self expression is concise, vocabulary is good. He was unhesitant explaining the abuse and his personal problems and most willing to share all of his concerns. Mr. W-007 went to St. John the Beloved Elementary School; he was a server at Mass. He described himself as very service oriented when he was a kid, always willing to help people. He spoke of even having thought about being a priest in the 6th and 7th grades ... prior to the abuse. He went to Salesianum High School for his first three years of high school and he finished his senior year at Dickenson High School. Following his graduation ... I am not sure if it was immediately after graduation or sometime after that ... he and a number of buddies joined the Marine Corps. He gave service to his country in Vietnam in 1969 and 1970. In the course of our discussion he did not discuss what went on in Vietnam but did make an oblique remark about having been stationed near the area W-007 where Lt. Calley "did his thing." Sometime after returning home from the service stated that he never thought he would come home alive), he married. For the first 10 years of their marriage there were no children. He described himself as getting into the bottle early, perhaps for a sustained period of time for 5 or 6 years. When he and his wife were finally blessed with children he decided to change his life so that he could model appropriately to his children. He had kept the secret of his abuse from anyone and everyone. He said that he lived in fear that people would find out. The abuse was multiple and he apparently blames himself for having allowed it to go on.

related that after having had their first child, there was an accident one day where his tea spilled on his little boy. He rushed him to the hospital thinking he had scalded him. It was at that point he broke down and told his wife that he was under much pressure about things that happened in his life, among them the abuse. This was the first time he made a disclosure to anyone.

He suggested that he has been bothered by a number of happenings in his life, but in particular the abuse ... especially when there was pressure. However, he put on a good face, to use his expression, to be supportive to his two boys and to his wife, although he did admit to having a very short fuse, being angry often, and getting upset over little things, particularly with his wife. (He later related that his wife came from a verbally abusive mother.) In recent years he has been suffering from depression ...

probably suffered from depression in the past but did not or refused to recognize it. He was active in his parish; athletics, coaching kids; a member of the Athletic Association. He had not practiced his faith until his children came along. Then he decided that he had to model to them. He returned to church. He says he never went to confession since he was 13 years of age.

He described having to fight with his demons through most of his adolescent and adult life, suppressing the abuse. It was on the occasion of the terrible events of 9-11 that pressure began to build up and his worries were in such an extreme that he lost much sleep, worried about all kinds of things, had flashbacks of what happened in his life. He described his basic approach as protective again of his children, worried that the country would be torn apart, that the President had to reintroduce the draft. He worried about work. He said always his worries and his nighttime dreams included thoughts about the abuse. Finally in the spring of 2004 it got so bad he was fearful of breaking down completely and thus sought the assistance of a psychiatrist and a therapist. He spent some outpatient days at the Rockford Center. He got so depressed that he could not work for a couple months. Currently he is under the care of a psychiatrist at St. Francis Hospital and also a therapist, a woman at the University of Delaware.

I asked him if any of his depression and anger was related to the war or other events in his life and he admitted yes, but stated everything goes back to the abuse.

He described his relationship with his wife as great, saying she is very patient, especially in view of his outbursts of anger which evidently occurred often. He is under medication to control the depression and other psychological issues. His wife has told him recently that the outbursts have become less frequent since he has been taking the medication. The doctor tells him he will not be on medication all of his life, that they will gradually take him off it as he begins to become more calm and comfortable.

We then talked about what the Catholic Diocese could do for him. (Prior to that I again offered apology.) I described our policy. He decided that he would stay with his psychiatrist. However, he does not feel the woman with whom he is taking therapy is helping. I spoke to him about our Victim Assistance Coordinator, Beth Krieger, and I gave him her telephone number. (Subsequently Beth advised he called.) I told him that the Diocese would pay for any out of pocket expenses going forward and I asked him also that if he could possibly determine what his out of pocket expenses had been in the past for abuse related issues, we would consider reimbursing part or all of it.

I advised him of our protocol with the attorney general, that we would report any past abuse reported by an adult provided we had their permission.

We ended the interview with a promise for prayer and once again the invitation to talk with him at any time.

He will not be permitted to celebrate Mass publicly or to administer the sacraments. He is to be instructed not to wear clerical garb, or to present himself publicly as a priest."

Therefore, I have determined that there is no need to process these cases further with the Congregation for the Doctrine of the Faith. Thank you for your kind consideration and assistance.
