

IT IS HEREBY ORDERED that the Defendant shall have standard visitation throughout the trial. Because Mr. Jeffs will be in Court during the weekdays, the jail will need to make special accommodation to permit ^{standard} visitation to either occur on weeknights or on the weekend. The frequency of the Defendant's standard visitation shall not be diminished during the trial. *Visitation will not exceed that of other inmates in duration, only in timing.*

Additionally, the Defendant shall be entitled to use the telephone and have the same telephone privileges during the trial that he had before the commencement of the trial. Once again, because the Defendant will be in Court during weekdays, the jail may need to make special accommodations in order for the Defendant to utilize his telephone privileges.
