AFFIDAVIT

I, the undersigned affiant, Cynthia L. Schroer, after having been first duly sworn, do state and swear upon oath as follows:

Lafayette County Investigator Ray Burns received information of numerous criminal of fenses having been perpetrated against six children with-in one family. An investigation into these allegations led to the arrests of five individuals who are currently charged with various felonies concerning the sexual assault and rape of these six children when they ranged from age six to twelve. Some of the witnesses described a girl who lived in the basement but they did not know her whereabouts or whether she was alive. They did not know her identity.

Following press coverage of the arrests, a witness came forward to say that she was held on the property at Bates City. Missouri, 64011 in a basement area. She stated that she was abused by all five defendants. She recalls becoming pregnant to ice while in captivity. Following her delivery of the first baby, she recounts that Burrell E. Mohler, Sr. and Burrell E. Mohler, Jr. buried the infant in the basement which at that time had a dirt floor. The infant was in a box. Within days of this event, the basement floor was covered with a layer of concrete.

Acting on this report, on November 11, 2009, investigators contacted an employee of DNR-DER who is licensed to operate a ground-penetrating radar instrument to examine the location of the basement where the witness reported the infant was buried, specifically beneath the only window in the basement. The examination, which was conducted with the consent of the property owner, revealed a anomaly with 90 degree angles and flat sides buried approximately twelve inches below the concrete, consistent with the shape of a box. It is approximately 18-20 inches by 24-30 inches in size.

I, the undersigned affiant, Cynthia L. Schroer, after having been first duly sworn, do state and swear upon oath as follows:

- 1. On the date of October 7, 2009, I received a 36 page report from three witnesses who stated that they had observed several murders that took place in Lafayette County and Jackson County in the state of Missouri. The three witnesses are identified as All of these witnesses are biological sisters. This search warrant request pertains to a murder that took place in Lafayette County Missouri on the property located at the property loca
- 2. According to were driven to the Independence Shopping Center located in Independence Missouri where they observed a man get into his vehicle after leaving the Independence Shopping Center. Their father, Burrell E. Mohler Jr., was driving the vehicle. stated that her father followed the victim to his residence which was an older residence with the driveway on the left side of the residence. Burrell Mohler Jr. instructed his daughters to get out of their car and that her father was having a heart attack and they needed his help. The victim went to the passenger seat to take a look at Burrell Mohler Jr. The victim got on his knees to lean toward their father inside the vehicle. Their father was leaning back in the seat holding his heart and making groaning sounds. When the victim leaned in close enough their father wrapped his arm around the victim's neck and subdued him very quickly. Burrell Mohler Jr. told his daughters to get into the back seat of their vehicle. In a statement written by Adescribed the victim as being 6'2" and weighed about 300 pounds and the man looked to be in poor health.
- 3. stated that their father made them place blindfolds over their eyes so they would not know where they were going. After they had driven for an undetermined period of time, Burrell Mohler Jr. stopped the vehicle and had his daughters get out of the vehicle telling them to hold each other's hands and walk

until they reached a stopping point. Stated that her blindfold was very tight however she raised her blindfold and observed their grandfather's A-frame house and realized they were on their grandfather's farm in a wooded area. In a statement written by she stated that this event took place in the woods behind Burrell Mohler Seniors farm which is located at Bates City, Missouri.

- 4. Burrell Mohler Jr. told his daughters that once he let the victim go, he would kill them unless they killed him first. Mr. Mohler gave his daughters knives to stab the victim with. When their father let the victim go. Mr. Mohler counted to three and then all of his daughters were required to attach the victim. Once the victim was free, stated that she jumped on his back and tried to choke him with her arm. The victim stood up very fast and knocked to the ground. Ms. stated that she was mad that the victim had hurt her and she was scared that the victim would kill her or her sisters. Stated that she jumped on the victim's back and stabbed him repeatedly in the back. stated that her father stabbed the victim on the front part of his body which resulted in the death of the victim.
