INVESTIGATION PROCESS:

The 1988 claims were taken to H2 by the Vicar for Clergy and acknowledged. Subsequent claims have been consistent with the reported pattern. Most of the victims were from large families. H2 became friends with the family and subsequently invited the male children in the family to his home where the assaults took place.

RESTRICTIONS AND CONDITIONS OF MINISTRY
REV. DAVID HANSER

1. You will continue in individual therapy with Dr. [REDACTED]
[REDACTED]
2. The appropriate hospital administrator will receive full disclosure regarding the allegations made against you in the past. The administrator must consent to your continued employment. In addition your immediate supervisor will receive appropriate disclosure including these conditions and restrictions.
3. The following restrictions will be in place regarding your ministry as a hospital chaplain:
 - A. You may minister only within the following constraints as noted in the January 1, 1996 letter from Bishop Richard Sklba to you:
 - a. You are permitted to engage in the celebration of the Sacraments of Baptism (in emergency situations), Eucharist, Penance, and Anointing of the Sick within a hospital setting only; No other public ministry is permitted.
 - b. The faculty to hear confession is restored in the limited setting noted in (a).
4. No other public ministry includes no parish help out work, no public funerals, no other sacramental work whether in a private or parish setting, no home Masses, and no public representation of the pastoral care department of the hospital in which you are employed outside of the hospital setting.
5. You are to refrain from all contact with minors. The only exceptions are the following:
 - A. You may provide pastoral care to minors within the hospital setting provided there is no one else available to do so and you have first attempted to provide alternative coverage.
 - B. Within the hospital setting, you will refrain from being alone with minors except for the Sacrament of Penance.

You are on notice that any violation of the trust placed in you by your administration of the Sacrament of Penance in these situations will result in canonical action against you. Any violation by way of sexual misconduct with minors in the limited settings noted will result in the notification of the appropriate civil authorities.

C. Under no conditions will you be present with any minor within the hospital setting who is sedated, asleep, anesthetized, or otherwise in an altered state of consciousness without another individual present.

D. Extended counseling of minors (more than two pastoral visits) in the hospital setting is prohibited.

E. In any hospital situation in which there is ambiguity about whether these restrictions may be possibly violated, you are to consult with the monitor appointed by the Vicar for Clergy or with your immediate supervisor prior to providing ministerial services.

F. Under no circumstances will you continue any relationship with a minor whom you have met as a condition of your employment at the hospital.

6. You will cooperate with the monitor appointed by the Vicar for Clergy regarding oversight of compliance with these restrictions and conditions for ministry.

8. You will report any disciplinary actions against you in the hospital setting immediately to the Vicar for Clergy.

9. Review of these restrictions and conditions for ministry will occur in June 1997 or sooner at the discretion of the Vicar for Clergy. It is your responsibility to initiate the June 1997 review.

On Wednesday, July 6, 1988 I received a phone call from Sister Rosemarie Klotz indicating allegations of inappropriate activity between Dave and members of the [REDACTED] family. I also received a call from [REDACTED] requesting that I contact [REDACTED] about the same matter (work, [REDACTED] home, [REDACTED] but was not able to find anyone at the office.

On Friday, July 8, 1988 I spoke with Mr. [REDACTED] (work, [REDACTED]; home, [REDACTED]) regarding allegations of abuse toward his brothers, [REDACTED] and [REDACTED]. Two are substantially, allegedly, emotionally traumatized as a result of this matter. I then spoke with Dave by telephone indicating the general nature of the serious allegation without names. I subsequently visited Dave on Friday evening, July 8, 1988 at the parish rectory, reviewing briefly the way in which the information came to my attention through the Common Council Task Force, the general nature of the allegations (without names) and stating the request of the Archdiocese that Dave accept an administrative leave as of Tuesday, July 12, 1988 in order to protect all parties concerned with formal residence at Bethany House and the request that he not have young people at his cottage at Moose Lake. Dave took notes of our conversation, and informed me that his lawyer, Mr. Charles J. Hausmann (633 West Wisconsin Avenue, 271-5300) was very angry about lack of due process. I refused to speak with the lawyer directly and simply pointed out that I was following the administrative procedures outlined in the Clergy Manual for such allegations. Dave stated that he would fight the matter on a legal basis and indicated that he would contact me over the weekend. On Saturday, July 9, 1988 I spoke with [REDACTED] and his wife agreeing to change my vacation plans in order to meet with the alleged victims on Thursday evening, July 14, 1988 at one of their homes. On Saturday, July 9, 1988 I spoke with Dave's lawyer, Mr. Charles Hausmann with Dave in attendance on the other end of the line. I authorized Mr. Hausmann to be in communication with Joe Dean and informed the lawyer that I had scheduled an initial meeting with the alleged victims on Thursday, July 14, 1988. We agreed that the administrative leave would be effective Wednesday, July 13, 1988 and that formal residence effective that same date would be at Bethany House although Dave would be free to spend time at his mother's home in Milwaukee. Father Casper, OFM Cap., will provide sacramental services at St. Mary Parish in Pewaukee with no formal statement to the parish this weekend.

On Wednesday, July 27, 1988 I spoke with Attorney John McNally in order to reaffirm my desire that Dave have formal residence at Bethany House. I described the situation, and John agreed that this might be a beneficial arrangement providing Dave have the opportunity to live with his mother at: [REDACTED] even though his mail would be sent to the Bethany House address. In our discussion I again recommended the alternative as residential treatment at one of the major institutions authorized for specialized care such as St. Luke's in Maryland, Southdown outside of Toronto or St. Barnabas Center in Oconomowoc. John agreed to bring these matters to Dave for further discussion.

On Friday, July 29, 1988 Attorney John McNally called to say that David would accept the site of residence, namely, Bethany House, as requested by the Archdiocese. On Monday, August 1, 1988 I had an extended telephone conversation with [REDACTED] who gave me an update of her association with the [REDACTED] Family and expressed a positive assessment of my method of dealing with them thus far.

On Wednesday, August 3, 1988 I met with [REDACTED] ([REDACTED]) [REDACTED]; telephone, [REDACTED] who stated that his relationship with Dave began when he was a senior in high school or first year in college and has continued intermittently every since. [REDACTED] also stated that he has experienced [REDACTED] for some years after 1980 and then again during the last two years, and suspecting that some of his inability to obtain a full-time, permanent position may be related to this association. I also met with his father, [REDACTED], at the same address who requested that the names of the family not be divulged to Father Hanser out of fear that the more vulnerable members might undergo pressure or harassment. On Thursday, July 14, 1988 I met with [REDACTED] ([REDACTED] telephone, [REDACTED] who alleged a single unsuccessful attempted encounter in approximately 1969 at the age of 18 or 19; [REDACTED] (temporarily at [REDACTED] telephone, [REDACTED] who alleged a single contact with force as a high school junior in approximately 1970 or 1971; [REDACTED] telephone, [REDACTED] who alleged between 25 and 40 encounters between the ages of 12 and 17 or approximately from 1968-1973; and [REDACTED] ([REDACTED] who had not experienced any improper activity on the part of the priest. I was informed that contact had been made earlier this spring with Waukesha County Child Abuse Office and with Chief of Police of Pewaukee. I also learned that efforts are currently underway to contact parishioners who have left St. Mary Parish in an effort to see if such actions were in any way related to similar allegations. I expressed my consternation, regret and apologies for these allegations, and promised to speak with their father, Mr. [REDACTED] and their brother, [REDACTED] (same address as the father) as soon as possible. I expressed a willingness to assist in paying for therapy deemed necessary. The common requests of all parties was for some expression of pastoral care from the Church in their regard, assistance in therapy costs and the assurance that Father Hanser would not be allowed to function in some situation where such activity could continue. The tone of the conversation was candid, calm and respectful. [REDACTED]

On Monday, July 25, 1988 I spoke with Mr. John McNally, a partner in the Law Firm with Mr. Charles Hausmann (absent from the country for vacation for two weeks), requesting that St. Barnabas Center be named the legal residence for Dave rather than Bethany House which supposedly had some pejorative notoriety. I explained that St. Barnabas Center in Oconomowoc was a residential treatment center and could not be used for mere legal address and requested that the formal residence at Bethany house be maintained since I had no alternative to suggest. I also expressed my frustration at my inability to speak directly with Dave himself during this time of crisis and wrote a letter to that effect.

On Monday, February 6, 1989 I had an extended phone call with [REDACTED] in [REDACTED] to review and explain the contents of my recent letter. I explained the current status of the situation, noted the limitations within which I work and described the investigation which I pursued over the recent months. I explained how proposals associated with "Project Benjamin" would be viewed as a partial response to this particular situation and agreed to speak with Father John Hanley about the matter in the future since [REDACTED] was at the high school at the time referred to in the allegations.

On Tuesday, February 21, 1989 I received a phone call from Chaplain Don Sass of St. Luke Hospital reporting that Dave will enter a basic CPE Course at St. Luke's beginning February 27, 1989 and is intending to move into an advanced second unit at St. Joseph Hospital in Milwaukee beginning June 5, 1989. In view of rumors regarding alleged pedophilia, Don called asking if there was some information he should know of. I acknowledged the allegation relating to several years back and suggested that the hospital designate areas of adult patients pending the conclusion of investigation. I also recommended that Don speak with Dave so that Dave might receive the type of pastoral care he needs at this time.

On Monday, May 8, 1989 Bishop Leo and I met with the Archbishop to review several cases. It was determined that prior to any specialized assignment there would be a candid conversation to see if there were any matters still not disclosed or discussed from earlier history. It was presumed that a detailed plan would be in place regarding the therapeutic support group, ongoing supervision, counseling and some type of spiritual life.

Dr. [REDACTED] again telephoned asking for some information regarding the ministerial restrictions imposed upon David at St. Joseph's Hospital. He called again in my absence with this inquiry.

On August 30, 1995 the Archbishop requested, after consultation with Dr. [REDACTED] of Milwaukee Psychiatric Hospital and the Consultants, asked that I notify Dave of renewed faculties restricted to certain areas of hospital ministry at St. Joseph Hospital in Milwaukee. I attempted to do so later that same day ([REDACTED] at [REDACTED] Nashota, WI 53058) but was only able to speak with his sister who resides with him.

Richard O'Donnell who gave assurances that he would take responsibility for doing so). I also learned that the Hospital might be proceeding to terminate David's position because of an allegedly negative review of David's condition, given by Dr. [REDACTED] to the Hospital Administrator the previous week.

On May 17, 1996 I joined Carrol Straub in meeting with David Hanser (who requested the additional presence of Thomas Trepanier) in order to discuss the status of David's ministry and current restrictions. After a ranging discussion of issues it was agreed that David would seek the Vicar's permission for any liturgical celebration outside the actual confines of the hospital. He also agreed to the basic proposal for monthly support/monitoring by Deacon Thomas McGuine according to the specific profile to be established in consultation with all parties concerned. I reviewed the fact that I had initiated conversation with the head of Pastoral Care at St. Joseph Hospital earlier that year in order to make sure that the Hospital Administration was properly informed of the background allegations. David indicated that Mr. [REDACTED] was no longer in employment at the hospital and might be a source of problems with the information he possessed.

694. Hanser, David
I visited him to discuss some of the complaints that had come to my attention from Father Darnieder, Father Newman, and the Archbishop. With her permission I discussed Mrs. [REDACTED] letter to the Archbishop with Hanser. He had an answer to all the complaints listed in the letter except for the accusation that he uses vial and terrible language in front of the children. He denied this vehemently and asked me to help him get the matter cleared up so that this kind of smear would not emanate through the parish. I got the general impression that Father Hanser was trying very hard to do a good job in a parish where situations like obtaining a new principal and other school personnel have caused some hurt feelings as usually happens.

He told me that things were going well in the parish now that school has started and they have a new principal. The people seem to be calmer and at least there is no tension or controversy at present. He would like Sr. Rene to help him reconcile the differences between himself and [REDACTED] if possible.

Sister Rene Kuban asked my advice about confronting Hanser with some of the information she is receiving from parishioners and even from the new principal. I asked her to do it in a calm and gentle manner.

He just called to give me a little update on things at the parish. He said in general everything is good and that he is feeling fine. He is experiencing a problem with his neighbor, Father Huettl, who will not cooperate with the parish school district in order to help inlist children from his parish for the Catholic Grade School of St. Mary's. He refuses to allow any bulletin announcements to be made or to have any of his parishioners contacted. He has hung up on the principal of St. Mary's twice. On Thursday, August 25, 1988 I spoke with Bishop Maida regarding the case. He advised the limitation of faculties in some way as a temporary response to the allegation pending final investigation and also suggested that an evaluative process be recommended as part of an assessment of whether or not Dave should return to the parish. This would preclude all possible discussion of treatment prematurely during this time of investigation. On Friday, August 26, 1988 I called various treatment centers to learn that St. Barnabas Center had an opening immediately, that St. Luke's Institute in Maryland had an opening as of September 18, 1988 (which I requested be temporarily reserved for Milwaukee) and that Southdown, outside of Toronto, did not have an opening until November 13, 1988. That same afternoon I met with Mr. Charles Hausmann in his office for an hour and a half (with Dave present but not participating in the discussion). Mr. Hausmann indicated that his own investigation suggested a very strong desire on the part of the complainants (whose names I did not mention) for substantial settlements. He asked that I pursue some effort to obtain the specific amounts of recompense desired by the plaintiffs in order for him to properly protect Dave's rights. He stated that he would take my request for an evaluation under advisement and would respond after considering all implications. I stated that if this were refused I would feel forced to invoke complete suspension. I also requested that Dave formally avoid any ministerial or social contact with adolescents pending the investigation.

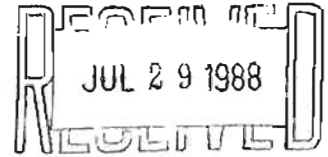

I write to express my sincere thanks for your letter of January 9, 1989 and to say again that I am very pleased to learn that some positive results are beginning to show as a result of the counseling sought by your two brothers. In conversations and letters I strongly encouraged them to seek the professional care needed, and I am pleased to hear your comments.

As you know, even before our meeting last July, I invoked an administrative leave for Father Hanser according to the stipulations of Canon Law. While the matters discussed at your home are both serious and complex, extensive investigation has not revealed any evidence of further improper relationship with minors on his part. In view of the issues raised from the past, Father Hanser's resignation was requested, and the present months have been devoted to professional counseling and spiritual direction. When sufficient therapy has been received, an appropriate assignment will be sought in the light of the professional judgements upon which our office must rely.

I assure you that I am handling this entire matter with the seriousness it requires with all respect for its long and complicated history. I ask your trust and confidence that these issues are being properly cared for, and that the matter is far from resolution as an episode of passing significance. While the resignation does not signify final action in the matter, pastoral confidentiality and respect for the needs of all concerned dictate that a more specific response to your inquiry cannot be provided. Thank you for your professional understanding and assistance.

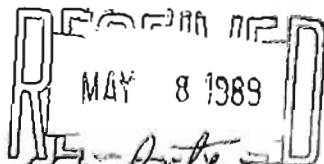

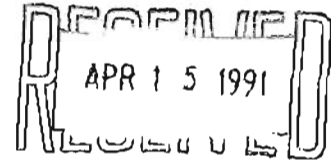

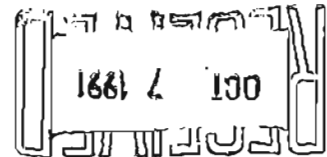

Dear Father Hanser,

As you are aware I must frequently review the situation of priests who have had allegations of misconduct placed against them. You know of my comments at the Spring Assembly for Priests where I indicated that accused priests may have to have some restrictions placed on the ministry they can offer. My concern is both to ensure that the integrity of the priesthood is upheld and to protect the diocese from any allegations of improper monitoring which might place persons at risk.

I have pondered how best to proceed with decisions regarding your status and exercise of ministry. I must bear in mind both my responsibility toward the good of the whole community and respect for your individual rights.

Given the serious nature of the obligations of celibacy, as well as the seriousness of violations alleged to have occurred by you, I find that some necessary and prudent precautions must be taken. This decision is ultimately a pastoral measure to protect the rights and reputations of all involved.

Therefore, I am enclosing a document which specifically details any ministerial restrictions which are to be observed by you. You have never been officially assigned to ministry at St. Joseph Hospital but have offered services there on your own. In order to avoid any scandal, we will have to inform the hospital that you can no longer provide such service.

I know that I can count on your cooperation and obedience in this matter.



LAICIZATION RESCRIPT - UNOFFICIAL TRANSLATION
Congregation for the Doctrine of the Faith

Prot. N.: 247/04

Milwaukee

Father David John HANSER

September 30, 2005

The Supreme Pontiff Pope Benedict XVI

having heard the opinion of this Congregation concerning the serious actions of the above named presbyter of the Archdiocese of Milwaukee (Milwaukee, USA), with the proper documentation having been sent and finding this final decision to be beyond appeal and not subject to recourse,

has decreed

that the penalty of dismissal from the presbyterate be imposed.

This same presbyter is also granted a dispensation from all of the obligations connected with sacred Orders in accord with the following consideration:

1. The dismissal and dispensation take effect at the very moment of the decision of the Roman Pontiff.
2. The decree of dismissal and dispensation are to be communicated to the presbyter by the competent local Ordinary and no one has the right to separate those two elements. Indeed, further, it carries with it, insofar as it is necessary, absolution from censures.
3. Notice of the granting of the dismissal and dispensation is to be inscribed in the baptismal register of the aforementioned presbyter's parish.
4. With regard to the celebration of a canonical marriage, the norms set down in The Code of Canon Law must be applied. The Ordinary, however, should take care that the matter be discreetly handled without pomp or external display.
5. The ecclesiastical authority, to whom it belongs to notify the priest, should earnestly exhort him to take part in the life of the People of God, in a manner consonant with his new mode of living, to give edification, and thus to show himself a most loving son of the Church. At the same time, however, he should be informed of the following points:
 - a) the dismissed presbyter automatically loses the rights proper to the clerical state, as well as ecclesiastical dignities and offices; he is no longer bound by the other obligations connected with the clerical state;
 - b) he remains excluded from the exercise of the sacred ministry, with the exception of those functions mentioned in canons 976 and 986, §2, and, as a result, he may not give a homily nor is he able to hold a directive office in the pastoral field nor to exercise the function of parochial administrator;
 - c) similarly, he may not discharge any function in seminaries and in equivalent institutions. In other institutions of higher studies, which are in any way whatever dependent upon ecclesiastical authority, he may not exercise a directive function;

- d) in those institutions of higher studies which are not dependent upon ecclesiastical authority, he may not teach any discipline which is properly theological or closely connected with the same;
 - e) in institutions of lower studies, which are dependent upon ecclesiastical authority, he may not exercise the function of teaching a discipline which is properly theological. A dismissed and dispensed presbyter is held by the same rule in teaching Religion in an institution of the same kind not dependent upon ecclesiastical authority.
6. The Ordinary is to take care lest the dismissed presbyter, because of a lack of prudence, exhibits scandal to the faithful. This pastoral solicitude of the Ordinary is most important if a danger of abuse of minors, although remote, is present.
 7. Notification of the dismissal and dispensation can be made either personally or through an ecclesiastical notary or through registered mail. The dismissed priest ought to retain a copy properly signed attesting to his reception and acceptance of this dismissal and dispensation and also its precepts, but if he does not it does not impede the effect of this decree.
 8. At an opportune time, the Ordinary is to send a brief report to the Congregation on his completion of the notification, and, if there is any wonderment on the part of the faithful he is to provide a prudent explanation.

All things to the contrary notwithstanding.



Your Excellency:

About three months ago I visited you at the chancery office. At this time I came to you with the situation in which I found myself at Christ King.

On the occasion of this meeting I admitted at great length that I was quite confused and knew not what to do about the "events" that happened to me since my placement after ordination last June, 1959.

In the course of your kind discussion you had asked me, "Father, what is your solution to the problem; what would you do if you were me?" Those words made such an impression upon me that therein I found the solution to the situation.

Your words made me think as I have never thought before about the matter I presented to you; and shortly thereafter I came to these two conclusions regarding myself:

1. When I left the seminary, I had dreams of the future work that lay ahead of me. But the little "shocks" that occurred to my over-idealistic and immature mind (shocks that any newly ordained is bound to find in his first years) were gradually bringing me back to reality. I did not recognize that this was happening until after I had given your above words lengthy consideration. I was forced to admit to myself that immaturity and ultra idealism were causing the problems to exist in a over magnified light and unduly out of proportion to reality.

2. Also, I woke up to the fact that I consulted you expecting to get "the magic answer", "the magic pill" that would remove all "aches and pains" that occur at one time or another in the life of any priest.

So realizing my immaturity and over-idealistic outlook, plus the fact that I wanted someone else to cure the situation here painlessly for me, I tried an approach which I should have done from the beginning of my assignment. And so my "beginning" began not last June of 1958, but shortly after my visit with you about three months ago in 1959.

In the course of a realistic approach, I have come to know the true Father Joseph Huepper; and he has come to know me. There has been such a change in the over-all picture that words fail to describe it now. Regardless of what others say or what I have said or thought in the past, I now look back and ashamedly admit my errors.

It is unbelievable how we understand each other even in spite of the little differences of our natures that exist between us. These things seem to make no difference at all; in fact, they actually have and are now making us appreciate one another for what we truly are.

Rather than continue to describe the new picture as it has developed and continues steadily to do so, I feel that I owe you an apology for my immaturity in approaching the problems that confronted me. But rather than an apology, I would prefer to extend to you my sincerest gratitude for you questions. They might seem as nothing, but to me they have made all the difference in this priestly world of mine- a world of true reality and growing maturity that has brought a contented type of happiness that I once firmly and erroneously thought impossible at Christ King.

Dear Archbishop Weakland:

Allow me to take this opportunity to thank you for your valuable time and concerted interest in meeting with Dr. [REDACTED] and myself on July 28, 1995. I appreciated your sincere pastoral concern and significant affirmation for my ministry at St. Joseph's Hospital. I am grateful. Thank you.

Dr. [REDACTED] asked that I present you with a synoptic summary of events leading up to our meeting. In the Fall of 1987, I contacted Fr. Tom Trepanier regarding possible allegations that might occur. After much personal disclosure and discussion, and following the policy regarding allegations, he directed me to contact attorney Charles Hausmann, stressing that I follow his advice as an important part of the process. Having done this, I kept in frequent contact with Fr. Trepanier informing him of the status of my situation. At the same time and on my own volition, I met with psychotherapist [REDACTED] whom I knew for about ten sessions in later Winter - early Spring of 1987 to 1988. He recommended psychiatrist Dr. [REDACTED] whom I began to meet till the present.

In July of 1988, Bishop Sklba met and informed me of allegations requesting the necessity of resigning from the Pastorate of St. Mary's, Pewaukee according to policy with which I complied. I continued to work with my lawyer and followed his legal directions as reinforced by Fr. Trepanier. In the interim, the lawyer became the intermediary between the Archdiocese and myself until the situation was settled in late December of 1988.

I followed Bishop Sklba's request in the early Fall of 1988 to have an evaluation at a number of suggested sites. I complied and entered Carl Rodgers Memorial Hospital, Valley Road, Summit, Wisconsin, for a five day period in October of 1988. In my early contacts with Bishop Sklba, he suggested that I might possibly try to get into some Clinical Pastoral Education program (CPE). His advice proved to be very appropriate. I enrolled in my first unit in the Spring of 1989 at St. Luke's Hospital, Milwaukee, and found it to be extremely insightful. I thanked Bishop Sklba for the opportunity and pursued unit two in the summer of 1989 at St. Joseph's Hospital under the Pastoral Care Director and Supervisor, Fr. Richard O'Donnell, with whom I shared and grew. He became my confidant and in turn had contact with Bishop Sklba and Fr. Trepanier in priest personnel. Fr. O'Donnell saw that the hospital environment was conducive to my well-being in many faceted ways. This conclusion was based on what was being achieved through the mysterious and graced world of suffering which opened up dimensions of compassion dormant in my life.

Continuing this pursuit, I was accepted for unit three in the Fall of 1989 through Spring 1990 at the Veteran's Administration Center, Milwaukee. The CPE program was suddenly and permanently terminated. Fr. O'Donnell offered me 1989-1990 Fall-Spring extended unit at St. Joseph's in which I enrolled and successfully completed. At his request, I did fill in at St. Joseph's as needed. From January of 1991 to June I also worked at the Veteran's Administration Hospital under Chaplain Richard Weeden. This experience provided another dimension of ministry to the sick. Then in the summer of 1991, Fr. O'Donnell suggested that I might work simultaneously at St. Joseph's and St. Camillus Campus in the nursing home area. He also advised me to be certified in the National Association of Catholic Chaplains. I immediately began this process and presented the completed requirements in the Fall of 1991. I was certified in early Spring of 1992 and maintain NACC certification to date. Somewhere in this time frame, in a meeting with Bishop Sklba, he appraised me of a Pastoral Care position of Directorship at Marian Franciscan Home, Milwaukee, and encouraged me to apply. I did so but a woman with experience as chosen. Shortly thereafter, Fr. O'Donnell invited me to a full-time position as resident staff chaplain at St. Joseph's. Approval was given by letter to Fr. O'Donnell from Bishop Sklba and Fr. Thomas Venne, the Vicar for clergy. I accepted the position with Dr. [REDACTED] concurring with his approving encouragement.

I had been employed full time until your letter of May 28, 1995 requesting I terminate this position at St. Joseph's. I immediately informed Dr. [REDACTED] and Fr. Tom Trepanier. In presenting this to Fr. O'Donnell, he recommended and arranged an official Personal Leave which was approved by him and granted by the hospital for a six month period with the ability to return at anytime within that period. Fr. O'Donnell wanted to keep this possibility open. At our meeting of July 28th, 1995, I requested your permission to return to St. Joseph's on September 1st, 1995, continuing under Dr. [REDACTED]'s supervision. As you recall, Dr. [REDACTED] has agreed to assume complete legal and personal responsibility for my ministry in his professional capacity.

Archbishop, I have tried to detail as closely and accurately as I can recall the events leading up to our meeting. I continue to see Dr. [REDACTED] and maintain a close relationship with Fr. Trepanier who has proven to be a personal and competent confidante. I have kept both Dr. [REDACTED] and Fr. Trepanier closely appraised of my ongoing life events. I have shared the same with Fr. O'Donnell. In my work with him, I sincerely feel that I have grown and been graced in many ways by his support and understanding. I have earnestly striven to fulfill all agreed upon requirements and complied with the expectations of my person and position. I have also appreciated your support as well as that of Bishop Sklba along with the Archdiocese these past eight years. I sincerely hope and pray that I may be permitted to work at St. Joseph's Hospital serving the needs of the sick and suffering in commitment.

Upon the advice and recommendation of your therapist, I have considered moderating some of the ministerial restrictions that were issued in May of this year. Given the assurances of Doctor ██████ regarding your situation, I have altered the conditions under which you may exercise priestly ministry.

Effective September 1, 1995 you may resume some limited exercise of priestly ministry according to the following requirements:


- 1) You may celebrate the Sacraments of Baptism (in emergency situations), Eucharist, Penance, and Anointing of the Sick within a hospital setting only; no other public ministry is permitted.
- 2) The previously placed restriction to refrain from all contact with minors remains in force;
- 3) You are to continue to avoid all places and situations that, from past experience, have been occasions of serious temptation in the area of sexual morality;
- 4) Until further notice the faculty to hear confession is restored only in the limited setting noted above.

These ministerial conditions and restrictions will remain in effect until further notice. They are to be shared with your therapist and periodic reports on your condition are to be provided to me by him.

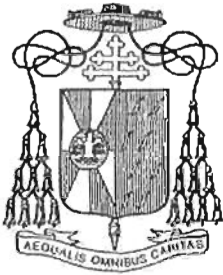
Given the nature of your situation, I am unable to formalize your ministry with an official chaplaincy assignment. However, if a hospital administrator, having been fully informed by you of the conditions under which you may minister and the reasons for such limitations, should choose to employ your services, I would not place any objections to such a plan. Because this would not be a regular ministry assignment it would not be published or listed as such.

I hope these matters are clear. If you have any questions about the meaning of any of these conditions, please contact my office immediately. I know that I can count on your cooperation and obedience in fulfilling these requirements for ministry.

PRECEPT

In response to the pastoral needs of this Christian community, in virtue of my authority as diocesan bishop (c. 381, §1), and in accord with the provisions of canon 49, I formally place upon Reverend David J. Hanser the following obligations:

- 1) To refrain from all contact with minors, vulnerable adults, and other persons or categories of persons who have proven to be occasions of temptation in the area of sexual morality;
- 2) To cease until further notice all public ministry including the celebration of Eucharist; Eucharist may be celebrated in a private setting alone or with only another priest or priests in attendance; the celebration of any other sacraments will require explicit permission of a local ordinary in each case;
- 3) To avoid all places and situations that, from past experience, have been occasions of serious temptation in the area of sexual morality;
- 4) To cease any and all activities and relationships that may be described under the broad category of pastoral counseling;
- 5) Until further notice the faculty to hear confession is revoked.

The reasons motivating this decree are the allegations of sexual activities in violation of the obligation of clerical celibacy (c. 277, §1). These restrictions are seen as necessary and prudent precautions and will remain in effect for three months from this date or until notice of their revocation. Any violations of this precept could result in penal action and this decree shall serve as canonical warning to that effect.

This decree shall be executed by means of its communication to Reverend David Hanser by Very Reverend Joseph Hornacek.

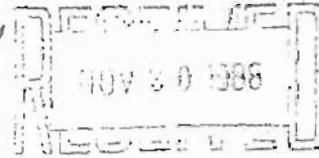

Your Eminence:

In accord with the norms of *Sacramentorum sanctitatis tutela*, I am submitting for your consideration the case of a priest of the Archdiocese of Milwaukee. Reverend David John Hanser has been accused of multiple acts of sexual abuse of minors. The summary of these allegations is enclosed. Father Hanser has admitted that a number of these acts of sexual assault occurred.

Over the years, efforts were made to provide spiritual and psychological interventions that would rehabilitate Father Hanser. It was thought that a non-parochial assignment might be possible. With our current understanding of the nature of his condition, it is clear that he will never be able to assume any public ministry.

As we have reviewed the various files, it is clear that he consistently abused his office both to gain access to vulnerable boys and to elicit the trust of their parents. He used his personal and family wealth as a way to approach families of similar status and befriend them. He manipulated those friendships into opportunities to take the young males to his lake cottage where the sexual contact occurred.

The impact on his various victims has been significant. The Archdiocese of Milwaukee is paying ongoing therapy costs for several of them and has done so for a number of years. Our new found awareness of the severity of damage caused by sexual abuse at the hands of clergy makes it impossible for us to ignore this situation.

The notoriety of this case became even more serious in 2002 with the announcement of a criminal investigation. While no charges were filed because of the statute of limitations, the district attorney concluded that, in his professional judgement, the assaults did occur. Additional publicity arose with the filing of civil suits. Rather than take a humble and remorseful stance, Father Hanser occasioned more scandal by suing the individuals who filed the suit. Because of his financial status, he was able to arrive at a monetary settlement the details of which have not been shared with me.


Given the nature and frequency of the alleged and admitted sexual abuse, along with the serious abuse of office, I have pondered long and hard to arrive at an opinion about the most appropriate action to be taken. In order that justice may be made manifest and healing of the victims and the Church may proceed, I am asking that Reverend David John Hanser be dismissed *ex officio, ad poenam* from the clerical state. Father has sufficient financial resources to care for his personal needs and will continue to receive his pension. He owns his own home where he is currently residing.

If the judgement of Your Eminence is that this case should proceed to a dismissal by decree of your Congregation, I would cede to that judgement. Furthermore, if it is your judgement that this case should proceed through a canonical penal process, I humbly request a dispensation from prescription as well as a sanation of any procedural errors that may have occurred during the years this case was under investigation. The severity of the offenses is such that it is my opinion that these requests are justified.

I look forward to your further instructions in this matter.

Your Eminence:

I write to you today as the advocate and procurator for Father David J. Hanser, a priest of the Archdiocese of Milwaukee. I am enclosing a copy of the mandate.

Father Hanser contacted me on February 9, 2005, after he had just received a letter sent from the Archbishop of Milwaukee, the Most Reverend Timothy M. Dolan, on February 5, 2005, which indicated the Archbishop's intent for the laicization of Father Hanser. The Archdiocese has not yet provided any information or explanation about the allegations made against Father Hanser. The only source of information has been the media. I have requested the opportunity to review Father Hanser's file and am waiting to arrange a specific date.

I understand that his current situation stems from incidents that allegedly occurred a number of years ago. It is also my understanding that Father Hanser is living in retirement and has had his faculties restricted. Further, I have spoken briefly with Ms. Barbara Anne Cusak, the Delegate of the Archbishop of Milwaukee, the Most Reverend Timothy M. Dolan, who informed me that Father Hanser's case has already been forwarded to the Doctrine of the Faith along with the Archbishop's *votum* asking for an involuntary dismissal from the clerical state.

Father Hanser has been retired since May, 2002. His ministry has been restricted. The Archdiocese has sought little contact with Father Hanser since that time. Father Hanser is well over seventy years of age.

Father Hanser does not want to be laicized. He wishes to remain a priest in his retirement, but he does not seek to be active. He is concerned about the supplemental health insurance provided by the Archdiocese – something very understandable for a man of his age.

I ask you to allow me time to review Father Hanser's files and the information which the Archdiocese has so that I can provide an appropriate defense statement on his behalf.

Your Eminence:

I am in receipt of a copy of a letter sent to you by Mr. Michael Ritty on behalf of Reverend David Hanser (copy enclosed). The matter being addressed was sent by the archdiocese to the Congregation for the Doctrine of the Faith in May 2004. Since Mr. Ritty is being given incorrect information by Father Hanser, I thought it important to correct some statements contained in the letter you have received.

Father Hanser has apparently informed Mr. Ritty that he does not know the substance of allegations against him because the archdiocese has not "provided any information or explanation about the allegations." This statement is false. Father Hanser was informed when these allegations first came forward in 1975 and again in 1988. In 1988 one family with multiple victims came forward and he admitted the veracity of the reports. He resigned from office at that time. Again, in 2002, when he was confronted by the parents of three members of a family who were abused, he again admitted the abuse and offered to send them a letter of apology. He was a party to a settlement and provided a portion of the monetary compensation in the first instance. Father Hanser filed suit against that same family in 2002. Clearly he knows what allegations have led to canonical action against him.

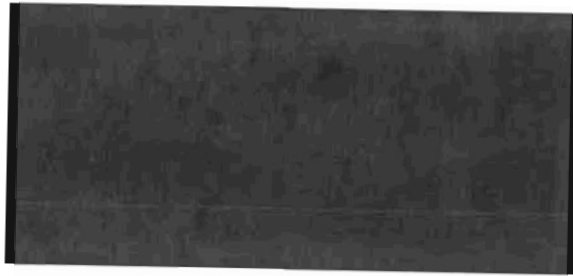

Dear Archbishop ListECKi:

I am writing to file a claim for monetary damages against the Archdiocese of Milwaukee for sexual abuse on me by a priest, Father David Hanser. This abuse occurred in the early 1960's on the property owned [redacted] in Nashota, Wisconsin. Father Hanser was renting a cottage on [redacted] on Moose Lake for a number of years and would always be bringing young boys out to the cottage throughout the summers to play at the lake. What went on in his cottage at night was a nightmare.

His sexual abuse on me occurred over one of the summers I spent at [redacted] property when I was around 11 or 12 years old. I told my older brother shortly after it occurred, and he insisted that I tell our parents. He and I told our parents of what had happened, but they, as well as my grandfather and grandmother, did not believe us. How could a Catholic priest sexually assault a young boy, they said. Impossible, they said. That's the way it was in the early 1960's. Nobody believed such a thing was even remotely possible, partly because the Archdiocese covered it up.

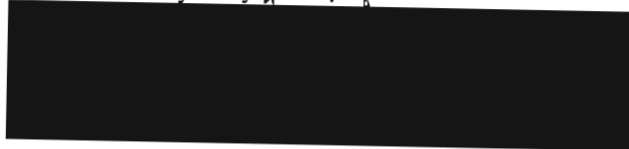
I have been repressing this sexual abuse over the past 50 years, but the recent disclosure in the press involving the Pope has brought all the repressed memories rushing to the surface. [redacted]



I am really not interested in going public with this information. I would rather settle this manner quickly, quietly and fairly without fanfare. To that end, I am making a demand on the Archdiocese in the amount of \$250,000.00 to forever settle this matter.

The Supreme Pontiff Pope Benedict XVI

having heard the opinion of this Congregation concerning the serious actions of the above named presbyter of the Archdiocese of Milwaukee (Milwaukee, USA), with the proper documentation having been sent and finding this final decision to be beyond appeal and not subject to recourse,

has decreed

that the penalty of dismissal from the presbyterate be imposed.

This same presbyter is also granted a dispensation from all of the obligations connected with sacred Orders in accord with the following consideration:

1. The dismissal and dispensation take effect at the very moment of the decision of the Roman Pontiff.
2. The decree of dismissal and dispensation are to be communicated to the presbyter by the competent local Ordinary and no one has the right to separate those two elements. Indeed, further, it carries with it, insofar as it is necessary, absolution from censures.
3. Notice of the granting of the dismissal and dispensation is to be inscribed in the baptismal register of the aforementioned presbyter's parish.
4. With regard to the celebration of a canonical marriage, the norms set down in The Code of Canon Law must be applied. The Ordinary, however, should take care that the matter be discreetly handled without pomp or external display.
5. The ecclesiastical authority, to whom it belongs to notify the priest, should earnestly exhort him to take part in the life of the People of God, in a manner consonant with his new mode of living, to give edification, and thus to show himself a most loving son of the Church. At the same time, however, he should be informed of the following points:
 - a) the dismissed presbyter automatically loses the rights proper to the clerical state, as well as ecclesiastical dignities and offices; he is no longer bound by the other obligations connected with the clerical state;
 - b) he remains excluded from the exercise of the sacred ministry, with the exception of those functions mentioned in canons 976 and 986, §2, and, as a result, he may not give a homily nor is he able to hold a directive office in the pastoral field nor to exercise the function of parochial administrator;
 - c) similarly, he may not discharge any function in seminaries and in equivalent institutions. In other institutions of higher studies, which are in any way whatever dependent upon ecclesiastical authority, he may not exercise a directive function;

- d) in those institutions of higher studies which are not dependent upon ecclesiastical authority, he may not teach any discipline which is properly theological or closely connected with the same;
 - e) in institutions of lower studies, which are dependent upon ecclesiastical authority, he may not exercise the function of teaching a discipline which is properly theological. A dismissed and dispensed presbyter is held by the same rule in teaching Religion in an institution of the same kind not dependent upon ecclesiastical authority.
6. The Ordinary is to take care lest the dismissed presbyter, because of a lack of prudence, exhibits scandal to the faithful. This pastoral solicitude of the Ordinary is most important if a danger of abuse of minors, although remote, is present.
 7. Notification of the dismissal and dispensation can be made either personally or through an ecclesiastical notary or through registered mail. The dismissed priest ought to retain a copy properly signed attesting to his reception and acceptance of this dismissal and dispensation and also its precepts, but if he does not it does not impede the effect of this decree.
 8. At an opportune time, the Ordinary is to send a brief report to the Congregation on his completion of the notification, and, if there is any wonderment on the part of the faithful he is to provide a prudent explanation.

All things to the contrary notwithstanding.


This Dicastery, after a careful and attentive study of the facts, and in light of the faculty granted to this Congregation by the Supreme Pontiff on 7 February 2003 to dispense from Article 17 of the *Motu proprio "Sacramentorum sanctitatis tutela"* requiring a penal judicial process, has decided to support your request that the above-mentioned priest be dismissed *ex officio et in poenam* from the clerical state.

In an audience granted on 30 September 2005, the Supreme Pontiff decreed that the Reverend David John Hanser is dismissed *ex officio et in poenam* from the clerical state and is, moreover, released from all obligations of the Sacred Priesthood, including that of celibacy. Any censures under which he may be labouring are remitted by this decree.

Your Excellency is asked kindly to inform Father Hanser of this grave decision according to paragraph 7 of the enclosed decree. A signed and notarized copy of the decree should be returned to this Dicastery at your earliest convenience.



Based upon my review of the file, at this point in time, I will be closing the matter out with no adverse action being taken against David Hanser. Unfortunately, I am not able to proceed against David Hanser due to the statute of limitations. My review of his personnel file was not able to document any time that he was out of the State of Wisconsin for a significant period of time. There is no doubt in my mind, based upon the review, that David Hanser assaulted these young boys and has caused them significant harm. I wish I could hold him criminally responsible, but unfortunately, I cannot.

I do, however, want to thank you and the Milwaukee Archdiocese for the very professional manner in which you handle these cases, as well as your sensitivity in these matters. I know the victims very much appreciate it. Best of luck to you, and again, thank you for your cooperation.

Father Hanser became friends with the family and subsequently invited the male children in the family to his lake cottage where the assaults took place.

Statement of the Archdiocese of Milwaukee

An allegation of sexual abuse against Fr. David Hanser was received by the Archdiocese of Milwaukee in 1988. Fr. Hanser was immediately placed on administrative leave. At the time, Bishop Richard Sklba met with both the victims and their mother.

On the recommendation of Fr. Hanser's therapist and with the therapist's assurance that there was no risk in placing Fr. Hanser in a pastoral assignment doing hospital ministry, Fr. Hanser was allowed to work as a hospital chaplain. He began that ministry in 1991.

At the onset and on multiple occasions, Bishop Sklba personally contacted the Director of Pastoral Care at the hospital and reviewed the background regarding the allegation of sexual abuse, the assurances of the therapist, and the ministry restrictions placed upon Fr. Hanser by the Archdiocese of Milwaukee. Those restrictions excluded unsupervised contact with minors and excluded work in the pediatric areas of the hospital.

In addition, notification of the past allegation, therapist's assurances, and ministry restrictions was given to the hospital administrator.

In March 2002, Fr. Hanser notified the Archdiocese and the hospital of his plans to retire as of May 6, 2002.

On Tuesday, November 1, 1988 I met with Attorney Charles Hausmann to discuss the current status and future plans for Dave's ministry. He reported that Dave has been seeing Dr. [REDACTED] of the Milwaukee Psychiatric Hospital for professional counseling and [REDACTED] SDS for spiritual direction after his return from St. Barnabas Center at the end of September. We discussed an agreement by which any conversation I might have with Dave would be considered confidential. I subsequently informed Attorney Hausmann that one of the plaintiffs had requested a settlement of \$500,000 to cover counseling costs and damages. On Wednesday, November 2, 1988 I brought both the letter from [REDACTED] and the proposed agreement to Joe Dean for his study and review. On that same morning I met with Dave Hanser in my office in order to discuss his needs and those of the larger Church at this time. I recommended that he resign from the pastorate at St. Mary's in Pewaukee for personal reasons, that he take some time to continue counseling and seek either CPE for hospital ministry down the line or some other type of specialized training should a different ministry better match his gifts.

On Wednesday, November 2, 1988 I received a phone call from Dr. [REDACTED] indicating that [REDACTED] had begun some type of treatment with him. I authorized billing to our office in my brief conversation with Dr. [REDACTED]

In view of the fact that his suggested sum of money had been formulated in consultation with a lawyer, I stated that I would be forced to refer the matter to our Archdiocesan Legal Counsel before formalizing a response.

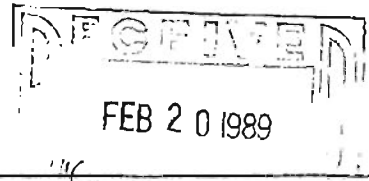

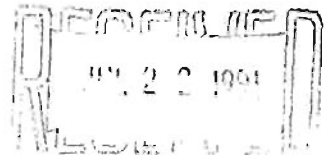

I spoke with [REDACTED]
[REDACTED] is concerned about the current whereabouts and activities of Father David Hanser, and initially requested to come to Milwaukee to review his records. According to [REDACTED] he and her husband, [REDACTED] first became acquainted with Father Hanser when they were both students at [REDACTED]. He sexually abused [REDACTED] and then three of his younger brothers ([REDACTED]). The abuse came to light when the brothers gathered for Christmas in 1987, and again in July, 1988. Bishop Skiba came out to their home. (There was initially some confusion about dates, but the Vicar for Clergy office confirmed that it was July, 1988, which [REDACTED] subsequently agreed to have been the case.) [REDACTED] is upset that the statute of limitations issues prevented further pursuit, and she indicated an inability to look at their wedding pictures [REDACTED]. [REDACTED] also was upset because one of her sisters-in-law saw Fr. Hanser functioning at St. Lukes Hospital in 1988. I checked with Barbara Anne Cusack, Chancellor, who reported that Fr. Hanser was one of the priests returned to limited ministry with supervision at the recommendation of his therapist. However, Fr. Hanser has now decided to retire rather than be reviewed by the new Task Force. I explained to [REDACTED] that Fr. Hanser had been allowed to engage in limited hospital ministry under supervision, but was now retired.

- 4/24/02 Sexual abuse intake report alleging abuse of an 11 year old boy by Hanser at St. John Vianney in approximately 1972. Hanser slept in the same bed as the survivor, fondled him, kissed him, and told him he loved him.
- 10/17/06 Sexual abuse intake report alleging abuse of 7 or 8 year old boy by Hanser in 1977 at St. John Vianney. Hanser brought the survivor to the rectory and manipulated and fondled the survivor's genitals.
