Brian Faulkner ABI 4500 Hatch Blvd, Shoffield AL 35660 On Sunday, February 2, 2014, ABI Cpl. BRIAN FAULKNER, Investigator, CRAIG RICKMAN and Lt. SIEG MUELLER interviewed JEFFREY EDDIE at the Muscle Shoals Police Department. EDDIE was interviewed regarding allegations of possession of child pornography and sexual abuse. The sexual abuse was alleged to have occurred between he and some of the members of his children's ministry. EDDIE was read his miranda rights by Cpl. FAULKNER and waived his rights by signing a waiver form. During the interview, EDDIE confessed to performing oral sex and physically masturbating several of the minor members of his church, numerous times. So many that EDDIE advised he could not remember. One of those minors he named was white male, date of birth minor (minor)

On Monday, February 3, 2014, white male, date of birth minor) and his father spoke with Cpl. BRIAN FAULKNER and Inv. CRAIG RICKMAN with the Muscle Shoals Police Department, regarding sexual abuse allegations involving JEFF EDDIE. EDDIE was employed as the children's minister at Highland Park Baptist Church in Muscle Shoals, Alabama.

According to (minor), in the Summer of 2010, at 11 years of age EDDIE began to masturbate said juvenile as the abuse progressed. EDDIE performed these acts on juvenile three (3) different times during that summer. Juvenile stated each time occurred in the electrical room, downstairs, at the church. Juvenile stated in February of 2011, the abuse escalated to EDDIE performing oral sex on juvenile at Highland Park Baptist Church in Muscle Shoals, Alabama. Minor stated these incidents also occurred in the electrical room, downstairs at least once a month from February, 2011 until July of 2013 for total of twenty nine (29) times. Minor stated the oral sex occurred more than once a month, most months, but was certain it happened at least once a month.

Minor stated this past year, in the fall of 2013, Minor went up to the church a couple of times and EDDIE performed oral sex on juvenile, twice at the church on two separate occasions, between August and November of 2013.

states that she is a staff member at Highland Park Baptist Church located at 501 w. Sixth Street in Muscle Shoals. States that on January 22, 2014 she walked into the office of Jeffrey Dale Eddie, the Children's Minister at the Church. States she observed Eddie with one arm around the waist of a minor child and the other hand underneath the minor's shirt. States Eddie appeared startled and removed his hand from the minor.

Brett Pittman (Church Pastor) and Jeff Beech (Worship Pastor) on January 27, 2014. Pittman and Beech immediately began looking into the reported incident and on January 29, 2014 they asked Eddie to view his Church issued electronics (laptop, cell phone and tablet). Beech states that Eddie was cooperative and gave them the electronics along with his consent to search their contents. Beech states he looked through the cell phone and tablet and did not notice anything unusual. However, the laptop contained so much data that he transferred its contents onto a flash drive to view at a later date and then gave all of the electronics back to Eddie.

Beech states that on February 01, 2014 while viewing the information, he obtained from Eddies computer, he noticed two pornographic images of a nude minor male. This same day the Muscle Shoals Police were notified and the images shown to Investigator's Sieg Mueller and Craig Rickman.

Affiant states that on February 02, 2014 Eddie was picked up and transported to the Muscle Shoals Police Department where, after waiving his Miranda Rights, he stated that he was addicted to pornography and that he has downloaded images of nude young males onto his Church issued computer.
