## Resolution of the Members of Shiloh Missionary Baptist Church Sunday, October 5, 2014

Vote of Membership of Shiloh Missionary Baptist Church declaring that the constitution and by-laws for Shiloh Missionary Baptist Church, presented by Reverend Juan D. McFarland in January 2013, and was not officially adopted or passed by the membership of Shiloh Missionary Baptist Church.

WHEREAS, the Shiloh Missionary Baptist Church located at 452 Cramer Ave., Montgomery, Alabama (herein after referred to as Shiloh Missionary Baptist Church) has been in existence for more than 90 years, and whereas Shiloh Missionary Baptist Church has since from its existence operated under the rules of the National Baptist Convention USA out of Nashville, TN, and,

WHEREAS, under said rules the majority of the membership controls the organization in the running of the Baptist Church and whereas, Shiloh Missionary Baptist Church has over 170 active members and whereas, in January 2013, Reverend Juan D. McFarland attempted to pass a constitution and by-laws for Shiloh Missionary Baptist Church without first notifying the membership or the Board of Deacons of a vote to take place on the passage of a constitution and by-laws for Shiloh Missionary Baptist Church, such that there was less than 25% of the active membership present and,

WHEREAS, Reverend Juan D. McFarland attempted to have a constitution adopted whereby he would become the dictator of the church, whereby he could only be removed by his death or resignation, while he fraudulently concealed from the congregation of Shiloh Missionary Baptist Church, that he had knowingly engaged in adultery in the church building with females members of Shiloh Missionary Baptist Church, while knowingly having AIDS, which not only is against the laws of Christianity, but also against the laws of the State of Alabama for which Pastor Juan D. McFarland could be prosecuted for violation of criminal laws and,

WHEREAS, Reverend Juan D. McFarland fraudulently withheld information that he had been engaging in the use of illegal drugs while preaching and performing pastoral duties and,

WHEREAS, Reverend Juan D. McFarland had fraudulently withheld information from the church membership that he had misused church funds.

THEREFORE, in consideration of the foregoing, the membership of Shiloh Missionary Baptist Church hereby votes that the constitution and by-laws for Shiloh Missionary Baptist Church, which Reverend Juan D. McFarland attempted to have adopted and passed by a vote in January 2013, was not officially passed by the membership of Shiloh Missionary Baptist Church, since they were not given proper notification that a vote was to take place on a constitution and by-laws for Shiloh

Missionary Baptist Church, and that said constitution and by-laws is hereby set aside and declared to be null and void, and to no longer be the constitution and bylaws of Shiloh Missionary Baptist Church.

Passed this 5th day of October 2014, by the membership of Shiloh Missionary Baptist Church by a vote of 90 for the resolution and \_\_\_\_\_\_ against the resolution.
