Fr. Kaczorowski [VP] contacted Joseph Kissane [JK] via phone at 10:00am from the Vicar for Priests Office for the scheduled appointment. After introductions were made, PFRA described the responsibilities of the Office of Professional Fitness Review as well as those of PFRA.

PFRA continued by reading the allegations of misconduct made against JK by [REDACTED] JK began his response by stating that, "I don't remember the details, but I did have a relationship with her [REDACTED]" JK stated that he would "take rides and be physically involved with her [REDACTED]"

JK stated that he never did question [REDACTED] as to what she did with her boyfriend, as alleged by [REDACTED] He responded to the allegations of "the video thing and the thing in the church [sacristy], I don't remember." JK stated that he did have "a VCR that came with a camera, but electronically, I'm a klutz." When PFRA attempted to have JK clarify his statements regarding the allegations made by [REDACTED] regarding the video camera in his room and being with [REDACTED] in the sacristy of the church, JK responded by stating, "The problem is, I'm saying, I'm just not sure." PFRA then asked JK if he ever had [REDACTED] in his room with him and his response was, "I don't think so. I just don't remember." In regards to the relationship that he had with [REDACTED] JK stated, "As an adult and an adult priest, I went through my adolescence."

The Review Board process was then explained to JK by VP. JK then asked some legal questions which were answered by VP and VAM.

Fr. Kaczorowski [VP] contacted Joseph Kissane [JK] via phone at 10:00am from the Vicar for Priests Office for the scheduled appointment. After introductions were made, PFRA described the responsibilities of the Office of Professional Fitness Review as well as those of PFRA.

PFRA proceeded by reading to JK the allegation of sexual misconduct made against him by [REDACTED]. JK's initial response to the allegation was that it is "100% false." He also stated, "I am denying whatever he [REDACTED] said—this is insane." JK spent a considerable amount of time describing the layout of the rectory in response to [REDACTED] allegation. JK stated that there were no stairs leading to his room, that there were two stairs outside of the front steps in front of the rectory. Once one would walk into the rectory, the secretary's office was to the left [where there was "a kid" there until 9:00pm] and a door on the right. Inside the door was a stairwell to the basement, a stairwell to the upstairs, and then JK's bedroom and office. Up the stairwell were a landing and two flights of stairs. Each floor upstairs had a bookcase on one side of the landing. JK laid out the following bedroom occupants in the rectory: Fr. Sharpe's room was in the Northwest corner, Fr. Friedl's room was in the Northwest corner, Pastor Schaumburg's room

was in the Southwest corner, and the common area of the rectory was located in the Southeast corner JK added that he had a twin bed and all of the other priests had full beds JK described his quarters as “one large room” where he had “made a divider out of bricks and plywood ”

JK stated that he does remember [REDACTED] and recalls that his father was a [REDACTED] He continued by stating that [REDACTED] As for [REDACTED] JK stated that, “He may have been an altar boy ” JK has a “faint recollection that [REDACTED] may have misbehaved [at school] ” JK believes that there may have been an incident where [REDACTED] was talking while on the altar and that JK gave the minor “two chapters of gospel [to read] as punishment ”

In regards to the allegation by [REDACTED] JK feels that [REDACTED] “may have the years mixed up ” JK stated that he was given a one-year extension at St Cajetan’s due to his health and that he was not assigned to the school during the years noted by [REDACTED] JK left St. Cajetan’s in June of 1976 JK stated that Fr Sharpe had passed away by 1976 and that a new priest “had taken his [Fr Sharpe’s] room ” As per [REDACTED] allegation, JK stated that, “on occasion I would be in front of the school ” JK then stated that he is “still mystified” about [REDACTED] allegation VP then asked JK if he recalled which priest replaced him at St Cajetan JK was unable to recall the priest’s name, but recalled that he was a “redhead with glasses ”

When asked by PFRA and VP, JK stated that he did not bring “a soul” into his room at the rectory He continued by stating that he never brought any young boys into his room and/or into the private section of the rectory JK believes that [REDACTED] may have accompanied his father into JK’s room on [one] occasion. JK suggested that PFRA ask [REDACTED] what he saw outside of the window of the room he was in where the alleged abuse took place When asked by PFRA, JK stated that one could see “the ground, the street, and the front lawn” from his window because he was on the first floor

In regards to [REDACTED] allegation, JK stated, “Trust me, I would really know if I were with another male ” He added, “ I’m heterosexual That’s the reality of who I am ”

It is my understanding that [REDACTED] met with Kathleen Leggdas and Michael Bland to report his allegation against Joseph Kissane. Apparently, there is no written record of that interview. At the same time, it is my understanding that the Office of Professional Fitness Review received a detailed letter describing the abuse. The first-hand account letter accompanied a letter of notice that Jeffrey Anderson was representing [REDACTED]

Question: will the Archdiocese accept the letter in lieu of a face-to-face documented interview?

[REDACTED] is "marginal" psychologically. A request that he be interviewed again is not in his best interest given his marginality, in my opinion. I suggest that Michael Bland be consulted since he has met with [REDACTED] and can contribute his professional opinion on my question.

### Victim Statement Abstract

This abstract replaces the letter written by Victim BK to Cardinal Bernardin, dated August 12, 1994. In the letter, Victim BK alleged that she was forcibly raped by Rev. Joseph Kissane in the convent at St. Catejan's parish when she was a minor, in or about 1974 or 1975. Victim BK also reported that Fr. Kissane showed interest in and spent money on young girls in the parish, and regularly invited them to his room in the rectory in the evenings. Victim BK also reported that she recalls that Fr. Kissane was transferred from St. Catejan parish around the time that rumors began circulating about him and other young girls.

Sister Mary Brian Costello, Chief of Staff to Cardinal Bernardin, forwarded us your letter of August 12, 1994 as well as her letter to you dated October 4, 1994.

In Sr. Brian's letter she mentioned that I would be contacting you to explore with you how the Office of Assistance Ministry might be able to assist you.

[Redacted] the office is staffed by myself, Rev. Michael J. Bland, O.S.M. and Mrs. Mayra Flores. The office was established by the Cardinal to help those who, as minors, may have been abused by an Archdiocesan priest. We offer the help, at least, on a preliminary basis in response to the pains, hurts and/or other emotions or feelings expressed by the person making an allegation. We offer our help even prior to any formal inquiry into the allegation.

The assistance we offer includes pastoral outreach, spiritual direction, and counseling. The counseling includes psychotherapy by independent therapists at the expense of the Archdiocese.

In addition [Redacted] if you choose to formalize your allegation we can be of assistance to you in doing that as well. We would be happy to explain the procedures and then to help and support you through the next steps.

[Redacted] the purpose of this note, as you can see, is to extend our offer of assistance to you. We invite you, whenever you see fit or need, to be in contact with us. We are usually in the office between the hours of 9:00 a.m.-4:30 p.m.; our phone number here is (312) 751-8267 or 8256 (feel comfortable to call collect). Mrs. Flores will answer the phone. You can be comfortable and confident in speaking with her in the event I am not in.

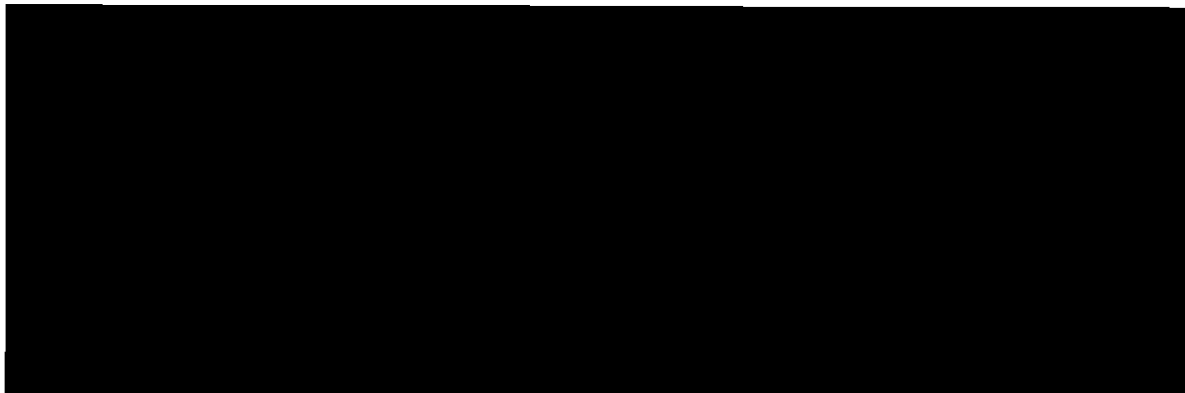





Discussion Between Victim Assistance Ministry's Rev. Michael Bland and Review Board:

- Rev. Michael Bland of Victim Assistance Ministry was introduced to the Review Board and discussed with the Board the general guidelines and approached which VAM takes in its work. Michael Bland answered all of the Board's questions as part of the ongoing dialogue between the Board and that ministry.

Matter of PFR-19 (J.K.):

1. Pursuant to Article 4.7(c) of the policy, at the least, the Administrator informed the Board of a situation which had just come to his attention involving a letter referring to sexual misconduct as a minor against now-resigned former Archdiocesan priest J.K. by a [REDACTED]. The Administrator informed the Board he'd just received a copy of the letter [REDACTED] wrote Cardinal Bernardin on 8-12-94 and which had been referred to the Victim Assistance Minister, who subsequently wrote to [REDACTED]. The Administrator further informed the Board that the Office of Professional Fitness Review had [REDACTED]. Also, the Administrator stated that the Victim Assistance Minister and Vicar for Priests did confirm formally that J.K. was an "old" case of an Archdiocesan priest with prior allegation(s) of sexual misconduct with minors lodged against him in the past; however, the Administrator noted that he had received no further details from the Vicar for Priests about the prior allegations. The Administrator then informed the Board of the various ways it could proceed in this situation.

2. The Board learned through the Archbishop's Delegate to the Board that J.K. had indeed left the priesthood [REDACTED]. As such, the Board directed the Administrator to attempt to discover the conditions placed upon J.K., such as therapy he may have been required to attend [REDACTED], and whether J.K. had complied with such terms, so as to ensure that minors are not at risk even though J.K. is no longer a priest. The Board again concluded that the Executive Sub-Committee should further discuss how the Board wants to handle resigned priests' cases in general in the future and that the Sub-Committee will get back to the entire Board about that after it meets.

- Other Miscellaneous Information: The Administrator returned to the Board copies of comments from the Vicar for Priests regarding the two, new proposed Questionnaires regarding assessments and therapy. The Board resolved to take the comments home with them and to defer discussion on it until the next Board Meeting.

- The Board also decided to defer discussion on the housing/supervision proposed changes' materials for its comments/input to the next Board meeting.

- The Administrator reminded the Board that its next Board meeting was scheduled for 11-19-94.

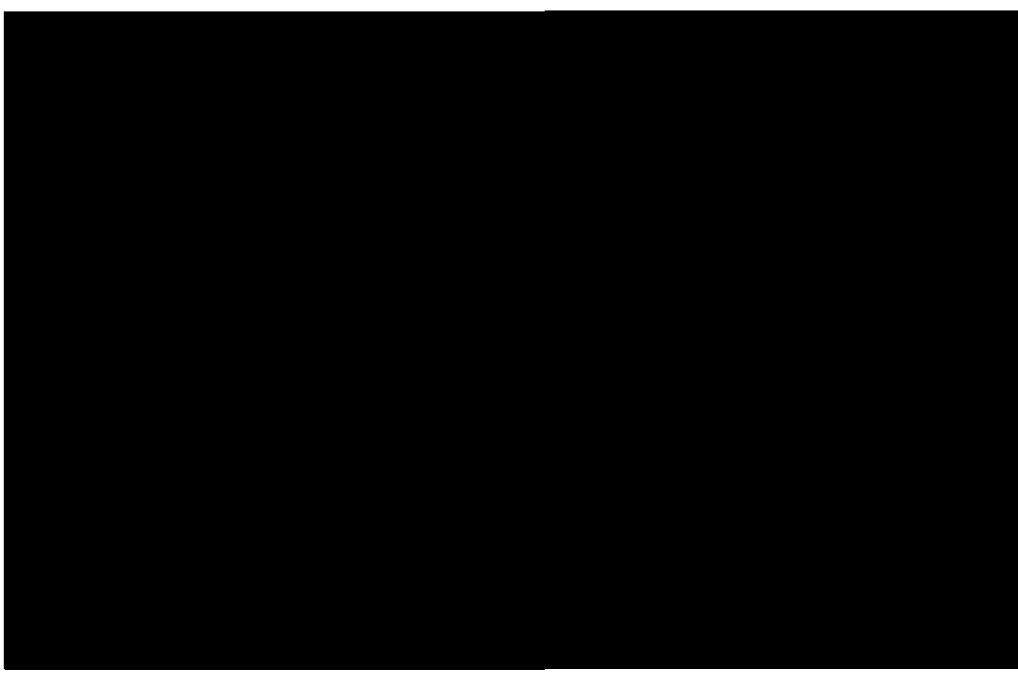

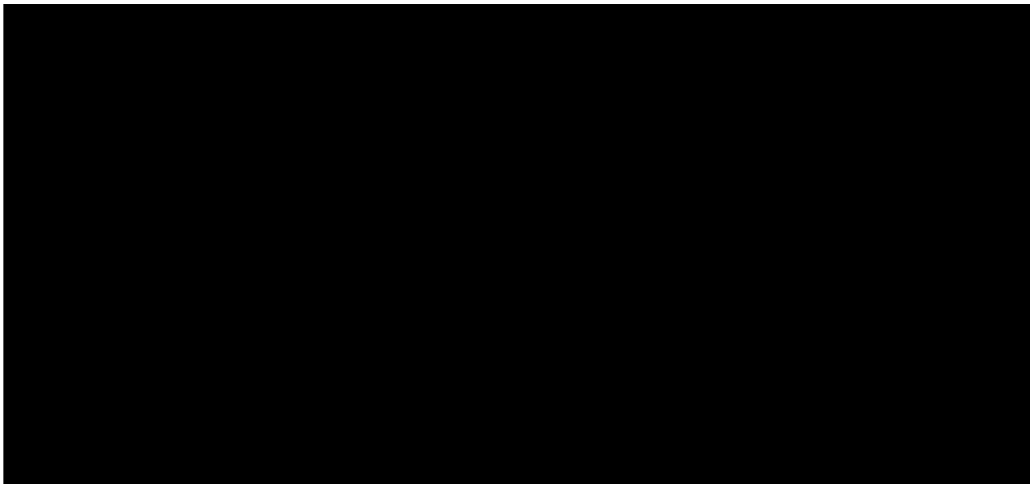



### Victim Statement Abstract

This abstract replaces the written statement provided by Victim BL to the Archdiocese of Chicago on or about October 25, 2004. In the statement, Victim BL stated that she was sexually abused by Rev. Joseph Kissane when she was in her 20's between approximately 1985 and 1988, and in the course of counseling with Fr. Kissane. The alleged abuse consisted of fondling and digital penetration. The alleged abuse occurred at Most Holy Redeemer parish, in Fr. Kissane's car, and at the homes of Fr. Kissane's relatives.

3. What action, if any, does the Archdiocese intend to take to prevent this from happening to others?



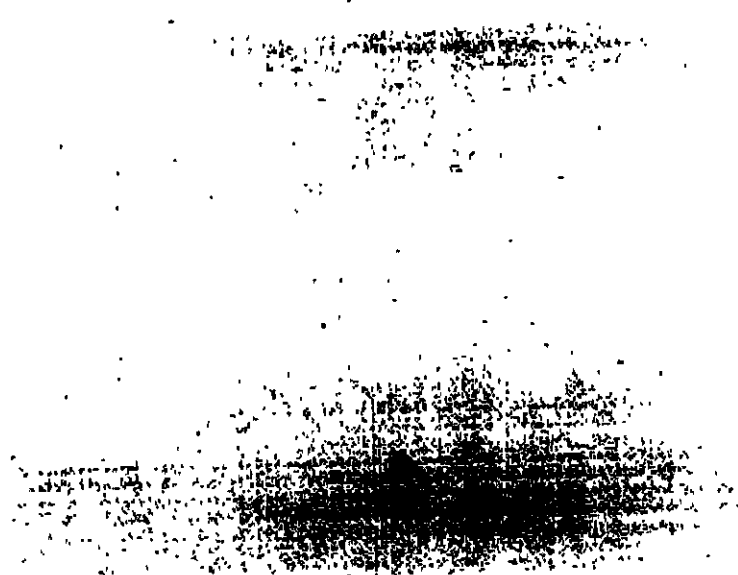

This abstract replaces the letter written by Victim BO to Jeffrey Anderson dated April 23, 2002. In the letter, Victim BO alleged that he was molested and raped by Rev. Joseph Kissane when he was 12 year old student at St. Cajetan in approximately 1975. The alleged abuse consisted of one incident of fondling and two incidents of anal penetration. The alleged abuse occurred at St. Cajetan's parish. Victim BO reported that on one occasion a parish secretary or housekeeper saw him come into the rectory with Fr. Kissane prior to being escorted to Fr. Kissane's room.

2. I called Jim Hardiman. Jim said that when he went to St. Catherine's, John Kane was the pastor. This was 1977 and John retired the following year. George McKenna became the pastor and it was just George, Joe Kissane and himself. Joe was already at St. Catherine's when Jim arrived. Jim left St. Catherine's in 1981.

3. I briefly told Jim what the situation was. He said that John Kane never said anything at all that would indicate that he had any knowledge of what was going on. Neither did George McKenna. But Jim said that George was always in a world of his own and had enough difficulties with the parishioners, etc.

4. With regard to his own knowledge, Jim said that he had no clue whatever that there was any sexual misconduct going on. Jim did recall that there would always be several grade school girls hanging around, like they so often do with young priests. They become attached and from time to time they would be up in Joe's room or Joe would take them for a ride in his car. Jim noticed this and he told Joe on one occasion that he thought Joe was making a mistake to have the kids around. Jim didn't say this because he suspected Joe was guilty of anything, but rather from his own experience of knowing how kids can behave, he thought Joe was being imprudent, because who knows what these kids might say about him later on, etc. So Jim never suspected any misconduct on Joe's part. He just thought it wasn't a prudent thing to have young girls hanging around the rectory so much. Jim mentioned this only once to Joe and to Jim's recollection, Joe took the advice seriously and Jim does not recall young kids hanging around after that.

5. Jim said that Sr. Muriel, the principal, happened to mention something to Jim right around the same time that he himself made the comment to Joe. Sister had said that she was concerned about the young girls paying so much attention to Joe and being at the rectory so much. The fact that Sr. Muriel brought it up around the same time Jim was becoming conscious of it probably prompted him to say something to Joe. Sr. Muriel is now deceased.

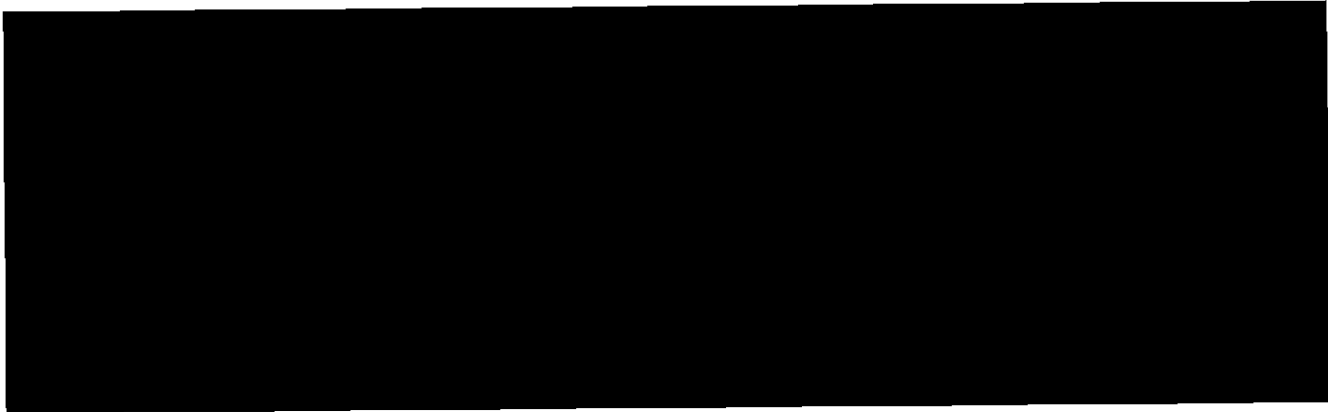
6. Jim said that if he had suspected anything of a sexual nature, he would have certainly told Joe off in no uncertain terms. But he just thought it was a case of imprudence. Joe would let the girls see his fire engines. That was a hobby

with Joe. He would spend his days off building fire engines. Jim never suspected anything beyond that.

7. I asked Jim if he was aware of any other girls besides [REDACTED] hanging around. Actually, Jim did not seem to recollect [REDACTED] but he did remember a girl by the name of [REDACTED]. Evidently she used to hang around Joe's room a lot and her parents found out about it and they came over to tell Joe in no uncertain terms that they did not want their daughter to have anything to do with him. They did not talk to Jim about this, but Joe himself mentioned it to Jim.

8. Jim said that he and Joe were always on friendly terms and they used to get together about once a month for lunch. In fact, he was just getting ready to call Joe, as he said that Joe took him to the hospital four years ago today when Jim had surgery.

9. I asked Jim to keep all of this under his hat and that he should not let on to anyone any knowledge of the situation. I did say, however, that if the matter were to go to litigation, it could very well be that Jim would be contacted as a witness.

Dear Cardinal Bernardin:

We are confident that you share our concerns regarding the need to restore the faith community here at Most Holy Redeemer. As you well know, our parish has been faced with many difficult problems during the past three years. As members of the Most Holy Redeemer School Board, we continue to be most concerned over the behavior of Fr. Joseph Kissane. While we are grateful to Fr. McBrady's attempts to conciliate our situation, we feel our problems continue to escalate.

Fr. Kissane's responsibilities include the supervision of the maintenance of the parish facilities. His inability to administer his responsibilities has resulted in a school building and parish hall that is, in our opinion, a health hazard. Our children must attend a school that is dirty and unsafe. Our school lavatories have not been supplied properly with soap, toilet tissue, hand towels and sidewalk ice removable products have been unavailable. Over the past three years, our school budget has allotted \$145,000.00 for maintenance, supplies, custodial salaries and building repairs. We have not seen evidence that these funds have been allocated appropriately.

Fr. Kissane has openly encouraged us to become security minded. Yet fourth grade children are assigned to open the school doors to all visitors against the advice of the School Board. We have on numerous occasions advised installation of security doors. In addition, our parish hall is regularly entered by unauthorized youth. This problem has significantly increased over the past year. When confronted with these concerns, Fr. Kissane has either denied their existence or at times he has exaggerated the situation, placing the blame on the community. Father has been quoted as saying, "People in this parish just don't care."

Cardinal Bernardin, the people of this parish do care. We have hundreds of good parishioners who collectively have volunteered thousands of hours toward the various fund raising events that take place annually. This is done out of love for our parish and community.

It disturbs us when these caring people are insulted from the pulpit. On one occasion Fr. Kissane, in his homily, accused the people of Most Holy Redeemer of being "un-Christian." We wonder if the significant and sustained decrease in our Sunday collection is a direct result of Fr. Kissane's insults and negativism.

As elected representatives of our parish, the School Board has tried very hard to "wipe the slate clean" and work effectively with Fr. Kissane. We have consulted with Father on several projects. One of these has been the renovation of a classroom to provide our community with a preschool. Fr. Kissane responded to our efforts positively, while giving others the impression that "The School Board is trying to shove this preschool down everyone's throats." We are frustrated and saddened by the divisiveness this behavior causes in our community.


As time passes, we look to you to help us in this matter. We are confident that you will not abandon the people of Most Holy Redeemer. We look now beyond conciliation to resolution.

### CLERGY SUFFERING FROM SEVERE PSYCHOLOGICAL DISORDERS

Reverend Robert L. Kealy, S.T.L., J.D., J.C.D.

#### A. DEALING WITH CLERICS SUFFERING FROM SEVERE PSYCHOLOGICAL PROBLEMS.

When a cleric has committed pedophilia or some other form of abnormal behavior, he is often suffering from some deeply-rooted psychological illness. Canon 1321 provides that: "No one is to be punished unless the external violation of a law or precept committed by the person is seriously imputable to that person by reason of malice or culpability." In such cases, instead of invoking penal procedures, the Ordinary should consider invoking canon 1044.2, n.2.

A cleric who is afflicted with insanity or some other form of psychic defect which makes him incapable of rightly carrying out the ministry, is impeded from the exercise of orders (c. 1044.2, n. 2). The determination of this is made by the Ordinary, after consulting with experts (c. 1041.1) and is expressed in the form of a decree, duly notarized. The cleric has the right of recourse against such a decree to the Congregation for the Clergy.

A cleric decreed to be suffering from such a condition is forbidden to carry on the ministry until such time as the Ordinary, after consultation with an expert, decides that he is capable of rightly exercising the ministry.

Where it is foreseen that such a condition is likely to be perpetual, the Ordinary would be prudent to try to induce the cleric to resign.

#### B. CRITERIA TO BE CONSIDERED.

In considering the severity of a cleric's psychological problems the Ordinary will consider psychological evaluations and the behavior of the cleric. The Ordinary's primary concern will be for the good of the Church and the sacred ministry. Specific factors he would do well to consider include:

NATURE OF THE PROBLEM: What is the psychological nature of the cleric's problem? What is its duration and intensity? Possible treatment and prognosis?

BEHAVIOR: Did the cleric engage in objectively immoral or criminal behavior? Of what gravity? How often? Over what period of time? For someone in another profession, would such behavior be grounds for removal of one's license? Did the person's behavior create liability for civil damages?

VICTIMS: Was someone victimized or injured by the cleric's behavior? How many people? How often? In what manner? What were the effects? Was the injured person a minor or someone with a diminished ability to protect himself? Are people at risk if the cleric continued to function?

THE CLERIC: Does the cleric show a sense of guilt or shame for misconduct? Remorse or contrition? Is he uncooperative or hostile? Is the cleric capable of controlling his behavior? What type of treatment or supervision would be necessary in order to be certain that the cleric could minister fruitfully without being a danger to anyone?

THE PUBLIC GOOD: If the cleric's behavior were known to the public, would reasonable people be shocked or scandalized? To what degree? If this cleric were allowed to function and people knew of his condition, would reasonable people have diminished respect for the Church and the sacred ministry?

#### C. INDUCEMENT TO RESIGN

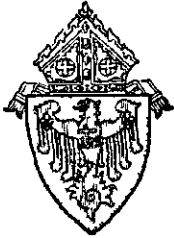
Where there is no likelihood that the cleric will recover his ability to minister fruitfully, the Ordinary would be wise to offer an inducement to the cleric to resign. Such an inducement should be large enough to elicit the cleric's cooperation.

To avoid continuing legal entanglements, the payment should be made in one lump sum or in the form of an annuity to be paid over time. It should enable the cleric to make the transition to secular life and to provide for continuing medical and psychological therapy.

In exchange for this severance payment the individual should sign a prepared letter of unconditional resignation from the priesthood. He should also be encouraged to seek laicization.

If the cleric is resistant to resignation he should be informed that if he doesn't resign the Ordinary would have to inform the presbyterate and other Ordinaries of the decree. If he is still uncooperative, he could be ordered to reside at an ecclesiastical treatment center in a remote location, away from population centers, so that risk to the public would be minimalized. If he refuses, penal sanctions could be invoked for that disobedience.

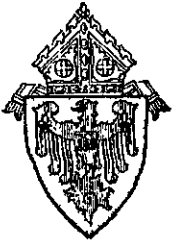

**Conference Call**

This meeting took place entirely via conference call. PRA arrived at the Vicar for Priests' Office for the 9:30 am scheduled meeting. PRA and Rev. James T. Kaczorowski then contacted Mr. Joseph Kissane via phone.

Once introductions were made, PRA asked Mr. Kissane if he had any questions or concerns regarding the Review Board process. Mr. Kissane stated that he did not have any initial questions or concerns prior to hearing the allegation.

PRA then read [REDACTED] allegation of sexual misconduct against the former Rev. Joseph Kissane without interruption.

Upon the conclusion of the allegation being read to him, Mr. Kissane stated that he does remember [REDACTED] name and that his memory connects her to a [REDACTED] at St. Cajetan's [at the time of the alleged abuse].

Mr. Kissane then stated that he "...definitely knows there was no rape." He also does not think that he [REDACTED] in the rectory as alleged by [REDACTED]

Mr. Kissane confirmed that his room was located on the first floor of the rectory and that “90%” of the time the door was open. He stated that he usually closed the door after dinner. Mr. Kissane also confirmed that he and all of the other priests had men and women over at the rectory.

[REDACTED]

Mr. Kissane stated that [REDACTED]. He continued by stating that he did not “...rape, attack, or hurt this girl on any level.” Mr. Kissane mentioned that he would like to know who [REDACTED] is [the [REDACTED] refers to in her allegation]. He then stated, “...this [the abuse alleged by [REDACTED] did not happen...” Mr. Kissane mentioned another individual who brought forward an allegation against him as well. He referred to this individual by name and stated that the abuse alleged by the other person did not happen either.

Mr. Kissane stated that, “...nothing happened with any of the girls [REDACTED]

[REDACTED] He again stated that he did not attack anyone [as alleged].

Referring to [REDACTED] allegation, Fr. Kaczorowski asked Mr. Kissane if he ever [REDACTED] raped her. Mr. Kissane responded, “I don’t know why she’d say that—the rape... [I am] 190% sure that the rape didn’t take place.”

Referring to [REDACTED] allegation, Mr. Kissane stated, “I am not a candle person.” Mr. Kissane also stated, “I think I may have kissed her...I don’t think that I put my hand under her shirt and on her breast.”

Fr. Kaczorowski and Mr. Kissane then identified the other priests assigned to St. Cajetan’s at the time of the alleged abuse. Fr. Schaumburg was the pastor and Rev. Martin O’Donovan was also assigned there. Fr. Kaczorowski agreed with Mr. Kissane that Fr. O’Donovan is not a person who would have “...let this [alleged abuse of a minor] go.” Both also agreed that Fr. Schaumburg would have reacted/acted in a similar manner as Fr. O’Donovan. Mr. Kissane expressed his feeling that Fr. Schaumburg “...would have said something...” had he known that a priest was abusing a child.

Mr. Kissane then stated, “I guess quite frankly, I have done really dumb, stupid things...” which eventually removed him from the priesthood. He stated that he was/has never been attracted to males [referring to the other allegation against him]. Mr. Kissane

expressed that he is having “...problems...” with the last two allegations made against him.

At this point in the June 16, 2005 meeting, Fr. Kaczorowski suggested that Mr. Kissane participate in Spiritual Direction [REDACTED] Mr. Kissane verbalized his agreement with Fr. Kaczorowski’s suggestion.

[REDACTED] At the time of the alleged abuse, St. Cajetan’s was a newer rectory. Mr. Kissane described the first floor as complete at the time and stated that the second floor was “...not ready yet.” He was the first to move into the rectory and described his room on the first floor as “...one long room.” [REDACTED]

When asked by PRA, Mr. Kissane stated that, “...it could have happened...” that he kissed [REDACTED] in his room. PRA then commented to Mr. Kissane that the act of him kissing a minor in his room would still have been an abusive act. Mr. Kissane responded by stating that he knows that such an act is wrong and agrees that it is abusive.

Mr. Kissane then stated, “...I feel I’ll get nailed by the Archdiocese [as a result of [REDACTED] allegation]...[and] I feel badly about it.”

Mr. Kissane declined PRA’s offer to provide him with contact information. Prior to ending the phone call, it was agreed that Mr. Kissane would contact PRA or Fr. Kaczorowski with any questions or concerns.

Both PRA and Fr. Kaczorowski thanked Mr. Kissane for his time. It was agreed that PRA would send Mr. Kissane a copy of the draft report of his responses to [REDACTED] allegation for his review. Mr. Kissane will then return the draft report to PRA with his additions and/or corrections.

Phone Discussion With Victim Assistance Minister Ralph Bonaccorsi  
Regarding [REDACTED] 11-17-94

- "I did speak with her (since he sent her long letter) - we had a long conversation as a result of my letter. She said she's fine at this time, doesn't need any help." (i.e. regarding therapy, pastoral counseling, etc.)

- She did want to know were the SA's contacted. Ralph B. did tell her he was no longer a priest/had resigned. [REDACTED]

- She did express to Ralph that Kissane did physically/sexually assault her, although perhaps she was using the term in a more generic state - it wasn't detailed much beyond that.

- Ralph said he understood [REDACTED] purpose in talking to Ralph was to convey that she was okay. She only said in terms of detail that Joe Kissane threw her down on the ground, ripped-off her clothing and he was upon her. It was rough and mean apparently, per [REDACTED] Ralph said, but she did not actually use to Ralph's recollection, the term "rape."



ARTICLE 4.7(c) REPORT TO REVIEW BOARD FROM PFRA S.S.;

10-13-94

Pursuant to Article 4.7(c) of the Policies, I am informing the Board of a situation which just within the past week has come to my attention. It involves an allegation of sexual misconduct as a minor by a (currently) 32 year old woman who alleged she was sexually abused by Rev. Joseph Kissane during approximately 1974 and 1975 (you may read the attached letters should you so desire).

immediately called Ralph Bonaccorsi and Ralph noted that he had received a copy of a letter which [REDACTED] of Chicago had written to Cardinal Bernardin dated 8-12-94. Ralph noted that the Cardinal's Office sent it to him and asked him to respond to [REDACTED]. On 10-6-94 Ralph said he intended to write [REDACTED] and would likely mention me as the Administrator in these matters if she decides to formalize/further detail any such allegations. At that point, Ralph did not note the priest's name or further details, but noted it was an "old" case of a priest with prior allegations.

I concluded that the Review Board should be apprised of this situation, at least what I know about it to date, in its 10-94 meeting. As such, I later contacted Ralph's Office and requested a copy of the letter from [REDACTED] to Cardinal Bernardin. Ralph also faxed copies of letters both Sr. Costello (the Cardinal's Chief of Staff) and Ralph recently mailed to [REDACTED].

It is my understanding that Rev. Kissane has left the priesthood, although I do not have formal information in my file to that effect. (Presumably Rev. Pat O'Malley or Rev. Tom Paprocki will know for a fact and I will try to get a hold of Pat before the 10-15 meeting). *\* P.M. confirmed that (Rev.) Kissane did resign - made official 12-93. SS*

There is no set precedent as to how to deal with these types of situations (i.e. situations where alleged priest perpetrators have left the priesthood or are deceased). Overall, they have been in general treated as Article 4.7(c) situations. In some instances, I have been advised not to proceed obtaining further details to such allegations. In other situations, I have been advised that I should attempt to gather further information. In any event, the Victim Assistance Ministry is reaching out to [REDACTED] as of now, and I would be more than happy to discuss her allegation in greater detail with her should the Board so direct. Also, I could

either directly contact her in writing (she did not leave a phone number) to explain who the Board and I am, or the Board might direct me to wait and see if [REDACTED] chooses to contact me eventually as Ralph Bonaccorsi has inferred might be appropriate eventually. Another possibility would be to simply allow Victim Assistance Ministry to work with [REDACTED] and for myself and/or the Board not to get further involved with this situation, as both the Board and PCAC have sometimes advised me in different situations in the past.
