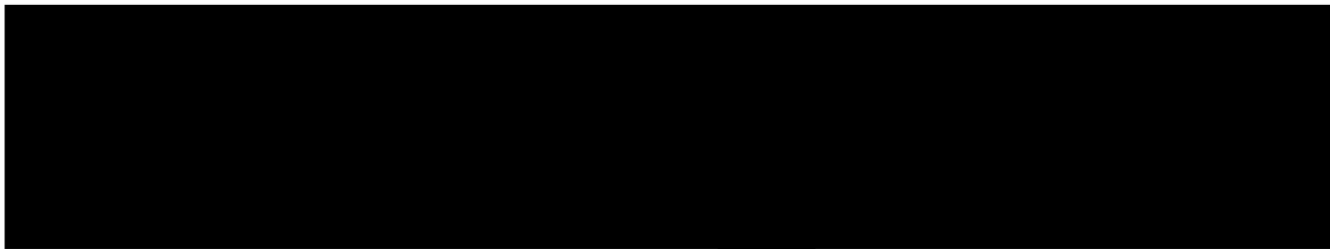
1. That he began an amorous relationship with [REDACTED] 17 years old, about two months ago [REDACTED]
2. That at one time she tried to break off the relationship but fell back into it.
3. That at times he gave her gifts.. [REDACTED]
4. That he had her up in his room along with other young people for pizza parties - - but alone after the others had left.
5. That [REDACTED] he was seen kissing her and going off with her alone for for long periods of time.
6. That he visited her home many many nights.
- \* \* \* 7. That she spent the night with him in his room a couple of weeks ago. This was a Tuesday night when both Father [REDACTED] and Father [REDACTED] were away; and Father [REDACTED] was asleep in the back of the house.
8. That he or they are "sweating it out waiting to see if she is pregnant".
9. That there have been continuous phone calls and visits to the rectory by [REDACTED]
10. That Father McNamara told our secretary, [REDACTED] of this involvement and predicament. She felt in conscience duty bound to reveal it to the pastor. He also revealed this information to [REDACTED], a leader of our teen club. She did not reveal this to us but to one of our seminarians, [REDACTED], who did reveal the information to us.
11. That Father has been trying to cover up in the last week by extending his attentions to [REDACTED] - - trying to throw us off the track.
12. That he has revealed this illicit relationship with [REDACTED] to a few other teen agers and young people.

The other priests in the house had no indication of impropriety because:

2. She is active in our [redacted] and [redacted] at Sunday Mass. Father was in charge of the liturgy and so dealt with them.
3. Reports of this impropriety have come from several independent and reliable sources. Each day we learn more details from more sources. The stories all coincide and give rectory detail nobody could make up.
4. Father McNamara weakly denied the reports when I confronted him July 28th. A week before when our secretary first mentioned them to him and me together he seemed noncommittal. I took it for gossip and warned him about leaving himself open to gossip.
5. When our secretary a few days later warned me there was something to the stories I began to investigate.
6. Our secretary is willing to testify that she is telling the truth in passing on to us Father McNamara's admissions to her. At first she felt bound to secrecy but then thought of the good of the church.

[redacted] our seminarian entering Niles, is willing to swear to the truth that he acquired from [redacted] Father's admissions and confessions. He also has some first hand information.

[redacted] and a few other young people would probably testify if not afraid of a difficult confrontation with Father McNamara.

P.S Your Eminence, I did not imply any criticism of the personnel board. They began to process the case but decided it was so serious that you should hear of it immediately.

Neither did I intend to be critical of Msgr. [redacted]. I meant that he is so kind and charitable that he must give everybody a break.

I, PETER J. McNAMARA, do hereby certify:

1. That I freely and without condition have requested to return definitively to the status of layman in the Church, dispensed from all the obligations I assumed by Sacred Orders (and religious profession). This dispensation, now granted by the Holy See, has been formally promulgated to me and is henceforth in effect.

2. That henceforth I shall not represent myself as a priest or exercise any power or prerogative attached to Holy Orders or the clerical state.

3. That I shall not volunteer the fact of my ordination to others, that I shall defer to the sensitivities of others by discretion in the matter, and that I shall do all in my power to prevent any scandal or damage to the Church or the priesthood.

4. That I shall submit the celebration of any eventual marriage on my part to the exclusive direction of my local Ordinary and shall abide by whatever conditions are required by the Holy See.

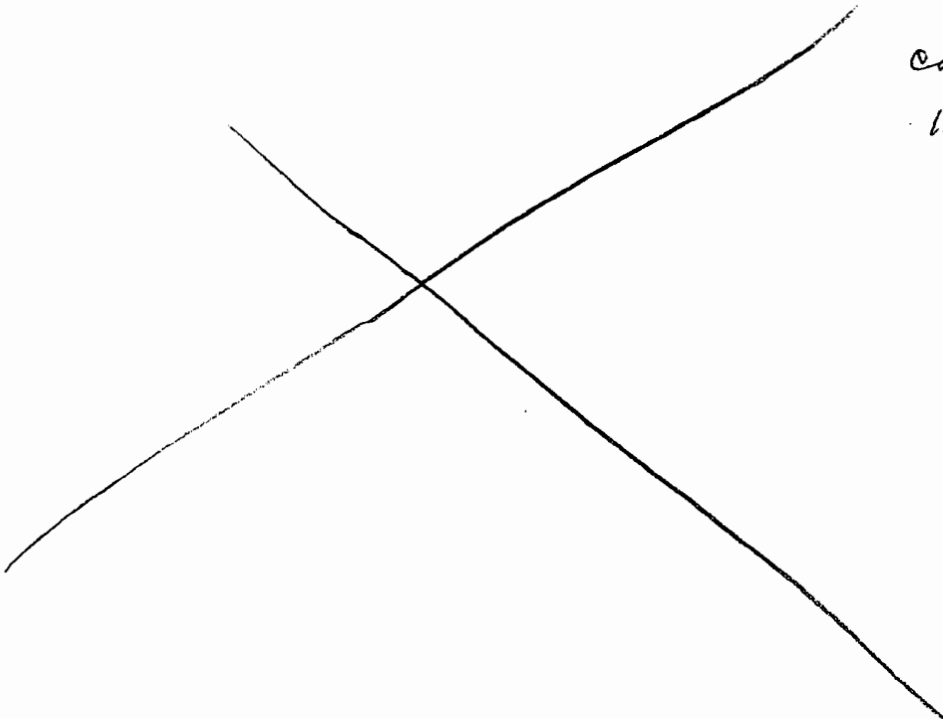



As the Archbishop's Delegate to the Professional Fitness Review Board, I am writing to you regarding the matter of **Peter J. McNamara**, a resigned priest of the Archdiocese of Chicago, against whom an allegation has been made by a [REDACTED] that he had engaged in sexual misconduct with a minor when he was still functioning as a priest.

This letter is written in order to provide you with information regarding the cleric's file or background as required by Archdiocesan Policies and Procedures, Book II, Part I, Title III, Chapter I, policy and procedure §1104.7.1, and as authorized by policies §702.1.a and §1106.3.2.

Even though Peter McNamara is no longer active as a priest, policy §1104.2, procedure "e" requires that an allegation that is made against a cleric who has resigned from active ministry "shall be processed in the same manner as any other allegation to the extent necessary to make a determination whether there is reasonable cause to suspect that the accused had engaged in sexual misconduct with a minor during the time he was serving as a cleric of the Archdiocese and to facilitate the outreach to those affected as contemplated by these policies." The following information was gleaned from the "laicization files" at the Archdiocesan Pastoral Center.

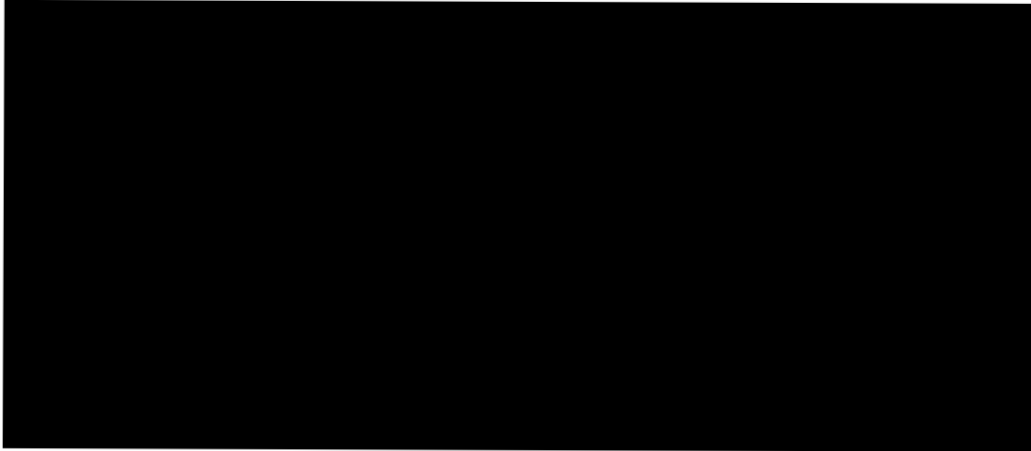
Peter J. McNamara was born in Chicago, Illinois on [REDACTED]. He attended the Archdiocesan seminaries and was ordained a priest by the late Most Reverend Alfred L. Abramowicz, Auxiliary Bishop of Chicago, on June 6, 1970. He had not been ordained with his classmates in 1969 because of "bizarre behavior and [REDACTED]" during his diaconate year at St. Thaddeus Parish. Among other things, it was reported that "McNamara locked himself in his room, and would send out irrational notes." After an additional year of diaconate at another parish, McNamara was ordained a priest and was assigned as Assistant Pastor ("*Vicarius Cooperator*") to Reverend William J. Quinlan, Pastor of St. Bernardine Parish in Forest Park, on June 7, 1970. McNamara left active ministry as a priest as of August 1, 1971.

On November 10, 1972, the Holy Father, Pope Paul IV, granted Peter McNamara a dispensation from all the obligations of Sacred Orders. The Rescript of the Sacred Congregation for the Doctrine of the Faith (Prot. N. 1578/72) in essence granted Peter McNamara's petition to be laicized with permission to marry. On December 22, 1972, Father Ronald N. Kalas, Co-Chancellor for Administrative Affairs, witnessed the canonical marriage of Robert McNamara and [REDACTED] at St. Raymond Church, Mt. Prospect, having been expressly delegated to do so by the late John Cardinal Cody. The ceremony was performed with no other witnesses present and under obligation of secrecy, as was required at the time by the rescript of laicization from the Holy See. This marriage was later declared null by the Metropolitan Tribunal of the Archdiocese of Chicago on May 23, 1989 (Case Number T 1078/88), which declaration of nullity was confirmed by the Court of Appeal on August 1, 1989.

In his letter dated March 28, 1972 supporting Peter McNamara's petition for laicization, Cardinal Cody wrote the following to His Eminence, Franjo Cardinal Seper, Prefect of the Congregation for the Doctrine of the Faith:



Enclosed is a copy of a memo dated August 1, 1971, to Cardinal Cody from Father McNamara's Pastor, Father Quinlan, outlining McNamara's "amorous relationship with [REDACTED] 17 years old," including notations that "she spent the night with him in his room a couple of weeks ago" and they were "sweating it out to see if she is pregnant." Father Quinlan also wrote that McNamara admitted his "involvement and predicament" to the secretary, [REDACTED] and to one of their seminarians, David Dowdle, both of whom informed the pastor. Father David Dowdle now serves as the Director of Spiritual Formation for the Diaconate Formation Program at Mundelein Seminary.

This memo is being written as a follow up to a previously distributed memo regarding the Review Board's requests for additional information regarding Peter McNamara.

As per the previous memo, I did speak with Sr. Mary Ann at the Vicar for Priests office via phone on 8/22/02 and requested that she search Peter McNamara's file for any past allegations of abuse. Sr. Mary Ann was unable to locate a file for Peter McNamara at the Vicar's office or at Archives Records Center of the Archdiocese.

I did receive a copy of a letter written by Fr. Paprocki to Kathleen Leggdas, Professional Fitness Review Administrator, dated June 15, 2002. Detailed in the letter written by Fr. Paprocki was information regarding Peter J. McNamara's "bizarre behavior" and his [Peter McNamara's] "amorous relationship with [REDACTED] 17 years old" [as described in a memo dated August 1, 1971 from Father McNamara's Pastor, Father Quinlan to Cardinal Cody]. The mentioned letter written by Fr. Paprocki was read in its entirety to the Review Board on September 7, 2002.

Fr. Paprocki requested that it be made clear to the Review Board that information regarding Peter McNamara's past involvement with [REDACTED] has been previously documented, along with behaviors leading up to Peter McNamara's laicization on November 10, 1972.

### Victim Statement Abstract

This abstract replaces the summary prepared by Michael Just, Interim Professional Fitness Review Administrator for the Archdiocese of Chicago's Office of Professional Fitness Review, of Fr. Peter John McNamara's response, given on January 14, 2003, to Victim KM's statement of alleged sexual abuse. In response to Victim KM's allegations, McNamara stated that he did not meet Victim KM until the spring of 1971, when Victim KM was 17 years old, contrary to Victim KM's assertion that they met years earlier. McNamara acknowledged kissing and fondling Victim KM during the summer of 1971, but stated their relationship did not become "sexual" until August, 1971, after McNamara left active ministry. McNamara also contradicts various statements made by Victim KM concerning the length of their relationship and specific details alleged by Victim KM in her statement.

Last week I spoke with Bishop [REDACTED] about Peter McNamara. Peter's [REDACTED] [REDACTED] said that she had heard that the seminary was reluctant to ordain him because he allegedly had child pornography in his possession while he was in the seminary. It seems that [REDACTED], a priest of the archdiocese now deceased, who served at St. Bernardine Parish from 1966-1973, passed on this information. St. Bernardine's was the parish in which [REDACTED] McNamara served during his brief stint in the active ministry. Since Bishop [REDACTED] was the rector of the major seminary in 1970 I asked if he could shed some light as to whether or not this allegation was true.

Bishop [REDACTED] said that he had a difficult time recalling anything about Peter McNamara. He assumed he would have remembered a case involving postponing ordination for a seminarian who kept kiddie porn in his quarters. He suggested that I contact either Father [REDACTED] from his original class, or Father [REDACTED] from the class in which McNamara was ordained.

On Friday, September 15<sup>th</sup>, I spoke on the phone about Peter McNamara with two priests, Father [REDACTED] and Father [REDACTED]. McNamara was originally in [REDACTED] class but his ordination was delayed for a year thus placing him in [REDACTED] class.

[REDACTED] was the first to return my call. He said "Petey" McNamara was a character who was very involved in electronics and wires. [REDACTED] said McNamara had a heart of gold who could fix anything but was also "different" and rather odd. He agreed that Petey was better in dealing with things than with people. I asked [REDACTED] very directly if he had heard anything about Peter McNamara and child pornography. He responded by saying he had no idea about that.

[REDACTED] called later and said that when his class returned to the seminary for winter quarter of deacon year the class discovered McNamara had been "clipped" from priesthood ordination but he had no idea why.



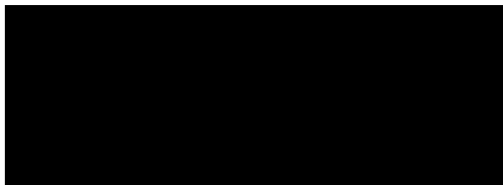

Dear Cardinal George:

This letter is in regards to my name being published in the May 30, 2007 Chicago Tribune and Sun-Times along with tried and convicted (some with numerous victims) former priests. I have never been tried or convicted of anything. You have defamed my name. I have never seen the accusations against me and have not been given an opportunity to defend myself.

After being a priest for about one year (June 1971) I met a marriage-minded woman [REDACTED]. When we wanted to begin a dating relationship I did the right thing. On August 1, 1971 I was offered a transfer to another parish but choose to take a leave of absence. I then requested laicization and resigned from the priesthood. We eventually married in a civil ceremony attended by her mother and other well-wishers (June 1972) and later in a private Catholic ceremony (St. James Arlington Heights December 1972). We were married for eight years and had two children.

I do not know how [REDACTED] got acquainted with Barbara Blaine and SNAP but my name does not belong on a list of pedophile former priests. You have caused great distress to my wife and I and to our twelve year old son whom we needed to inform about this when it was published in the papers.

I continued to follow the rules and my marriage to [REDACTED] was annulled in 1988. I then married [REDACTED] at St. Catherine Labore in Glenview June of 1990. She died at 39 November 23, 1991 of complications of diabetes. On February 13, 1993 I was married to [REDACTED] at St. Mary of the Woods in Chicago and now have a 12 year old son, [REDACTED].

This harassment has went on for long enough now!! We have suffered through over four years of unexpected contacts from different Archdiocese personnel giving me inconsistent information about what would happen next and what I could do about the situation. I demand that you do the right thing and remove my name from your list. If this is impossible I insist that you note by my name that I have one allegation; 17 years or older; ex - wife; the way the state of Illinois does. This will somewhat mitigate the slander you have committed against me.

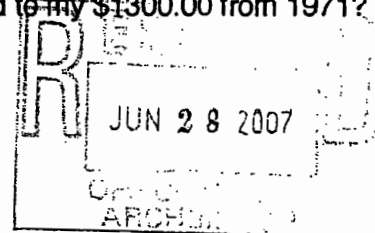

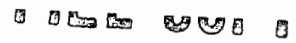


