

Victim Statement Abstract

This abstract replaces the summary prepared by Steve Sidlowski, Professional Fitness Administrator for the Archdiocese of Chicago, of Victim AI's and Victim AJ's statements, given to Mr. Sidlowski on March 30, 1993, formalizing their allegations of sexual abuse against Fr. Ralph Strand. According to the statements, Fr. Strand sexually abused Victim AI and Victim AJ in approximately 1973 when Victim AI and Victim AJ were in the seventh and eighth grade at St. Simeon's School. Fr. Skriba made sexual comments and fondled the boys' genitals and buttocks on numerous occasions. The victims reported that Fr. Skriba sexually molested at least 12 male classmates in a similar manner.

Victim Statement Abstract

This abstract replaces the summary prepared by G. McNamara, Investigator for the Office of the Cook County State's Attorney, of Victim AI's statement, given to Mr. McNamara on March 30, 1993, reporting his allegation of sexual abuse against Fr. Ralph Strand. According to Victim AI, he came in contact with Fr. Strand in approximately 1971 when he was in 6th grade. Victim AI reported that Fr. Strand provided students with beer and wine on occasion, grabbed their buttocks and put his hand on their lap while wiggling his tongue.

Victim Statement Abstract

This abstract replaces the summary prepared by G. McNamara, Investigator for the Office of the Cook County State's Attorney, of Victim AJ's statement, given to Mr. McNamara on April 2, 1993, reporting his allegation of sexual abuse against Fr. Ralph Strand. According to Victim AJ's statement, Victim AJ came to know Fr. Strand in seventh grade in approximately 1971 and Fr. Strand always made sexually suggestive remarks around students at St. Simeon's. Victim AJ reported abuse consisting of Fr. Strand grabbing Victim AJ's genitals over the clothing, putting his hand in Victim AJ's pocket while sticking out his tongue, and propositioning Victim AJ for oral sex. Fr. Strand's behavior got worse by eighth grade and some students reported it to a nun working at the school in 1973. According to Victim AJ, Fr. Strand was also a Boy Scout chaplain.

Victim Statement Abstract

This abstract replaces a summary prepared by Kathleen Leggdas, Professional Fitness Review Administrator for the Archdiocese of Chicago's Office of Professional Fitness Review, of Victim AK's statement, given to Ms. Leggdas on August 24, 1999, formalizing his allegation of sexual abuse against Fr. Ralph Strand. According to Victim AK's statement, the abuse consisted of discussion of sexual topics and genital fondling when Victim AK was in the sixth through eighth grades at St. Simeon School. Victim AK also reported that he may have been abused by Fr. Strand at an earlier age, but had difficulty remembering the details of the abuse.

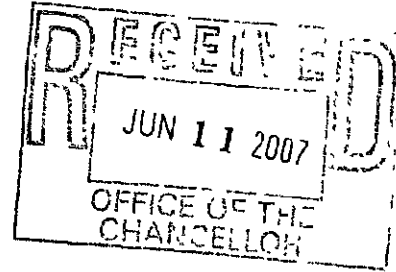

After a review of files, I came across the matter of [REDACTED] allegation of the sexual abuse of a minor against Rev. Ralph Strand. Mr. [REDACTED] allegation was first received on August 24, 1999.

This matter was before the Review Board for its consideration on September 18, 1999. The minutes from the meeting include, "Based on observation of PFRA and Michael Bland from VAM, as well as the following factors, the Board determined it is reasonable to conclude that allegations made concerning 7th and 8th grade are credible."

I have attached a copy of the September 18, 1999 meeting minutes pertaining to Mr. [REDACTED] allegation against Fr. Strand to this memorandum. Despite the Review Board's recommendation on this matter, I was unable to find a specific letter to informing you of the recommendation and/or a response from you noting your decision.

As I continued to review Mr. [REDACTED] files, I determined that he also alleged that Msgr. [REDACTED] was involved in the sexual abuse that took place when he was a minor. A review of the meeting minutes from the October 16, 1999 meeting provide the following information: PFRA received a letter from [REDACTED] dated September 19, 1999.. [REDACTED] vaguely recalls that he 'may remember that Msgr. [REDACTED] [sic] was involved in the sexual abuse as well...' I have attached a copy of October 16th meeting minutes to this memorandum as well. The Review Board's actions are recorded as there being "insufficient information" to make a finding of reasonable cause to suspect.

Essentially, it seems that Mr. [REDACTED] allegation against Msgr. [REDACTED] was clearly documented past the October 16, 1999 Review Board meeting and reflected in our database system. However, Mr. [REDACTED] allegation against Fr. Strand was not clearly documented past the September 18, 1999, namely, a letter to you stating the Board's recommendation of "reasonable cause to suspect that the alleged misconduct occurred" and then a necessary written response from you with your decision on the matter.

Please let me know how you would like to proceed with the matter of Mr. [REDACTED] allegation against Fr. Strand. This is necessary for documentation purposes as well as notification purposes to Mr. [REDACTED] and Fr. Strand, to inform them that the matter was presented to the Review Board and whatever your decision would be in response to the Board's recommendation.

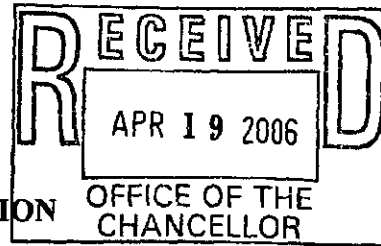

PFRA received a letter from [REDACTED] dated September 19, 1999. In this letter [REDACTED] vaguely recalls that he "may remember that Msgr. [REDACTED] was involved in the sexual abuse as well." He describes this as a "snippet or flash" of memory but is very vague on any "explicit memory of abuse on the part of Msgr."

The Board Members discussed this and were unable to make a determination on this allegation. The information is vague and there is no way to verify, as Msgr. [REDACTED] died February 16, 1986.

Requests to concelebrate at St. Francis of Rome installation and to serve as assistant to Chaplain on two week cruise were denied. Decision is based on Individual Specific Protocol restrictions from active public ministry. Fr. Strand is encouraged to attend installation, and may wear his collar as indicated in previous protocol change.

PFR-41 Rev. Ralph Strand

Three males ranging in age from 12 – 17 have made allegations of sexual misconduct against Father Strand. Abuse took place over years of 1964 – 1973. One allegation of sodomy was made one of oral sex. Others included sexually explicit conversations and touching the boy's genitals. Father Strand served 22 months in prison for criminal sexual abuse of minors and was on parole until 1999. He is now compliant with laws governing Registration of Criminal Sex Offenders. He resides in a monitored setting at Koenig Hall in Mundelein. He has been withdrawn from active ministry and works in the Vicar for Priests' Office two days a week. Father Strand's protocol requires a daily phone call to Professional Fitness Review Office, daily log submitted and only private celebration of the Eucharist.

RE: Review Board Meeting – [REDACTED]

Fr. Coughlin and Fr. McBrady met with the Review Board to discuss the disposition of [REDACTED] which is scheduled for purchase by the City for a new park. The proposal is to move the residents of [REDACTED] to a restricted area of St. Mary of Perpetual Help Rectory. This would primarily involve full-time residence for Fr. [REDACTED] and permission for Fr. Ralph Strand, whose full-time residence is at Koenig Hall, to stay one or nights per week at St. Mary of Perpetual Help.

Fr. Coughlin made the presentation regarding Fr. Strand, and Fr. McBrady spoke on behalf of [REDACTED]. After their presentations and further discussion in response to the questions of the Board, Fr. Coughlin and Fr. McBrady left the meeting, and the Review Board deliberated on their proposals.

Regarding Fr. Strand, the Review Board recommended by a vote of 5-2 that he be allowed to stay at St. Mary of Perpetual Help Rectory only in exceptional circumstances such as inclement weather, poor health, etc. In each circumstance, he is to obtain the permission of the PFRA. The Board further asked that this be done on an experimental basis to be reviewed by the PFRA in consultation with the Board every two or three months.

Concerning [REDACTED] the Review Board recommended unanimously that he not be allowed to stay at St. Mary of Perpetual Help Rectory and asked that another alternative be found.

[REDACTED] Father Strand is no longer on parole, I have accepted the Board's recommendation that Father Strand be allowed to wear the Roman collar at clergy gatherings, at wakes, and at Masses for which he has received approval to participate. I also concur with the Board's agreement to reduce the frequency of his calling in to the Professional Fitness Review Office from twice a day to once a day.

I further accept the Board's recommendation that Father Strand continue to maintain a daily log which is submitted monthly to the Office of Professional Fitness Review, although this log may be less detailed than in the past. As the Board suggests, it should primarily indicate where Father Strand is spending his evenings, weekends and overnight stays.

I am grateful to the members of the Review Board and yourself for your assistance in this matter.

Newly received allegation reviewed by Board. [REDACTED] alleges sexual misconduct as a minor against Father Strand.

Based on observation of PFRA and Michael Bland from VAM, as well as the following factors, the Board determined it is reasonable to conclude that allegations made concerning 7th and 8th grade are credible.

- Fr. Strand was at St. Simeon at that time and did work with the altar boys.
- Alleged behavior is consistent with previous credible allegations.
- Other altar boys named by [REDACTED] appear in previous allegations made in reference to the same time period.
- [REDACTED] description of Fr. Strand detailed and accurate.

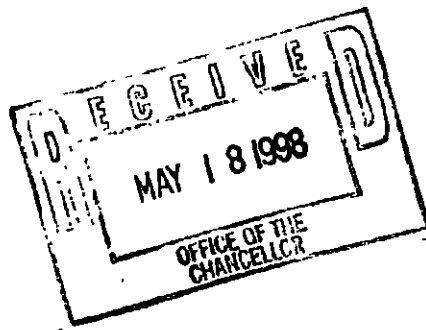
Earlier memories are per Mr. [REDACTED] vague, and cannot be verified. Nor do alleged dates (1966 - 67) coincide with Fr. Strand's years at the parish. He was assigned to St. Simeon from 1968 - 1975.

Fr. Strand recalls the name [REDACTED] Denies sodomizing any minor; denies allegation of sexual intercourse with religious and/or participation of [REDACTED]

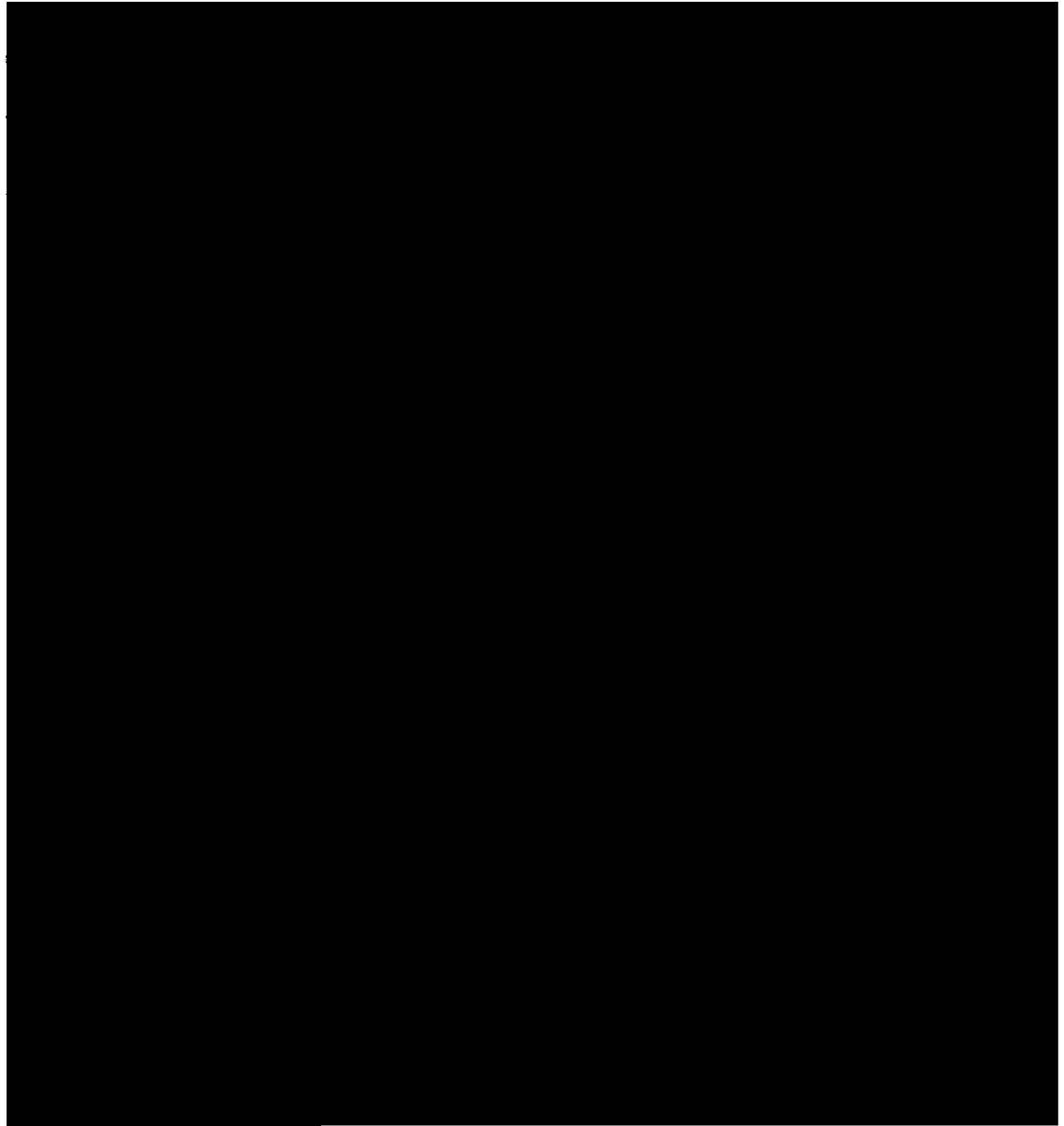

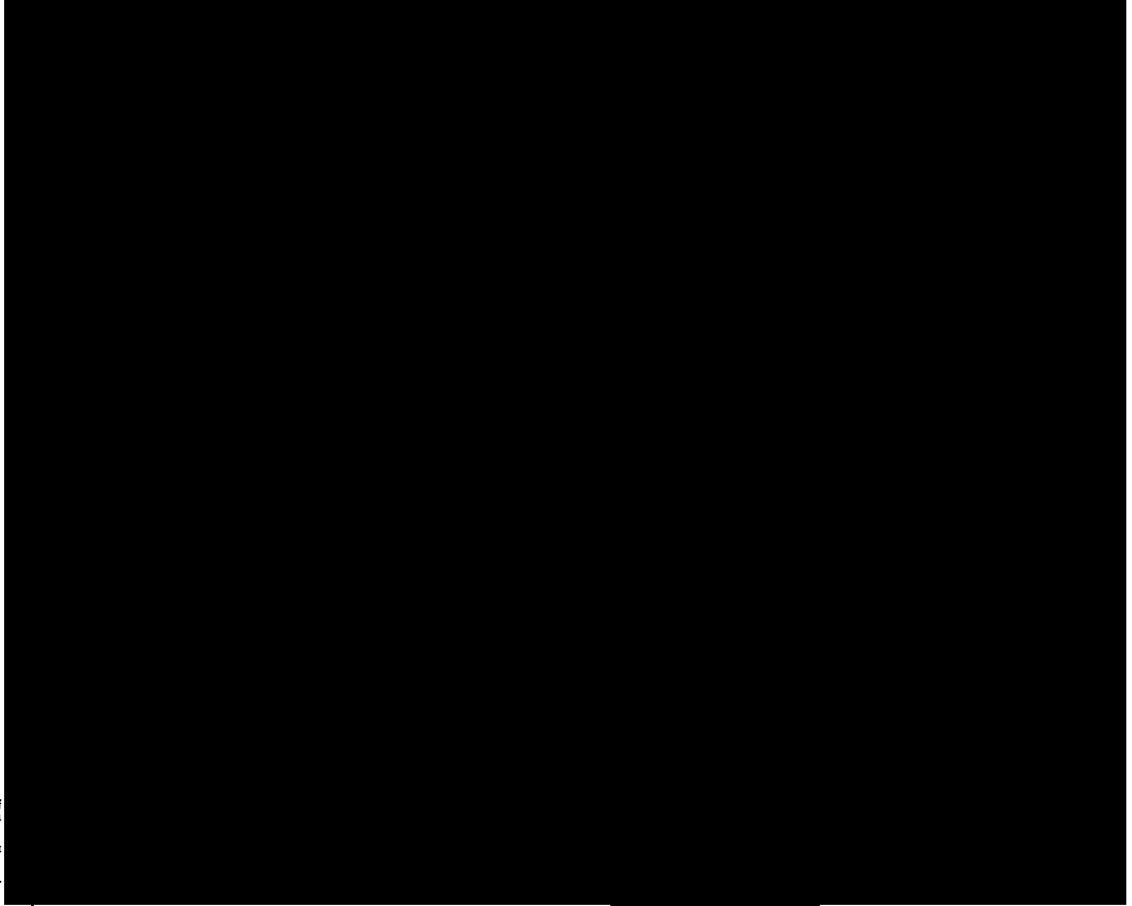

Dear Ralph:

Despite the fact that I have not recently seen you, I have been thinking and praying about your situation. The Vicars for Priests have kept me informed about your situation these past months. I know that Father Coughlin recently visited you and shared with you what my intentions are with regard to your priesthood. Let me reiterate how I am approaching this matter.

Because of the requirements of canon law, I had to consider whether a "canonical penalty" should be imposed in your situation. Considering the circumstances of your case as they are known to me, I have decided that I will not seek your dismissal from the clerical state. Father Coughlin, I am informed, told you that verbally. I do not judge that justice and equity would be served by so severe a sanction. You have suffered enough by your present deprivation of ministry and your incarceration.

On the other hand, because of your conviction and imprisonment, I cannot guarantee any public ministry for you in the future. Although I cannot speak for any future Archbishop who will someday succeed me, you should expect that any decision regarding future ministry will have to be made in accord with canon law and Archdiocesan policies and procedures, in consultation with the Professional Fitness Review Board. Apart from the question of any ministerial assignment, it is my hope that as a priest you would focus on being dedicated to a fervent life of prayer, nourished by attention to deepening your own priestly spirituality.

Ralph, I hope this information helps you focus on your future in as constructive a way as possible. If you have any questions about it, please discuss it with one of the Vicars.

Please be assured of my continued prayers on your behalf.

Conclusion ① while our top priority is safety of children we have to look again at our procedure. It should not only be just, but should also have the appearance of justice - and right now, that's not how the parishians see it.

- appears to be unjust to accused. His reputation is destroyed - even if he eventually exonerated, his ability to minister again is practically nil.

- part of the problem is the public manner in which we handle the accused - by removing him we broadcast the issue to the world. Media picks up on it immediately & exploits it for its own purposes - namely, titillation of the public's curiosity to assure high ratings

- Is there not some other way to protect children & at the same time not destroy the accused, e.g. leave the accused in place, but assign a monitor, spell out his restrictions, inform leadership, etc. (house arrest is better than public disgrace)

② I would raise the question again - why do we feel obliged to further victimize the victim by insisting the matter be reported to DCF & State Attorney, even though:

a) the victim is no longer a minor

b) the victim and his family clearly want to avoid involvement in the civil arena

Our policy makes good PR, initially, but in effect makes the church an arm of the State Attorney & DCF & causes severe problems without any guarantee that children are better served. On the contrary, some victims and their families will shy away from reporting abuse because of their unwillingness to become involved in civil or criminal proceedings. As a result the victim is not cared for and the accused goes untreated. We ought to learn something from the experience of therapists - cf. Dr. Berlin testimony.

③ There are competing values:

a) safety of children - minimize risk.

b) constitutional right of accused to be treated as innocent until proven otherwise.

Our policies do not adequately respond to either value - and in fact, do just the opposite as far as the accused is concerned.

(4) I don't have an answer as yet, but rather do I think our procedures are the answer. Strong resentment was expressed by parishioners at both meetings that one person (Fitness Review Board) should be allowed to make a decision to remove the accused with so little evidence, etc. It didn't help to say that the Cardinal and the Review Board entered into the decision, since they all relied solely on the opinion of one person. Removal of a pastor with the devastating effect of the media on his good name is too high a price to pay - there has to be a better way, but we haven't yet discovered it.

(5) Bottom line - under the present system, the church simply can't win. We are damned, no matter how we handle the issue. The irresponsibility of the media renders us helpless to protect the good name of the accused.

(6) So far, we have heard nothing about the new allegations against Fr. Strand. It seems to me that Jane & I ought to be kept up to date on what's going on. I was criticized at the public meeting for not having any info. that the people hadn't already heard in the media. People assume we are "covering up" & several verbalized this.

I spoke to Ralph Strand [REDACTED] on Wednesday evening, May 12. I relayed to him our message about the follow-up letter to his resignation letter to the Cardinal.

I asked him to send a clarifying letter to the Cardinal.
[REDACTED]

I told him what little I knew about the pending indictment. As far as I can tell, it won't come down for another week or two. I mentioned to him the call that was received on the 1 - 800 number concerning a man named [REDACTED]. In the course of our conversation, I asked Strand if he had received the full physical examination and whether all aspects of his condition had been dealt with. He said he was quite sure he had the tests, but he would get that information back to me as soon as possible. He does not believe that the previous contact entailed any danger of disease.

With regard to allowing the name of the first person he had a liaison with to be released to the State's Attorney's Office, Strand said he would ask his lawyer. His lawyer, Brent Stratton, would consult with [REDACTED] if there is need to look into this.

The Cardinal was touched by your letter of resignation and your evident concern for the people of St. Francis Borgia parish. May I make a suggestion? I would ask that you send him a follow-up letter. In this letter, I would suggest something like the following text:

Dear Cardinal Bernardin,

I sent you my resignation from the pastorate of St. Francis Borgia parish because I wanted the important ministry and life of St. Francis Borgia parish to go on. I realize that I will be [REDACTED] for quite a while.

I want you to know that my resignation in no way indicates any admission of guilt in the allegations made against me. It merely stresses my own willingness to step aside for the good of the parish. Please accept my resignation in the spirit in which I submit it. Thank you very much again for your support.

Ralph, my own feeling about this is that your resignation may have left a wrong impression. I suggest you put it on record that you did not in any way admit guilt for the allegations of sexual abuse. I'm sure that, had you consulted your attorney on the wording of your resignation he would have made sure that you reiterated that you were in no way incriminating yourself. You are of course free to talk to your attorney on this matter. My reason for suggesting a follow-up letter in your file is that we must keep the copy of the resignation that you sent since it was accepted, but you have the right to submit clarifications. I recommend that you do so. If I can be of any help in this matter, please don't hesitate to call collect.

I am referring information to your Office regarding a phone call and meeting with a person who had information regarding an adult acquaintance of the Rev. Ralph Strand. Apparently, the other adult has since died. The person I have spoken to stressed that he would like confidentiality respected as much as possible. He does not want his name used in regard to matters involving Rev. Ralph Strand if at all possible.

I clarified for this person that in my role as the Professional Fitness Review Administrator, I receive, make inquiries into, and process allegations of sexual misconduct by priests involving minors. As this person is bringing no such allegation against a priest directed toward himself neither as a minor nor as an adult, nor any other alleged minor victim, and rather has made reference to this other, deceased adult acquaintance of Ralph Strand, I have concluded that this information should be appropriately referred to the Vicar for Priests' Office.

Please note the enclosed memo entitled "Phone call from [REDACTED]: 4-28-93," first. Today I met briefly with Mr. [REDACTED] as well. He stressed that his information is not germane to sexual misconduct with minors by Rev. Strand and that nothing ever happened to himself in particular which could be considered sexual. Mr. [REDACTED] noted that as an attorney in the Cook County Public Defender's Office in the 1980's, he represented a criminal defendant who was eventually convicted. An adult acquaintance of that defendant explained as an alibi in record Mr. [REDACTED] had access to at that time, that the defendant's adult acquaintance could not have been in the defendant's presence at the time of the crime because on that date and time he was involved sexually with Ralph Strand. The defendant later told Mr. [REDACTED] that Ralph Strand was a "lover" of the defendant's adult acquaintance and that the defendant, his adult acquaintance, and Ralph Strand would often go to "gay bars" together.

The defendant was a [REDACTED]. His adult acquaintance was a [REDACTED]. [REDACTED] was convicted of murder - of chopping up a victim's body and putting it in eight garbage bags and placing the

body parts in a dumpster. [REDACTED] was apparently involved sexually with [REDACTED] at the moment the police broke into his apartment to arrest him. As a result, [REDACTED] was questioned by police at length and then later gave the Strand alibi. Apparently, [REDACTED] has since died of AIDS.

On 4 May 1993 RIs interviewed Father Paul Rosemeyer, Pastor at St. Marys Parish 749 Pearson Street Des Plaines, Illinois. Rosemeyer was informed the basic nature of this investigation and related the following in basic summary non verbatim.

Rosemeyer has been assigned to St. Marys Parish since 1981. Rosemeyer was questioned concerning a memorandum dated 25 June 1991 from the Vicar for Priests for the Archdiocese of Chicago to file reference Father Ralph Strand. The memorandum summarizes a conversation the Vicar had with Rosemeyer on that date in which the Vicar reports that Rosemeyer had no reason for thinking Strand had continued to act out a homosexual lifestyle. Rosemeyer stated that although he could not recall making the aforementioned statement he recalls Father Strand telling Rosemeyer of an incident shortly after Strand was assigned as Associate pastor at St. Marys in 1986. According to Rosemeyer, Strand advised Rosemeyer that an unidentified individual had alleged that he had been involved in a homosexual relationship with Strand. Rosemeyer stated that Strand did not identify the person making the allegation nor did Strand further elaborate. Rosemeyer believes the matter was never substantiated.

Rosemeyer additionally stated that he knew the identity of the person making the most recent allegation to be one [REDACTED] whose family are parishioners of [REDACTED]. During the period 1990-1991 Rosemeyer recalls observing [REDACTED] on several occasions on the second floor of the parish rectory, in the hallway outside of Strands living quarters. Rosemeyer was unable to recall if [REDACTED] entered Strand's room and could not recall the times of day or evening Rosemeyer made these observations. Rosemeyer had no knowledge of [REDACTED] ever spending the night in the rectory and maintained his living quarters in a separate adjacent facility known as the Father Bird House.

Rosemeyer was unable to provide any further information at this time and the interview was concluded.

You may be aware that the Mundelein Department of Police visited Ralph Strand some months ago informing him that he is residing less than 500 feet from Mt. Carmel School. (A sex offender needs to live more than 500 feet from the location of any children's facilities.) The property line was determined by the state's attorney who defined it as being the entry to Mundelein Seminary on Route 176 which is less than 500 feet from the entry of the school. We discussed the possibility of partitioning the land surrounding the retreat house as a separate entity which would be more than 500 feet from Mt. Carmel. However, Larry McBrady discovered that the Mt. Carmel ball field is directly across from the retreat house. This is also less than 500 feet.

Unless the interpretation of the law is changed, the future for Ralph residing at the retreat house looks very grim. We will need to find a different location for priests who are convicted sex offenders.

Ralph is very anxious and nervous about this situation. We will make efforts to retain the retreat house for a residence of priest sex offenders, but the future doesn't look promising.

On December 12, 2000 Rev. James Kaczorowski, Vicar for Priests, received a telephone call from Rev. David Jones, President of Quigley Seminary. Father Jones wanted to discuss a conversation that he had had with Father Snieg, one of the chaperones to the seminarians who accompanied Cardinal George on the Pilgrimage to Mexico the previous week.

Father Snieg reported that one of the seminarians had come to him to talk about a priest who was also on the pilgrimage with the group – Father Ralph Strand. [REDACTED]

Based on this information a meeting was held with Father Strand, Father Kaczorowski and the Professional Fitness Review Administrator.

The student's name is [REDACTED]. Father Strand was not surprised that concerns had been raised. On the other hand, his expectation was that there may have been talk about his "hanging around" with three women on the tour. They were coincidentally from St. Francis Borgia parish where Father had been previously assigned. The only information [REDACTED] had was Father's first name and the fact that he lived at Mundelein Seminary. ✓

Father Strand explained that upon one occasion he met the seminarian in the gift shop attached to the hotel. [REDACTED] was looking for souvenirs for his family. RS began a conversation with him about who he was buying things for etc. In the course of that conversation, RS asked the seminarian his age. RS clarified that he did this since would have been more comfortable talking with him had he been 18 or older. At that time RS gave [REDACTED] \$20.00 as he observed that he did not have enough money for the purchases he wanted to make.

On a second occasion RS was observed sitting in the hotel lobby talking to [REDACTED] by Mary McDonough from the Office of Communications. As she is familiar with Father Strand's case as a result of the publicity from the past, she stated to PFRA in a meeting following the return of the tour group that she was uncomfortable that they were alone. They were sitting across from each other and there were no visible improprieties. Mary McDonough spoke to James Vodak, Director of Communications and the two decided to tell the chaperones from Quigley of Father Strand's status as a client of the Office of Professional Fitness Review.

[REDACTED] had spoken of his discomfort to Father Sneig who was grateful for the information regarding Father Strand. Father Strand reported that he felt he was "being watched" by the two seminary chaperones. Based on the information provided by MMC this would likely be true.

Father strand stated that he was never alone with the student and that both interactions took place in the public areas of the hotel in which they were staying. At the end of the trip RS had another occasion to talk to [REDACTED] and asked him if he had bought himself a souvenir of his trip. [REDACTED]'s response was in the negative. RS then took out a medallion he had purchased from the shrine of Guadalupe and gave it to the young man. RS stated that [REDACTED] said that "they should get together for lunch some time." To which, RS stated that he made no response.

In retrospect and based on the observations of Jim Vodak and Mary McDonough the question was raised concerning the advisability of allowing Father Strand to accompany the Cardinal on the Pilgrimage. Mary Ann Ahern and other press representatives were there and could have recognized him to the detriment of RS and the Archdiocese of Chicago.

PFRA categorized RS's behavior as "grooming" behavior but father disagreed and was either unwilling or unable to relate to this interpretation. He was annoyed and angry at his not being able to publicly interact with the young man and interpreted his actions as those of a generous man, not a predator.
