did knowingly commit a lewd or lascivious act on or in the presence of a child under the age of sixteen years, to-wit: [REDACTED] born 29 January, 1974, by touching or fondling the child on or near her breast or on or near her vaginal area in a lewd, indecent or lascivious manner, but without committing sexual battery, in violation of Florida Statute 800.04;

contrary to the form of the statute in such cases made and provided and against the peace and dignity of the State of Florida.


