

INDEPENDENT INQUIRY INTO CHILD SEXUAL ABUSE FINANCIAL REPORT – 2016/17

1. OVERVIEW

The information in this report sets out the expenditure for the financial year of 2016/17 ending 31 March 2017, with a further breakdown of costs in relation to staffing and expenses. The expenditure for the full year was £20.8m against a full year budget of £30.94m.

2. FURTHER DETAILS OF EXPENDITURE RELATING TO CHAIR, PANEL MEMBERS AND SECRETARY

a. Dame Lowell Goddard (1 April 2016 - 4 August 2016)

The table below shows a breakdown of the contractual cost for Dame Lowell Goddard as per the <u>terms of her appointment</u>, which were published on the Inquiry's website in July 2015. The below expenditure is up to her resignation on 4 August 2016.

The Inquiry incurred £41,751 costs during the last financial year on travel included in Dame Lowell Goddard's terms of appointment. This included travel to and from New Zealand for her and her family. The Inquiry incurred £1,651 on official business travel and accommodation for Dame Lowell Goddard.
