Acts of the accused:

Former Third Order Regular, Province of the Immaculate Conception Ministers Provincial Father's Anthony "Giles" Schinelli, Robert D'Aversa and Anthony Criscitelli, conspired to, and did, endanger the welfare of children by placing, and continuing to place, Third Order Regular Franciscan Friar Brother Stephen Baker, in ministry, contact with the public and contact with children, from April 1992 to January 2010 after knowing about sexual abuse allegations against Brother Baker and numerous other Friars. The Minister Provincial is the head of the individual province and the only person able to make assignments of the Friars. The province is the employer of the friars.

Pursuant to 42 § 5552 (C)(3), the statute of limitations is extended until the minor reaches 50 years of age.

This course of conduct, and criminal conspiracy, allowed Brother Stephen Baker to sexually abused more than 88 children from Bishop McCort High School during 1992 to 2010. See attached presentment of the 37th Statewide Investigating Grand Jury.

AFFIDAVIT of PROBABLE CAUSE

Your Affiants, Special Agent Jessica L. Eger and Supervisory Special Agent Robert Drawbaugh, from the Bureau of Criminal Investigations with the Pennsylvania Office of Attorney General (hereinafter: OAG), being duly sworn, depose and says:

Your Affiants have been conducting an investigation of allegations of endangering welfare of children. The OAG's investigation has utilized a Statewide Investigating Grand Jury. As a result, the 37th Statewide Investigating Grand Jury made Presentment No. 43, same accepted by order of the Honorable Judge Norman Krumenaker, Supervising Judge. This Presentment, attached to this affidavit and incorporated herein by reference, recommends charges be filed by the Attorney General, or her designee, against the defendant.

Your Affiants have reviewed the above cited Presentment and aver that the factual findings described therein correspond to the OAG Investigative findings. Your Affiants have reviewed the sworn testimony given by the witnesses before the Grand Jury and find that it is consistent with the information contained within the Presentment. Your Affiants have reviewed the evidence presented to the Grand Jury and find that it comports with the results of the OAG investigate efforts and findings as to the allegations contained in this criminal complaint.

Your Affiants state, based upon the above facts which are listed in the attached document, there is probable cause to believe that the defendants, Anthony Joseph "Giles" Schinelli, Robert John D'Aversa and Anthony Joseph Criscitelli, committed the act detailed herein, in violation of Pennsylvania law.

I, JESSICA L. EGER/ROBERT DRAWBAUGH, BEING DULY SWORN ACCORDING TO THE LAW, DEPOSE AND SAY THAT THE FACTS SET FORTH IN THE FOREGOING AFFIDAVIT ARE TRUE AND CORRECT TO THE BEST OF MY KNOWLEDGE, INFORMATION AND BELIEF.
