I have reviewed the information that the Diocese of Manchester provided to our office on Thursday, February 28, 2002. I appreciate the time and effort that you and the Diocese have spent on this very important issue. I believe that the approach that the Diocese of Manchester has taken with respect to this difficult and painful issue is a credit to the institution.

As we discussed on the telephone, we still need some additional information before we can begin the process of determining whether there are any viable cases that can be pursued. In as much detail as you possess, please provide the following information on each and every accusation involving the fifteen priests that you identified: (1) name of the victim; (2) age of the victim when the abuse took place; (3) date of the abuse; (4) the city or town where the abuse took place; (5) date of the complaint to the Diocese; (6) age of the victim when the complaint was made to the Diocese; and (7) description of the abuse in as much detail as possible. This last piece of information is especially important so that we can determine whether the abuse was a felony or a misdemeanor.

If you do not have a particular piece of information, such as how old the victim was when the abuse occurred or where the abuse took place, please include any information you have which may assist us in finding the missing details. While I realize that you may not have all of information requested, please indicate which details you are missing so that we will be able to determine whether and how to obtain that information in the future.

#### Dear Friend in Christ:

It is about two weeks since I wrote to you about my concerns, intentions and efforts regarding the protection of our children. These past few weeks have been marked by feelings of anguish and questions about the acts of sexual misconduct by a few of our priests. Sensing that as faithful parishioners you must be experiencing similar feelings and thoughts, I decided to share a reflection with you.

A phrase often quoted to me by a friend as being inscribed above the altar of a church in Rome surfaced in my mind several times. The phrase is, "PIANGO, PREGO, SPERO – I cry, I pray, I hope." Remembering this phrase helped me to think and pray about what concerned me, and so I share it and my thoughts about it with you.

"PIANGO – I cry." It is easy to sense and shed tears these days for all that has happened and is happening. Tears are about loss, the loss that so many of us feel within our Church — for the victims who have lost their sense of trust and joy, for the priests who through their actions have lost their good name and their pastoral ministry, and for parishioners and their priests who grieve over the cloud that overshadows the good name and work done by the Church and her ministers these many years. Yet, acknowledging the sense of loss is helpful for us, because "tears cleanse" our anxious hearts. They help us to let go of the things that need letting go and to believe and hope that from the ashes of these difficult days the Lord will bring about a renewed life for us and for our Church.

"PREGO, I pray." Our constant and faithful friend is the Lord Jesus. "I shall be with you all days, even to the end of the world." And so it is with Him that we gather in our prayer, giving to Him all our disappointments, pain and sorrow; seeking from Him understanding and strength; knowing He will guide us through all this. I find myself daily asking Him to help me to continue to face these matters in a manner that is respectful, honest and understanding; to help people deeply affected by sexual misconduct and their families to deal with these matters in a helpful and healing way; to help the priests, members of parish staffs and parishioners assist and support one another.

"SPERO, I hope." There is part of me that wants and hopes that these matters will be over soon. Yet, there is another part of me that is reminded that deep wounds heal slowly. So what kind of healing can you and I hope for in the coming weeks?

First, I hope that our anguish for the Church, for the victims and for the priests accused does not cloud the faith we have in God and the respect and care people have for their local parish and priest. Knowing the grief and embarrassment you and I can feel for all these matters, there is a danger of feeling alone and not dealing with our anxieties and our sentiments in a constructive way. I encourage you to talk about your sentiments and feelings with other parishioners, with your parish priests whom you know and

with friends. The more we are able to talk about our concerns, the more our wounds now opened, can be healed Then we will begin to experience needed support.

Secondly, I hope you know how much I want to serve you and the Church in New Hampshire well, in the best way I can. I can best serve you by serving your pastors — our priests. Whatever I can do to help them during this period of trial, I am pleased to do. I hope too that you will avail yourselves of the good and competent services offered by the staff of Catholic Charities. They have skills about coping with such issues and understanding such matters that many of us do not have. They are ready and willing to assist us all in dealing with these matters, be it a personal concern or in helping people through a local or regional listening session or through individual counseling.

I hope because God has helped me to pray 'with tears.' May our tears cleanse us, our prayer strengthen our trust in Jesus, so that we might be patient in healing and firm in our hope. "PIANGO, PREGO, SPERO."

Dear Friend in Christ,

The Season of Lent offers each of us the opportunity to seek the Lord where He may be found, and to call to God while He is near. This year, Lent takes on a special meaning as our local Church reflects on our errors of the past and seeks to turn back to the Lord, who is ever faithful and ever true.

The news regarding the handling of priests accused of sexual misconduct in Greater Boston has an effect on the Church in New Hampshire. It is normal for people to ask if it has happened there, what about here?

People wonder not only what has the Church in New Hampshire done about this in the past but also what is it doing to make the Church safe for children in the future. There have been instances in New Hampshire where priests have had inappropriate contact with children. In each instance, the Church has responded to those affected by these criminal acts, reported the matters to civil authorities in accordance with State law and sought to heal the deep wounds that these violations of trust leave behind.

As bishop and pastor of the Church in New Hampshire, I have responsibility for the teaching, worship and administration that is carried out in our parishes. I want the membership of our Church, as well as the members of the wider New Hampshire community, to know that there is no tolerance for sexual abuse of children and youth in our Church.

My delegate has reviewed all our files regarding past allegations of misconduct by priests with children. These allegations are now being reviewed according to the 1998 Diocesan Policy on Sexual Misconduct, which states that, "no priest will be assigned to pastoral ministry who has abused a child". I assure you today that in view of all the cases we know no priest who has abused a child is presently assigned to pastoral ministry.

Our diocesan policy in this regard is thorough, clear and carried out by people whom I trust to represent me well. More information on this policy and ways of contacting those who implement the policy will be made available in the coming week to everyone in our parish communities.

To ensure that this is our practice as well as our policy, we have taken steps over the years to inform and assist parish priests and pastoral ministers, as well as the heads of our educational and social service institutions, in understanding sexual misconduct and their responsibility in acting on any sense that sexual misconduct may be taking place.

Presently we are in the process of providing additional training to priests and training to deacons, religious and lay employees in our parishes and institutions regarding our policy. This training includes forthright discussions about the nature of sexual abuse of children and what to do if any such abuse is seen or even suspected. As with any policy, its effectiveness relies on the cooperation of us all and a spirit of accountability in our community. We all must be diligent in helping to protect our children. I know that trust lost or questioned must be restored.

Sexual misconduct by priests affects the very core and well being of the victims and the long standing trust of every member of our Church. In addition to helping victims through assistance for counseling, there is a further need to help all members of the diocesan Church.

As a way of helping parishioners deal with their concerns about these matters and their trust in the Church, I am asking pastors to focus on providing a time to listen to the concerns of their parishioners and to gather with other parish communities later in Lent to pray for the victims of sexual abuse and their families. We need to ask God to help us as Church to see and accept our failings in preventing this in the past and to strengthen our resolve and awareness to prevent such incidents in the present and the future.

I would be remiss if I did not thank God for the gift of the many good and faithful ministers — priests, deacons, religious and laity — who serve the Lord well in church ministry in New Hampshire. The failings of some sadly affect us all. Yet, Easter will come soon. The handful of ashes with which we begin this Lenten journey becomes, through God's Spirit, the fruitful earth for our rebirth. Whatever we do well, we need to do together. May our resolve to be a people of hope be more powerful than ever during this Lent and Easter Season.

The Bishop had read the prepared statement word for word. I arrived as Chancellor Arsenault was making his statements.

A review of all files was begun in response to the issues in MA. All of the files were reviewed and they communicated with the Attorney General. The review was for a thirty (30) year period. There are fourteen (14) priests that were identified. One was currently assigned to a parish, six (6) were retired but still celebrating the Mass. These seven (7) have been removed from performing any further functions. The remaining seven (7) had been removed from ministering in the past.

Ques. when the complaints were received, were they reported to the police? The Diocese complied with the mandatory reporting law. As each report was received, if there was a minor involved, it was reported to the police. If the reporting person was no longer a child the matter was not reported to the police. The Diocese dealt with the reporting person and at times there was a monetary settlement. The Diocese did a lot with the reporting individuals.

### Ques. so you always had the details?

The Diocese knew the details from the day the reports were filed. The details have been kept within the respective files.

# Ques. How many victims, amount of awards, boys or girls?

Do not have those types of details. Do not know the number of victims, if there were multiple victims associated with one priest. Do not have the particular amounts of the monetary settlements. Can not comment on the number of boys or girls. Can say that every allegation was responded to.

# Ques. the number of parishes and priests?

There are 130 parishes and 145 active priests.

# Questif 14 priests were removed from ministering?

NO, 6 or 7 of the cases the psychiatrist said they could continue in some form of ministry.

# Ques. 9 or 10 yrs. ago Rev. McCray and Shea were prosecuted. Shouldn't you have done the same with these?

NO medical personnel felt these 6 or 7 were not at the Shea level and they could continue in some form. NOW, the medical personnel are not willing to say that they can continue.

# Ques. is this in response to MASS?

Yes, because of MASS. the standard has been raised and a new policy instituted. 'No priest accused and confirmed will continue in the ministry."

# Ques. pedophiles seek out the priesthood?

Bishop responded that there are pedophiles in all walks of life. The selection process attempts to discover anyone of this capacity but not at times evident.

# Ques. if medical personnel associated with church?

NO, these are independent in house or out patient facilities.

There have been no reports involving a minor since 1987.

All priests received treatment before returning.

Presume Attorney General will now do what is necessary with the list.

At the request of the Roman Catholic Diocese of Manchester, Attorney General Philip McLaughlin met in Concord on Monday, February 11, 2002 with Reverend Edward J. Arsenault, Chancellor and Secretary for Administration of the Diocese. Father Arsenault requested the meeting in light of recent and widely publicized disclosures of the names of priests assigned to the Archdiocese of Boston who either have committed or have been suspected of committing sexual crimes against children.


Father Arsenault, in a letter which he personally delivered to the Attorney General, stated that the Roman Catholic Diocese of Manchester, since the enactment of mandatory child abuse reporting laws in 1979, "... has complied and continues to comply with the child protection laws and the mandatory reporting requirements of the State of New Hampshire."

The Attorney General has spoken personally with each of the state's ten County Attorneys regarding the events in Boston and has forwarded Father Arsenault's letter of reassurance to each county. The County Attorneys are responsible for sexual assault prosecutions in New Hampshire.

The Attorney General commented that, "In light of events in Boston, Father Arsenault's visit and his letter are most welcome and reassuring. New Hampshire reporting laws exist to protect children, and all of us, including clergy of all faiths, have a duty to report child abuse and to comply with the letter and spirit of the law. Law enforcement personnel will continue to investigate any allegations of abuse which are brought to light."


I want to reiterate Bishop McCormack's willingness to meet with your investigators and you to answer whatever questions you may have. We hope such a meeting will be scheduled promptly.



## Report of the Incident

On November 23, 1983, Division of Welfare Director Richard Chevrefils received a report of suspected child sexual abuse of fifteen-year-old The alleged perpetrator was Rev. Gordon MacRae previously of Hampton, N.H. now of Keene, N.H.

Director Chevrefils assigned the investigation and report to law enforcement official to Jeannette Gagnon, Administrator of the Office of Social Services, N.H. Division of Welfare.

# Incident of Sexual Abuse

The incident/act occurred in the early summer, 1983. Rev. MacRae allegedly had sitting on his lap and was kissing the adolescent.

The incident of abuse was made known to the child's counselor Judy Patterson of Catholic Social Services during a counselling session. The child had been referred for counselling by Rev. MacRae for matters other then the alleged incident of sexual abuse.

Founded Abuse: Rev. MacRae has admitted the incident to his superiors.

<u>Victim/Family:</u> Mr. and Mrs. are aware of the incident and that the report has been made to the Division.

The victim is currently an in-patient at Hampstead Hospital in New Hampshire.

The adolescent's parents are also involved in therapy related to a number of difficult problems.

NOTE: For therapeutic purposes, the child's therapist feels he is vulnerable and requests that no information be shared with or discussed with the child regarding the referral of Rev. MacRae to the Division of Welfare.

Treatment/Outcome: Rev. MacRae is currently in active, regular therapy with Dr. Henry Guertin-Ouellette. Dr. Ouellette feels very confident that therapy positive and that Rev. MacRae is now self-controlled enough to give some caningful assurance that he is not likely to engage in deviant behavior.

Rev. MacRae is aware of the report to the Division of Welfare.

Dear Mark:

As you are aware, the Attorney General's Office is in the process of investigating whether the Diocese of Manchester or its representatives engaged in criminal conduct with respect to the manner in which they handled allegations of child sexual abuse by clergy members. You represent a number of clients who have information that would be helpful to this investigation. I understand that several of your clients are reluctant to be interviewed by investigators from the Attorney General's Office because of concern regarding the public disclosure of their identities.

As we discussed on the telephone today, the Attorney General's Office can take steps to protect the identity of your clients from public disclosure. If we determine that the Diocese or any of its agents engaged in criminal conduct, we would not bring any criminal charges involving any of your clients without first discussing that with the victim and obtaining their approval to proceed with such charges.

• In the event that there is a Right to Know request from the media or other members of the public at the conclusion of our investigation, we will make every effort to ensure that the identity of any victim who gave statements to our investigators would not be disclosed. New Hampshire's Right to Know law specifically protects from disclosure "files whose disclosure would constitute [an] invasion of privacy." RSA 91-A:5, IV.

In responding to a Right to Know request, we would redact not only the victims' names but <u>any</u> information that would allow the public to infer the victims' identities. As you are aware, this Office handles many sensitive public intergrity cases, in which witnesses

often are reluctant to have their identity publicly disclosed. The approach I have set forth in this letter is consistent with our past practice in this matters.

I hope that this letter adequately addresses the concerns of your clients. Our investigators are interested in talking with the victims as soon as possible. Do not hesitate to contact me if you have any questions regarding this matter.

Our understanding is that speaking to the Attorney General's Office is not a breach of a civil settlement agreement.

Please contact me at your earliest convenience to reschedule the interview with Father Ham.



I am following up on our conversation of last week regarding our request to interview Monsignor John Quinn in connection with the investigation of the manner that the Diocese handled allegations of sexual abuse of minors by clergy. You requested the names of priests that we wanted to question Monsignor Quinn about so that you could evaluate whether Monsignor Quinn should assert his right against self-incrimination. As I informed you, this office does not believe that it is in the interest of justice to give Monsignor Quinn immunity.

We believe that Monsignor Quinn has information about how allegations of sexual abuse were handled with respect to Gordon MacRae, Joseph Maguire, Paul Aube, and Mark Fleming. We do not intend to limit our questions to these priests because he may have been involved in other matters of which we are unaware or he may have knowledge of how other cases were handled, even if he was not directly involved. We are unwilling to provide any records from our investigation to you.

Please inform me at your earliest convenience whether Monsignor Quinn is willing to speak with us. Our factual investigation of the Diocese is nearing completion. It is important that we speak with decision-makers at the Diocese regarding how these matters were handled so that our factual investigation is complete.



Thank you for what I thought was a productive meeting on October 30, 2002. We await your thoughts on whether the proposals that were made will enable you to get the information you think you need to round out your inquiry.

I wanted to respond to the letter that you sent me on October 25, regarding Father George Ham and Auxiliary Bishop Francis Christian. I am puzzled by the suggestion that they or I are somehow responsible for delaying your investigation.

You first asked to speak with Bishop Christian and Father Ham in early September 2002. We agreed Father Ham would meet with you on October 25, and you would speak with Bishop Christian on October 28 and 29. The delay was occasioned by their need to review files that bear on the decades-old issues you have under investigation. I understood you did not object to giving them time to prepare for the interviews and thought you viewed that as the best way to ensure their answers to your questions would be as complete and accurate as possible. In fact, you said that to focus their preparation, you would identify in advance the priests about whom they would be questioned.

On October 15, you informed me your office would not honor an agreement we had reached on the conditions under which the interviews would be conducted. It was not until last week that you named definitively those priests you wished to discuss with Father Ham, and it took time for me to obtain the Diocese file on at least one of those priests in order that Father Ham and I could review it. I still do not know the identity of priests whose cases you wish to raise with Bishop Christian. To the extent you intended to imply that we are at fault for the delay you have encountered, the facts show the blame is misplaced.

You set a deadline of November 8 for establishing a date on which to interview Father Ham and I will do what I can to accommodate you.

Dear Bishop Christian:

The State wishes to interview you in connection with its investigation regarding the Diocese of Manchester because it is apparent that you had significant involvement in the way that allegations of sexual abuse of minors were handled by the Diocese. You have informed the State through your attorney, Brian Tucker, that you will refuse to testify or provide information on the basis of your privilege against self-incrimination unless given assurances that the testimony and/or information provided by you remains protected under the Fifth Amendment and Part I, Article 15 of the New Hampshire Constitution.

After much consideration, the State is unable to provide you with the cloak of immunity that you have requested. Over the past months, the Attorney General's Office has investigated the manner in which the Diocese of Manchester responded over the years to allegations of sexual assaults by priests against minors. The Diocese, itself, is a target of this investigation. As such, the conduct of various high-ranking Diocesan officials -- including your own -- has been central to the State's investigation. The State has not concluded its investigation at this time, nor has it made any final decision regarding whether to present formal charges against the Diocese.

Although this matter remains open, the State's investigation to date has reaffirmed the following: the Catholic Church, its priests, and high ranking Diocesan officials play remarkably and uniquely important roles in the day-to-day life of the residents of this State, regardless of religious belief. Diocesan officials and priests occupy positions of public trust. Thousands of New Hampshire citizens continue to look to the Church for strength, guidance,


spiritual direction, and moral integrity. In every corner of this State, the Church maintains parishes, priests counsel parishioners, and Diocesan officials make decisions regarding the direction of the Church. In grave matters concerning public safety, the public has the right to scrutinize your conduct and that of other Diocesan officials. Ours is an extraordinary investigation. We are probing personnel decisions that marked the lives of many.

As the current Auxiliary Bishop of the Diocese of Manchester, please reassess the extent of your affirmative responsibility to the residents of this State to be truthful, complete, and forthright in providing information. I fail to understand how considerations of personal risk can impact the duty and willingness of a bishop to tell the truth. Diocesan personnel practices beg to be explained. I urge you to meet with the State, to be forthright, and to provide information, but the State will not provide you with immunity to do so. If you have any questions or concerns, please direct them to Senior Assistant Attorney General Will Delker.

Dear Mr. McLaughlin:

We are writing in response to your October 14, 2002 letter to our client, Auxiliary Bishop Francis J. Christian. The letter followed your decision to withdraw a representation to us as to how your office would treat information Bishop Christian provided to your investigators. The contents of your letter and the manner in which you addressed it, your staff's inconsistent statements about how information would be treated, and your previous public statements about the guilt of diocese officials, cause us to fear that this investigation lacks objectivity and impartiality. The history of our recent communications with Mr. Delker of your office serves to underscore our point.

On September 10, 2002, Mr. Delker called us and requested to speak with Bishop Christian in connection with your investigation of how the Diocese of Manchester addressed allegations that priests were sexually abusing minors. Mr. Delker informed us the issue under review was whether there was a violation of the child endangerment statute (RSA 639:3). He further said the Diocese was a target of your investigation and that Bishop Christian was a "subject" of this investigation. Prosecutors commonly use the term "target" to indicate a belief that there exists substantial evidence linking a person to the commission of a crime and that he is a putative defendant. The word "subject" in this context typically means the person's conduct is a specific part of the inquiry.

When we spoke with Mr. Delker again on September 20, 2002, we raised with him certain comments you made in the June 16, 2002 edition of the New Hampshire <u>Sunday News</u>. Among other things, you said you were "absolutely convinced" that Church leaders committed crimes through the manner in which they dealt with priests accused of sexual misconduct. You continued,

I think it is absolutely self-evident that that's the case. There's no ambiguity about it. The question is, can we get the kind of evidence necessary to bring prosecutions within the statute of limitations. . . . [T]he scope, frequency and duration of these crimes would have been absolutely impossible absent the aiding and abetting of some of these bishops. And in New Hampshire, we are actively investigating this aiding and abetting issue.

Your decision to pronounce publicly subjects of your investigation guilty before an adjudication of guilt from a court (or even the filing of charges) raises serious ethical issues. See N.H. Rule of Professional Conduct 3.6 (b)(4). Your statements also strongly suggest that this inquiry has a predetermined conclusion. You stated the statute of limitations is the only possible obstacle to conviction, plainly making Bishop Christian not just a subject, but in fact, a target. You further appear to have concluded, as early as June, that he is guilty of criminal wrongdoing even though it took another three months before your staff indicated an interest in hearing from him.

Since you appear to have prejudged his guilt, we asked Mr. Delker if, in light of your comments, he would provide us with a letter indicating that information provided by Bishop Christian would not be used against him. Mr. Delker's response was that he would make inquiries within your office and let us know. We understood Mr. Delker was authorized to speak for you in this matter. He is the chief of your criminal bureau and, in fact, your letter of October 14 directs Bishop Christian to deal with Mr. Delker as issues arise.

On October 3, 2002, Mr. Delker told us he would send the letter that week. On October 7, 2002, Mr. Delker told us the letter was on your desk and although you needed to review and sign it, the representation stood. On October 15, 2002, Mr. Delker called to say your office would not be sending the letter. Your correspondence to Bishop Christian followed.

Your correspondence suggests Bishop Christian would assert his privilege against self-incrimination and refuse to speak with representatives of your office without a letter from you that restricted the use to which you could put information he provided. That conclusion is baseless and your presumption about Bishop Christian's thinking on this issue is entirely speculative. As a result of your public comments, we asked Mr. Delker about the availability of letter immunity. We did not discuss what Bishop Christian would do in the absence of immunity or whether he would remain silent without such a letter. Our discussions were limited to whether informal immunity was available, and then to Mr. Delker's statements, that it was, and then, that it was not.

It is also unfair for you to suggest Bishop Christian has been anything less than cooperative. Several months ago he testified on behalf of the State at its request in a related proceeding in Belknap County Superior Court in which Mr. Delker participated. He has never rejected any request your office has made of him for assistance or information. Your comment that you "fail to understand how considerations of personal

risk can impact the duty and willingness of a bishop to tell the truth" is gratuitous and offensive.

Bishop Christian will meet with your representatives at a mutually convenient time. In the interest of fairness, however, we must ask that you provide us in advance of such a meeting with every document within your custody or control that you believe is incriminating of him. It is only through such a disclosure that we can meaningfully and fairly address the issues you have apparently decided to raise in this case.

Mr. Delker notes in the October 22 <u>Union Leader</u> that your investigation involves a review of "forty years of cases." Bishop Christian is being asked to speak with you about decisions you question today, but which were made a number of years ago. It is unfair to expect him to address directly your questions without first knowing how you interpret his conduct to constitute misconduct. Since you have already stated your belief that Bishop Christian engaged in criminal wrongdoing, it is only fair that you allow us to meet your contention head on and have a full and complete opportunity to address it with you before you take the extreme step of filing a criminal charge or criticizing him as part of a public "report." In our experience, prosecutors often permit a target or subject of an investigation of nonviolent conduct to review the evidence before indictment to permit him to point out errors in the prosecutor's analysis. Even if you would reject this request in the typical case, you noted in your October 14 letter that this investigation is "extraordinary."

In closing, we want to comment on your tactic of attempting to communicate directly with Bishop Christian. The rules of professional conduct prohibit an attorney from attempting to address a person known to be represented by counsel, see N.H. Rule of Professional Conduct 4.2, and your letter was a transparent attempt to circumvent that prohibition. It is our responsibility to advise our client. We will do so to the best of our professional responsibility and ability without your advice. We expect future communications from you regarding Bishop Christian to be made to us and not to our client.
