The following are four matters that I think should be brought to your attention:

1. On 10 June 1995 you received a short note from Mr. and Mrs. Fred and Jo-Anne Fraser of Tilton, NH inquiring about the status of the recent Ecumenical Covenant celebrated among Our Lady of the Lakes Parish in Lakeport, Saint James Episcopal Parish in Laconia, and Good Shepherd Lutheran Parish in Laconia. I teleponed Mrs. Fraser that same day to discuss the matter, after having made some preliminary inquiries. I discovered that Father George Harvey, pastor in Tilton, does not know the family because they do not attend church there. In speaking with Mrs. Fraser I learned that she does not attend Mass in NH but when she can attends a Latin Tridentine Mass in Still River, MA.

We discussed the ecumenical covenant and indicated that the covenant was in complete keeping with the tenets of the Roman Catholic faith and in accord with the 1993 Ecumenical Directory issued by the Vatican. I also suggested that she and her husband considering the Holy Father's most recent encyclical, "Ut Unum Sint," of which she was unaware. The matter is settled.

2. Father Nicholas Rogers, pastor of St. Patrick Parish in Manchester, has secure the full-time assistance of Father A.M. Hilary, a priest of the Diocese of Kottar, India. Father Hilary has presented papers from Bishop Leon A. Tharmaraj, Bishop of Kottar, indicating that Fr. Hilary has pemission to serve in any Diocese in the USA for a period of three years. Fr. Hilary was ordained on December 12, 1970. Bishop Kottar writes, "I assure the authorities concerned that Fr. A.M. Hilary will return to the Diocese of Kottar and resume parish work here after three years of stay in USA."

Fr. Rogers intends that Fr. Hilary will live at St. Patrick Parish and assist him for a period of three years, if you have no objection. Attached are copies of the documentation.

3. Since Msgr. Philip Kenney who is retired will be attending the Fall 1995 Institute for Continuing Theological Education (ICTE) in Rome, there is

obviously no need to provide pastoral assistance for him in his absence. Fr. Tetu, who generally provides pastoral coverage for priests on sabbatical, while also working part-time in the Tribunal, has requested what arrangements might be in store for him for the fall. I assured him that there is plenty of work in the Diocese and that some arrangement will be forthcoming during the summer. Are you aware of any need or do you have any plans already for him?

4. Attached is a copy of a suggested recommendation to the ICTE from you on behalf of Msgr. Kenney. If it meets with your approval, I would ask that you kindly sign it on the reverse side and date it. I will mail it to Rome with a check and other documentation.

I trust you are getting some rest this summer. If you wish to speak to me about any of these matters, please let me know.

Your Excellency:

Recently, Father A. M. Hilary, a priest from your Diocese, has presented himself to one of the pastors here in Manchester requesting parish ministry. This pastor would be of a mind to engage him.

However, it has been reported to me that Father Hilary has a serious problem with alcohol and a long history of serious drinking. I have also been told that, when he is drinking, there have been several occasions in which he was involved in molesting girls who went to his rectory. At least one of these instances allegedly has been verified by an investigation which you conducted.

Given the explosive situation in the United States at this time in regard to these problems, I can obviously not permit Father Hilary to serve here, if the reports made to me have any substance. Would you be so good as to respond to me at your earliest convenience to inform me whether or not these problems have in fact plagued Father Hilary, as well as any other information you feel that would be helpful.

I am Father Benjamin M. Sebastian, a catholic priest, of the Diocese of Kottar, India. Bishop Leon Tharmaraj is our bishop. Presently I am doing my studies in Alcoholism Counseling while working for St. Vincent's Services, a child care

agency of the diocese of Brooklyn, New york.

I would like to send you the following CONFIDENTIAL information regarding Father A.M. Hilary (Anthony Muthu Hilary) of our diocese. He was granted permission by our bishop Leon Tharmaraj due to pressure to come to United States. Father Hilary is an alcoholicknown to the diocese. Two months ago he had a mild cardiac arrest due to his dripking and he was warned by the treating physician that he could die if he would relapse. He was twice arrested and fined in court for DWI (driving while intoxicated). He was a few times assaulted by his own parishioners due to his rude behavior resulting from his drinking. There were allegations that under the influence of alcohol he molested girls who went to his rectory. The diocese once investigated one of the allegations and found it to be true.

Fr. Francis Soosai Marian, a drinking buddy of Father Hilary, belonging to the same diocese, came to America an year ago and worked in Little Rock diocese where he was treated for alcoholism and sent back to the diocese of Kottar just last

month.

Mr. Tony Epaphras, an ex-priest & good friend of Father Hilary, lives at 169 Lafayette Street, Manchester. Tony submitted sponsorship letter to U.S. Consulate in Madras, India, inviting Father Hilary to the United States. Father Hialry is scheduled to land in America on 25th of this month on a visitor visa. Tony and Father Hilary are likely to approach the diocesan office for Pastoral assignment for Fr. Hilary in Manchester diocese.

You may contact our bishop Leon Tharmaraj to know more about Father Hilary's drinking problem and you may contact the diocese of Little Rock to know more about Father Francis

Soosai Marian of our diocese.

Hearty Greetings from Kottar, India. I am writing these few lines concerning Rev. Fr. A. M. Hilary of my diocese who is now in Manchester, N. H., with his friend Mr. Toni Epaphras, 169 Lafayette Street, Manchester, N. H. 03102. I have given him permission to go for the United States for a period of three years. I would be happy if he would be provided with the possibility of doing some pastoral work in a parish of your diocese. He had worked in my diocese for the last 25 years. He had been very active and doing lot of good to the people wherever he was.

Now I come to know from Fr.Hilary that certain complaints have been received by you about him. I know that he is used to take alcoholic drinks occasionally, but he is not an alcoholic. I have also never heard of any incident of child-abuse by him. Hence I am surprised that such complaints have been made against him.

I shall be happy and thankful to you if you give him an opportunity to serve in your diocese for three years. If he does not do his ministry to your satisfaction, you may at any time withdraw your permission to work in your diocese.

Dear Bishop Leon:

I write to you to ask for a clarification, one that is extremely important.

In your confidential letter to me of July 27, 1995, you indicated that Father Hilary did indeed have "some problem with alcohol" and at least "one case proved" of problems with girls. Based on this information, I instructed my Chancellor, Msgr. Christian, to inform Father Hilary that we could not offer him ministry in the diocese that would be permanent because of the number of priests we will be ordaining next year. Obviously, the real reasons for our refusal of ministry were the problems mentioned above, but we wished to maintain your confidentiality in the matter, as requested.

Father Hilary began actively, with the help of Toni Epaphras, to attempt to find ministry in the area and even arranged certain interviews. At this point, Msgr. Christian met again with Father Hilary and told him that subsequent to their previous conversation, the diocese had become aware of allegations regarding his drinking and sexual problems. Msgr. Christian did not reveal the source of this information although Father Hilary assumed it was from other priests of your diocese currently working in the United States. He denied the allegations and Msgr. Christian told him that there was no way that we could offer him ministry unless he obtained a letter from you clearing his name.

Obviously, it was our intention in this regard to have you corroborate the information in your previous letter. Since you have not done that and in fact have contradicted it, it puts me in a very difficult situation. On the one hand, I would like to respect your confidentiality, but on the other hand, I am very uncomfortable offering Father Hilary ministry in light of the allegations you confirmed.

Keeping in mind the seriousness of the situation in the United States, and the terrible scandal and perhaps civil liabilities that could come to the Church if Father Hilary is knowingly allowed to function with an unresolved history of these problems, could you please send me immediately some clarification of the apparent contradiction in your letters of July 27 and September 6.

The first letter in response to yours is my personal letter confidential wherein I shared with you my opinion from the reports and complaints, received mostly after he left the country. This I have not shared with my curia members either as it was not opportune. However I did not want this my opinion be known to anyone except to you.

The second letter is an officil one wherein I have explained what the curia members feel about him. Since we could not have any enquiry with him officialy I cannot say anything more than what I have mentioned in that letter.

Having said this I would leave it to you to decide what is good for the moment. In case you decide against him I would only request you not to reveal my personal information as it would create unpleasant situation in my diocese. I do realise your delicacy. As a matter of fact I have given him permission only for three years. Kindly bear with me for the trouble I have given you in this matter. Only thing is I am afraid of the consequences if my first letter is known outside.

· Dear Father Hilary:

I have received your letter of December 1st. I am sorry that you have not been able to find appropriate ministry in the Diocese of Manchester. I must state, however, that I am surprised at the judgement you make that this fact is due to my "non-helping attitude" and the assumption that whatever assistance you felt I owed you was withheld because of the allegations from one of your fellow priests.

If you recall correctly, I told you from the very beginning that the Diocese had no ministry to offer you because of the number of priests that we would be ordaining this spring. I further indicated that it would be unfair to you or to any parish or institution to assign you there for a short time knowing that we would have to remove you from that position in the near future. The allegations raised by the priest from your Diocese had nothing to do with the reasons why the Diocese of Manchester could not offer you ministry.

When those allegations became known to us, it was of course necessary for us to check with your Bishop in regard to them. When he vindicated you in regard to them, this then freed you to look for ministry on your own since the original position of the Diocese, in terms of our need, remained the same.

While it is true that I did not share the name of the priest from your Diocese with you, I did share with you the specific allegations and Bishop O'Neil wrote about those specific allegations to your Bishop. Since you knew what the allegations were, since you have been vindicated of them, and since in any case the allegations had nothing to do with your receiving a priestly assignment from the Diocese, I do not feel it necessary to reveal to you the name of the priest in question, who, in any case, requested confidentiality.

I can understand your disappointment in not finding appropriate ministry here in New Hampshire, but I tried to make the position of the Diocese clear to you in regard to our needs from the very beginning. I once again indicate to you that if you can find a pastor or an institution that can use your services, we will be more than happy to confirm whatever arrangement you make in that regard.

Dear Msgr. Christian.

Thank you for your letter dated October 16,1995. In your letter, you have left to my ability to find a placement in the Diocese of Manchester. I thought that it would be easy to find a parish to work since there have been a few openings due the illness, retirement, death of a few priests. However, now I realize that it is almost impossible for me to find a place to work without your personal interest.

I think that I am duty bound to highlight the following facts. I have been under the realization that the United States of America is a country committed to peace and freedom of people in and outside the country. In my case, I am made to feel insecure and helpless.

I arrived at Manchester on June 24, 1995. The same day I was introduced to Father Nicholas Rogers of St. Patrick's. He showed much interest in my service to his parish.

On two occasions. (on July 10, & August 7), I had met with Msgr Quinn who had given me positive signs of hiring me in this diocese.

I was introduced to you and I had a meeting with you as the Chancellor of the diocese. On August 31, you have called me over the phone and said that you have a place for me and asked me to meet with you on September 5 and get the appointment order.

When I met with you on September 5, you informed me that you had received a negative report from a priest of my home diocese with two specific charges. At your request, the matter was clarified to your satisfaction by my bishop Leon Thannaraj of Kottar, India.

I believe that I have all the right to know the name of my accuser and the content of the communication you have received against me. The false allegations against me as well as your non-helping attitude based on those allegations have caused me unspecified damages to my personal and professional life.

Therefore, I request you to send me a copy of the communication with false allegations against me in your possession by December 11,1995.



Your Excellency:

I write to you in reference to Father A. M. Hilary. As you know, he has been looking for ministry in the Diocese of Manchester for a period of several months. Since he was unable to locate any suitable ministry, it is my understanding that he has now returned to India and to his own diocese.

I have the unpleasant duty of notifying you that shortly prior to his departure from the Diocese of Manchester a serious complaint was lodged against him in regard to his behavior with a woman. That woman, has written a detailed account of this problem, a copy of which I enclose for your information. I believe, must be taken very seriously. She is an honest woman, happily married, with a good family, and would have no reason not to tell the truth in such a matter.

While statement speaks in detail about the incident, I feel I should highlight several points of concern. First, it appears that when hearing confessions Father Hilary often stood outside the confessional so that he knew who the people were who came in to go to confession. Even if they chose to confess behind the screen he had previously seen them. Given allegation, I would wonder whether he did this in order to highlight certain people for improper advances.

Secondly, it is clear from previous times when to confession to him that after hearing her confession he would come around the screen to engage her in conversation and in inappropriate signs of affection. Since she believed this was an Indian custom, she raised no objections to these previous situations.

Thirdly, in the case at hand, it is clear that Father Hilary attempted intimacies with her that are totally inappropriate for a priest, and are compounded by the fact that he did this immediately after hearing her confession.

You will certainly get a better understanding of the situation from statement, and I know that you will treat this matter with all the seriousness that it deserves.

After this complaint was made known to the Diocese, Msgr. Francis J. Christian, the Chancellor, attempted to meet with Father Hilary to discuss the matter. Father Hilary, however, was away from Manchester and returned only a day before he departed for India, so such a meeting proved to be impossible.

In closing, I thank your Excellency in advance for dealing with this matter in an appropriate fashion. because of her love for the Church and the priesthood, is content in knowing that I am writing to you about this matter and that you will give it your every consideration.

Father Christian:

I'm writing this because I get flustered when I talk about such things. I feel it is my duty and also I feel God wants you to know about this incident. I have no intention of taking this to the Civil Authorities as I feel it would do more damage then good to the Church.

On Saturday, Dec. 9, 1995 at approx. 3:45 PM, I went to Confession to Father Hillery, (the Indian Priest staying at our Parish). It was at St. Patrick's Church in Manchester. We, my two daughters - ages 13 & 16 - and I were waiting about 15 min. to go to confession. We go to confession every 2 weeks if possible.

Father Hillery came in and turned on the heater in the Confessional because it was ice cold in there. He stands outside the Confessional till someone wants to go in and Confess. Since the girls get impatient, I went up and asked to go. He asked if I was in a hurry or could I wait till the Confessional warmed up. I said I could wait and did so.

After a few minutes he went in, then I went in and knelt at the screen while he sat on the other side and I made my Confession. As soon as I finished he came around the screen

and asked if I would miss him (because he had to go back to India). I said yes, (because I knew Father Rogers needed all the help he could get). Then he asked if I would write to him. I said yes (because Fr. Kaminsky S.J., who was at our Parish for a while had asked the same thing. He sent Christmas cards and different notes to us on the Rosary).

Father Hillery then gave me some paper and a pen. I wrote down my name and address. He then asked for my phone # and I wrote that down. When I finished he asked me again if I would miss him. (Thinking he was insecure) I said yes. Each time I said no more then just yes.

After that yes he took my hands and rubbed his cheeks on my cheeks. He had done this other times when I went to Confession and also once outside our Sacristy. I had thought it was and Indian custom and did not want to offend him, so I let him do that.

After that, he held me in a bear hug, one arm over my shoulder and on arm under my arm. (This I am accustomed to when my brother-in-laws doing before they leave to go home to New Jersey.) So I hugged him good-bye, then tried to get loose and he wouldn't let me go.

While holding me firm with his right hand he kept pressing me up against himself as I tried to get away. With my hands I

tried to propel myself backward toward the door. (I was not inclined to punch or kick the person of a Priest of God.)

Each time I tried to get away, he would move his left hand up and down the back of my body pressing me harder against him and himself against me. He was also with his face constantly rubbing my face. His cheeks to my cheeks. He also said I was very beautiful (which made me feel sick and bad).

When he tried to kiss my lips I lunged backward as hard as I could, caught the nob of the Confessional door and threw it open. As soon as it opened he dropped both of his hands to his sides and stood there as I ran out as fast as I could.

I was upset but did'nt want to expose the Church in a bad light to my children. I also knew my daughters would be very quick to exit the Confessional because they get embarrassed when the Priest does see them. So I told them to go to Confession but run out as soon as they were done. Both of them did because Fr. Hillery had tried to come out from behind the screen on them before.

I told my Husband when he joined us for Mass. (He is not Catholic but attends Mass with us every week.) He thought it was the cheek brushing bit, so he told me if I was concerned to go tell Fr. Rogers. When we came home I explained it to my Husband in detail. He felt helpless and said to tell Fr.

Rogers. He also told me to stay away from St. Pat's (I go to Mass daily) until Fr. Hillery leaves.

After I made supper, I needed to talk to because it bothered me. That is how came to know of it and here I am.

I beg your pardon Father, for having to present you with this problem. Said you would notify Fr. Hillery's Bishop. I have prayed for Fr. Hillery but now I want to forget about it because when I think of it I have difficulty sleeping and it upsets me very much.

I hope and pray that Fr. Hilary will take my warning seriously and will behave properly in the future.

May I thank your Excellency for having brought this incident to my attention. Once again I am sorry for this unpleasant episode and for the embarassment and anxiety it caused to you and to Kindly inform about my regret for what has happened and I will keep her in my prayers.
