wanted me to go down to Boston to get some help with a psychiatrist down there, who was I think, if I recall correctly he was a teacher at Boston University and he was a Jewish convert and ah he was doing a new thing in interpreting dreams so I went down to see him and ah, ah I just, I could not you know I could not do what he wanted me to do. I could not remember my dreams and so forth so that's.

AF: Go right ahead sir.

LL: That answers your question.

AF: All right. Let me back up here a little bit.

LL: Okay.

AF: Father Egan?

LL: Father Charles Egan.

AF: What was Father Egan's position at the time, sir?

LL: He was the, what they called the provincial. He was in charge of the whole province.

AF: Stignatine Fathers?

LL: Yes. That is correct.

AF: And can you again describe how or what Father Egan told you as to how things had come to light as to your problems, sir?

LL: All he said was that I remember is that there are rumors or allegations, but I don't remember them using the word allegation.

AF: Did he tell you specifically sir what those rumors were?

LL: That, that I was involved with some boys.

AF: Okay.

LL: And that he wanted me to go down to Boston and get some help from this psychiatrist.

AF: I see. Do you remember the psychiatrist name, Mr. Landry?

- LL: I really don't. Right now I don't.
- AF: And this would have been in the timeframe sir of you being assigned to Agawam?
- LL: Yes.
- AF: Okay, which would have been.
- LL: '61, '60, '61, '62 somewhere around there.
- AF: Okay. And you agreed to Father's request?
- LL: No. You had to go by obedience because of the vow of obedience you had to go and I did go, but the first time I went down there I couldn't find the place. What is the big, is it Massachusetts Avenue
- JR: Commonwealth Ave.
- LL: Commonwealth Ave. That doctor was someplace on Commonwealth Avenue and I couldn't find his office the first time. I called him up, come down again another time, but then you know you've got to tell me your dreams.
- AF: Did in fact that happen sir? Did you see this gentleman?
- LL: I saw him maybe three times. I don't, I don't believe four, but you know it, it was driving me crazy.
- AF: Did you during these visits with him um openly tell him about some of the problems or contacts that you had had with minors at that particular time, sir?
- LL: Yes I did. Especially the first one I tried to tell him you know that I had this problem and ah and it was like he was shutting me off when I was telling him this. He would stop me and he wasn't, it was like I felt he wasn't interested in that. He wanted my dreams.
- AF: Did you tell him what your dreams were?
- LL: No I didn't because you know at that particular parish you know at that time you know, Father Ruscetta was my pastor, was a very sick man. He had ah psoriasis very bad and I had for the better part of it I was I had the whole parish to myself and I was working I mean very hard so by the time at night I went to bed. I was crashing too.
- KK: Huh, huh.

AF: Do you recall how, a couple of questions.

LL: Okay.

AF: Do you recall how it ended? What, what made these sessions come to an end, sir?

LL: I couldn't tell him my dreams and I was driving all the way down there and then I would, you know I'd start to talk about something and I fell asleep and he let me sleep for the whole half hour.

AF: Did you relay this to the problems you were having with Father Egan or somebody there?

- LL: No I didn't.
- AF: Okay.
- LL: I don't recall doing that.
- AF: At what point did they, did Father Egan or the Stignatine Fathers find out that you weren't going to this man again?
- LL: Oh, I don't remember. I really don't remember.
- AF: Did anyone in the Stignatines ever follow up with you to make sure that you were going or how you were progressing?
- LL: No.
- AF: Did, to your knowledge did this doctor ever send a report as to his results of your sessions to the Stignatine Fathers?
- LL: I don't know.
- AF: You don't know. Never saw anything like that?
- LL: No sir.
- AF: Did Father Egan or anybody in the Stignatines ever say one word to you after about how you were doing or whether or not you were cleared for a lack of a better term?
- LL: No sir.

- AF: You just went back to your parish?
- LL: Yes.
- RM: Who paid the bill for this guy?
- LL: Stignatine Father, well I think, I think it was a freebee. He was doing it because you know it was an experiment.
- RM: I'd like one.
- KK: Did you sign any kinds of release forms that you remember to share anything that you ah told the doctor in confidence?
- LL: No I do not remember signing anything ever.
- RM: Did you know anybody else whoever went to this guy?
- KK: I was just going to ask that question.
- LL: I you know, I have no knowledge of that. You know I don't know.
- AF: Was this gentleman connected to the Stignatine Fathers or?
- LL: No.
- AF: Do you know how they became to how they came to refer you to him?
- LL: No sir I don't other than the fact that Father Egan said you have to go down. Other than that I know nothing about that man at all.
- AF: Where are the Stignatine Fathers located today? If they were, let me ask you this if there are files and records on you sir today, where would they be?
- LL: 554 Lexington Street, Waltham, Massachusetts.
- AF: Okay.
- RM: That's a little closer than just Commonwealth Avenue. Is this guy um somebody you called a doctor. Was he a doctor somebody?

LL: I understand he was, yes. I understand he was a professional psychiatrist who was teaching and I thought at the time at Boston University and at the time you know that was the new thing about dreams you know.

KK: And interpreting the

LL: Interpreting dreams you know.

- KK: What did you feel that your problem was? When you were searching for some help either through a spiritual guidance ah with the Carmalights or through some other outside psychiatric help, what did you first think that your problem was?
- LL: I, I didn't know you know and that's what I was looking for. You know, you know it's the old cause and effect thing. This is the effect. You know let's try to find the cause. I could never find the cause. You know I was searching. I went to several people you know for help, priests you know as spiritual fathers for this help.
- KK: Did you ever confide totally in your behaviors to one of your um colleagues, one of your priests?
- LL: One of the Stignatine Fathers?
- KK: Yes.
- LL: I, I perhaps I perhaps went to confession to some of one or two of them. I don't know. I think maybe I may have. I just can't remember who right now.
- AF: Did you at the time that you were speaking to Father Egan about these rumors, did you confirm with Father Egan that in fact maybe some of these rumors were true?
- LL: I don't ever recall telling him that it was true. I just remember that he said there were rumors and I want you to get some help, but I don't remember saying to him they were true.
- KK: Did he ever ask you if they were true?
- LL: I don't remember that either.
- RM: Did it appear to you that he believed they were true?
- LL: I do think, I do believe he did, yeah. I do believe he did believe they were true.
- LW: Leo, did Father Egan rise to a higher position within the Catholic church during his career?

- LL: I, I don't I think that's as high as he ever went. He was our superior in Rome. When we first went to Rome he came over with us and for about the first four years he was our superior and then he went back so he knew us pretty well and ah, ah no I don't think that he went any higher than that. I do know while he was in Rome and he was our superior he got his degree in Canon law and then ah he went.
- LW: He never became a Bishop or a Cardinal?
- LL: No, no, no nothing like that.
- KK: My question just disappeared. I'm sorry. I thought it was a good one too. Yeah, it will come back.
- AF: After, I believe we had finished off with South Porcupine, Ontario or was it Virginia?
- RM: Woodbridge, Virginia.
- KK: Yes. I remembered my question. Do you recall whether there were any specific policies with the Order that you were with regarding ah sexual misconduct?
- LL: No.
- KK: You didn't have anything written, was there any kind of verbal communication when you were going through your training about what to do or if you ever found yourself in the situation?
- LL: No. No. There's a big difference between the education in Rome and the education over here. Most of the seminarians over here have a very practical education. We had a very theoretical education. Now theologians we were and that's theory. But you know with regards, but we had to have special courses over there with the Jesuits. We went to the Jesuits like once every two weeks or there was a Father Healey over there. He use to give us a course for Americans only. Just how to hear confessions cause we didn't have the courses over there.
- AF: I see. After Virginia, sir. How long were you in Virginia by the way?

LL: I was only in there I think about 3 or 4 months. It was a big ah brew ha ha over there with the pastor. He was ah, ah what's the word for a dual personality?

KK: Schizophrenic?

- LL: Schizophrenic was the word they were using and just as good I guess and ah you know he was so they took me out of there.
- AF: And I would just ask you to speak up if you would.
- LL: I'm sorry.
- AF: No, that's okay.
- LL: I keep forgetting.
- AF: We all have a tendency to fade off.
- LL: Yes, yes.
- AF: All right, after Virginia where did you go sir? Where were you transferred?
- LL: I'm not sure, but I think I went back, I went to Waltham, Massachusetts to the retreat house just as a place to stay. I don't know if I want to call it an assignment. He wasn't an assignment.
- AF: Nope, that's fine.
- LL: It was just to stay there in preparation cause they were going to send, they were sending me back. I think I went from there to Timmons, Ontario for about a year or so and then after that from Timmons, Ontario I went to Sue St. Marie, Ontario cause they wanted me to teach. I was teaching um in an information center. I was teaching English and Italian and ah I also had the convert course there and ah it was in the information center.
- AF: Was this, was this assignments we've already spoken about or was this a return to Canada?
- LL: It's a return.
- AF: Return to Canada?
- LL: Yes.
- AF: Okay. And you went back to Timmons,
- LL: Ontario.

- AF: How long were you there, sir if you had to approximate?
- LL: About a year I think.
- AF: And what did you do in Timmons, sir?
- LL: I was ah I was with two other priests, the pastor and my classmate Father Charlie Gonet.
- AF: Gonet?
- LL: GONET.
- AF: Okay. What was the pastor's name, sir? Do you remember?
- LL: Ah, I have his face, but I can't get his name.
- AF: Think about it and we'll come back.
- LL: Okay.
- AF: During the time that you were in Timmons, sir, was there other contact with minors? That particular time?
- LL: I can think of one.
- AF: Do you remember the name of the boy sir?
- LL:
- AF: How old would he have been, sir?
- LL: I think about that age, 13, 14 somewhere around there.
- AF: And can you describe what that contact was Mr. Landry?
- LL: Same thing masturbation.
- AF: Masturbation, you on him?
- LL: Yes.
- AF: Any other type of contact?
- LL: No sir.

AF: And how many times would you say that occurred sir?

- LL: Two, three.
- AF: Okay. And this was after Father Egan had heard about some rumors and sent you to the dream guy down in Boston?
- LL: Yes.
- AF: Okay. Did that, during the time you were there sir, were there any formal complaints or allegations brought against you?
- LL: No sir.
- AF: Okay. Do you know of anybody else up there that knew about this contact with this boy?
- LL: No sir.
- AF: Okay.
- KK: Where there any restrictions placed on you when you went to ah any of your assignments after Agawam when you went to Boston?
- LL: No sir. I mean no maam. Sorry.
- KK: I've been called that before.
- AF: Did anybody in the Stignatine Order Fathers ever monitor or follow up with you to see how you were doing with your problem?
- LL: No. No. No they did not.
- AF: Okay.
- KK: Were there any restrictions placed on your returning to any of the communities where you'd had former assignments?
- LL: I don't recall going back to any place where I had a former assignment.
- RM: Were you told not to go?
- LL: No. No. I was just never.

AF: After Timmons, sir where did you go? Sue St. Marie again?

LL: Yes.

AF: Okay.

KK: So that was a second return?

LL: Yes.

KK: If you had been there in the late '50's.

LL: Yep. First one was a parish.

KK: Yes.

LL: And this was an information center.

KK: Okay.

AF: What were your duties there, sir?

LL: That was when I taught that course and ah they're mostly Italians. There were some that were not, but they were mostly, I was mostly teaching English and two Italians.

AF: Did you have any contact with minors there sir, at that particular time?

LL: I have an allegation up there. I don't, but I and they gave me the name of the person and I don't remember that name.

KK: Who gave that name to you?

LL: Ah, what the heck was his name.

RM: You mean this was something you learned about after a lawsuit was filed here in New Hampshire?

LL: Yes.

RM: Okay. A lawsuit that was filed by Mr. Abramson?

LL: No. It was before Abramson. This came up before Abramson and there was ah. The guys name he's in Manchester. Green & Lawyers.

JR: Utter?

LL: Utter, Phil.

RM: Phil Utter.

LL: Phil Utter. Phil Utter.

KK: So it was a lawsuit filed against you

LL: Yeah.

KK: From something that occurred in Sue St. Marie?

Yeah. There were a couple of detectives that came to my house. I taught, I LL: taught a after I retired from high school, I taught a year at St. Elizabeth's Seton Grammar School in Rochester, the 6th, 7th, and 8th graders. I taught them French and there was an accusation of some parent about you know me saying a bad word to her daughter and the daughter wanted to punch her or something like. There was some allegation which wasn't true, but they evidently said something that there was something more to this and something about my background, you know and then there were two detectives that came to my house with this accusation of this thing and in the mean time after they accused me of this school thing, then they brought up the subject of Sue St. Marie, Ontario. There was a guy by the name of I want to say It's a Polish name anyway, something like that who said I molested him and I, I can't remember this name up there at all. I cannot remember. I don't remember you know. I don't remember working with kids up there.

AF: At Sue St. Marie's?

- LL: Yeah. I may have gone to hear, gone to the summer schools or something to first Friday confessions or something like that. I don't remember, you know I didn't have anything to do with you know I didn't have anything to do with kids, but there was an allegation up there of that and they, they just dropped it.
- AF: I'm sorry.
- RM: The um the allegation was brought forward by Phil Utter?
- LL: No, I, I went to there's an attorney a kind of a business lawyer in Rochester by the name of Dick Bois, I think.
- RM: Stop. We have to go off of tape.

- AF: We're going to stop the tape right now. Attorney McDaniel has asked to go off of the tape. It's ah 2:26 p.m. Okay, we're back on tape. It is 2:28 p.m. Investigator Anthony Fowler, same people are present. We're continuing the interview with Leo Landry. We had stopped the tape for a Attorney McDaniel wanted to confer privately with Mr. Landry. At this point we're going to continue with the interview. Again, Mr. Landry, do you mind if we continue audio taping this interview?
- LL: No, go right ahead.
- AF: All right. So why don't you tell us about you were talking about Attorney Bois.
- LL: Yeah.
- AF: And, and some allegation that was brought against you.
- LL: I, as I said I was teaching at the Catholic School and I had, I had Dick Bois' son as in my homeroom.
- AF: Where was this, sir?
- LL: At ah St. Elizabeth's Seton School in Rochester.
- AF: Okay. This was after.
- LL: After I had retired. This was at least 4 years ago. Yeah, 4 years ago.
- AF: All right.
- LL: And ah, I didn't know who to go to you know because these detectives came and asked me some questions so I called Dick Bois and he says I have, he says I have an excellent lawyer that you should go to and that is Phil Utter and so I called Phil Utter and I told him that Dick Bois recommended him and I would like to come and see him and I did so I went down to see him and I told him about what the accusations was and he took care of the case.
- AF: What do you mean took care of it, sir?
- LL: Ah,
- AF: Represented you?
- LL: Yes. Yes.

- AF: What happened to that case?
- LL: Well I as far as I know they ah they told Canada that I you know that they weren't going to send me up there because they felt that there wasn't anything that they, there was no evidence because I answered all his questions and you know I couldn't I didn't even know the guy so that went on for about a year. Afterwards, after about a year or so I got a civil suit at my door.
- AF: Filed by the same.
- LL: Guy, wanting some money. You know a civil suit and I so I went again to Dick Bois and you know I said you know I don't have any money, you know. I don't have any money.
- AF: And what happened with that, sir?
- LL: I, I don't know. All I know is that I was, got a letter or told from Phil Utter it was resolved up there and that the case was placed in a file.
- KK: Up there meaning?
- LL: In Sue St. Marie.
- KK: Okay. All right.
- RM: Up there, Sue St. Marie, Ontario or Sue St. Marie, Michigan?
- LL: Sue St. Marie, Ontario.
- AF: I think I asked you this, but during the second time that you were at Sue St. Marie's do you recall having any sexual contact with minors at that time?
- LL: No, I do not.
- AF: And how long were you at Sue St. Marie that time?
- LL: I was only there just a very short while. I can remember being there in the winter and then after that in the summer. Father Egan came up and I told him I was leaving the Stignatine Fathers.
- AF: Okay. Why did Father Egan come up sir?
- LL: Well he, he that was an ordinary visit.
- AF: Ordinary visit?

- LL: Yeah.
- AF: And at some particular point you had made a decision that you were leaving the Stignatine Fathers?
- LL: Yes.
- AF: And what was Father Egan's?
- LL: Well he didn't want me to leave.
- AF: Did he ever mention to you after that meeting you had with him about the rumors? Did he ever bring up your problem to you again, sir?
- LL: No he did not.
- AF: And at that, based upon you telling Father Egan that you were leaving the Stignatine Fathers ah can you tell us where you ended up after that, sir?
- LL: I, I went to Springfield, Massachusetts, just as a place to stay and then I found and then I got invited to come to this Diocese.
- AF: Manchester Diocese?
- LL: Manchester Diocese, yes.
- AF: Who invited you to the Manchester Diocese?
- LL: Well at the time the Bishop Primeau said he would take me on.
- AF: And this was in 1960?
- LL: Five. Has to be '65, the summer of '65.
- AF: How did you get notified that Bishop Primeau was willing to ah have you come to the Diocese of Manchester, sir?
- LL: I think I was sent a letter saying that I was invited to come to the Diocese.
- JR: How did they know that you were available?
- LL: I had to write a letter to them.
- JR: Oh, okay.

- LL: I first wrote a letter to them asking to come to the, come into the Diocese and it's either, either Father Egan told me that he had received and I could go or I got a letter from them personally.
- JR: Why did you apply? Why did you write that letter?
- LL: I, I really wanted to get away from the Stignatine Fathers.
- AF: Why did you chose the Diocese of Manchester in particular, sir?
- LL: You know other than the fact that it's my home Diocese I guess.
- AF: Okay.
- KK: Did they do any kind of background checking on you before you were invited to the Diocese?
- LL: Not with me personally, they didn't. If they asked the superiors I don't know. I have no idea about that at all.
- KK: Were there any kind of requirements placed on you as far as joining the Diocese? Did you have to have a recommendation or any kind of paperwork like that to join the Diocese?
- LL: No. No, all I did was write a letter asking and then I think they have to notify the Stignatine Fathers that they have a request and that they will accept the request. Now either they notify me, could be both.
- AF: Did any representatives of the Diocese at the time ever talk to you about any of the rumors or the problems that you may have had in years gone by or did anybody from the Stignatine Fathers to your knowledge mention to the Diocese of Manchester, to your knowledge that there had been a problem?
- LL: No.
- AF: No?
- LL: They did not. They did not. I was When I I was never, that subject never even came up. I was just accepted and I came into this Diocese.
- KK: Do you know whether it could have been discussed without your knowledge?
- LL: If it had I would probably would not have been accepted.

- KK: Why do you say that?
- LL: I just have that feeling you know that they, they would not have accepted me if they had known I had that problem.
- KK: You talked a little bit about the letters and correspondence. Did you keep any of that?
- LL: No. I don't have any of that.
- JR: Did you ever interview with anyone from the Diocese of Manchester about the possibility of your making the transfer to New Hampshire?
- LL: No.
- AF: Did anybody ask you to take a psychological evaluation prior to being accepted by the Diocese?
- LL: No.
- AF: Okay.
- KK: How long of a period of time did this process take? This invitation and acceptance process?
- LL: Two or three weeks and that's it didn't take long. You know by the time I got, I said I'm not coming back here. I don't want to do this type of work I was sent to Springfield and within just a few weeks I was in New Hampshire.
- AF: What was your first assignment in New Hampshire, sir?
- LL: Lincoln, New Hampshire.
- AF: And
- LL: Father Edmond Guay.
- AF: Okay. Would this have been in '65, sir?
- LL: Yes. The summer of '65.
- AF: The summer of '65.
- LL: Pretty sure.

- AF: Okay. And Guay for the record will be G U A Y.
- LL: That is correct, yes.
- AF: Okay. Um, what were your duties, sir?
- LL: Well Father Guay wanted to go, the reason why I was sent up there was because Father Guay wanted to go to Florida for a month and I was taking over the parish. What was the name of the parish, sir? Do you remember?
- LL: No, I don't remember.
- AF: Okay. During the time that you were there, Mr. Landry, did you have any inappropriate contacts or contact with minors?
- LL: No I did not.
- AF: And how long were you there?
- LL: I could have been there two months.
- AF: Okay. Up to this point sir, had you had any prior contact with any of the boys that you had sexual contact with?
- LL: No sir.
- AF: Okay. After the Lincoln assignment, Mr. Landry where were you sent after that?
- LL: I was sent to Laconia.
- AF: Laconia?
- LL: Yes.
- AF: And what were your duties there, sir?
- LL: I took the place of Father Bill Quirk because Father Bill Quirk had to under go an operation and I was there from fall until December, January, somewhere around there.
- AF: Fall of '65 to December, January '66?
- LL: Correct.

- AF: Okay. And during the time that you were there, sir, was there any inappropriate sexual contact with minors in Laconia?
- LL: No sir.
- AF: Okay. After Laconia, where were you?
- LL: Somersworth.
- AF: Somersworth?
- LL: Yes.
- AF: In a parish?
- LL: Parish with Father Leo Ryan. R Y A N.
- AF: And that was in the winter of '66? Does that sound correct?
- LL: Yes. Yes.
- AF: And what were your duties there?
- LL: Regular parish priest.
- AF: Okay. Um, during the time that you were in. Well let me ask you this. How long were you assigned to Somersworth, sir?
- LL: I think, I think I was told by the Diocese that you know after these allegations came out in the paper that ah I think I was there 8, 9 months. Not more than that.
- AF: All right. During your time in Somerworth, sir, did you have inappropriate sexual contact with minors there?
- LL: Yes sir.
- AF: Okay. Can you tell me approximately how many, sir?
- LL: I know of one person
- AF: Okay. And how old would have been, sir at the time?
- LL: 13, 14.

- AF: All right. Do you recall the names of any other lads?
- LL: Can I speak with him outside for just a second, please?
- AF: Sure. We're going off tape again. It's 2:40 p.m. Mr. Landry has asked to confer with his attorney, Mr. McDaniel. Okay, we're back on tape after a brief recess I guess for a lack of a better term. It's 2:41 p.m. Mr. Landry do you mind if we continue audio taping this interview?
- LL: Please do.
- AF: Same people are present. All right. Let's ah, let me ask my question again. Do you recall the names of other boys that you may have had contact with in Somersworth?
- LL: Yes.
- AF: Could you tell me who you recall?
- LL:
- AF: And how old would ve been?
- LL: 13, 14.
- AF: Okay. Do you recall a name of any other boys? How many boys would you estimate, sir? I think I asked you that, but I don't remember.
- LL: No you didn't ask that.

AF: Okay.

- LL: I can't think of any more than those two.
- AF: Does the name and I'll ask you this, the name mean anything to you?
- LL: No it doesn't. I do not know him.
- RM: It does. You've heard that name before Leo.
- LL: Oh, I'm sorry. I thought you meant, okay.
- AF: How do you know that name?

- LL: I know that name from the newspapers.
- AF: In what, in what, how do you know that name from the newspapers?
- LL: Because he was searching for some, he said that he had been touched by somebody in Somersworth, but he didn't know who and that at least three or four occasions in a one month period, a month and a half period he was searching for somebody.
- KK: How do you know that information?
- LL: That he was searching for somebody? Because the papers said so.
- KK: Okay.
- AF: Do you recall or did you have any inappropriate sexual contact with a
- LL: No I did not.
- AF: Somersworth, New Hampshire.
- LL: No sir.

RM: Do you know somebody named Somersworth?

- LL: No I do not.
- AF: During the time that this was occurring in Somersworth, sir, where did most of this activity take place?
- LL: Ah, my car. I remember one night came to the Rectory.
- AF:
- LL:
- AF: Okay.
- KK: He came to the Rectory?
- LL: Yes.
- KK: In the Rectory where, can you be more specific about where the contact occurred?

- LL: Yeah, it was in the living room.
- KK: You're private quarters?
- LL: No.
- KK: Or in a public area?
- LL: Regular downstairs living room.
- KK: All right.
- AF: What was the contact that you had with these boys in Somersworth, sir?
- LL: Masturbation.
- AF: Can you again would it be you masturbating them?
- LL: No, with masturbated me as well.
- AF: He did?
- LL: Yes he did.
- AF: Okay. Ah, was there any other contact, such as any type of penetration that would have occurred?
- LL: No, no sir there was not.
- AF: Okay. And these boys under what circumstances or how did it lead up to this, this touching occurring was it again done through classes then or was it through confession or how did this come about?
- LL: No. It had to be through classes like you know priests visiting the class room you know talking about different things and the sin and so forth.
- AF: Did you ever tell the boys it was a sin to masturbate, sir?
- LL: Yes.
- AF: Okay. Go ahead, I'm sorry to interrupt.
- LL: No, that's fine.

- AF: You're explaining the circumstances of how
- LL: Just through classes.
- AF: Just through classes.
- LL: Yeah.

After reviewing DET. BLONIGAN'S report contacted the ROCHESTER POLICE DEPT. RECORDS DIVISION and spoke to ROBERTA-335-7536. Requested all police reports relative to complaints filed against LEO LANDRY, and in particular, reports of inappropriate contact with minors. ROBERTA stated if the reports were very old, specifically in the 70's, they had been purged. She did find a complaint against LANDRY in 1998, which appeared to be a sexual assault complaint. She will be sending those reports to us. She also related that complaint was referred to STRAFFORD COUNTY and I should speak to TOM HARTT 749-2808. ROBERTA could not find any other complaint, such as a complaint that initiated while LANDRY was a teacher in their town.

Called TOM HARTT and he stated that he would look for any records they have on LANDRY and the referral. He recalled that this incident might have been a complaint from Canada, which they followed up on for Canada. It does not appear that LANDRY was prosecuted for this complaint (possibly from Canada) in 1998. HARTT called me back and indicated he could not find any card on file in their office for LANDRY, and this case may have been referred back to the ROCHESTER PD without prosecution. They are checking their archives for any records. He again stated this may have been a follow-up for Canada.
