I met with to review his account and to make an attempt at a one party intercept. We met at attorney's office (Robert Upton of Concord). I reviews my report with and the following was added or corrected.

Page 1:

states he was speaking with his mother on the Friday after the indictment was handed down. She told him of this and he disclosed to her that he had similar experiences. He did not give his mother any specifics of the sexual abuse. His mother gave him my name and said he should decide whether or not to contact me and to cooperate with this investigation. After some thought decided that he would contact me and assist.

older brother presently lives in South Dakota and is out of the military.

Page 2:

can not recall the vehicle used by Father Macrae at the time. He does recall this vehicle being different than the one Macrae had when he first came to Keene in 1983.

is listed as 15 years old in the first half of 1982. He would actually be only 14 years old. The incident described (1st half of 1982) occurred on a stretch of Route #101 near the Rocky Brook Motel (Keene).

described MacRae's first floor office has located on the Main Street side and closest to the church (SE corner of the building).

I asked if he could recall the subject discussed that resulted in him becoming emotional during the counseling session. He said this was about his drinking and relationship with his mother. He said Macrae told him how he could take care of this and patch things up between im and his mother.

Page 3:

Macrae would usually lock the door of the office when he was punseling

states he was coerced into counseling sessions by his mother who wanted him to go. He went to appease her and to help with their relationship. States nothing constructive was ever offered by Macrae. Macrae would offer his help in getting him back together with his mother, saying that mother would listen to him.

also said that Macrae would come and hug him during these counseling sessions. This allowed Macrae to press his erect penis (clothed) against him.

When was 15 years old and sleeping in the rectory Macrae would engage him in sex as outlined in the report. In addition Macrae would hold buttocks as he performed fellatio on him. does not recall any digital/anal penetration or attempts.

states that the situation were other quests were on the third floor was unusual.

Page 4:

states that during these counseling sessions in 1984 that Macrae also performed fellatio on him between 4 and 5 times. estimated that fellatio occurred 80 per cent of the times he saw Macrae in a counseling setting.

The August 2/3/4 dates in 1986 are from memory. What is sure of is that he spent two successive nights at the rectory before admittance into Derby Lodge. He said that Macrae told him that he had to be clean of drugs and alcohol for 72 hours prior to entering the facility.

states their was a counselor with the first name of Debbie who worked at Derby Lodge who was also a friend to Macrae. told Debbie some information about his sexual contact with Macrae when younger. Macrae later confronted him saying that Debbie had told him about their conversation and threatened him about ever talking about it again and that no one would believe him. Macrae told that if he continued to want his help that he should not tell others.

Page 5:

These roommates were identified as formula of Quincy, Massachusetts and (unknown last name now deceased via suicide in Gardner, Massachusetts). Delieves that formula came in contact with Gordon when he visited. It is the roommate who returned to Massachusetts and thus made the apartment unaffordable to the others.

described the size of the metal briefcase. This would be large han a briefcase and consistent with the size of cases used to house and transport video cameras. States their were three loose video tapes and one in the camera for a total of four. Played one of the loose tapes. He did not play the others.

Page 6:

The blue gym bag belonged to Father Macrae.

states his mother was not home when he stowed the gym bag. He believes hi sister who lives in Swanzey was home at the time. also said he did not hide the bag, but just placed it in the laundry section of the home for safekeeping.

The confrontation with Macrae occurred in the late afternoon. He later stayed in Maine for about 5/6 months before going to California. He did not learn of MacRae's arrest until having contact recently with authorities.

Page 7:

states the counting room at the church was in the basement of the rectory. Their was a counting table and safe in this basement area. He was with Macrae a number of times when he took cash from this source and gave him the money. No check or note was left.

I had faxed the attached document to the Attorney General's office requesting a one party intercept between and the suspect. I spoke with Cindy White at 1415HRS and gave her additional information. She then authorized an attempt to take place between 1420HRS and 1700HRS (04-01-93).

We made an attempt to reach Macrae at (505) 829-3586 EXT 28. Spoke with a women who he identified himself to. He asked to speak with Father Macrae and was told that he no longer worked there. She said she had a number for him. She said she was replacing another lady who usually works there. She then said that Macrae has a desk there that is locked but she would attempt to get into it and get him a number. She then came back on the telephone and gave him this number, 1 800 484-9675 EXT 2007.

attempted this number and received an answering machine that said that the number was busy and to leave a message after another message in Spanish. I tried the same number the following day and got another message to leave a message, this time a different message than that received the day prior.

BL: This is an audio taped statement taking place at the Attorney General's Office in Concord. The date is the 24th of October 2002. The time is 10:22 a.m. This is Detective Brooke Lemoine. Also in the interview conference room is Sgt. Brenda Blonigen and we're conducting the interview, statement of Jeanette Gagnon. Jeanette, could you spell your last name for me please.

JG: GAGNON.

And could you please tell me where you live please, ma'am? BL:

JG: I currently live in New Hampshire.

Okay. Could you give me your address? BL:

JG:

BL: And could I have your date of birth, please, ma'am?

JG:

Okay. I know we've been speaking with you for several minutes and we are, we BL: received some information from you and we also told you that we are conducting an investigation relative to the Diocese of Manchester. Is that correct?

Yes it's correct. _ JG:

BL: And ah we've been sharing some information ah specifically ah with you regarding ah a case involving a Gordon Macrae, correct?

- JG: Correct.
- BL: Whose Gordon Macrae to you?
- JG: Gordon Macrae was um a priest of the Catholic church. He was assigned to the church, St. Bernard's, in Keene, New Hampshire.
- BL: Okay. And ah just I want you to, to go back to either the early 1980's. What was your position in ah the early '80's? Where were you employed?
- JG: I was employed in the Division of Welfare. I was the Administrator of the Office of Child and Family Services.
- BL: Okay. When did you first start with the Division of Welfare?
- JG: I started with the Division of Welfare in July, 1964.
- BL: Okay. And I understand that you are now retired from the Division of Welfare?
- JG: I'm retired from. I retired from the Division of Elderly & Adult Services. After the children services we were separated from the um the Adult Services were separated from the children services. I became the Administrator in the Elderly Service Division.
- BL: Okay. And I think you explained that you retired in 1999.
- JG: I did.
- BL: Okay. And ah when you were speaking about your career with the Division of Welfare, that became DCYF correct?
- JG: That's correct.
- BL: Um, you were a social worker, a supervisor and ah finally Chief Administrator?
- JG: Chief, Chief Administrator, yes.
- BL: Okay. And where were you primarily headquartered ah Jeanette?
- JG: Well in the earlier days when I began my work I was headquartered in Manchester and then when I became ah Chief of the Bureau Child & Family Services I was assigned to ah the Concord State Office.

BL: Okay. Now, ah turning your attention to um 1983. I believe it's the month of November, um did you receive some information relative to ah Father Gordon Macrae, a priest that you'd mentioned. Did you receive any information?

JG: I received the information ah that had originally been made known to the ah Welfare Director, Richard Chevifields at that time.

BL: Okay, Richard Chevifields. Whose he?

JG: He was the Director of ah the Division of Welfare.

BL: Okay.

JG: In '83.

BL: He would have been your boss?

JG: My boss.

BL: Okay.

JG: He was my boss.

BL: And who would have been his boss?

JG: His boss at that time was Sylvia Dupre.

BL: Okay. She would, she was the Commissioner, okay.

JG: Commissioner.


BL: She received some information um from your boss Mr. Cheversfield. What did you receive for information that you can recall back then?


JG: Ah, there was a report of an alleged, suspected child sexual abuse um on a then teenager. I think he was 15 years old,

BL: Okay.

JG: Who was um, who was living with Reverend Gordon Macrae in Hampton, New Hampshire

BL: Yeah.





- JG: At times the supervisors in the district office would be assigning the investigation, but this was an unusual situation.
- BL: Distracted from the norm?
- JG: It did distract from the norm and I, my understanding of it and I accepted it is was because we were dealing with someone and the alleged perpetrator who was a Catholic priest.
- BL: Okay. Um, I think you had mentioned earlier that ah, ah Mr. Dupre had somewhat of a closer relationship with Catholic Charities and ah was very familiar with their operation and so forth. Can you maybe give me some insight as to what you believe to be the relationship that Mr. Dupre has with the Catholic Charities?
- JG: Well I think that um, Dr Dupre and the Commissioner was very involved in, in ah manners of the Catholic church. Um, and that his relationship ah with people within the system, with the Bishop and with the administrative staff of Catholic Charities was close. They had worked together on a number of ah programs directed by the Catholic church.
- BL: Do you recall if Mr. Dupre told you anything relative to how this investigation was going to be conducted?
- JG: Um, no he didn't tell me, but I told him that ah that I was very committed to the law and rules that we operated in and that this report and any report would be conducted as every other one.
- BL: Okay.
- JG: Ah, and that there was to be no special considerations because that was important had to be done as it would with any other ah report.
- BL: Okay. Did um Commissioner Dupre ask for any special considerations or did anyone that you had contact with at the Diocese have, ask you or insinuate that some special consideration would be made to them on this matter?
- JG: No, I don't think anyone was direct, but you know I just felt that they ah expected that ah, that um they would be um granted some consideration because it was important that they be um seen being as cooperating with this investigation, wanting to get to the bottom of this and that it involved a Catholic priest and they were not really looking for, for any publicity and they would have wanted this to be something um that they would be involved in and that they could handle it and it would be quiet.

- BL: Okay. That information that you said about it being quiet and having the appearance of, of doing a proper conducted investigation, getting to the bottom of it, was that something that was communicated to you by ah Father Quinn?
- JG: Yeah, I remember Father Quinn mentioning that um you know very specifically that I would understand that this was a very serious matter and that it could um, perhaps people wouldn't understand.
- BL: Okay.
- JG: Um, but again I think, I recall having a conversation back and forth with him, but he had to understand that we were very committed to the law and to the rules that we had relative to any investigations.
- BL: Okay.
- JG: And that again the focus was on the alleged victim and ah so you know he would, we would expect your cooperation.
- BL: Okay. I just want to get a flavor of this conversation. I think you had mentioned earlier when we were discussing the meeting with Quinn and Dupre over this that you felt that you had to get ah very forward kirt almost with them, um with Father Quinn regarding this allegation, abuse. Maybe you can give me a little bit more information as to how you felt, that you had to be very forward them about ah the allegations here and how they were going to be handled.
- JG: Well not that it was something that was explicit that they came right out and told me what they wanted some very special consideration as they moved through the investigation because, because of the status of those people involved. Ah, and that this could be um a um difficult time if this became known that they had these, this priest was um allegedly molesting children and that over time and if and ah if they had known and had first not made a report according to the law or they hadn't done anything about it it would be difficult for them and embarrassing.
- BL: Okay.
- JG: But I must say that they seems to me as I recall they understood that there was a law and there was a process and the had to cooperate and that the focus was again on the child who was then originally molested and after some discussion there seemed to be some understanding about it.
- BL: Okay. Um, did ah Father Quinn tell you anything about ah what the Diocese was going to be doing with ah Father Macrae now that these allegations have come to life?

JG: If I recall there's some degree that they had made, they made statements that they would, would um would be getting the appropriate counseling and for Father Macrae and um that they were confident that um they could, that he would understand that, that that was not to be tolerated.

BL: Okay.

JG: To remain a priest.

BL: But I know that ah when you're telling me this information I can see you looking down at ah a report that we showed you that um, that you authored and signed dated 27 December 1983, is that correct?

JG: That's correct.

BL: Okay. And this report was authored by you?

JG: It was authored by me.

BL: Okay. And you recall the ah circumstances that ah I know we went through the ah report line by line um and that this particular child abuse ah investigation resulted in a founded abuse ah situation. Is that correct?

JG: That's correct.

BL: Okay. And um ah is it my understanding that in your report you indicated Reverend Macrae has admitted the incident to his superiors. You wrote there on that line, correct?

JG: Yes I did.

BL: Okay. Um, did Monsignor Quinn tell you that Macrae admitted to this incident?

JG: I don't recall that he directly um, um told me that. Um.

BL: Okay.

JG: Look at my notes here, but um it would be, it would be consistent with other um, um Father

BL: Macrae?

JG: No. Quinn.

BL: Quinn.

JG: Assurance that they would, they would ah

BL: Okay.

JG: Would not impede with standing in the way of this investigation.

BL: Ah, did you have the occasion to interview Father Macrae? No?

JG: No.

BL: Okay. Is that something that in a normal investigation ah such as this that the perpetrator would be interviewed by a worker?

JG: Yes.

BL: Okay. So by you not interviewing ah Reverend Macrae was that sort of a detraction from the norm?

JG: Yes it would have been a detraction from the norm.

BL: Um, I'm just speculating and maybe you can clear this up. Is it, is it possible that Reverend Macrae was not interviewed by you because you were told that he already admitted to it and that there was no reason to interview him?

JG: That sounds reasonable.

BL: Okay. Um, were you given any information relative to ah Reverend Macrae ah seeking any psychological help or assistance um because of ah this admitted child abuse?

JG: Yes.

BL: Okay. What were you told?

JG: Um, that he had agreed to counseling and he was involved in counseling and that it was successful.

BL: Okay. They told you that he was in counseling and that ah they were confident that the counseling was successful?

JG: Yes.

BL: And I think you admitted, you indicated in your report that ah Reverend Macrae is currently in active regular therapy with a Dr. Henry Geurton Ouellette. They feel

very confident ah or Dr. Ouellette feels very confident that therapy is positive, that Reverend Macrae is now self-controlled enough to give some meaningful assurance that he is not likely to engage in deviant behavior.

- JG: That's correct. That is part of my report.
- BL: Okay. Did you have ah a conversation with Dr. Ouellette at all?
- JG: No.
- BL: Okay. Um
- JG: Would that have been information that ah possibly came from Monsignor Quinn also?
- BB: Yes.
- JG: Most likely because they, they have selected the particular therapist and so the information would have gone to them.
- BL: Okay, it's a therapist that they indicated that they use?
- JG: I'm not sure. I don't remember that detail. Most likely. Most likely.
- BL: Okay.
- JG: They had other agencies to have a counselor
- BL: Do you have any um, do you have any independent knowledge of this particular therapist?
- JG: No, I had never, I have never met nor had I discussed this particular case with the therapist.
- BL: So is it probably that ah your recollection that, that the name Henry Gurdon Ouellette would have been supplied to you by the Diocese.
- JG: Yes he is.
- BL: Okay. Okay. And ah you submitted this report and um ah was there any further follow-up with ah the Diocese relative to this matter after you filed your report on the 27th of December 1983?
 - JG: December, yes on January 26th um, 1984, I sent a letter to Father Quinn.
 - BL: Okay.

JG: At the request of social services.

BL: Okay. Um, I just wanted to back up one second. Um, I'm just looking for the reports from the County Attorney's Office that we showed you. After the ah, the ah, I just want to back up a little bit, excuse me. Um, after you completed your report ah um as far as the Macrae sexual assault on as a matter of protocol did you have any contact with the ah Cheshire County Attorney's Office in regards to that ah report?

JG: Yes.

BL: Okay.

JG: Um, I um called the ah, I called the County Attorney.

BL: Okay. Is that something that ah is protocol? That once you complete a report and that is certainly founded that you would have to have contact with law enforcement ah specifically the County Attorney's Office? Is that normal protocol?

JG: In some, in some situations. Obviously founded is important to do so in the particular case.

BL: Okay. And ah judging by this letter I showed you dated January 13, 1984, ah it appears you had contact with a man with the name of Edward J. O'Brien. Does that ring a bell with you at all?

JG: Um, I recall that he was a County Attorney. I don't recall the details of the conversation with him, but it is clear that um I um advised someone that I had called to discuss um, um his letter.

BL: Okay. Ah, when we showed you this letter, do you recognize um the name, Edward O'Brien?

JG: I recognize the name.

BL: Okay.

JG: As a County Attorney.

EBL: Okay. That would have been someone you would have, recalled that you had ah spoken with?

- JG: I, I could have spoken with him. Ah, recall, I don't recall the direct conversation, but um we were trying to work closely with the County Attorneys and I think in this particular, it would have been um, part of the procedure to contact him.
- BL: Ah, and he indicates ah is Cheshire County I'm not very good with the counties in the state. Ah, is Cheshire County the County in which ah this incident involving occurred in?
- JG: No.
- BL: Okay. Ah, I believe that it occurred in another county.
- BB: Is it unusual Jeannette for a county attorney. I mean Cheshire County is where Keene is located and that's where Gordon Macrae had been transferred.
- JG: Right.
- BB: Is it unusual for the County Attorney in the county that the perpetrator is in to respond as opposed to the county attorney in the county where the incident occurred?
- JG: Well, it would be unusual, but not you know cant recall circumstances whether or not there were conversations with the two or one of the county attorney was um.
- BL: This, this man would have been your local contact because of where you are at. Is that the way I understand it?
- JG: No, he ah he would not have been, we were in Concord. I just don't recall the details of how um the reason why I contacted him at that time.
- BB: Do you think it's a possibility because that's where Macrae was actually, physically living?
- JG: That would have been the reason that was the reason I would have contacted him because that's where Reverend Macrae was stationed at that time.

On the above listed date and time, listed investigators responded to the New Hampshire State Prison 281 North State Street Concord, New Hampshire and made contact with CLAYTON LEGAULT Investigator with the Department of Corrections. The purpose of our contact with Investigator LEGAULT was to set up an interview with GORDON MACRAE date of birth 9 April 1953 who is currently incarcerated at the prison serving a multi year sentence for sexual assault. Investigator LEGAULT made contact with MACRAE who agreed to be interviewed by investigators at the prison facility. A private office was used for the interview that began at approximately 1030hrs. The interview was also recorded in its entirety.

Listed investigators covered with MACRAE his career as a Priest starting at pre ordination in seminary training to include a 1978 Psychological report. Investigators questioned MACRAE regarding his assignments after he was ordained to include assignments while on "sick leave" or "leave of absence" from the Diocese of Manchester later in his career. MACRAE also spoke in a general sense about his psychological treatment received by Dr Henry Geurtin- Ouellette while a practicing Priest. It should be noted that MACRAE spoke freely about certain persons he had allegedly abused, however maintains that he is not guilty of these crimes that he is convicted. Investigators covered with MACRAE his specific contact with the hierarchy of the Diocese of Manchester concerning these abuse allegations when they surfaced, and what actions his Diocese took when these allegations became known.

At the conclusion of the two-hour interview, GORDON MACRAE was thanked for his time and contact ended. Cite transcribed statements (two audio cassettes for details)

She said that, to her recollection,

DIOCESE OF MANCHESTER STATEMENT MAY 6, 1993

Gordon MacRae has been prohibited from serving as a priest in the Diocese of Manchester since July of 1988. This was the time at which the Diocese first became aware of his sexual misconduct. At the recommendation of the Probation Department of the State of New Hampshire, he began inpatient treatment in March of 1989 at a New Mexico facility specializing in the treatment of sexually addictive behavior. The Diocese grieves with those people who might have been victims prior to the discovery of his problem, and will assist them in whatever way is appropriate.

It is clear that Gordon MacRae can never again function as a priest.

DIOCESE OF MANCHESTER STATEMENT, MAY 7, 1993

It was only in July of 1988 that it was definitively and indisputably clear that Gordon MacRae had a sexual problem. The 1983 Hampton incident by itself could not lead to such a conclusion.

In order to clarify, the sequence of events took place as follows:

- 1. The Diocese of Manchester wants to make clear that Father Gordon MacRae was transferred from Hampton to Keene in June of 1983, several months prior to the diocese becoming aware of the allegations of impropriety in Hampton. He was not transferred as a result of any allegations.
- 2. Several months after the transfer, a young man's counselor became aware of a hugging and kissing incident in Hampton, involving Gordon MacRae and the young man. The counselor immediately reported to the diocese, and the diocese reported in turn to the State of New Hampshire.
- 3. That report was made to the state because of diocesan concern, and to be in full compliance with state statutes, even though the nature of the incident was questionably reportable.
- 4. Father MacRae was already in counseling, of his own choosing, for personal reasons. The diocese reported this questionable incident, whatever its significance, to his counselor, so that it could be addressed in counseling.
- 5. The State of New Hampshire investigation did not result in any charges being placed against MacRae, nor did the State advise the diocese to take any further action with regards to this incident.
- 6. As a result, the diocese concluded that everything appropriate had been done in this situation, and that there was no reason to conclude that MacRae had a serious problem.
- 7. Subsequently, in 1988, when it became clear that he did have a problem, the diocese acted decisively and suspended him.

It is always tempting in retrospect and hindsight to judge what should have been done at the time. But for the reasons already stated, the diocese, in 1983, simply did not have sufficient information to judge that there was a serious problem.



Report of the Incident

On November 23, 1983, Division of Welfare Director Richard Chevrefils received a report of suspected child sexual abuse of fifteen-year-old The alleged perpetrator was Rev. Gordon MacRae previously of Hampton, N.H. now of Keene, N.H.

Director Chevrefils assigned the investigation and report to law enforcement official to Jeannette Gagnon, Administrator of the Office of Social Services, N.H. Division of Welfare.

Incident of Sexual Abuse

The incident/act occurred in the early summer, 1983. Rev. MacRae allegedly had sitting on his lap and was kissing the adolescent.

The incident of abuse was made known to the child's counselor Judy Patterson of Catholic Social Services during a counselling session. The child had been referred for counselling by Rev. MacRae for matters other then the alleged incident of sexual abuse.

Founded Abuse: Rev. MacRae has admitted the incident to his superiors.

Victim/Family: Mr. and Mrs. are aware of the incident and that the report has been made to the Division.

The victim is currently an in-patient at Hampstead Hospital in New Hampshire.

The adolescent's parents are also involved in therapy related to a number of difficult problems.

NOTE: For therapeutic purposes, the child's therapist feels he is vulnerable and requests that no information be shared with or discussed with the child regarding the referral of Rev. MacRae to the Division of Welfare.

Treatment/Outcome: Rev. MacRae is currently in active, regular therapy with . Henry Guertin-Ouellette. Dr. Ouellette feels very confident that therapy is positive and that Rev. MacRae is now self-controlled enough to give some meaningful assurance that he is not likely to engage in deviant behavior.

Rev. MacRae is aware of the report to the Division of Welfare.

Report to Legal Authority: This report is made in accordance with RSA 169-6:38. The Division's Administrator, Jeannette Gagnon and the reporter of the sexual abuse Father John Quinn of Catholic Social Services, Inc., are available to discuss this matter.

Dear Mr. Delker:

On October 25, 2002 I was interviewed at the NH State Prison by Sgt. Brenda Blonigen and Det. Brooke Lemoine representing your task force investigation of the Diocese of Manchester. The two investigators told me that if I was interested in contacting you directly I should feel free to do so.

During the course of the interview, I became aware that the AG's office, and/or the Task Force, is in possession of multiple documents that I have produced since my conviction in 1994. Det. Lemoine told me that the AG's office did not copy any of my post-conviction case file when the Task Force obtained files at the diocesan offices. I did not consider this to be truthful, however, due to the investigators' questions and references regarding information that I know exists in only one place: a post-conviction case history that I prepared.

I told your investigators that officials of the diocese asked me to send them copies of some of the documents. I accumulated in my defense before and after my trial. Det. Lemoine asked me why this request was made, but I was unclear in my response. Last March I initiated a telephone conversation with Father Edward Arsenault in which I pointed out to him that one of the persons who accused me in 1993 also accused another priest, but this was never investigated. I then offered to make some of the documentation I have accumulated available to Father Arsenault. My attorney sent it to him at my request in early May, and your office obtained it when you acquired documents from the Diocese at some point after that.

At any rate, since it seems that your office already has much of the post-conviction documentation I have produced, I have decided to send you two pages of information that I am certain you have not seen. Page one contains excerpts from police reports produced by Keene Police Detective James McLaughlin during interviews with in August of 1992 and December of 1993.

Please note the multiple and clear accusations involving Rev. Stephen Scruton. Scruton's name was later dropped and never mentioned again in subsequent interviews and police reports because there was a math problem. date of birth is Even though I knew the family since 1979, I was never assigned to Keene, nor had access to St. Bernard Rectory, until I was assigned there in June of 1983 when was fourteen years of age. Stephen Scruton was assigned to Keene in June of 1985 when was sixteen years of age.

The claim referenced as Page 004 ¶3 is notable. In 1991, a year before brought his claims, Father Stephen Scruton and the Diocese of Manchester were sued by The lawsuit was settled out of court. Claimed that, when he was 15 years old in 1987, Father Stephen Scruton took him to the Keene YMCA on several occasions and fondled him with his foot while the two were in the YMCA whirl pool. After the lawsuit was filed, Det. McLaughlin charged Scruton with a misdemeanor sexual assault. The matter was resolved in a plea agreement, and the lawsuit was settled out of court. Prior to my 1994 trial, my attorney sent copies of the above citations to Father Stephen Scruton for comment, but he refused to respond. When my attorney attempted to subpoena him, he left the state. My attorney also discovered multiple checks written on parish accounts to both These were all dated between 1985 and 1987 and all were filled out and signed by Stephen Scruton.

It appears that the police investigator ignored or suppressed the claims made about Scruton because the math problem was insurmountable. The second enclosure is a copy of page #25 from Interrogatories answered by Keene Police Det. McLaughlin in response to a lawsuit I filed in 1994. The responses are dated September of 1994, one to two years after his interviews with the brothers. Please note Question #43 and Det. McLaughlin's response.

There were other indications that the had originally pointed to Rev. Scruton as a perpetrator. In 1987, after Father Scruton was arrested and left St. Bernard Parish in Keene, informed me that he had found and viewed a pornographic videotape in Scruton's living quarters. In 1993, claimed that the videotape was found in my quarters. Presumably the change was made because Scruton was not there until was over eighteen years of age.

A third brother, (DOB: Claimed in police reports that he was forcibly raped by two unknown priests at a Hudson parish in the Spring of 1982. His attorney in the lawsuit brought in 1993 was Mark Abramson, who has repeatedly claimed in press releases involving his current lawsuits that he represented a man who was twelve years of age when he was raped by two priests in Hudson. Was sixteen years old, not twelve, in 1982. The two priests assigned to the Hudson parish at the time were Rev. Stephen Scruton and Rev. Mark Fleming. At the time made the claim in 1993, he knew both Mark Fleming and Stephen Scruton but identified them in his lawsuits only as "Father John Doe II" and "Father John Doe II." Not one of the seventeen persons who lived or worked at St. John's rectory in Hudson in 1982 was ever questioned about claims.

In 1998, I was told by a credible prison inmate that Det. McLaughlin and another Keene police officer presented him with a veiled offer of financial gain if he would join the brothers in accusing me. In 1999, a relative of one of the brothers came forward with an offer to "sell" information that one of the brothers lied about his claims because he was desperate for money, and that he found the "scam" to be so easy that he has since settled other lawsuits over contrived injuries.

In his lawsuit against the Diocese of Manchester, which was settled for a six-figure amount, was represented by Attorney William Cleary who also represented the Keene Office of DCYF, for whom the mother of the was a supervising social worker. Mr Cleary is currently an Assistant Cheshire County Attorney. Another claimant was represented in his lawsuit by Attorney Peter Heed, the current Cheshire County Attorney. It occurs to me that the public officials who would evaluate any claim I make for a reconsideration of my conviction are the same people who profited substantially from the claims.

I have also enclosed a news article about Rev. Scruton dated February 20, 2002. Since my 1994 conviction I have been given the impression by diocesan personnel that Rev. Scruton's location and activities were unknown.

Since you have much of what I have produced in my defense, and in the hopes of further investigation and appeal, I feel that you may as well look at the enclosed as well.

Page 002, ¶1:

"also gave information about another priest identified as Father Scruton as also sexually abusing him on at least two occasions."

Page 003, ¶4:
"When was twelve (12) or thirteen (13) years old he would spend nights in the Keene rectory (St. Bernards). Father MacRae would fondle and perform fellatio on when he spent the night. On one of these visits Father MacRae started to fondle and perform oral sex (fellatio) on him and then left the room. Another priest, believed to be Father Scruton, came into the room and continued the oral sex (fellatio) on

Page 004, ¶3:

"After racquet ball Father MacRae would have take a whirlpool with him and at times Father Scruton joined them. It was during these times that would be seated in the whirlpool and both Father MacRae and Father Scruton would be joined in conversation and they would alternate in rubbing their foot against his genitals. Was unsure if the priests were acting in concert or if they were unaware of each other's actions."

Report dated December 7, 1993 Page 1, ¶4:

"I spoke with and asked him to think of the two incidents of fellatio by MacRae which took place in the rectory during the Summer of 1983. I asked him to give this some thought and that we wanted to give the defense specifics about these two incidents so they can be differentiated."

"I asked about who might have seen him stay the night in the rectory. Stated that Father Scruton was a witness to his having stayed the night."

Note: Between August and October 1992, Det. McLaughlin wrote three letters pretending to be Each letter was signed, and the letters were based on information in interviews. The following is contained in the second letter.

Letter Dated October 5, 1992:

"Another thing I need an answer to is about Father Scruton. One night you were having oral sex with me and then left. Father Scruton came in and finished. Were you doing a favor for him? If so, shouldn't you have asked me first?"

Note: This page is from Interrogatories answered by Det. McLaughlin in September, 1994. He was the defendant in a lawsuit, and these Interrogatories were a part of the discovery process in that suit.
