The end-of-the-fourth-year evaluation of Philip Petit concerned

The very detailed report submitted by the pastor and Father Groleau, with the cooperation of Philip, showed that some concerns raised by the faculty in the previous evaluation were still problems; self-will; inadequate docility; and difficulty with community living.

My summation of the faculty discussion and the faculty interview with Philip would be that there is general agrement that Philip has the problems raised in the pastor/supervisor report and in the previous faculty evaluation. At the same time, there was reluctance to end Philip's preparation for the priesthood, because he did give some limited evidence of an attempt to respond to the faculty recommendations.

The faculty voted affirmatively on the question of Philip's basic suitability for the priesthood. (6 affirmative; 4 negative; 2 abstentions)

My own vote was negative, but I am not so completely certain about the issue that I would not go along with the faculty decision.

Dear Paul,

According to Bishop Gendron's letter of June 28th, 1978, I am to be "Supervisor and Vocation Board Representative" for Phil Petit.

Consequently, I have seen Phil on an average of once a week since his arrival in Lebanon in August.

At this point, I am very concerned about the way this man's problem is being handled. I think that the time has come to bring the case to a head and the sooner the better.

I have been given the impression that Phil is not entirely clear as to just why he is being held up from Ordination. Therefore, I think you would be helpful if you would write him a specific letter (please, send me a copy)....and spell out the reasons. Then, let us check and see if the reasons are being eliminated...at least gradually.

I frankly was surprised that now we are bringing in a Sister to advise and direct this candidate! ("Sister Mary Elizabeth") I do not know the Sister, but surely we have anough priests who are willing and able to direct this man. I have suggest3d a regular confessor -director, able to direct this man. I have suggest3d a regular confessor -director, and I am aware he is seeking spiritual help from Fr. Richard Clavelle. I am trying to help the man. ... Father Pichette is too..... and I really think that with your analysis too, we can all give a sufficiently good recommendation to the Bishop.

I have discussed this man's problems.... in and out and up and down.... and I realize that he has some "rough edges" that need rounding off. Yet, when our discussions are over, I have the "gut feeling" that this man should be advanced to Deaconate and Priesthood. There are times, you know, Paul, when we have to go with a "gut feeling": Noone has yet been able to tell me the "CAUSES" of the rough edges....we have members of the Vocation Board theorizing that this man has "a great deal of anger". What competent person says so and what are the causes

ot that anger? And during the months that he is spending with Father Pichette....what is being done to eliminate the causes of the "brusqueness", and the "lack of common sense" that the candidate seems to show occasionally?

In my opinion it is UNJUST to leavethis man in his present situation.... without instating that an malysis of the underlying causes of his seeming difficulties be made by someone who is competent to do so.... and then, when we have that report back.....we can make our recommendte dation to the Bishop.

I know you are trying to be very fair with him. Now I think justice and fairness requires this one last important step....

I recommend that you make an appointment and tell Phil that he is to go and see the Priest=Psychiatrist, Father James J. Gill, S.J.

That's why I feel we need a Doceor's help.

Indeed it is a privilege and honor for me to be able to work with you. Your letter was another example of it. Your concern and love for God, the Church and people comes through loud and clear.

I am pleased that we will be getting together with Phil on Monday, November 6th. This meeting should help clear the air and give all of us something "to sink our teeth in."

I am sorry about the confusion surrounding supervisors. However, you were appointed and still are the Deacon Supervisor and Vocation Board Representative. However, in the past, in addition to the Diocesan Supervisor we have always appointed a local supervisor. The local supervisor is normally one who works closely with the deacon or lives in the same house. Because of this the local supervisor gets a first hand opportunity to guide, support and confront the deacon. The diocesan supervisor which is normally "myself" works closely with the local supervisor and the deacon and makes sure that the issues that need to be faced are indeed being dealthwith. In any case, we could certainly discuss this further whenever we meet next Monday.

Our supervision process was two-fold: discussion one-to-one etween Phil and me at least 3 times each semester; and participation in a group theological reflection, approximately every two weeks. Phil was very responsible in taking initiatives to see me for individual supervision and de-briefing sessions. He took his commitments at the Paulist Center with a good deal of enthusiasm. He related well to staff and employees and was readily available when "on duty".

Coming to grips with the interrelationship of theology and ministry was the continuous theme of our individual sessions. Phil questioned the theological and scriptural approaches used by Jim Young as the underpinning for the ministry to divorced and separted Catholics at the Paulist Center. He also at many points questioned our experimental approach to liturgy. I felt that Phil questioned these facets of our ministry without taking enough time to look into these ministries as they are carried on at the Paulist Center.

Nevertheles, for Phil to bring his perspective to the Center through me and through the field group experience was valuable for our on-going questioning. But I believe Phil also grew in the process of appreciating service to people "where they are" as being more important than the "right order" of things.

Evaluation of Field Education Setting:

As indicated above, an approach to the integration of theology and ministry was important to Phil. The direct and at times rather stark encounter with crisis intervention in a clearly churchly setting brought the immediate of people and their needs to Phil's perspective. Theological issues raised by the ministry to divorced Jatholics and the exphasis in Paulist Center liturgy on "ministry of all believers" challenged so he of Phil's presuppositions. And without scallowing x wole any of this new input, Phil has, I believe, integrated into his pastoral approach some of the sonse of hospitality to the alienated and the questioning ones that is focal to the Paulist Center.

Phil had a commitment in a diocesan parish as a minicter of music. As a result he was not available to contribute much to our liturgical life, a definite part of his expertise. I believe had he been able to become more a part of the Sunday community of worship here, Phil's putting together of his Center experience would have been more complete. Perhaps such involvement would have been on tually enriching for Phil and our worship community. Surely it would have proceed for questions from Phil. Supervisor's evaluation of student - Phil Petit

Phil came to the Paulist Center with a good searching approach. He is inclined to be rather traditional in his theology and tends to intellectualize in pastoral situations. I believe that Phil learned a good deal of flexibility in his approach as he grew through the year at the Center. He himself notes that he could function quite a bit more easily at the Center after the first semester of his field education experience.

One of the assets of working at the Paulist Center for Phil was his first experience with crisis intervention, e.g., giving food to a bungry person, getting someone to a detox center. It was the immediacy of people he saw on his "duty day" experience that we made the strongest impact on Phil. It was an overall learning experience for Bhil, helping him to take people where they are, whether it be members of the Divorced Catholics Group or someone off the street looking for a hand-out.

Phil seemed to be xx quite concerned in his education ministry with retting across the "straight doctrico" rather than dealing with the feeling level of faith. For him, one staff member in whose Catholic Belief class Philk assisted was too "secular" in his approach. There seemed to be too much common sense and not enough theology to satisfy Phil. However, Phil seemed to be able to provide a religious educational experience in which people were asking good and intelligent questions.

I think that Phil appreciated the questioning and sourching that he observed going on at the Paulist Center as something more appropriate to a place like the Paulist Center than to a regular parish. In a special way, Phil made great strides in relating his theology to his sinistry at the Paulist Center. **REXERS** In her ways for him, Phil questioned: "where does my theology come from?" "Why do I have the theological position I have?" If he has made some strides in coming to grips with these questions, I believe that Phil has had a thoughtful and creative experience here.

To whom it may concern:

Upon the suggestion of Fr. Fernand Pichette of Sacred Heart Church, Lebanon, I would like to give you my own personal impressions and evaluation of Philip Petit, the seminarian assisting in the parish.

Firstly, I would like to state that I have known Phil only recently, that is, the four and a half months that I have been on home leave here in Lebanon.

He has struck me as being a man of the truth, i.e. open and sincere with himself, others and handling of affairs.

He also appears to be quite affable and approachable and able to deal with people and problems as they come up.

He impressed me as quite willing to carry out the functions assigned to him, even to anticipating the needs of others and things to be done which shows considerateness, helpfulness, and personal initiative.

Besides that, he is careful with things and has an appreciation of lpeople and things, and respects them for what they are and what they think. But still he is capable of facing them with the truth and the faith we profess, i.e. not being afraid to argue theologically, etc in order to defend our beliefs.

Of course he is still a person of this age, new outlooks and opinions and ideas on liturgy and the like, but at the same time he follows sound theology. I myself do disagree with him and as far as that goes with many other priests on going-on things involved with liturgy, external dress, and the like.

On theology he seems quite sound. That I can assure you from the night he and I discussed a number of points with some of my more learned relatives, on the night of my parents 50th wedding anniversary. We were discussing such things as the Immaculate Conception, the virgin birth abortion. We were arguing with one of my cousins who is an Anglican from Canada and quite clued up on theology.

Like all of us, he could perhaps use some improvement in the realm of community living and in team work, as regards all parish activities. We all have to try more and share each other*s burdens with a cheerful outlook, even if we disagree with superiors or subordinates. Then too he could watch becoming downcast and complaining about persons and things, which is a constant danger for our work.

That is about all I can say about Philip Petit. I sincerely hope it will help in a little way.

1) a) Did the seminarian become truly involved in the parish ministry?

Yes, Phil did all he was asked to do, but some feel that for the most part t'at he failed to initiate on his own.

b) In what particular areas was he involved?

Liturgical: music director, choir director, helped plan a children's liturgy and an ecumenical Thanksgiving service, and served as the homilist at all masses on several occasions.

Sacramental: Baptismal preparations, took part in a parent-sacramental program.

Pastoral: Hospital and home visitations

2' How do you rate his effectiveness in the aforementioned areas of involvement?

As music director, Phil has contributed to congregational singing, however, he could be more practical in his approach to rehearsals of new material. We suggest that he study ways to motivate people to participate more fully.

As a homilist, Phil is well-prepared. He delivers his material well, shows confidence and ease, speaks without notes.

In area of sacramental preparations, Phil established a bond with the people he instructed or prepared in that he helped to set up for the ceremony itself and attended the baptisms on his own initiative.

3) a How did he communicate with his fellow workers?

For the most part, Phil's dialogue is limited to small talk. He is generally non-communicative about his daily experiences in ministry.

Phil fails to see the difference between sharing and reporting, however there has been improvement in this area lately.

4a) Did he express deep interest in parish liturgies?

b) How do you evaluate his participation in liturgical functions?

b) Phil delivered his homilies with ease and a marked sense of presence, however, his homilies could be enriched with a more personal touch.

5. you consider him a man of prayer? Explain.

We have not had enough opportunity to experience Phil at this level to comment.

6. Has he demonstrated friendliness and courtesy in his relationships with the laity of the parish?

7. How would you rate his leadership ability, that is, his ability to inspire others and maintain confidence?

Thus far we haven't seen too much evidence of leadership, It is imporant to note here that Phil has only been with us three months making it difficult to assess a quality such as leadership.

- 9. Phil is defensive, is a rationalizer, gives the impression that he has all all the answers, operates from his own theories, does not seem to value experience as a teacher.
- 10 How would you rate his punctuality?

There is room for improvement. .

11. Has he shown initiative and creativity in his parish experience?

Yes, in an emergency situation, Phil took the iniative to offer to give part of the imput at a parent program. He did an excellent job. Phil has also shown initiative in bringing choir together and also in the one children's liturgy he helped to plan.

12. How would you rate his personal appearance?

Phil is always neat and clean, but does not dress to fit the occasion. In regard to mannerisms, he tends to be loud and has a notably forced laugh.

13. Is there any age groupor area in which his ministry seems most effective

Phil seems to relate well with the elderly and adults. We have not experienced him too much with children, but certainly he got down to their level at the Hallowe'en liturgy homily. He does not seem comfortable with teens.

hat has impressed you most about this person?

Phil's diction and his capacity to express himself. Phil generally make a pleasant appearance. He communicates well on the intellectual level. We have noted a definite positive change in attitude during the last

me which indicates an openness on Phil's part to grow. He has become more sharing regarding his ministry.

15. a) Does he demonstrate those qualities which are required in one aspir: to sacred ordination?

> We find this question hard to respond to since no qualities were stated. We do not see any outstanding negative qualities in Phil. The areas of concern we have indicated throughout this questionnair are more attitudinal or areas of growth and maturity we would hope to see developed further in Phil.

b) Do you recommend that he be encouraged to pursue his priestly formation and education. Please explain.

This does not apply as Phil has already completed his required studies, However, we recommend that he be open to on-going formation, especially that he develop an openness to learning from life and the lived experience of others in ministry.

16. Does he seem to have an adequate understanding of theology?

Yes

Are there any points which you feel should be brought to our attention as we help, guide, and support this semanarian?

We think it worthy of serious consideration that if Phil is called to the Deaconate by the Bishop that his past and present involvement in parish ministry be considered as part of his deaconate year. Considering this experience, we question the need for a full deaconate year.

18. Are there any points you feel should be brought to the seminary's atten tion?

19. Are there any points you feel which ought to be brought to the seminari attention as he prepares himself for ordination to the priesthood?

We would like to see Phil develop a clearer understanding of the balance between the works of the apostolate and the sacramentality of the priesthood.

20. Any further comments concerning this Seminarian?

Not regarding Phil, but as a team we feel from our experience of having a seminarian with us and trying to respond to the evaluation questionnaire honestly and responsibly, that we would like to make the followir suggestions: -

 We believe there would have been a real value in our seeing the evaluation instrument, or at least those "areas" we would be asked to comment on, early in the fall when Phil first joined us.

- If we and other parish groups are expected to evaluate the seminarian we feel it is equally important that he be asked to reflect on these same questions himself. Therefore, we recommend the use of selfevaluations.
- 3) Regarding the laity's evaluations: We believe that it is significant to know something about the person responding. e.g. Is it a 75 year old parishioner or a couple very involved in the parish with young children or teenagers. Perhaps it would be well to at least include a question which asked the lay person to indicate in what capacity they have experienced the seminarian.
