Your Excellency:

This letter will not carry to you all the things that it would please me to state. However, I will attempt to bring out the most important matters trusting that I personal interview can be arranged whereby other important details relative to my case might be discussed in detail.

The Manchester Chancery contains the just and weighty reasons for which the late good Bishop Brady suspended me. Such an action taken by him, I know, was most painful yet I realize that he was forced into it for the good of souls. It is only the Rev. O. L. Dufault, classmate and pastor of Holy Cross Church, Morrisville, Vt., who is completely aware of the difficulty I had in procuring a Bishop and it was only he who witnessed my self-inflictedsuffering during the lengthy time of my suspension and the determination I had in proing myself a good priest with the strong resolve of rehabilitating myself.

It was after a year and a half of priestly inactivity that I was finally accepted into the diocese of Grand Rapids through the intercession of the late Cardinal Mooney. This invitation came to me from Bishop Babcock in March of 1958. Upon my arrival into the diocese of Grand Rapids until my dismissal this past week, I saw him only once. During that time I was given three assignments and now I find myself in difficulty once more as the end osed letter will indicate (kindly save).

Upon my dismissal from the diocese of Grand Rapids, I acquainted the Rev. C. G. Nugent with my problem. He is a diocesan priest in the same diocese, who, in turn, directed me to his brother, the Reverend Father Liguori, C. SS. R., Rector of Villa Redeemer, Glenview, Illinois.

This afternoon Father Liguori arranged an interview for me with the Most Rev. Raymond Hillinger, Auxiliary Bishop of the Archdiocese of Chicago. After having discussed my difficulty with His Excellency, he advised me to write you for an appointment; that

Dear Monsignor Hansberry:

Your files, I am sure, will give the history of Father John T. Sullivan up to the time he requested work in this diocese in 1958. Because of dire need for priests and been cause Father Sullivan had been recommended by a priest with whom he had been living for over a year, I gave him an opportunity of rehabilitating himself. He had three different appointments in the year and a half he was with us, but he could not get along with any of the three Pastors to whom he was assigned. I honestly believe Father Sullivan is a psychopath. He makes a very good impression. He seems to be sincere in his efforts to amend the past, but his judgment is far from what is desirable. I honestly do not think he is aware of the disturbing influence that he is in a parish and in the rectory. Someone else is always to blame, not he. While nothing of an immoral nature came cut in the open while he was with us, there were indications of danger of this in his conduct with children.

The above is a conscientious analysis of his time with us. I have no bitter feeling toward Father Sullivan but feel obliged to write to you as I have in regard to him. If there is any further information you desire, please do not hesitate to write.



On this day, Bishop Primeau interviewed Father John T. Sullivan concerning his request for an assignment in the diocese. He told him it would not be possible because of his past history and present involvements. He gave Father Sullivan permission to spend two weeks seeking a benevolent Bishop who might accept him. After that period, he is to go to Via Coeli or some other institution of its type or be laicized.

Father Sullivan was informed by Bishop Primeau that the diocese would not give him a recommendation.

Dear Tom,

Thank you for your interested and discreet telephone call of yesterday. At your request I am enclosing the facts of the case which were prepared for me by Father Doud and opened in the presence of Fr. Sullivan and the presence of the case which were prepared for me by meeting after the enjoyable day we had to geather at Camps Fatima and Bernadette.

Fr. Sullivan admitted every fact as given by morning, I talked with Father for my information by Fr. Dowd. The mother is unaware of Fr. Sullivan's past add as her oldest daughter is supposed to be entering the convent in the fall felt as she did.

These are all the facts that I am able to give you. Fr. Sullivan's mother and sister told me after Mass this morning that he had left for the West and I have advised Fr. Doud of your direction from the Bishop regarding his presence in the parish.

May I assure you that I have been very generous to Fr. Sullivan financially and I have done all I could to help him and am quite disturbed that he should tie-up with this new family who just moved into the parish.

Thank you for your confidence and interest and I await any further advice that you on the Bishop wish to convey to me.

On Tuesday I was approached in the afternoon by a pelative to her son's being placed in anho orphanage. Later she called me and told me that Fr. Sullivan had been seeing quite a bit of her daughter and that he the had been taking her out and keepting her quite late. She felt that although there was nothing intrinsically wrong that it did not look good for her daughter or for Fr. Sullivan. She explained that also he had been taking her daughter home after Mass in the morning. One morning when they overslept me she drove her daughter to church at about 8:30ÅN and that they had passed Fr. Sullivan at the barber shop down the road. The claughter said that he had been waiting for her. She could not understand why he waited there. On another occassion (the previous Sunday) she said that he had called when she was supposed to have been to at the hospital, she delayed purposly and when answering the phone he mentioned that he thought she was to be out.

She also told me that he had been at the house several times when she had been out, and that she did not think this looked right at all.

She mentioned that he had been at the house when her younger 14 year old whiter was there and that something had happened which greatly disturbed the child. She did not wish to say what over the phone.

I told here that I would call Fr. Boner and ask his advice as she had asked. I spoke with Father and he agreed that the mother's original idea of forbidding her daughter to see F_n . Sullivan or to have him at the house would be the best thing. I called and she came to the rectory where I simply told her what Fr. Boner had said.

She told me that her daughter was then in Keene with her Father and that her father was to be away and that she thought Fr. Sullivan was going up to see the daughter there from a conversation he had had on the phone with She asked me what she should do. I told her that if she could she would be wise to have her daughter come home or to call her and tell her not to see Fr. Sullivan for the sake of both of their reputations. I agreed with her that although there was must nothing bad going on that it did not look right for appearances sake for them to be seen togeather so frequently.

In a later conversation she mentioned that one one occassion Fr. Sullivan and her daughter had gone out in the early afternoon and were to have gone to a ive-in that evening, but that upon questioning her daughter when sie got home are found that they did not go so and that they only node around all days the

Dear Father Lee:

Allow me to thank you most sincerely for your letter of September 16th concerning Rev. John T. Sullivan of this diocese. I am pleased to know that he has sought refuge at Via Coeli, although he did this of his own accord and was not assigned there by diocesan authority. I note that you speak of possible week-end work for him. May I suggest that you use extreme caution in giving him such assignments. His past history is such that my predecessor, Bishop Brady, would not recommend him to any Bishop and he recently left the diocese under a dark cloud after becoming involved with two young girls.

Father Sullivan's case was referred to Father Gerald at Via Coeli in New Mexico in 1957 and he said that he would be "willing to shelter Father with a program that will help him save his immortal soul — but it should not be with any hope that he will be recommended to another Bishop even after he has spent some months with us." Bishop Brady felt that "the only possible solution of his case seemed — that he become a permanent guest at Via Coeli or that he be laicized."

I suggest that you consult Father Gerald about the 1957 correspondence between him and Bishop Brady concerning Father Sullivan. You may add to this a continuing history of escapades with young girls since that time. These have occurred even during the time that we were trying to assist him in getting back on his feet.

The diocese will be pleased to assume the cost of Father's board and room at Via Coeli, so I suggest that you bill the Chancery periodically. If there is any further information you wish to have, please let me know.

Allow me to acknowledge your recent letter concerning Rev. John T. Sullivan of this diocese who has sought work in your didcase. He has been in bad odor in this diocese for several years, is suspended and is not permitted to say a public Mass in the diocese. The Most Reverend Bishop is not able to recommend him for service in any diocese because of his scandalous actions which have extended over many years. He left New Hampshire a few months ago ostensibly to enter Via Coeli on his own initiative and we viewed with alarm the thought of the authorities there to recommend him even for week-end work because of his past history. He is known throughout the State of New Hampshire for his efforts to seduce teen-age girls and he left here in the nick of time after his last escapade. I suggest that Monsignor Baer keep a close watch on him during the period of his visit in his parish.

As regards the Insurance Fund Program, it would perhaps be well for Father Sullivan to continue his membership in our Blue Cross-Blue Shield Plan because I doubt that he will remain in one diocese long enough to warrant a transfer to another. We have been paying for his board and room at Via Coeli and are willing to carry him on Blue Cross as long as he is unable to pay for it himself.

The first paragraph of this letter may sound a bit strong but I feel that you should know the facts in order to be able to protect yourself. We have done everything in our power to help Father Sullivan over a period of many years. Our efforts have always been in vain. I pray for him every day and I know that many others do also.

Allow me to thank you for your letter of June 9th concerning Rev. John T. Sullivan of this diocese. I am sure that you are acquainted with details of his case from correspondence with Bishop Brady several years ago! This probably gives you a better picture of the situation than Father Sullivan would paint for you himself. At that time, you expressed the opinion that he should plan to remain at Via Coeli for life or be laicized.

During the past few years, there has been no evidence of a change for the better in Father Sullivan. He worked for a while in Grand Rapids diocese and was released. Although I have no official confirmation of the basic reason, I have heard from good authority that it was the same as in previous cases. He returned to the diocese of Manchester for a brief period and immediately became involved with two teem-age girls. He left under a cloud and went to your Minnesota house on kis own. In spite of our warning to the Superior, he was permitted to take critiside work but apparently did not keep it for long. He next turned up in Amerillo and Bishop Morkovsky gave him parish work without consulting us. He has now arrived at Jemez Springs.

I must say that I am very much disturbed over this errant padre. He has been in very serious difficulties in every parish in which he has served. Priests who have known him are of the opinion that he should have been laicized years ago. The scandals in which he has been involved have been most serious and it is amazing that he has escaped civil prosecution.

In view of your broad experience, I wish that you would give this case your careful attention and advise me as to what you think should be done. In the meantime, please bill our Chancery Office for expenses involved in the care of Father Sullivan because we shall want to take care of them.
