



From the best information available at this time, the following clergy have been accused of the sexual abuse of a minor while exercising ministry either in the Diocese of Raleigh and/or prior/subsequent to their ministry in the Diocese of Raleigh. In no instance were any allegations of sexual abuse made known to the Diocese of Raleigh prior to the assignment of these clergy in this Diocese. These clergy were either of the Diocese of Raleigh, or those who had served in the Diocese of Raleigh.

For a clergy member to be listed, the Review Board of the Diocese of Raleigh or another authority determined that the allegation made has a semblance of truth. This list covers the period from 1950 to the present, with the year indicated of when the alleged abuse occurred, when it was reported to the Diocese, and if the report to the Diocese of Raleigh also included subsequent reports of abuse (ff).

Each listed allegation has been reported to law enforcement. This list was compiled from the records of the Diocese of Raleigh, in consultation with the Diocesan Review Board and having received their approval.
