Dear Father Keefe:

On August 23, 1996 I wrote to you ending your assignment as a member of the team ministry at Saint Stephen Parish in Framingham and placing you temporarily in Unassigned Status. On that date I assigned you to Saint Luke Institute in Silver Spring, Maryland for a psychological assessment. I pointed out that the effective date of this assignment would be determined by Rev Brian M. Flatley, the Delegate of the Archbishop, in light of his conversation with Saint Luke Institute and you. I directed you to be in contact with Father Flatley by September 6, 1996 to initiate this conversation.

The Office of the Delegate has been notified that you received that letter. Since you have not responded I am writing again to ask that you accept this assignment willingly in a spirit of obedience. However, I must inform you that this letter should be viewed as a second warning. If you do not accept this assignment, it will be necessary for me to invoke canonical penalties according to Canon 1371, 2. I direct you to be in contact with the Office of the Delegate by Friday, September 27, 1996.


Please send written notification to Most Reverend William Murphy, Moderator of the Curia, indicating that you have received this communication.
