Sr. Ann Ellen Ouirk and Mrs. Mrs. " \underline{B} " was also supposed to come. However, yesterday she again went to Don and talked to him about what has happened to him with her son. Don tearfully begged her not to come and see that bishop; told that he would be removed and no priest would replace him because of the shortage; and that he was getting help for himself. He told her that Lee Marco was councseding him. Because of these remarks, Mrs. "B did not come.

These ladies told a story of repeated attempts of Fr. Donald to sexually assault their teen age sons (14 - 17). He took one of them on a tip and at the motal that night grabbed the young $\underline{MRS-A''Son'}$ He hit Don and was afraid to sleep that night. For a year after that inceident he was afraid to be near Don . Only now is he working through the anxiety caused by this attacj

Things seem to have escalated in September. Don's mother has lived with him for some time, but lately is spending more and more time away from the rectory. When she is gone, Don has forced at least two boys on the bed inthe rectory. One fought him off. The other result is vague. MRS - B SON has worked around the rectory for some months and goes with Father shopping, etc. The two women who saw me felf he may ahve a homosexual tendencies since he kept going back to the rectory when all others refused to do so.

Sr. Ann Ellen sees many of the teenagers at St, Rose in Wilmington; they no longer go to Bradiwood. Many of these are the staunch Cathhlic families tin town. Although only two of the four or five boys involved have gone to their parents and confided in them, these women felt that some rumors might be circulating in twon.

Sr, Ann Ellen who knew Don when fe was an associate in Wilmington fefls he has some deep=seated problems. According to her, he hated his father who died when he wa 13.; and of course been very closeto his mohher. He cannot relate well with adults at their level. When he preaches, he closes his eyes even when talking to the children. In his CCD clasees he tells **thet** kids that it is a sin to smoke; to look at yourself in the mirror when naked, etc.

From my own personal obsercations I know that he has an inordinate fear of the Bishop and the Chancery. These are authority figures which threaten him. He has said that he would be happy to live in Braidwood forever, without once having to come to Joliet. He does not always attend priests' gatherings, staying by himself or with a highly select group. He is extremely nervous incividual.

If you call him in, I would expect him to be extremely threatened. I t could be a very emotional encounter; or merelt a superficial agreeing to everything you say in order to make the encounter as brief as possible. He certainly needs far more professional help than L-e Marco can provide.

Jim Fitzgerald also called during the week. He knows all the families involved and can vouch for their sincerity and their real desrie that Don get help. The long delay has come mainly from the hope that this cure could be affected withiut the Bishop being involved. They realize now that only a third party coming from outside can help.

Reverend Donald O'Connor - Immaculate Conception, Braidwood

After a Youth Mass on Sunday afternoon, I visited with Don for about 20 minutes to a half an hour. His mother lives with him, and has for 10 or 11 years. She is very pleasant, but quiet, but did stay so that I had no chance to talk to Don alone. However, I did tell him my purpose in coming was just to show him that I am interested. Don said about three times that he would be glad to go to Wilton Center when and if Father Irwin was transferred. He said he also told that to Bishop Imesch. I don't think he was just kidding. I told him that he has too much talent and potential for a small place like that. He said he is chaplain of the Will County Sheriff's Department and also would be glad to be a Master of Ceremonies for the Bishop. That would give him three things to do. Don said there is a lot of chasing around, visiting County policemen in the hospital, etc. I gathered he is not wildly enthused about the job, but he does not seem opposed to it, and somewhat seems to enjoy it. He said he is ill at ease in attending parties, as he is expected to do, and also does not know whether the people who he is called upon to visit are Catholic or not before he gets there. I take it he is a bit uncomfortable in those kinds of settings.

While we were talking, Matt Heberer came in. Father O'Connor seems to have a fine relationship with the young people of the parish. That was also evident in the sacristy before and after Mass. Don has two brothers, both of whom are married, older and live out of state, I believe.

Don and I had a pleasant and innocuous visit. I commended him on the fine shape of the parking lots, buildings, etc. Everything is in tip-top shape maintenance wise. Don also showed me the back three lots that he purchased and cleaned up behind the rectory. It used to be a dumping ground and now you can see the street behind, and the grass is neat and well kept. Don himself and a volunteer from the parish take care of it.

We spent a good bit of time talking about his 91-year-old mother, who is quite frail. They had just come back from the doctor. She falls, is losing weight, and he is very concerned about her. We were able to trade stories.

Don repeated his usual theme that he wants Wilton Center when it is open, and I told him there is no way he is going to get Wilton Center. He still has ads in the newspaper. He has \$200,000.00 in the bank - about \$150,000.00 more than there was when he came.

He chided me for not having something in the paper about Ed Poff. He said there was something about Jim Lennon and the people in his parish are very interested and concerned about Ed Poff.

I mentioned my only two questions are annual retreat and cluster meetings. He said he always makes his annual retreat at Mundelein, and never attends cluster meetings. I chided him for that, but got absolutely nowhere. He said he has enough grief at the parish and doesn't need to go and hear the griping at cluster meetings. I told him other priests need his presence, but I'm sure I did not make a dent.

I asked if there was anything I could do to help him, and he said there isn't. I told him to give me a call if there is.

Memo re: Father Donald O'Connor

I asked Don if he had said Office of Readings, Morning Prayer and Daytime Prayer, and, of course, he had prayed all of them, so I said we want to start with prayer, so we said my Prayer to the Sacred Heart. And then I gave him a crucifix brought back from the Ad Limina visit.

I would not characterize Don as hostile, but pretty close to resentful about coming for these visits. I think this was the third or fourth time that rescheduled him, and I still haven't seen Dick Ross after the same or more.I probably did not help by my response to Don's opening question.

He asked if he could get an extension at St. Bernard's. I said I didn't think there was a chance in the world of that. Then he said how about a one-year extension? I asked what the reason for that would be. He said his 35th Anniversary. I said maybe 25th, but I didn't think he stood much chance at all of getting an extension for his 35th, but he could put it in writing in December after my letter goes out. I said I'm only one member of the Board, but would review it and make a recommendation to Bishop Imesch, but I think he'd be much better off to prepare himself and his people for his transfer. He obviously was not pleased with my reluctance. I told him I know his people love him and that he is doing a great job at St. Bernard's.

I also told him not to think about Wilton Center, because I am sure that that will become a mission of another parish when Sal Giunta retires. He said there is some growth in that area, but I observed our shortage that will increase in the next several years. Don said we should be closing parishes, and that Bishop Imesch's successor is going to have to come in and close a whole bunch all at once because he won't close them now. I told him I thought by that time there would be a turn around in vocations, and that if we had worked as hard the last 25 years encouraging vocations, as we did to get lay people ready to take the priests' place (which they really can't do), we would have enough priests today.

Fr. "R" stated that in 1967 – 1969, when he was 12-14 years of age (born 1955), he was abused by Rev. Donald O'Connor, a priest of the Diocese of Joliet, who was then an associate pastor at Assumption Parish in Coal City.

Fr. Flynn, the pastor, recommended that he get away from the "death watch" and was taken to Chicago by Fr. O'Connor. Fr. \mathcal{R} " stated that he was groomed. There were multiple incidents of abuse that occurred both in Cook and Grundy counties. He was unable to talk to anyone about his experiences.

At the age of 16, in 1971, Fr. \mathcal{R}'' drove to a monastery in lowa where he spoke to a Trappist priest about what happened to him. The priest told him that he admired him for his courage, for dealing with the matter and said he needed to tell someone.

Upon his return home, Fr. ${}^{*}R^{**}$ mother asked him what was wrong, so he told her. He had such shame. That same year, he confronted Fr. O'Connor at D'Amico's restaurant on Jefferson Street. Bishop Blanchette was the bishop at the time and some inference was made by Fr. O'Connor that the bishop would not believe Fr. ${}^{*}R^{**}$ Fr. O'Connor is supposed to have said that "It's better than shacking up with a woman."

Dear Don,

In view of our recent conversation I am removing you from your assignment as pastor at Assumption parish in Coal City, effective Saturday, May 18th. This action is being taken because of sexual abuse of a minor that took place between 1967 and 1969 when you were assigned as an associate at Assumption parish.

In removing you from your pastorate, I am also taking away your faculties to function publicly as a priest. You may, however, continue to say Mass privately.

Don, your age allows you to be eligible for retirement benefits. I will see that those benefits begin in the month of June. Your check will normally be sent at the end of each month. Since you are not yet 70, one-half of one percent of your retirement benefits is deducted for each month short of 70. Rather than provide you with a pension check that differs every month, your benefits will be figured on an annual basis and so you will receive the same amount in each check for a calendar year. When you have an address, I would appreciate receiving it so that your monthly benefits may be mailed to you.

Don, you have been a compassionate and caring pastor in all of your assignments. The sexual abuse of a minor, no matter when it occurs, is a terrible act. You have expressed your remorse to me and I have experienced the pain you are feeling. The Lord is a merciful loving Father and I know that He will care for you during this difficult time. I will

Tonight I met with a former student of mine, at his request. He said he does not wish to be identified, does not wish to be drawn into the legal arena. He is coming forward because Bishop Imesch asked that anyone abused by a priest do so. 27 years ago, he was abused one time by Father Donald O'Connor. Father O'Connor was a very good friend of his family, was a frequent visitor to their home, and often took him and his siblings on outings, for ice cream, etc. One night, this boy and a buddy were supposed to stay overnight with Father O'Connor, but the other boy was sick and unable to come. So just the two of them played cards. They played in their underwear. The winner was to be able to fondle the genitals of the loser. The young man, not wanting to touch Father O., said he knew he could lose and would not have to. And he did. Moreover, he told Father O. that he did not have to touch him, but Fr. O. insisted, and fondled him, then started to masturbate him. The young man told him to stop, and said he had to go to the bathroom, and locked himself in the bathroom. He told Father O. to "Go away." And then went to bed himself at the rectory. He declined ever to go back to the rectory. This took place in the rectory at Braidwood. On many previous occasions he had been on outings with Fr. O., both alone and with others, but there was never anything improper.

He never told his parents, but will do so, after talking to me. He has told only two other persons: one of his siblings; and his fiancee during their pre-Cana marriage preparation, when they were challenged to tell their intended spouse anything they had not yet confided. Since the recent announcement about Father O.'s removal, earlier this week he and his wife talked about it again, and he told his wife that he was going to see me and tell me. She has always been very supportive of him.

I offered him counselling, but he said he really doesn't think he needs it. He is in an administrative position, and often is in my chair in such situations. But he said if he later feels he needs some help, he will let us know. He once expressed concern that he should have come forward years ago. I told him not to judge himself as a young man from the vantage point of the wisdom he now has as a mature adult. He wanted to know what the next step is. I said the first thing would be the offer of counseling, which I had already made. I likewise told him I would of course have to tell both Bishop Imesch and our diocesan attorney, and very frankly I didn't know whether this would have to go to the State's Attorney, but I presumed it would. However, I assured him, since he had initially said in making the appointment that he wanted to come to get some spiritual guidance and repeated tonight that he wishes to remain anonymous, that I would not identify him to anyone. He told me he knew he would one day have to talk to someone about it, and had long ago decided that someone would be me, because I had had such a profound impact on him as his principal. He likewise said that his Catholic Faith has been a bulwark for him - and continues to be. He has no desire to meet with Father O'Connor, but said he has long ago forgiven him, and he thinks that forgiveness is necessary to be at peace oneself. We had started with prayer, ended with prayer and he also wanted to receive that Sacrament of Reconciliation, saying that was an added reason he wanted to come to see me. I was very impressed with this man, and told him so!

I spoke with Mrs. "A" (Phone#) on Monday, May 20th. Mrs. "A" lives in St. Rose Parish in Wilmington. She said that Mrs. "R" 5..., a friend of Father O'Connor from Braidwood, had asked her son, , to go to Chicago together with him. For some reason "R" 5...did not go and Father O'Connor took Mrs." A" to a hotel in Chicago. Evidently Father O'Connor attempted to abuse him, but the boy, whom she said was small, was also a wrestler and he fought Father O'Connor off. He spent the night huddled in a corner of the room. Mrs." A" wanted Mrs." R" to come with her to the Chancery but she would not come. She said that she and Sister Ann Ellen came and saw Father Donnelly, but he would not let her see the bishop. This was in 1978.

She said when Father O'Connor brought the boy home, Man " 50-7 walked right past her without saying anything. Father O'Connor was cheery and jovial. She knew that something had happened and after Father O'Connor left the boy told her. She said that "A" 50-7 is now living in and is fine, but wanted me to be aware of what had happened. She said that she told Sister Ann Ellen Quirk about this. Sister Ann Ellen told her that she knew of at least three others who had been abused by Father O'Connor

However, our Chancellor will phone this individual with the goal of having him consent to his name being released to the State's Attorney's office. I think this might be the simplest way to handle this. If he insists on confidentiality, I am sure we can work out another way so that you can obtain his name and pursue whatever investigation you deem proper.

The Diocese would be more than happy to comply with your request and I will obtain the necessary Affidavit that you have suggested, but I thought it best at this time to forward our two most recent phone calls.

My name is Mr. K

was an altar boy for Fr. O'Connor at Immaculate Conception Church in Braidwood, Illinois in the late 1970's. I was sexually abused by Fr. Donald O'Connor around this time. The only reason I would like to report the abuse I suffered at the hands of Fr. O'Connor is because someone else has. My sole

intention for reporting the abuse is so I can move on with my life. I am relieved to learn (today) that someone else has reported Fr. O'Connor. I sincerely did not want to ruin his career but I feel it is necessary to report the abuse so others may come forward. My mother sent me a newspaper article from the Morris Daily Herald dated Monday, May 20, 2002.

I decided that the sexual abuse from Fr. O'Connor was enough so I wrote him a

letter telling him that I would not go to his house/rectory anymore when I was about 14-15 years old (approx. 1979). I believe that Fr. O'Connor contacted my mother shortly after my letter to him. I did not know that my mother or family knew of the sexual abuse until my letter from my mother today. My mother ('Mrs." ?) wrote to me in her letter, "While I was in Illinois, I was looking at the Channel 9 News when they showed a map of Illinois and pinpointed Coal City and said Father O. was removed from his position at Coal City. I wasn't shocked - I was sure someone would report him eventually my brother-in-law) suggested I report him - now I won't need to. Remember when I talked to Fr. O when you and (my older brother) were altar boys. He told me if I didn't tell anyone (about the abuse) he would get help. I'm so happy someone reported him. Why don't you write a letter to the Diocese of Joliet reporting your experiences with him. I'll bet 'Mrs. "A" Sen will (an elementary school friend)".

Dear Bishop Imesch,

We know that allegations of sexual abuses has hit our Diocese and caused all of us deep sadness.

We do not believe all of these claims are true. We believe some of these people who are making these charges are just looking to smear the priests name and to get money for their revenge.

Two of the priests we know personally were at one time serving at St. Bernard's here in Joliet.

One was Fr. Poff and the other was Father O'Conner. Both were very good pastors when at St. Bernards's We knew Fr. O more than we knew Fr. Poff.

Whenever we went to the pancake breakfasts we have never seen a priest say Mass and then fly down to not only gree the parishioners, he also helped serve the breakfast with the other workers.

Stations of the cross duing Lent are very much a part of recalling the passion of Our Lord. When Fr. O had the stations at St. Bernard' he was the only priest that I know who had benediction after the stations. Too bad so many parishes do not take the time to have bendiction—it seems like they hurry through the stations and out we go. What's the hurry?

Our Lord couldn't run through his time of passion—it took time—but we never learn.

Fr. O never hurried with anything he did for people. He always was there for anyone who sought his help.

Only God knows if Father O is guilty of what they said he did. I'm not God and my family and I would never judge another person.

Someday we too will have to account for our faults before the Almighty. We only wish our lives could be filled with half of the good deeds Father O has on his record.

Live nowadays has become a society of finger pointing, suing, and blackening a person's character. Forgiveness is never enered into the picture.

Yes, some priests have gone on and on many times abusing young people, but it is not EVERY SINGLE priest.

Another thin is—why is the priest's name brought up, bu the person who accused the priest is presented to us as John Doe. How sad—don't mention my name. If you accused someone then by golly put your name in the newspapers too.

The payoff of money is something that does not set right in our book either.

If the priest is truly found to be guilty of the accusation and is found to have repeatedly done things then remove them from the parish he is serving and an apology given to the victim and see that the priest and the victime both receive therapy.

No large payoff is needed—if the therapy is given—that's a payment in itself.

Father O has been accused of something he did many eyars ago, but when you think about it he has more than made up for it by helping more people with all their problems all along the way.

In confession, we confess our sins and receive absolution, are given a penance to say and ask God for his forgiveness. God fortives us why cant' we forgive others who have failed as a human being?

Hope you bishops give this issue a servious consideration? You don't become a priest overnite, it takes many years of study. They're not perfect and God doesn't ask us to be perfect. He only asks us to believe, love Him and try our best everyday.

- 1. Why was Father Donald O'Connor removed as pastor of Assumption parish in Coal City?
- An allegation of sexual misconduct with a minor that occurred more than 30 years ago was reported to the Diocese of Joliet on May 14.
- In accord with our policy, the allegation was investigated and a determination was made by the Diocesan Review Committee.
- (Fr. O'Connor admitted his actions.)
- The Committee recommended that Father O'Connor be removed from ministry.
- The victim was prompted to report the allegations after reading a published letter in which Bishop Imesch encouraged victims to come forward.
- 2. What are the specific circumstances surrounding the allegations against Father O'Connor? (i.e. age of the victim at the time of abuse, specific details of incident, etc.)
- I'm sorry, but I don't believe any interest would be served by sharing those details.
- The important thing is that the allegations were determined to be credible. In accord with
 our policy, appropriate action was taken upon the recommendation of the Diocesan
 Review Committee.
- Have there been any prior allegations of sexual misconduct with minors involving Father O'Connor? If so, explain.
- There have been no prior allegations of sexual misconduct reported to us involving this priest.
- 4. Have his parishioners been informed?
- Yes. Parishioners were informed (are in the process of informing) parishioners during regular weekend Masses. Parishioners also will soon be receiving a letter from the Bishop about the situation.
- We are deeply saddened by this tragic development and have assured parishioners that our primary concern is for the safety of children and the for healing of all victims of abuse.

- We have assured parishioners that we are here to reach out to offer pastoral support to help and comfort them, particularly during this difficult and painful time.
- In addition, we have arranged for a team of experienced counselors to meet with them to help respond to their questions and concerns.
- 5. How did parishioners react to the news that their pastor was the latest in a series of 11 priests associated with the Joliet Diocese to have been removed from ministry in recent weeks as a result of allegations of sexual misconduct with minors?
- Many are understandably shocked and saddened.
- We have assured them that we are here to reach out to offer pastoral support to help and comfort them, particularly during this difficult and painful time.
- We also know that these parishioners are strong and compassionate people who will help each other through this difficult time.
- 6. Are some parishioners angry?
- There may be some who are angry. We sincerely hope that they will speak with us about their feelings or with one of the experienced counselors whom we will have available at their parish.
- This is a difficult and painful time for all involved. We hope that anyone who has concerns will share their feelings and ask us any questions they may have in order to begin the healing process.
- 7. Where is Father O'Connor now? What is his status?
- He is at an undisclosed location.
- He has been removed from his position as pastor at Assumption parish and from all ministry.
- In accord with our policy, he will be offered professional evaluation and treatment as necessary.
- He will not be assigned to any ministry.
- 8. How will the Diocese of Joliet ensure that no minors are placed at risk because of this priest?
- He has been removed from his position as pastor and from all ministry.
- He will be offered appropriate professional evaluation and treatment as necessary.

- He will not be assigned to any ministry.
- 9. Will Father O'Connor be monitored? How? By whom?
- He will be with someone who is aware of his past action.
- 10. Is Father O'Connor facing criminal charges?
- That is for civil authorities to determine.
- 11. Do you anticipate that the victim will pursue legal action against Father O'Connor and the Diocese of Joliet?
- The person will not be pressing charges.
- We are committed to acting responsibly and compassionately toward all victims of child sexual abuse with the goal of helping them to heal.
- 12. Father O'Connor is the 11th priest removed from ministry in the Diocese of Joliet in recent weeks because of substantiated allegations of sexual misconduct with a minor. I understand the diocese only has about 200 priests, so this seems like an unusually high number. Why do you think this is happening in your diocese?
- I can't speculate on what the number means.
- I can only tell you that we've been taking actions based on the recommendation of the Diocesan Review Committee to help ensure that we are doing everything in our power to protect children. In addition:
 - > We are cooperating fully with civil authorities.
 - We are continuing to encourage victims and anyone with information about such abuse to come forward.
 - We are taking quick and decisive action to remove priests who might pose a risk to children whenever an allegation of this nature is made.
- These actions are being taken with the hope that everyone affected by the tragedy of sexual misconduct with minors can begin to heal and move forward with God's help.

- 13. Some of your critics have suggested this number is so high because Bishop Imesch has mishandled the situation over the years and that's what's led to the problem today. What is your response to these critics' assertions?
- I can only respond by saying that we cannot change the past. But we can do everything in our power to help make sure that children are safe and victims are always treated with compassion and respect. Our commitment includes:
 - Cooperating fully with civil authorities.
 - Continuing to encourage victims and anyone with information about such abuse to come forward.
 - Taking quick and decisive action to remove priests who might pose a risk to children whenever an allegation of this nature is made.
- 14. For the past six weeks or so, a steady stream of priests associated with the Diocese of Joliet have been removed from ministry. When will this end? Can the public expect to hear about more priests' removals in the near term?
- I cannot speculate.
- I sincerely hope there are no more incidents of sexual misconduct with minors anywhere, ever again.
- But, we recognize our ongoing responsibility to ensure the safety of the children in our care, and we openly encourage anyone who wishes to report information about an allegation involving a priest from our diocese to contact us or, if they prefer, to go directly to civil authorities.

On his own, he stated that he is not permitted to wear such clothing. It appears that he understands that he will not wear clerical clothes, whether or not he really was seen in such attire.

At the time of his abuse, about 1966/68, he was an altar boy whom Fr. O'Conner took a liking to. Fr. O'Conner took him to the Museum of Science and Industry. They followed that by a stay at a hotel. When he awoke, he had no clothes on; he suspects he was given medications. There was shaving cream on his stomach with a smiley face on it. There was someone else in the room but he doesn't know who it was. He was still drowsy.

This event changed his life; there is no respect for priests or the church. He goes to church only for weddings or funerals. He knows that Fr. O'Conner is no longer an active priest, but lives in Braidwood.

I asked how I could help him. I offered help: talk to another priest, but it was soundly rejected; counseling, no, again. He had gone to a counselor in the past, but alone since his wife would not go with him. They continue to have relationship problems. He wanted a cash settlement but could give me no amount.

I told him I'd be meeting with Bishop Imesch on Monday, March 7th, and would discuss the information with him, although it would be the Review Board who would make any decision in his case. I asked him to put it in writing for me and I would submit it to Sr. Judith Davies.

On March 7^{th} , I received a call from Ms. H again saying Mr. G did not have time to write the letter yet but would send it at a later date.
