I trust that you probably already received copies of the enclosed orders from the Rhode Island Supreme Court. Our petitions for writ of certiorari with respect to the discovery orders were denied on February 8.

Accordingly, I sent an e-mail to Carl DeLuca and Tim Conlon advising them that counsel for defendants can meet with them at Mr. McCarthy's office so that we can produce, and plaintiffs' counsel can inspect and scan the records in question during business hours on the following dates: February 13, 14, 15, 22, 26, 27, 28 and on March 2, 5, 6 and 9.
