Dear Brothers and Sisters in Christ,

It saddens me very much to inform you that Monsignor Malachy McGinn died early this morning after a very lengthy illness. He fought a very courageous fight with cancer for a year and a half and will be greatly missed by all who knew him. May he now find peace and comfort in the presence of our Heavenly Father.

Monsignor McGinn was born to Philip McGinn and Elizabeth Cleary on May 2, 1931 in Corravacan, Co. Monaghan, Ireland. He attended Elementary School at St. Mary in Rockcorry, Co. Monaghan, Ireland. His college days were spent at the Salesian Colleges in Pallaskenry, Co. Limerick and Ballinakill, Co. Leix. He then went on to the seminary at the Salesian Novitiate, Burwash, Sussex, England, the Salesian House of Philosophy and Immaculate Heart Seminary in San Diego.

He was ordained by the Most Reverend Charles F. Buddy, Bishop of San Diego on March 17, 1961. He served in several parishes in the San Diego Diocese from 1961-1972. From 1972-1974 he was assigned as pastor at Blessed Sacrament in Twentynine Palms. In 1974 he served at Our Lady of the Assumption in San Bernardino until 1981, when he became pastor at St. Margaret Mary in Chino. His assignment at St. Theresa in Palm Springs began in 1985, where he served until his death.

Monsignor was very instrumental during the establishment of the Diocese of San Bernardino in 1978 when we split from San Diego. He served on many committees during this transition and was always available and eager to help. His outstanding insight and knowledge was invaluable to Bishop Straling during this time.

During his years of service here in the Diocese of San Bernardino, he was very involved with many ministries and programs within the parishes. He enjoyed life

to its fullest and was very devoted to God and his parish family, as well as his own family, many of whom are in Ireland. His love and concern was very evident in working with young people. Several of the parishes where he served had schools and the children were always by his side as his great sense of humor and caring came across to everyone, young and old alike. He will be missed very much by his fellow priests, religious sisters, parishioners, as well as all who knew and loved him. His warm and gentle manner will be remembered by all.

The Vigil Service will be held on Tuesday, December 16th at 7:00 p.m. at St. Theresa in Palm Springs. I will celebrate his Funeral Mass at 11:00 a.m. on Wednesday, December 17th at St. Theresa's. Monsignor Philip A. Behan, his very close friend, will be the homilist. Burial will be in Ireland.

In our prayers we will remember Father Malachy with great affection and esteem and although he is not in our midst, we have many fond memories of him and we will greatly miss him.

Please remember Father Malachy with the customary three Masses of suffrage for a Brother Priest.

Dear Father McGinn:

This is to confirm the information I gave when you phoned me yesterday.

We expect the Court to fix the inheritance tax on July 18th, after which it will be paid. Soon thereafter we will file a final account and expect it to be heard on August 15th or August 22nd. At that hearing the Court will make an order of distribution, and the executor will then send out the checks.

The executor expects there will be about \$160,000.00 to be distributed, but she intends to ask the Court for authority to withhold \$2,000.00 from distribution at this time on the possibility that the federal government might decide some additional taxes are due. So the distribution in August to THE ROMAN CATHOLIC BISHOP OF SAN BERNARDING for OUR LADY OF ASSUMPTION CHURCH will be approximately \$79,000.00, and the other \$79,000.00 less the inheritance taxes charged against them will be divided equally between Mrs. Tilson and Mrs. Priddy.


When the federal government gives clearance, any unused portion of the \$2,000.00 will be divided one-half to THE ROMAN CATHOLIC BISHOP etc., and one-half in equal shares to Mrs. Tilson and Mrs. Priddy.



You will actively participate in the meetings of the Diocesan Presbyteral Council and meet occasionally with your brother vicars. In this way, you can assist in the ongoing pastoral ministry of the diocese.

The first Presbyteral Council Meeting will be held on Tuesday, December 10, 1991 at 10:00 a.m. at Our Lady of the Valley in Hemet. I also look forward to meeting with you and the other vicars that evening for dinner. I ask that you make suitable arrangements for the Vicariate Meetings which are scheduled for the next year, 1991-92.

I am enclosing extracts from the Code of Canon Law on what the church envisions as the role of Vicar Forane, as well as some extracts from our own particular law which I hope will give you some idea of your responsibilities. 

Dear Father McGinn:

This is a follow-up to our meeting of December 16, 1988 with Father Paul Murtaugh, SS.CC., Father Tony Timlin and Monsignor Frank Nightengale, regarding the foundation of a parish in the 1000 Palms area. We also had the assistance of Mr. Walter Hill, a Real Estate agent from the vicinity, who assisted us with maps and other pertinent information regarding the 1000 Palms community.

I have received many inquiries about the foundation of a parish from people living in the 1000 Palms area and, after reviewing the growth status on both sides of Interstate 10 near 1000 Palms, it is my contention that we need to plan for a new parish community there.

As a result of our discussion, the following items were agreed to:

1. Under your leadership, a survey will be undertaken to ascertain the number of Catholic living in the 1000 Palms area, as well as where they are presently attending Mass. This report should be completed by June 30, 1989. I forsee that, if we establish a basis for ministry and service in that area, a first stage of parish foundation can begin in September or October of 1989. A parish coordinator would initially be assigned there on a part-time basis, with eventual full time work, to begin the organization of a new parish community. The role of the parish coordinator would be to organize the people, begin to build community idenity, provide such basic services as religious education and other instructions. Arrangements for the celebration of Sunday Eucharist for the area in a public or private building would be coordinated. In the beginning, this

coordinator would need to be subsidized, but, after a number of months, the community should be able to provide the salary and basic operating expenses. Once it is seen that the community is well enough advanced, it could be formally designated as a parish. The initial work of the coordinator would be supervised/moderated by one of the local pastors and I would suggest St. Theresa's or Sacred Heart Parishes as the logical choices. The new community would be considered a mission of that parish.

Father Bob Buchanan in Corona is beginning a project of this nature in the community of Cerritos. I have also asked Father Gerry DeLuney to begin such a community in the Pigeon Pass Road area of Moreno Valley. You may wish to contact them, regarding process and the progress that they have made.

2. We also discussed at our meeting the obtaining of acreage for a future parish. Some suitable property might be available around the Ivy Ranch. This would be centrally located, not only for 1000 Palms, but central to many other parts of that area, even to Indio. I believe it was Father Timlin, who had contacts with the people in Ivy Ranch, who might possibily donate property or help us obtain land at a very reasonable cost. It is my understanding that Mr. Walter Hill will also assist us with this and, in the next few months, may have some initial information as to what can be done regarding property. It would be good to begin with 20 acres, as this would give additional land that might be designated for some other purpose, or possibily sold to help defray expenses. The ordinary working area of a new parish plant should be 10 acres, centrally located to the total community to be served, and be accessible from freeway and other main access roads.

I appreciate your willingness to follow up on this project, along with Father Tony Timlin, Monsignor Frank Nightengale and Father Paul Murtagh. Father Bob Clover might also be invited to be a part of this team, seeing that as establishment of a parish in the Ivy Ranch area will have some effect on his parish community.
