Note: These publicly available archives were gathered by BishopAccountability.org. Some archives contain priest files that vary in completeness. For example, the archive released by the Archdiocese of Los Angeles under the nonmonetary terms of the 2007 settlement includes a priest file totaling 903 pages. But only 21 priest files in the archive are larger than 200 pages, and 37 files comprise only 2 or 3 pages. None of the files is likely complete. Document production has been reluctant and privilege claims have been expansive. Nearly all the archives have been redacted, some of them heavily. Sometimes the archives are complementary. For example, the 2,397-page LA archive filed with the court is much less heavily redacted than the archive released by the archdiocese. California is well-represented in this library of archives. BishopAccountability.org has in its library many archives not summarized in this spreadsheet, including materials on celibacy, survivor activism, and key cases in Pennsylvania and Texas. We have also archived investigative reports and diocesan lists of accused that complement the archives listed above. This list was last updated on April 15, 2020.
