This information is an excerpt from the file of [REDACTED] [REDACTED]. The following comes from the deposition by Simons, Cuddy, & Friedman, Attorneys at Law.

ALLEGATIONS OF ABUSE

[REDACTED] first met Griego at University Pool at Highlands when he was thirteen years old (1975). Griego was at Our Lady of Sorrows. [REDACTED] wanted to get closer to God and could read well aloud, so became a lector. He had to report to Griego before mass and practice his reading of the verses in the rectory. He remembers a study, the priest's room, the dining room and the kitchen in the rectory. He doesn't remember ever eating there with Griego.

[REDACTED] thinks Griego took the trailer to Las Vegas when he moved there. He doesn't know if there was sex with [REDACTED] and [REDACTED], but knows that Griego did give them money, and take them to nice places to eat, such as the Japanese Kitchen and the Cooperage,

Griego convinced [REDACTED] mom sometime during the eleventh grade that he had to come to Albuquerque because he had outgrown his hometown. Griego intimated that if [REDACTED] didn't move to Albuquerque, everyone in Las Vegas would find out about their sexual relationship. [REDACTED] moved to Albuquerque [REDACTED] and live with Griego. He didn't do well in high school and was suspended for having too many absences. When he refused to have sex with Griego anymore, he claims Griego kicked him out of the rectory. He then went to live with his Aunt [REDACTED] and uncle in Albuquerque, so he could finish high school.

Griego was mad, sad, and disappointed when [REDACTED] no longer wanted to have sex with him. Other priests who [REDACTED] remembers seeing at the rectory were Luis Jaramillo and Fred Luna. He feels these two probably knew about the relationship between Griego and [REDACTED]

The gossip in Las Vegas is that Griego got in trouble for sex acts at Our Lady of Sorrows. [REDACTED] heard that Griego was treated for pedophilia in 1976 and feels that the Archdiocese is responsible, as they never should have let him go back to being a priest.

Griego was always very friendly. [REDACTED] didn't suspect anything until Griego started touching his knee. The touching of knee progressed to fondling, kissing, oral sex, mutual masturbation and anal sex. Griego constantly told [REDACTED] that the sex was right in the eyes of God. Griego made [REDACTED] feel very special and called him "funny face."

performed anal sex on Griego one time in Albuquerque, but felt degraded by the experience. [REDACTED] remembers ejaculating on several occasions and remembers Griego ejaculating. Griego abused [REDACTED] from ages 13 through 19 (1975-1981).

Sabine began [REDACTED] drinking at age 13. He drank a lot between 16 and 17. He would drink the leftover wine, and if there were, for instance, three weddings in one day, he would go home drunk. He and Griego would get drunk together. They would drink wine and fancy beer. [REDACTED] and [REDACTED] would often go with them. They would go out to eat at Pizza Hut and have pizza and beer.

Since that time, he has had a drinking problem and thinks he will always have it. He used to also do drugs with Griego. While in the eighth grade, he smoked pot with Griego. He smoked pot with a friend, [REDACTED], in the tenth grade. [REDACTED] usually had drugs. Father Griego used to provide pot to the boys. He tried cocaine with another priest in Albuquerque with [REDACTED], but doesn't remember who the priest was. Since then, he has used cocaine and mushrooms. He buys them and does them with friends. All this time, Griego was giving him money and he was buying the drugs with the money Griego was giving him. He had a fake I.D. [REDACTED] made it for him with false baptismal certificates Griego gave [REDACTED], so that they could all have fake I.D.'s. 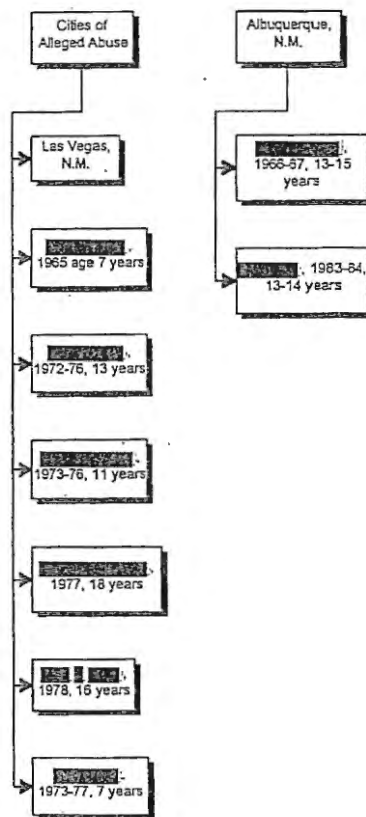

me on trips to Albuquerque including trips to visit Archbishop Sanchez. And once on the way to have lunch with the Archbishop at the hotel owned by the Maloofs. He also abused me in an Albuquerque motel. Mostly, he abused me at the Queen of Heaven rectory.

- d. Fr. Griego took boys to the State Tournament one year from Queen of Heaven, and he would give me and others alcohol and probably drugs hidden in the alcohol. The most messed up, drunk or drugged boy would have to sleep with Fr. Griego alone in a room. It could have been any one of us.
- e. Fondling, forced masturbation, oral and anal rapes
- f. There were numerous times that Fr. Griego abused me, and I don't know a number.

Interrogatory No. 11: State specifically and in detail the facts upon which plaintiff's contention is based that the alleged abuse was caused by any negligent conduct on the part of the defendants.

Answer:

I have no personal knowledge of Defendants' specific conduct other than seeing as a kid, that it was okay for the Archbishop that Fr. Griego was taking us boys out to restaurants and giving us alcohol and having us all sleeping in the rectory. Archbishop Sanchez met Fr. Griego and I for lunch at the classic Hotel one day where it was clear I was the 'boy toy' for the priest.

SETTLEMENT AGREEMENT AND RELEASE

THIS SETTLEMENT AGREEMENT AND RELEASE (hereafter "Agreement") is entered into this 7th day of April, 2015 by and between [REDACTED] and the Roman Catholic Church of the Archdiocese of Santa Fe, a corporation sole and San Francisco de Asis Parish (collectively, the "Archdiocese") ([REDACTED] and the Archdiocese to be hereafter collectively referred to as the "Parties"), in order to bring the matter in controversy between the Parties to a full and complete settlement.

RECITALS

WHEREAS, [REDACTED] has made certain claims against the Archdiocese for personal injuries arising from incidents alleged to have taken place in New Mexico in a lawsuit styled *John Doe I v. Archdiocese of Santa F, et al.*, No. [REDACTED] in the Second Judicial District Court, County of Bernalillo, State of New Mexico (the "Lawsuit");

Ms. Kennedy:

As you know, the trial dates set in a number of our cases against the Archdiocese are rapidly approaching. As you also know, the precedent set by any one of these trials will be publicly damaging to the Archdiocese, will set the tone for subsequent trials and will expose the Archdiocese to large judgments which the Archdiocese cannot afford to pay.

As you have now completed your investigation of our client's claims and damages in the above-entitled case and are aware of the overwhelming evidence of the Archdiocese's negligence that we have accumulated to date, our client has authorized us to afford the Archdiocese with a one-time opportunity to resolve our client's claims against the Archdiocese, thus avoiding further litigation expense and the likelihood of a large jury verdict.

This is a case involving the sexual molestation of our client, [REDACTED], by Father Sabine Griego and by Father John Esquivel. The sexual molestation by Father Griego and Father Esquivel began in 1978 when [REDACTED] was 17 years old. The abuse suffered by [REDACTED] at the hands of Father Griego included touching, fondling, kissing and the administration of drugs such as cocaine and alcohol. Father Griego introduced [REDACTED] to Father Esquivel who forced [REDACTED] to masturbate in front of an individual in the pornographic movie industry. Following this four-year period of sexual and substance abuse perpetrated on [REDACTED] [REDACTED] lapsed into a manic depressive state and began a lifetime of alcohol and cocaine addiction. [REDACTED] is still severely depressed and is currently being treated by a therapist in Albuquerque, New Mexico.

We have evidence that Archbishop Robert Sanchez knew of Father Griego's sexually deviant propensities at least as early as 1976 when another incident of sexual molestation was reported to the Archbishop by a priest in Las Vegas, New Mexico. No action to restrict Father Griego's access to children such as [REDACTED] was taken by Archbishop Sanchez.

As you know from the decisions of other judges hearing these cases, the Archdiocese will not be successful with any defense based upon the statute of limitations as applied under New Mexico law because [REDACTED] only recently came to understand the nature of the violation he suffered from the abuse perpetrated by Father Griego and Father Esquivel and how it damaged his life.

We have commissioned the completion of a Vocational Impairment and Loss of Pleasure of Life Evaluation by Patricia A. Murphy, Ph.D, CRC, LPCC, Diplomate, American Board of Vocational Experts, and a Loss of Enjoyment of Life Evaluation by John Myers, Ph.D, Forensic Economist, concerning a portion of the damages suffered by our client as a direct result of the sexual molestation perpetrated by Father Griego and Father Esquivel. A copy of these evaluations are enclosed. These evaluations do not account for the damages a jury could award for pain and suffering, nor do they account for the cost of medical, psychological or rehabilitation services.

The minimum value of [REDACTED] claims is in excess of [REDACTED]. In view of the evidence of the Archdiocese's negligence amassed through discovery to date, a New Mexico jury will likely award compensatory damages in excess of this amount.

In order to facilitate the immediate resolution of our client's claims against the Archdiocese before we proceed with additional discovery and trial preparation, our client is willing to substantially discount the value of his claims and will accept the sum [REDACTED], in cash, for a full and complete release of the Archdiocese of Santa Fe against any further liability to our client.

This discounted offer of settlement shall expire automatically at 5:00 p.m. on Monday, February 20, 1995. Full



This letter is to inform you of a case of sexual abuse which occurred in Bernalillo County. The alleged perpetrators were Fr. Sabine Griego and Fr. Arthur Perrault. Fr. Griego's address is [REDACTED]. Fr. Perrault's address is unknown. The alleged victim is Mr. [REDACTED], born [REDACTED].

The following is excerpted from Steven Tinkler, Esq.:

"The reading of [REDACTED]'s sworn statement reveals that he was sexually abused by Father Sabine Griego on a regular basis from 1982 to 1987. Fr. Griego engaged in all forms of sexual abuse with [REDACTED] and even introduced him to Fr. Arthur Perrault so that the two of them could sexually abuse [REDACTED] together. [REDACTED] was sexually abused by Fr. Perrault from approx. December 1982 through December 1986."

Father Sabine Griego was pastor at Queen of Heaven Church from 1979 until 1991. His faculties were restricted in 1993. Father Arthur Perrault served at St. Bernadette Parish from 1981 until 1992. His faculties were restricted in 1992.

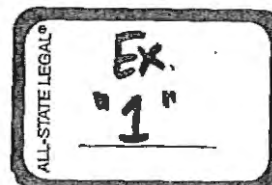



The Votum of Archbishop Michael J. Sheehan
Regarding Rev. J. Sabine Griego

Although the accusations against Rev. J. Sabine Griego occurred prior to April 30, 2001, and prescription is present in all of the allegations, Rev. Griego merits serious consideration for a process to dismiss him from the clerical state.

First, there is the sheer volume and heinous nature of the accusations. Seventeen victims, all but one boys, are listed. The detailed information is enclosed. These victims, even though they received counseling and financial recompense from the Archdiocese of Santa Fe, will have to live with the trauma of their experiences for a lifetime, let alone the suffering incurred by their families and loved ones. As the Archdiocesan Review Board agreed there was substance to the allegations, they certainly had occurred.

Particularly abhorrent is the case of the female victim, [REDACTED], who was nine in 1990 at the time of the alleged abuse. She indicated that she endured vaginal, oral and anal sex from the accused. The current rules for prescription would in fact allow for a criminal action still to be brought by this victim, the spirit of the present rule ought to encompass the rights of this then child.

Also, the faithful of the Archdiocese of Santa Fe suffered irreparable damage due to the actions of the accused. The total payments in reparation to the victims has approached \$3,000,000. The faithful willingly sacrificed to provide monies so that these costs might be met without having to plunge the Archdiocese into bankruptcy. It must be noted that the Archdiocese is basically poor as the people of New Mexico do not make large salaries. Yet, through their pastors, they were willing to give from their need to provide for the good of the local Church.

Further, the damage to the people of God of the Archdiocese caused by the accused is profound. Even though the faithful have continued and have even grown in their faith, the scandal and hurt is deep and never will be totally overcome.

The accused scarcely is living a life of "prayer and penance" as outlined in Norm 8B of the *Essential Norms* of the United States Conference of Bishops. As indicated, he receives monthly retirement benefits from the Archdiocesan Priest Relief Fund and total medical coverage. There is not even any indication that the accused acknowledged his crimes or that he has in any way even attempted to "have withdrawn from contumacy (contempt)" as illustrated in Canon 1347.

Penalties can be expiatory. Such penalties can remedy the societal damage done by the delict and deter others from similar behavior. The injury done to the victims and their families, the financial burden placed on the faithful of the Archdiocese, the spiritual damage inflicted on the same faithful, all of these postulate the most serious penalty so that justice can be restored and, to some extent at least, scandal be repaired (see Canon 1341). Simple suspension, or use of Canon 223, § 2, does not begin to do justice to the crimes involved. Further, if this expiatory penalty is not imposed, the impression will remain that others, or even the accused himself, can continue in this misconduct while the people of God and the victims will pay the price.

There is another urgent issue. He is presently only 66 years old. The Archdiocesan attorneys strongly suggest that the possibility of dismissal from the clerical state be sought in this case. Restrictions short of this may hold the Archdiocese open to further civil action. There is a strong possibility that the accused will, in fact, continue his behavior. Certainly the presence of Canon 223 § 2 however strong it may be worded, may not be adequate to protect the assets of the Archdiocese. Only dismissal from the clerical state can provide the complete severance necessary for such protection.

For all these reasons: the numerous and serious delicts, the spiritual and emotional trauma of the victims and their families and friends, the financial and spiritual damage to the faithful, the seeming indifference on the part

of the accused, the need to provide justice to the victims and the faithful, the need to deter further misconduct, and the protection of the Archdiocesan assets, I am requesting that this case be accepted by the Congregation for the Doctrine of Faith.


Further, I am asking for ex-officio dismissal of the accused from the clerical state. If this is not possible, I request that the case be permitted to be treated under the summary process of Canon 1720. (Sacramentorum Sanctitatis Tutela, Decisions Subsequent to Promulgation, Article 17).

In the same document of February 7, 2003, the "faculty [is] granted to the CDF to dispense from the requirement of priesthood and the requirement of a doctrine in canon law mentioned in art. 8 (judges), 9 (promoter of justice), 10 (notaries and chancellors), 11 (advocates and procurators), 12 (judges, promoters of justice, notaries, patrons in other tribunals)." This dispensation is only to be granted to persons who hold a licentiate in canon law and have worked for a reasonable time in ecclesiastical tribunals.

Currently, our Archdiocese has three priests with licentiates in Canon Law: Rev. Kevin Niehoff, OP; Rev. Jerome A. Martinez, also the diocesan Promoter of Justice; Rev. Jerome A. Plotkowski, Judicial Vicar. Reverends Niehoff and Plotkowski have not only worked in the Archdiocesan Tribunal for many years, they also have been Judges in Second Instance in a complex Penal Case involving dismissal from the clerical state. Rev. Martinez has worked in the Tribunal as well, and as Promoter of Justice, has been involved in penal matters. I ask for the required dispensation for these three priests, should there be a need for them to act in any capacity in this cause.

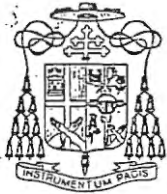



I am writing this letter on behalf of Fr. Sabine Griego, a priest in good standing in the Archdiocese of Santa Fe, New Mexico, USA.

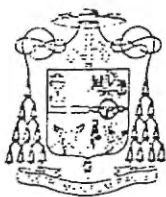

I am aware that this restriction may be difficult for you to accept. I have a pastoral and canonical concern for your welfare. You know that I stand ready to assist you in any way possible. However, I do have a mandate to safeguard the common good of the Archdiocese. I must never lose that focus. It is in such a context that this action is taken. Thank you for understanding.

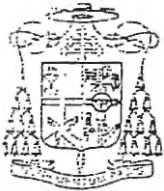



My most sincere well wishes to you as we celebrate this year's Holy Season and Resurrection of Our Lord.

Pursuant to your letter of March 2, 1994 announcing to us who are on leave that you can only subsidize our income with \$4,000.00 due to the financial situation of the Archdiocese, I am writing you this letter. In my situation after the insurance premium is deducted, the subsidy amounts to only \$183.00.

I understand the dilemma we are in financially in the Church today. I would like to request from you at this time to allow me to go into a Retired Status so that I can begin to draw from the Archdiocesan Priests Relief. I have spoken to Fr. Doug Raun and I qualify for the lowest retirement of \$1,000. I have been a priest for 30 years; my anniversary is this month.

I have tried to supplement my income by seeking professional jobs that would be compatible to my education. But I am sure that it will take some time before finding something I qualify for. If I receive my retirement, I can receive other income from menial jobs with a more reduced income.

I come from a very poor family. My mother and I have no other resource. She is going to be 82 in July and in need for me to care for her more and more. I intend to spend my time being by her in her need.

At this time I also wish to state my intention that I do not wish to be considered for Laicization. I intend to live out my vows of Celibacy, Obedience and the daily recitation of the Divine Office. I need the Eucharist for my own personal sanctification, so I celebrate it daily alone.

Please consider my request and allow me to enter into a retirement beginning this month of May. Thank you for your kind consideration and support.

The Votum of Archbishop Michael J. Sheehan
Regarding Rev. J. Sabine Griego

Although the accusations against Rev. J. Sabine Griego occurred prior to April 30, 2001, and prescription is present in all of the allegations, Rev. Griego merits serious consideration for a process to dismiss him from the clerical state.

First, there is the sheer volume and heinous nature of the accusations. Seventeen victims, all but one boys, are listed. The detailed information is enclosed. These victims, even though they received counseling and financial recompense from the Archdiocese of Santa Fe, will have to live with the trauma of their experiences for a lifetime, let alone the suffering incurred by their families and loved ones. As the Archdiocesan Review Board agreed there was substance to the allegations, they certainly had occurred.

Particularly abhorrent is the case of the female victim, [REDACTED], who was nine in 1990 at the time of the alleged abuse. She indicated that she endured vaginal, oral and anal sex from the accused. The current rules for prescription would in fact allow for a criminal action still to be brought by this victim, the spirit of the present rule ought to encompass the rights of this then child.

Also, the faithful of the Archdiocese of Santa Fe suffered irreparable damage due to the actions of the accused. The total payments in reparation to the victims has approached [REDACTED]. The faithful willingly sacrificed to provide monies so that these costs might be met without having to plunge the Archdiocese into bankruptcy. It must be noted that the Archdiocese is basically poor as the people of New Mexico do not make large salaries. Yet, through their pastors, they were willing to give from their need to provide for the good of the local Church.

Further, the damage to the people of God of the Archdiocese caused by the accused is profound. Even though the faithful have continued and have even grown in their faith, the scandal and hurt is deep and never will be totally overcome.

The accused scarcely is living a life of "prayer and penance" as outlined in Norm 8B of the *Essential Norms* of the United States Conference of Bishops. As indicated, he receives monthly retirement benefits from the Archdiocesan Priest Relief Fund and total medical coverage. There is not even any indication that the accused acknowledged his crimes or that he has in any way even attempted to "have withdrawn from contumacy (contempt)" as illustrated in Canon 1347.

Penalties can be expiatory. Such penalties can remedy the societal damage done by the delict and deter others from similar behavior. The injury done to the victims and their families, the financial burden placed on the faithful of the Archdiocese, the spiritual damage inflicted on the same faithful, all of these postulate the most serious penalty so that justice can be restored and, to some extent at least, scandal be repaired (see Canon 1341). Simple suspension, or use of Canon 223, § 2, does not begin to do justice to the crimes involved. Further, if this expiatory penalty is not imposed, the impression will remain that others, or even the accused himself, can continue in this misconduct while the people of God and the victims will pay the price.

There is another urgent issue. He is presently only 66 years old. The Archdiocesan attorneys strongly suggest that the possibility of dismissal from the clerical state be sought in this case. Restrictions short of this may hold the Archdiocese open to further civil action. There is a strong possibility that the accused will, in fact, continue his behavior. Certainly the presence of Canon 223 § 2 however strong it may be worded, may not be adequate to protect the assets of the Archdiocese. Only dismissal from the clerical state can provide the complete severance necessary for such protection.

For all these reasons: the numerous and serious delicts, the spiritual and emotional trauma of the victims and their families and friends, the financial and spiritual damage to the faithful, the seeming indifference on the part

of the accused, the need to provide justice to the victims and the faithful, the need to deter further misconduct, and the protection of the Archdiocesan assets, I am requesting that this case be accepted by the Congregation for the Doctrine of Faith.


Further, I am asking for ex-officio dismissal of the accused from the clerical state. If this is not possible, I request that the case be permitted to be treated under the summary process of Canon 1720. (Sacramentorum Sanctitatis Tutela, Decisions Subsequent to Promulgation, Article 17).

In the same document of February 7, 2003, the "faculty [is] granted to the CDF to dispense from the requirement of priesthood and the requirement of a doctrine in canon law mentioned in art. 8 (judges), 9 (promoter of justice), 10 (notaries and chancellors), 11 (advocates and procurators), 12 (judges, promoters of justice, notaries, patrons in other tribunals)." This dispensation is only to be granted to persons who hold a licentiate in canon law and have worked for a reasonable time in ecclesiastical tribunals.

Currently, our Archdiocese has three priests with licentiates in Canon Law: Rev. Kevin Niehoff, OP; Rev. Jerome A. Martinez, also the diocesan Promoter of Justice; Rev. Jerome A. Plotkowski, Judicial Vicar. Reverends Niehoff and Plotkowski have not only worked in the Archdiocesan Tribunal for many years, they also have been Judges in Second Instance in a complex Penal Case involving dismissal from the clerical state. Rev. Martinez has worked in the Tribunal as well, and as Promoter of Justice, has been involved in penal matters. I ask for the required dispensation for these three priests, should there be a need for them to act in any capacity in this cause.

I appreciate your attention to this very serious matter and ask for your assistance as promptly as possible.

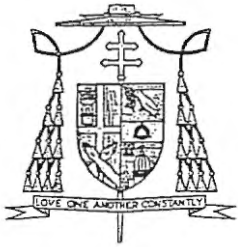

Dear Sabine,

This is a follow-up to our phone conversation the other day regarding the decision of the Congregation for the Doctrine of the Faith in Rome. I am enclosing the decree signed by the Prefect of the Congregation informing us that Pope Benedict XVI has given you laicization. The enclosed unofficial translation of the Latin document is made available to you. I would ask that you please sign the Latin document on the bottom left hand side of the back page, make a copy for yourself and send the original back to me.

The decree gives stipulations regarding your official status urging you to take part in the life of the Church as a lay person and the Dallas Charter that was adopted by the Bishops and approved by Rome urges you to live a life of prayer and penance for the reasons that moved the Church to laicize you.

You will continue to receive your pension and have health insurance, but not the long-term health insurance. Let us pray for one another and for priestly and religious vocations.



Griego refused the letter and it was returned to my office. I have enclosed a copy of the envelope. I did inform him by phone as well. I have also had to write to two priests of the Archdiocese informing them that Griego has been laicized (copy enclosed). I did this because I had received information that Griego continued to offer Masses publicly after he had been notified of his laicization.

At this point I want to completely close my records regarding this matter and thought it would be prudent to communicate with you this last time about its status. There was no mention of a taxa in your correspondence regarding this matter. Please advise as to what the taxa is and I follow through.
