
RE: Disclosure Statement *In re: Archbishop of Agaña, a Corporation Sole*,  
Case No. 19-00010, District Court of Guam Bankruptcy Division

Your Excellency,

You have asked our office, in joint effort with your Bankruptcy counsel, to assist the Archdiocese of Agaña (“AOA”) in fulfilling its obligations under Provision A of the non-monetary commitments set down in Bankruptcy case 19-00010 before the District Court of Guam.

As you recall, the AOA faced nearly 300 claims brought in civil lawsuits for sexual abuse covering the period of 1950 through 2015. The lawsuits were settled before the Court on June 20, 2023. Part of the Archdiocese’s obligation to the settlement involves a commitment to transparency where the AOA will “... post on its website home page the names of all known past and present perpetrators of the Archdiocese who are identified in the Complaints for Damages as child sexual abusers.” This contractual provision requires that the list includes all names of any individual connected to the AOA who was named in a civil complaint, and not just those individuals who may have credibly been found to have committed abuse. Those names and the associated case numbers appear at the end of this correspondence. The list was generated following a review of civil complaint summary records compiled by the AOA. If you have any questions, or would like to discuss the matter further, please do not hesitate to contact our office.
