Wanted priest talked of fleeing country

Warrant issued in sex charges

CHULA VISTA — A priest who has a warrant out for his arrest on alleged child molest charges recently asked an assistant bishop at the Diocese of San Diego what would happen if he fled the country for the Philippines.

The Rev. Steven Callahan, assistant to the bishop, said he met on Nov. 5 with Emmanuel Obillang Omemaga, a former priest with a Chula Vista church, and told Omemaga he didn't know if authorities would seek to extradite the priest if he left for the Philippines, his native land.

Police and church officials still don't know the whereabouts of the former Chula Vista priest who allegedly seduced and had sexual relations with a 14-year-old girl who was a member of his congregation.

The allegations against the priest came when the mother of the victim contacted the San Diego Diocese and police after she found a love letter from her daughter to Omemaga.

Police said the girl and the priest had a two month sexual relationship which started after he allegedly made sexual advances toward her while on a trip to visit the Pope in Denver, Colo., for an event called "World Youth Day 1993."

The priest brought the girl to motel rooms and took 37 photos of her in erotic positions, police said. The pictures were found in one of the priest's jacket pockets in his Lakeside rectory.

Callahan said he informed the priest he had legal and moral reasons to stay in this country and he must contact Chula Vista police detectives who are investigating the case. The bishop's assistant then told Omemaga he needed to "take this one step at a time," Callahan said.

"The sense I had was that he was totally panicked," Callahan added.

Omemaga met with Callahan after his return from the Philippines, where he was sent to inform his bishop of the legal matter. Since Callahan's meeting with Omemaga, neither he nor an attorney whom Omemaga also met with on Nov. 5 have heard from the former pastor of The Church of the Most Precious Blood.

"He was very upset," Callahan said. "He was really scared and frightened at what the possible consequences could be."

Callahan said he told Omemaga there would be no advantage to his going back to the Phi-

ippines and that he wouldn't be able to function there as a priest if the accusations proved valid.

"I told him in the long run it would be worse," he said. "It wouldn't make his problems go away."

Omemaga, 35, returned nearly two weeks ago from meeting with his bishop in the Philippines. Although directed by the bishop of the Diocese of San Diego to stay in town and contact police, Omemaga hasn't yet followed orders.

Chula Vista Police Sgt. Mike Becker said the District Attorney's Office issued a warrant for his arrest Monday. Omemaga will face child molest charges if found and arrested, Becker said. So far, no other victims have contacted the department.

Because Omemaga is most likely a Filipino citizen, chances are it wouldn't be too difficult for him to leave the country unless he is caught or someone recognizes him and turns him in, Becker said.

Ordained in 1983, Omemaga has also neglected to contact officials at a Lakeside church where he last served.

Monsignor Neal Dolan, who serves at Our Lady of Perpetual Help Catholic Church in Lakeside, said he thought Omemaga had gone on vacation when he left on his trip for the Philippines. Omemaga had served at the church for a little more than a month after being transferred from Precious Blood as part of a routine transfer.

According to a news release from the Diocese of San Diego,

Omemaga was on temporary loan to the San Diego Diocese. He belongs to and is under the authority of the Diocese in the Philippines. On Oct. 8, Omemaga surrendered his faculties to function as a priest pending further investigation.

When a priest surrenders his faculties, he no longer will function as a priest, although he will never cease to be one, said Mark Brumley, director of communications for the Diocese of San Diego.

If arrested and then tried and accused, Omemaga could suffer the same civil punishment anybody else would who committed such a crime, Brumley said.

Callahan, who said Omemaga was given permission to serve in San Diego by his bishop in the Philippines, said there have been no prior allegations, including in the Philippines. Omemaga told Callahan he had never been involved with a minor previously.

"He seemed sorry, he seemed devastated about what he did," Callahan said.

The Diocese of San Diego has also contacted Filipino priests, who were "stunned by the news," Callahan said. But no one there has heard from him either, he added.

Callahan said he told Omemaga that the family didn't plan to file charges but instead wanted him to seek professional help. Omemaga, however, seemed afraid the family was going to have a change of heart.

Callahan told Omemaga that he didn't know what was going to happen, but if he cooperated, it "would lead to the best outcome."

Wanted priest talked of fleeing country

Allegations hit church like loss 'in your family'

CHULA VISTA — Some members of The Most Precious Blood Catholic Church couldn't help but feel they lost a part of their family this weekend.

"I really felt bad when I read it. It really hit home. When I read about it going on in other places, I don't think about it much, but this really hits home. It's my own church and when something bad hits it like something terrible happened in your family," a churchgoer said.

Filled with shock and disbelief, the Chula Vista parish is still reeling from news about allegations of sexual misconduct against a former leader.

"You could have knocked me over with a feather when I heard about it," said a parishioner who wished to remain anonymous. "We really can't believe it, he was so well-liked. He was really great with the whole community and ever since he came here he was really outgoing. We're all just devastated"

Emmanuel Ojilang Omemaga, 35, a Catholic priest who formerly served at Precious Blood, is sought by police for allegedly engaging in a sexual relationship with a 14-year-old female church member.

The priest allegedly began seducing the girl while on a trip to see the Pope in Denver this summer. Sexual contact, however, is not believed to have taken place on the trip.

A mother, whose 18-year-old daughter was also on the trip, said her daughter was called to the church early Saturday morning for a meeting regarding the incident.

Both mother and daughter and all who were interviewed would only speak on the grounds they remain unidentified.

The 18-year-old, who is very involved in church activities, reported that Omemaga had taken off quite a bit while on the trip, apparently on sightseeing excursions.

Both mother and daughter said there were three chaperones and two other adults accompanying the group. They were together on the bus all the time, the mother said.

The announcement was first made to the congregation in a Saturday evening service after the story appeared in the *Star-News*.

"Everyone just looked around and their mouths dropped," the mother said referring to another church announcement made Sunday morning. "One lady beside me, her eyes started to fill with tears."

"What we saw, what was written in the paper, we couldn't believe it," said another church member. "I'm not saying it couldn't happen, they're only human. Everyone that I know is shocked."

"Father Eman," as he is known to the church community, was well respected for his service to the parish. Just before he was transferred to a Lakeside church in late September, he was honored at a parish dinner. "There were gifts that were bought for him and he sang a song and it was really touching," said one

member.

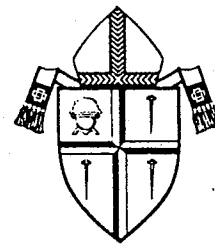
"Father Eman would come up to you after mass and say hello, he'd especially encourage the youth. He'd put his arm around them and give them a hug and say what a good job they did," one parishioner recalled.

Not wanting to see one of their favorite priests reassigned to another location, earlier this year a petition was circulated requesting that the Bishop keep Omemaga at the South Bay parish.

"We really wanted Father Eman because he had made such an impression. His masses were really inspiring and we felt good about what he was saying," said a member.

"I saw this picture in the *Star-News* and I knew I knew him. I knew his face, but I didn't recognize his name because we just call him Father Eman," said a longtime churchgoer.

Of the church members interviewed, no one has seen or heard from Omemaga since Sept. 26 when he celebrated his last mass services at Precious Blood.

Statement Concerning Fr. Emmanuel Omemaga

Emmanuel Omemaga, a 35-year-old priest temporarily on loan to the Diocese of San Diego from the Philippines, is being investigated by the Chula Vista Police Department regarding an accusation of having had a sexual relationship with a teenage girl.

When this allegation was brought to the attention of the Diocese, Bishop Brom responded promptly. On Friday, October 8, Fr. Omemaga surrendered his faculties to function as a priest pending further investigation. Furthermore, pastoral and professional assistance were offered to the girl involved.

Fr. Omemaga traveled to the Philippines to inform his bishop of this matter. When he returned to San Diego last week, Fr. Omemaga contacted Fr. Steven Callahan, Assistant to the Bishop, who conveyed the Bishop's directive that Fr. Omemaga remain in San Diego and that he contact the Chula Vista Police Department.

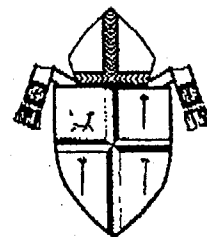
The Diocese is cooperating fully with the police investigation, but does not know the whereabouts of Fr. Omemaga.

Priest is sought by police in sex case

His whereabouts called unknown

CHULA VISTA — Parishioners at the Church of the Most Precious Blood here reacted with surprise and sadness yesterday after learning that a former associate priest at the church is being sought for questioning about possible sexual misconduct with a teen-ager.

The Rev. Emmanuel Omemaga, a 35-year-old priest on temporary loan to the Roman Catholic Diocese of San Diego from the Philippines, has been asked to contact Chula Vista police in connection with the accusations, according to a statement issued by the diocese.

However, he has not yet done so, and church officials say they do not know his whereabouts.

The allegations involve an underage girl who is a member of the Chula Vista congregation.

Omemaga had been an associate priest at the 4th Avenue church for about a year, said the Rev. Frank Wagner, the current parish priest.

Omemaga stepped down from his duties in the San Diego Diocese about a month ago, after the accusations surfaced, Wagner said.

But the church only officially released information about the investigation yesterday, with Wagner announcing the allegations to his congregation during morning services.

"Their reaction was shock and sadness," Wagner said, "and disbelief as well."

In a release from the San Diego Diocese that he read to church members, Wagner said that Bishop Robert Brom took prompt action when informed of the matter a month ago.

Omemaga surrendered his permission to function in the diocese on Oct. 8 pending further investigation, and he returned to the Philippines to inform his bishop of the situation, Wagner said.

When Omemaga returned to San Diego last week, he contacted the Rev. Stephen Callahan, assistant to Bishop Brom, who conveyed Brom's directive that Omemaga remain in San Diego and contact police.

Wagner said church officials are cooperating fully with the police investigation.

The girl has been offered "pastoral and professional assistance," he added.

Chula Vista police refused to comment on the case yesterday. However, detectives plan to release a statement today, a police spokesman said last night.

Priest sought by police on sex charges

Seduction of girl allegedly began on trip to see Pope

CHULA VISTA — Police are looking for a former Chula Vista priest who they intend to arrest for allegedly engaging in a sexual relationship with a 14-year-old female church member. The priest first made sexual advances toward the girl while on a trip to see the Pope in Denver, Colo., police said.

If arrested, Emmanuel Olilang Omemaga, 35, a former priest at the Church of The Most Precious Blood in Chula Vista, will be charged with statutory rape, child molest and snapping sexually explicit photos of an underage girl, said Chula Vista Police Detective John McAvenia.

Police confirmed the investigation after the *Star-News* was tipped and contacted the department.

Police, attaining a search warrant in late October, searched the priest's rectory at the Lakeside church where he last served. McAvenia said 37 photos of the girl in erotic positions on motel room beds were confiscated after being found in one of the priest's jacket pockets. Motel room receipts were also found, McAvenia said.

The girl, whose name cannot be released to protect her identity, had a two-month affair with Omemaga, McAvenia said. She was a member of the

Chula Vista church where he served. The suspected affair started in August after he supposedly "seduced" her during a bus ride on the way home from a trip to visit the Pope for "World Youth Day 1993" — an international gathering of young adults and youths event held in Denver, police said.

The following two months included alleged sexual encounters in at least four motels and also in the priest's rectory, McAvenia said. However, one motel receipt found, indicating two guests were registered, was supposedly not a time when the 14-year-old girl went with him, McAvenia said.

Police said no other people have reported sexual misbehavior by Omemaga.

Although the girl was willing to engage in most of the alleged sex acts during their affair, she said "no" to Omemaga during their last encounter, yet he still allegedly forced her in a non-physically abusive way to have sex with him, police said.

The last encounter was at the end of September, McAvenia said.

Police were called after the girl's mother found a love letter from her daughter to Omemaga and then confronted her daughter on the matter. Her mother, who declined to comment on the case, said her main concern is her daughter and protecting her.

McAvenia said her mother never suspected such a thing was happening between her daughter and the priest.

"Her mom feels bad because she was encouraging her daughter to go out with him for spiritual guidance," McAvenia said.

Omemaga, who switched from the Chula Vista Catholic church to Lakeside's Our Lady of Perpetual Help

church, "surrendered his faculties to function as a priest pending further investigation," according to a statement from the Diocese of San Diego.

When the allegation was brought forth to the Diocese, pastoral and professional assistance were offered to the female involved, according to the statement. Omemaga was sent to the Philippines to inform his Bishop of the matter. After returning to San Diego last week, Father Steven Callahan, assistant to the Bishop, conveyed to Omemaga

that the Bishop directed him to remain in San Diego and contact the Chula Vista Police Department.

In the statement, the Diocese says it's "cooperating fully with the police investigation, but does not know the whereabouts of Father Omemaga."

"Out of respect for the rights of the girl and the priest, the Diocese must decline further comment at this time," the release states.

McAvenia said Thursday that Omemaga has not yet contacted police.
