

Dear Father Sierra:

At your earliest convenience, I ask that you take up a collection for the Catholic Relief Services for the poor of the world. Kindly stress the fact that the Holy Father personally visited Thailand and saw the extreme need of the poor. The Vietnam offensive sent one million Indochinese fleeing from Laos, Vietnam and Cambodia. 644,000 refugees are now in Thailand and desperate for assistance. The Holy Father placed the obligation of assisting these people on the American Church.

The Bishops have accepted this responsibility and they are working with the hierarchy of Thailand operating programs to feed the people with rice, vegetables and milk, and to supply medicines. We have established two hospitals which contributed to the substantial reduction of sickness among the Khmer and Vietnamese refugees. This program provides a concrete answer to Pope John Paul II's plea to the American Church in 1984 that no refugee go hungry and homeless.

Together with the nutrition programs, Catholic Relief Services provides medical programs where special attention is given to pregnant mothers and children under 5 years to avoid malnutrition. We are looking beyond the immediate emergency and these refugees are being trained in self-help programs and support programs that will foster self-reliance.

We urge you to support us in accomplishing what the Holy Father asked us to do in caring for the refugee camps in Thailand. These people have nothing and they are relying on the American Church for the tremendous help that we must give them for the next few years.

Thank you for your very generous support in the past. I am sure that it will be similar for the tremendous need of the present time.

I would like to present to you a picture of the Brawley Parish, Our Lady of Perpetual Help, in its financial matters. The reason is that I need your help and guidance. The average income per Sunday is below \$300, especially now during the four summer months June, July, August, and September; it is more like \$200 per Sunday. The other income that we have is about \$200 or less from the Bingo activity fund raiser of every Friday.

The salary of the priest alone is \$730. The electricity, utilities, and phone average over \$600 a month. Food expense of \$400, office supplies, house supplies, and repairs, is another \$300. No money is left to pay a maid housekeeper, cook, janitor, or secretary. Now the other serious accounts are withe the Diocese such as; assessments, insurance, and pension.

- ----The grand total income amounts to \$2000 a month. (Summer months \$1600.)
- ----Monthly expenses average well over \$2000.
- ----This explains the serious debt on the Diocesan assessments and obligations.

This parish is several thousand dollars behind in payments to the Diocese on the above mentioned accounts. I would like to have help or a possible loan or what you have to recommend as my superior and my shephard.



RE: Donation of Funds and its Custody

This confirms that we have received authorization from St. Didacus Church in the amount of \$100,000.00 to be used as described in the parish's letters of July 7, 1983 in behalf of the Sisters of Nazareth program for an addition to the priests' retirement facility and for Our Lady of Perpetual Help Parish in Brawley.

On behalf of the Sisters of Nazareth, \$50,000.00 will be transfered from the St. Didacus funds on deposit to a custodial account which would be accumulative and non-interest bearing. This account, as directed by you, will be initially targeted to accumulate approximately \$300,000.00 for an addition to the priests' retirement facility. Nevertheless, it may as required, be drawn against for purposes of financing the priests' retirement facility.

An additional \$50,000.00 will be transfered from the St. Didacus funds on deposit to a custodial account on behalf of Our Lady of Perpetual Help Parish at which Fr. Frank Sierra is the pastor. Approximately \$30,000.00 will be used as soon as feasible for the purchase of property recommended by Father Sierra to be used for the parish drug addiction program. This property is to be made diocesan property and rented to the parish with a written agreement drawn by diocesan counsel for \$5.00 per year. The remaining funds will be used to liquidate accumulated debts and obligations of the parish including accounts payable to various vendors in Brawley, and diocesan debts and obligations including diocesan assessment, diocesan Stewardship, diocesan payroll and diocesan insurance programs. Given the circumstances, unless you object, I would recommend that all disbursements be made from the diocesan checking account. Any remaining funds after the purchase of the property and payment of obligations and debts, will remain in the custodial account to cover specific expenses as needed and as you authorize.

Please advise me if this meets with your instructions.

One important very important issue is that this is that this is the only Catholic directed center of this naure South of Los Angeles (Called Catholic Rainbow Outreach).

Catholics are being swallowed up by other establishments such as "Victory Outreach", "Victory Chapel".

They work like Jehovah Witness in hate and turn catholics away at a young age.

A Catholic priest has a strong influence on the program if the catholic church owns the program building, And has a say on who is in leadership there. What is taught in ways of religion and bible. Especially as it is now born a Catholic program.

Father Virgilio Elizondo considered such factors to be very important. Many other priests, bishops, ministers know about it. Our Lady of Perpetual Help parish was establised twenty seven years ago by Bishop Buddy.

Dear Father Sierra:

This confirms my having received from you an initial copy of a draft budget covering a request for subsidy from the diocesan office. A copy of the first draft is herewith attached for your review. Based on my initial calculation, this request for monthly subsidy amounts to approximately \$30,000.00 per year.

Subsequently, you advised Monsignor Eagen, and then me, that repair work would be needed on the 1973 Dodge van. Labor would cost about \$200.00, and replacement of the engine and other parts approximately \$800.00. Until this work is completed, the van is not usable, as you inform me, and the work cannot be completed until \$1,000.00 is provided your parish.

You also advised me that approximately \$900.00 would have to be paid to Heffernan, Kieler and Doble for auto and other vehicle insurance. Hence, your immediate need is approximately \$2,000.00.

As a general item of information, you advised me that your parish assessment is in arrears about \$600.00. Also, you have no hired staff and are assisted when available by volunteers.

I am now reviewing this matter and will be discussing it with Monsignor Eagen in order to provide you with some indication of the availability of the diocesan office to grant the subsidy you have requested. Nevertheless, it would be desirable that you provide me additional information in detail which you believe would assist us in analysing your request.

In checking the returns of the collection for Communications, I find you have not as yet sent in your parish contribution. As you know, there are four major national collections that are obligatory, namely: Propagation of the Faith, Bishops' Overseas Relief, Human Development and Communications. Other collections -- such as for the Pope, the Latin American collection which is given to our two neighboring dioceses, the Indian and Black collection -- are part of Stewardship and add up to about \$100,000.

Since our records do not show your contribution to the Communications collection, you are requested to send in your collection at the earliest possible date. If by chance you did not take it up at the scheduled time, you are requested to do so as soon as it is convenient. Certainly you recognize this is not an optional collection, but requested by every parish to promote the evangelical work of the Church on the national and local level.

Pastoral charity requires that priests avoid operating in a vacuum and that they work in a strong bond of union with their bishop and brother priests. If this be their program, priests will find the coordination and unity of their own life in the oneness of the Church's mission. They will be joined with the Lord and through Him with the Father in the Holy Spirit. This will bring them great satisfaction and a full measure of happiness.
